

Your promised Programs appear to be in "good health" and we can all be grateful for that as well; saddened and shocked as we are by the insane attack on another World Leader by yet another "hopped up" lunatic! Dear Mr. President:

First, I want to tell you how extremely happy we are that our Nation's prayers were answered. Your past care of yourself has paid off and we are grateful that your recovery is coming along so well and so quickly. I know that in a matter of weeks you will be back as physically active as always. As you have said: "There's nothing so good for the inside of a man as the outside of a horse." We hope that "inside good" will happen soon again.

I do not want to impose upon your recuperative period as well as your continuing leadership in affairs of State. These are very dangerous and tentative times, and I am sure the pressures are great. But, if you can think of another problem, I would like to share with you one that I believe is as urgent and pressing a problem as any with which our Nation is faced. Drugs - heroin, cocaine, P.C.P., to name the worst offenders.

I have been somewhat involved with a project related to drugs this last year which was conceived and designed by my good friend, Stanley Meyer. Stanley has been involved in many television and theatrical productions since he left Fox West Coast Theatres, where he served as Special Assistant to Charles Skouras. As a matter of fact, he staged premieres for two of your most prominent pictures, "King's Row," and "Knut Rockne."

To quickly tell you, Stanley has been working with the complete cooperation of Peter Bensinger and the Department of Drug Enforcement to package a program that shows the negative role of drugs in the United States, how the drugs infiltrate through our borders and the fine quality of our D.E.A. personnel. My role was to narrate this presentation, and I am very impressed with the possibilities of the effect it will have on the American public.

One of the problems in getting this off the ground is prevalence of the use of drugs in our Industry, which makes the producers reluctant to "blow their cover" so to speak. Sad, isn't it?

May I share some thoughts that occurred to Stan and me related to the excising of this problem? We feel that perhaps you might call a publicized meeting of your chief law enforcement officer, the Attorney General; your Secretary of State; your Ambassador to the United Nations, and your Secretary of Defense, the latter because drug usage in our armed forces is rampant. To lay the strategy, from this meeting you then state that our Government, Nation and you have declared World War III - a war against drugs, to protect our youth, our families and the future of our Nation from this incidious attack. Perhaps Vice President George C. Bush, as the head of the Crisis Management Team, and/or Ed Meese, might represent you, although leave no doubt you are the Commander-In-Chief of the army against this war as well.

Stanley and I are not naive enough to be unaware of the international impact this will have with governments from Southeast Asia to Southwest Asia to South America to Mexico. We do believe that we have some very valuable ideas and support for your program, if you choose to begin this project. We would be willing to come to Washington, or any location you indicate, to explain further to you and any other personnel of your choice.

My friend, we know that this proposal would take the courage no other President has had to make a dent in this disease to which our society is being subjected. We also believe it must be done, and we hope you agree.

It was not so long ago, as you recall, that gangsters such as Capone, etc. were running much of our country in the form of corporations, buying government officials, etc. There was a time we had 30 or 40 public enemies that were "untouchable." There was not the type of communications that we have at our fingertips today. We can, and must, make use of them for the public good, as well as mediums of entertainment.

Kathie joins me in sending our love and best wishes to Nancy and yourself.

PROPOSAL FOR A MOTION PICTURE AND/OR TELEVISION SERIES
BASED ON MY RESEARCH AND EXCLUSIVE AGREEMENT WITH THE
DRUG ENFORCEMENT ADMINISTRATION/DEPARTMENT OF JUSTICE.

BACKGROUND:

From all around the world drug traffickers focus on their golden target - the United States. It is known by law enforcement agencies that some sixty-four billion (\$64,000,000,000) worth of illicit drugs, (representing 20% of the total drug volume) pour into the country every year, providing massive untaxed funds. The USA receives no benefits from this untaxed money. An even greater volume of drugs, 80% in fact, eludes the net, saturating and corrupting the nation's population because of insufficient budget and manpower.

To combat this avalanche of mind-destroying filth, the United States Government set up EPIC - the first joint intelligence center, comprising the facilities of some eight or nine federal agencies, and operating from El Paso, Texas (EPIC - El Paso Intelligence Center), which is at about the mid-point of the 2,000 mile border between Mexico and the United States. Here, a dedicated force of agents keep world-wide watch on the movement of ships and aircraft and known drug offenders and dealers.

Their work in staunching the flow of dangerous narcotics involves the use of their own satellite, plus highly sophisticated computers and technology, as well as a vast network of informers around the world.

PROPOSAL:

To produce a two-hour motion picture for television dealing with the human drama involved in EPIC's work, as a possible spin-off for an hour series.

FORMAT:

The show will center in EPIC in El Paso, Texas, and feature the Drug Enforcement Agency agent in charge of the unit, as its lead character. Around him will be a small dedicated group of men and women whom we shall come to know as individuals from various law enforcement agencies.

It will open with an authoritative personality (Walter Cronkite, etc.), stating that the show is based on authentic DEA files, and warning the viewer of the harsh reality of the drug plague that is now affecting the lives of one in every two families in the United States!

While the two hour motion picture will resolve the major case with which its story deals, in the series we shall cover one or two or three different cases in each hour episode. One of these could be the pursuit of a major narcotics operation, taking a full hour to bring to fruition. Some cases could be resolved within the compass of the hour, while others could run through two or perhaps three episodes before its resolution within the hour program.

It is important to understand that the shows will not be merely "the Drug Bust of the Week." In every case EPIC's thrust will be to capture and convict those human vermin who mastermind the narcotics business, preying on the gullible, weak and defenseless.

The sheer magnitude of untaxed cash available corrupts people at every level of life, changing their lives, attitudes and morals. It also enables the drug traffickers to invest in counter-espionage technology which is sometimes even more sophisticated than that available to EPIC's agents.

IN CONCLUSION:

We are dealing with perhaps the most important story of the day, perhaps of all time. The flood tide of mind-destroying narcotics pouring into the United States is literally eroding the stability of our society, not only by undermining the health of the users - but by ripping apart the fabric that binds society together. Corruption reaches into the highest levels of the land, the law is perverted to enable criminals to evade justice. Unless public awareness is awakened, we face the eventual collapse of our family system.

The proposed show - EPIC - will alert people to the awesome dangers facing us, through exciting human drama, and hopefully tip the scales on the side of those who want to preserve democracy against those forces which are bent on destroying it.

But, above all, EPIC will be rich in dramatic potential, involving human beings caught up in one capacity or another in the truly enormous narcotics network that encompasses the Free World.

1. The unusual aspect of this presentation is that it proposes that the only real control of narcotics is to target and eliminate the "HEAD DRUG TRAFFICKERS." In this instance, the "HEAD" is not confined to the semi-mythical Mafia that has been popularized from fact into fiction, but is like a thousand Mafias. The fact is that each operation has cleared millions of dollars and totals \$64,000,000,000 of illicit drug trafficking in untaxed money annually.
2. Each of these illicit entities has its own hierarchy, and is in the main, run by leaders of high intelligence. Therefore, it was necessary to create an entire Drug Enforcement Agency of equal and even superior high intelligence and capability. In the same way that Sherlock Holmes was a great detective because he had a superior and equal adversary in Moriarty, DEA was established specifically to eradicate the national and international cunning, money, power and counter espionage equipment used by the narcotic traffickers.
3. It is important to present this television mini-series on the basis of being a factual "Mission Impossible" in the following sense: That specialized DEA teams are established on each new case in order to formulate, centralize and control their professionally planned coordinated attack against the highly sophisticated opposite teams of narcotic conspirators.
4. In conclusion, the following fact is pertinent: The commitment and dedication of the principles and objectives of the DEA organization, versus, the greed and disregard for human lives and suffering of current and future generations by narcotic traffickers. The result is a highly personalized television mini-series of authentic case histories and actual events that dramatize, on a one to one basis - PEOPLE VS. PEOPLE.

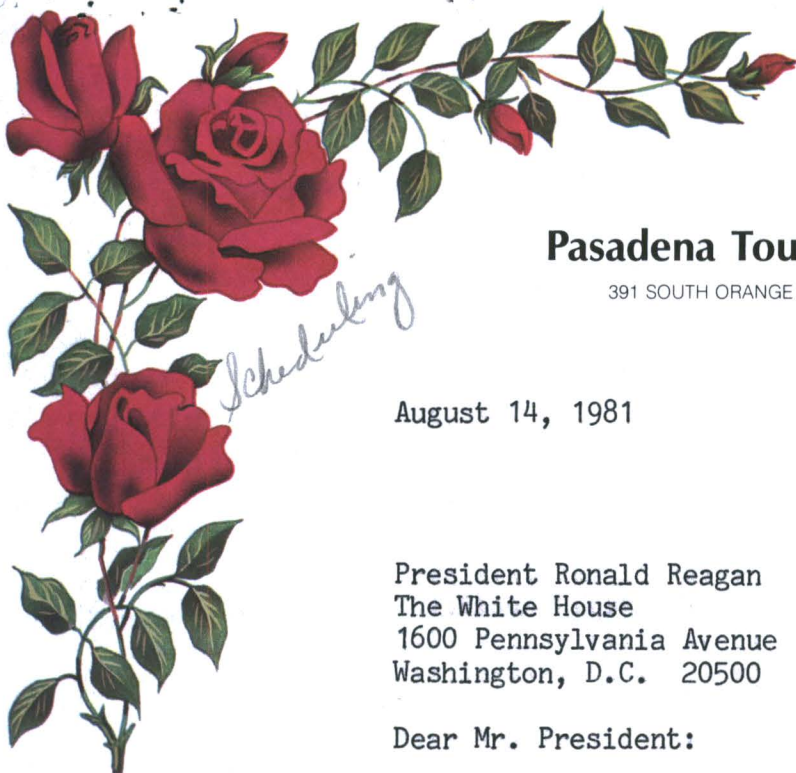



'Fireside' chats could resolve nagging economic question mark

NEW YORK — Memo to Ronald Reagan: Now that you've scored the political coup, you can move to resolve the economic question mark.

Conventional political and economic analysts don't know quite what to make of your economic recovery plan. Their general forecasting record in recent years constitutes the best known argument for flipping a coin.

Consequently, the consensus appears to be that we will just have to "wait and see" whether, a couple of years from now, your package proves to have been constructive or damaging.

One of your own alleged supporters in the Senate, catching this wind, has described the program as a "riverboat gamble". More obvious dissenters have been considerably less kind.

Specifically, there is much uncertainty about whether your tax cuts will indeed encourage savings and investment, as they are intended to, or whether they will merely encourage lovelier vacations or more exciting evenings on the town.

★ ★ ★

WHAT'S LEFT out of these calculations, Mr. President, is the impact you can continue to have as a master communicator. To wit:

(1) Why not plan right now a series of "fireside chats" (ranchside, if you prefer) in which you explain the economic realities to the American people and urge them to save and invest a goodly share of their tax reduction?

Instead of passively waiting to see which theorists are right about what taxpayers will do with their extra dollars, actively step in and help to guide that choice.

such decisions is often overlooked by professional economists obsessed with mathematical equations, but it should never be minimized.

Even poor Jimmy Carter, when he incorrectly targeted the Visa card as Public Enemy No. One last year, had a massive impact on public spending habits before he reversed himself.

You'll want to avoid such misguided overkill, but you should never underestimate your own ability to help produce the results you seek.

(2) A bonus feature of this public-education campaign could be greater understanding of the realities of Social Security — the economic area in which you've had the least success so far in 1981.

★ ★ ★

YOU CAN'T expect overnight victory over all the entrenched ignorance on this subject, but you can at least begin to resist the prevalent intellectual racketeering.

The purpose of this memorandum is to reiterate in the strongest terms the need for a major communications effort by the Administration and the Republican Party to explain the shift in decision-making from the federal to the state level as a result of block grants.

Premise

Of the three major components of the Reagan economic/spending package, block grants have received the least explanation and are least understood by the news media and the public. The public does not perceive that substantial responsibility for funding choices has been shifted to the state level. No meaningful effort has yet been made to re-educate the public on this vitally important shift. In the absence of such an effort (which will require significantly more work than the sales jobs done successfully on budget reductions and tax cuts), the public will continue to hold Washington responsible for funding choices because they are conditioned to do so already and will be encouraged to do so by our adversaries. The Reagan Administration thus stands to be held liable for selfish and short-sighted funding decisions which are actually being made by Democrat governors and state legislators. The situation will become a major political albatross for the President unless immediate steps are taken to preempt the debate and educate the public on this major change.

Magnitude of the Problem

Our adversaries are well positioned to sabotage block grants with impunity. They are far stronger and more numerous than we are at the implementation level (governors, state legislatures, mayors, local officials). They have hundreds of pulpits across the nation from which to blame the President's budget cutting for decisions they, in fact, make which are unpopular and painful. The Georgia example of cutting day care centers and nursing homes while paying cash for a new GBI building is a perfect example of the potential

problem we face. They will blame the President's cuts for the day care center and nursing home reductions, and they will get away with it unless the people know better. Our adversaries will find a ready ear in much of the news media, which will be drawn to emotional accounts of struggling, working mothers who now have no day care help, and hard-pressed families who can no longer afford to keep an elderly relative in a nursing home. Democrat governors and state legislators will have the forum, and they will use it to blame the President and the Republican Party for every painful program cut. Citizens who have longed looked to Washington to provide for social need will listen to the Democrats and believe them. By entering the debate too late, we will be on the defensive and will lose ground that may not be recovered. The momentum of the President's entire economic/fiscal initiative will change dramatically against us.

The Solution

The Administration and the Republican Party can preempt the debate and shift the focus to the state level before we are placed in an untenable posture of reacting and excuse-making.

We are well equipped to do this because we have the President and the "bully pulpit" and the organizational/communications resources of the RNC and Campaign Committees.

The key is speed. We must seize the debate and conduct it on our terms, rather than being forced into a defensive position.

The block grant communications/education program should include:

1. A major television address by President Reagan to outline the shift in responsibility to the state level. State officials, closer and more accessible to the people, will now decide what money goes to which programs. Thus, those decisions are now much more easily influenced by the people. The federal government is cutting the total amount of money available, because we would be bankrupt otherwise. It is now up to the states, however, to decide where the money will be spent. Where federal funds are less than before, the state can make up the difference if it thinks a particular program is important enough. Governors and state legislators must now be held accountable for decisions heretofore made in Washington.
2. A major communications effort by Republican Senators and Congressmen to reinforce the President's message, through vehicles such as speeches, weekly radio shows, newsletters, etc. RNC and the Campaign Committees should orchestrate this campaign, supplying data, canned speech material, etc.
3. Similar reinforcement by appropriate Cabinet members.

4. Similar reinforcement by GOP governors and state legislators. In states without a GOP governor, a team of GOP legislators should be primed as spokesmen, especially for such events as responding to the Democrat governor's state-of-the-state address, which we can predict will be used to blast block grants.
5. Similar reinforcement by Republican party officials at the national and state levels. Also by Republican elected officials at the city and county level.
6. Possible national advertising campaign by RNC, similar to "Vote Republican For A Change". The message should be that it's more important than ever before to know your state officials, because they are more important than ever before.

At all levels, the message must be as straight-forward and simple as possible. We should note, however, that block grants are not simple. The attached sheet is one indication of the restrictions that exist in some areas. It was thrown on my desk in disgust by Senator Holloway. Of special interest is the fact that this information about restrictions was not supplied by OMB or any federal agency; it was developed by the State Budget Office on its own, because almost no-guidance has been forthcoming from Washington. This is another shell the Democrats will lob at us. When the Democrats complain about strings being attached, however, they are complaining about what their own Party members insisted upon in the Congress. Part of our message should probably be to acknowledge those strings, bemoan the fact that the Democrats insisted on them, and express our intent to get rid of them.

In summary, we need to move rapidly and forcefully to take hold of the debate and frame it to our own advantage. Otherwise we are leaving ourselves open and vulnerable to a Democrat onslaught that will almost surely be effective in putting us badly off-balance during the 1982 election year.

'Fireside' chats could resolve nagging economic question mark

NEW YORK — Memo to Ronald Reagan: Now that you've scored the political coup, you can move to resolve the economic question mark.

Conventional political and economic analysts don't know quite what to make of your economic recovery plan. Their general forecasting record in recent years constitutes the best known argument for flipping a coin.

Consequently, the consensus appears to be that we will just have to "wait and see" whether, a couple of years from now, your package proves to have been constructive or damaging.

One of your own alleged supporters in the Senate, catching this wind, has described the program as a "riverboat gamble." More obvious dissenters have been considerably less kind.

Specifically, there is much uncertainty about whether your tax cuts will indeed encourage savings and investment, as they are intended to, or whether they will merely encourage lovelier vacations or more exciting evenings on the town.

WHAT'S LEFT out of these calculations, Mr. President, is the impact you can continue to have as a master communicator. To wit:

(1) Why not plan right now a series of "fireside chats" (ranchside, if you prefer) in which you explain the economic realities to the American people and urge them to save and invest a goodly share of their tax reduction?

Instead of passively waiting to see which theorists are right about what taxpayers will do with their extra dollars, actively step in and help to guide that choice.

The power of the Presidency to influence

such decisions is often overlooked by professional economists obsessed with mathematical equations, but it should never be minimized.

Even poor Jimmy Carter, when he incorrectly targeted the Visa card as Public Enemy No. One last year, had a massive impact on public spending habits before he reversed himself.

You'll want to avoid such misguided overkill, but you should never underestimate your own ability to help produce the results you seek.

(2) A bonus feature of this public-education campaign could be greater understanding of the realities of Social Security — the economic area in which you've had the least success so far in 1981.

We recently read of your interest in the International Year of Disabled Persons, as expressed during your trip to attend the Royal Wedding. The program which has been developed by the government through the Federal Interagency Committee and the private sector, through the U.S. Council, is an outstanding one. The collaborative working relationship which has been established by both the public and private sectors is a direct result of the leadership provided by your husband when he signed the Proclamation on his birthday, February 6.


To date, the private sector has stimulated the involvement of over 1,700 local communities, 300 businesses, and a host of voluntary agencies. The federal family has revitalized and strengthened its commitment to America's 35 million disabled persons. At present, over 40 federal agencies have dedicated over 275 projects. The interesting point here is that no federal agency or department has requested from the Congress one additional dollar to support IYDP in the United States. In other words, each agency has redirected operating funds to support its program and to contribute to the ongoing needs of the Secretariat. This is an accomplishment for which we are all deeply proud.

The goals and objectives of the Federal Interagency Committee are summarized in the attached document entitled "Executive Summary of Federal Involvement in IYDP." These plans have been updated to reflect the imprimatur of the Reagan Administration; the draft document entitled "Update" is also attached for your review.

You may be interested to learn that on July 31 I am leaving to head the U.S. Delegation to the United Nations Third Advisory Committee for IYDP. The Advisory Committee will develop a World Plan of Action to be considered by the General Assembly when it meets this fall. Upon my return on August 19, I will be prepared to brief you on the federal program for IYDP as well as the World Plan of Action.

While our program thus far has been tremendously successful, we would be able to reach new vistas of achievement if you were to become directly involved. We would request that you consider the feasibility of taping a public service announcement and/or serving as the Honorary National IYDP Chairperson for the remainder of the year.

Again, thank you for your interest and commitment.

Nancy Reagan: Toasts Around Town

LONDON, July 28 — Three big stories emerge from the first-lady front.

First, Nancy Reagan is wearing a three-piece peach Galanos day dress to the royal wedding. Second, she chatted with Lord Snowdon today during a visit to the Spastics Society. Third, the queen's ball she went to on Monday night was not a disappointment.

"It was like a page out of history," said Betsy Bloomingdale, here in her capacity as First Friend. "It was like

a page out of everything I ever read as a child. It just took my breath away."

The ball for 1,500 was held in the enormous staterooms of Buckingham Palace, many of them hung with huge paintings of the royal family. Most of the European monarchy was there, wandering around from room to room with their various cousins from the British aristocracy. For once, you could actually say everybody dressed for the queen.

"They all looked beautiful, stun-

ning and divine," said Bloomingdale, who is seldom at a loss for words after a good party. "Prince Charles looked so wonderful. And all the kings and people had their decorations on."

There was a disco in one room and two orchestras in another. Buffet tables were everywhere. Prince Charles and Lady Diana danced, he, in his decorations, she, in her raspberry ruffles. "Ravishingly beautiful," said Bloomingdale.

Nancy Reagan, who wore a white beaded Galanos gown with long, white gloves, danced with Angus Ogilvy, husband of Princess Alexandra. She was home at Winfield House by midnight, hours before hundreds of other guests straggled out.

The first lady has been keeping a social pace that is making zombies out of her staff and the reporters covering her. Today, there was a lunch given by Lord Westmorland (the chairman of Sotheby's in London) and Lady Westmorland, then a visit to the Spastics Society in Fitzroy Square, then supper at Buckingham Palace with the royal family and friends, then a ride with them to Hyde Park to watch the fireworks display.

It is considered significant that Nancy Reagan was included in the group going to Hyde Park; palace watchers say this kind of chumminess indicates she's getting very special treatment.

But did she demand it? One British newspaper says she did — specifically, that she asked to sit in the first row at the wedding.

"That didn't happen," said press secretary Sheila Tate. "I don't have any idea where I'm sitting," Tate said Nancy Reagan told her. "And I could care less."

At the fireworks tonight, Nancy Reagan sat on the right-hand side of the Royal Box about halfway up. Like others in the palace party, she arrived by royal bus. But it was a bus nonetheless. This was a fact not lost on the BBC reporter.

"We understand there had been some question whether she would be

think it's wonderful. I think it's wonderful. I would hate to see it ever disappear."

Of the polo match she attended Sunday: "I liked it . . . But it seemed to me as if they were all going to kill themselves."

On why she has so many security men with her: "Oh, I don't . . ." She stopped, staring off into space. She looked tired. "I think once you've had the experience like we had," she continued, "possibly extra precautions are taken. It's always on your mind."

Nancy Reagan's six-car entourage and the Secret Service agents who guard her continue to fascinate the British. Every time her motorcade drives up to this luncheon or that, onlookers always stare in amazement.

"I suppose we think it's a bit overdoing it, that's all," said Juliet Bingley, a 56-year-old social worker who watched Nancy Reagan arrive at the Spastics Society yesterday. "When Henry Kissinger used to come over here, people thought it was quite funny. Those tremendous security guards. It's like a television program."

Adding to the difference are the black limousines. They're monsters among the small British Rovers.

"They look like they've come over from somewhere else," said Bingley. One car in the motorcade was, however, a snazzy red Jaguar. It ruined the all-black color scheme.

Here's how one newspaper, The Daily Mail, characterized one of Nancy Reagan's stops on the London circuit: "At least half a dozen American security men in sharp suits, assisted by the glamorous body guard who travels with the first lady, leapt into positions on the steps as Nancy Reagan emerged to give a regal wave."

It just about happened like that when Nancy Reagan arrived at the Spastics Society, a services and assessment center for the handicapped. This was the one public service stop of her 15 events scheduled. She toured the rooms, then met

Lord Snowdon, who's been taking pictures of the royal couple.

Snowdon is also president of the International Year of the Disabled Person, and he was standing at the head of the Spastics Society receiving line. Rather than making the usual pleasantries, he asked Nancy Reagan point blank what kind of impact the International Year was having in the United States.

"We'll try to continue on the same track of keeping people more aware," she said. "Not to ignore it."

Snowdon continued talking, at most lecturing her, about disabled people. She stood straight, eyes wide, face tight and immobile as she looked at him. It was impossible to tell whether she was fascinated or angry.

At the end of his lecture she moved on through the receiving line, saying hello to another dignitary. But suddenly she shifted back to Snowdon.

"Do you have anything like the foster grandparents program?" she asked sweetly. Do you know what I mean?"

Lord Snowdon looked blank, but a reporter behind him smiled.

"You do," Nancy Reagan said to the reporter, then began carefully explaining to Snowdon that "it's bringing together the elderly and the young . . ."

"What is she doing?" an observer asked Sheila Tate.

"Pushing foster grandparents," Tate replied simply.

Minutes later, Nancy Reagan and her entourage were off.

A last item on her wedding day outfit: She's wearing a straw, "casual-tailored" hat with a chiffon scarf. As promised, it was revealed almost 24 hours before Lady Diana's dress.

Tate made the decision, saying she didn't want to make a "big deal" out of it by announcing it a week before the wedding. Meanwhile, it quietly became a big deal to the British press because she waited so long.

"I don't know," Tate sighed. "It was just a judgment call."

Preface

The following pages describe the United States Government's efforts to develop and implement the International Year guidelines which were provided by the United Nations. The Federal structure for the Year and the various organizing committees and councils which are working closely together on special programs and projects also are described. The coordinated and purposeful national effort of these groups, in combination with community actions, will affect the lives of disabled citizens in the decade to come. Major IYDP goals and highlights of planned Federal activities in celebration of the International Year constitute the main body of the report. Federal Interagency Committee members are listed at the end of the report.

An expression of appreciation is due to many people. Special gratitude is extended to Jill Priest-Miles and Michael Petell for coordinating the Federal effort and for authoring this publication. While a complete listing by name is impossible, special thanks are due to the Federal Interagency Committee members who have given willingly of their time to develop IYDP plans, to Susan Rose and Margaret Harley of the IYDP Secretariat staff, and to Betty Defay of J.W.K. International Corporation, for their invaluable assistance and support.

It is our hope that this information will prove helpful as a reference resource to the wide variety of individuals who are interested in Federal programs which serve disabled children and adults. The Secretariat staff plans to update the report during the Year.

The International Year of Disabled Persons — 1981

The General Assembly of the United Nations has designated 1981 as "The International Year of Disabled Persons" (IYDP). The theme of the 1981 observance is "Full Participation and Equality" for the world's disabled citizens. The International Year will draw attention to issues, problems, and activities of world-wide concern, establish long-term national objectives, and encourage the development of programs designed to improve the lives of 450 million disabled citizens throughout the world.

In 1976, the United Nations' delegation from Libya introduced a resolution to the UN General Assembly, which approved a draft plan for IYDP. In 1979, an Advisory Committee was appointed by the United Nations to advise member states and specialized agencies on the proposed plan.

The United States has actively advocated the civil rights of all of the world's citizens. It has supported a wide range of services to meet the needs of the 36 million disabled persons residing in this country. For these reasons, the United States co-sponsored the Libyan resolution which proclaimed 1981 as the International Year of Disabled Persons.

The United States responded to the United Nations' plan by establishing a Federal Interagency Committee which is chaired by the Secretaries of the Department of Health and Human Services, the Department of State, and the Department of Education. These co-chairpersons guide the work of the Federal Interagency Committee, which has representatives from approximately 30 departments, agencies, and commissions of the Federal Government.

Federal IYDP Activities

To supplement the work of the Committee, subcommittees offer support and advice in the areas of special activities, policy and consumer involvement, public awareness, and international activities. The sub-committee membership includes Federal Interagency Committee and consumer representatives.

The Federal Secretariat, under the direction of Harold O'Flaherty, is coordinating the Federal observance of IYDP. The Secretariat staff has coordinated the development and submission of the agency IYDP plans which are summarized in this report. The Secretariat also advises Federal agencies and supports a range of special activities





which will contribute to the greater independence of disabled people. The Federal Interagency Committee and the Federal Secretariat are working with each branch of the Federal Government to ensure that disabled persons have equal access to the health care, education, housing, transportation, and other services enjoyed by all U.S. citizens. Neither the Secretariat nor the Federal Interagency Committee are supporting or promoting programs which are not efficient and cost-effective. Another principle guiding the work of the Committee and Secretariat staff is the need to actively involve citizens, including disabled consumers, in the design of Federal programs which affect their lives. Every participating agency is being asked to involve consumers in the development of agency policies, procedures, programs, and long range plans.

The ten Federal regional offices are becoming actively involved in this important Year by disseminating information about the Year and by working jointly with the private sector on a number of IYDP initiatives. In addition, the Federal Executive Boards and Federal Executive Associations in 116 major metropolitan areas are becoming actively involved in local community observances of the Year.

U.S. Council for IYDP

The activities of the Federal Interagency Committee are complemented by the efforts of the U.S. Council for IYDP, a private sector consortium of businesses and organizations. The U.S. Council is promoting a partnership between disabled and nondisabled persons, between public and private sector organizations, and between the state and local levels of government. The council's three programs, the Community Partnership Program, the Corporate Partnership Program, and the Challenges of the New Decade Program, are developing community support and corporate participation in

the Year's activities. The Council is acting as a catalyst and promoter of national efforts and local community activities in celebration of the Year.

Both the Federal Interagency Committee and the U.S. Council are encouraging the full participation and integration of persons with disabilities into society during this International Year. This mutual effort will result in an International Year of Disabled Persons—1981 which reflects a partnership among governmental, private, and voluntary organizations.

The Federal Commitment to IYDP

The International Year is promoting improvements in the quality of life of persons with disabilities by supporting independent living services, economic self-sufficiency, and the prevention of disability. The independent living concept encourages disabled people to exert control over their personal living arrangements, to participate in peer counseling to help build confidence in independent living skills, and to actively participate in the administration of the support services which they need to live and function as independently as possible within their communities.

The Federal Government has become increasingly committed to the independent living concept and to other programs and activities which help disabled persons reach their maximum potential or which prevent disabilities. For example, an Interagency Independent Living Initiative was recently announced by the White House. This project combines the resources of the Federal Government and the private sector to support the economic independence goals of disabled workers through their training and placement in competitive employment.

The United States has traditionally supported the prevention of disability through primary health care and research and service programs. These programs emphasize prenatal care and the early identification and treatment of potentially disabling conditions in young children. The Federal Government also supports programs of public information on health issues, rehabilitation services, and a national occupational safety program.

Activities to accomplish the IYDP goals have been proposed by the participating Federal departments, agencies, and commissions. A common theme in the many agencies which analyzed current agency policies and programs is the improvement and expansion of programs dealing with affirmative

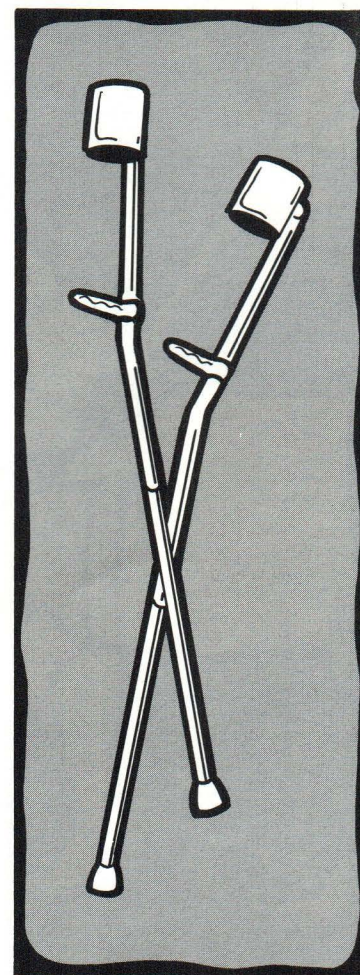
action, training and awareness, and public information and outreach.

Affirmative action programs set goals for the recruitment, placement, and promotion of disabled persons in the agency workforce; assess and modify facilities and programs to provide physical and information access; develop advisory committees and self-help groups of disabled persons to support affirmative action initiatives; and identify and correct barriers to the selection and training of disabled employees.

Training and awareness activities include programs which promote and foster attitudinal changes such as: training managers and supervisors on disability topics; training disabled employees and potential employees about their civil rights and educational opportunities; developing and disseminating public information and media materials on disability; and developing conferences, seminars, and workshops which highlight the abilities, achievements, and needs of disabled people.

Public information and outreach includes providing information on disability topics to the general public and Federal agency employees, using alternative formats to disseminate information to sensory impaired persons (Braille, tapes, captions, interpreters for the deaf); highlighting the achievements and needs of disabled persons in newspaper and magazine articles and public service announcements; and including photographs of disabled people in publications and audio visual materials.

Recent Department of Labor statistics conservatively estimate that 7.2 million severely disabled United States' citizens are of working age, which is nearly six percent of the workforce. As of December 31, 1979, records of the Central Personnel Data File indicated that approximately one percent of government employees identified themselves as

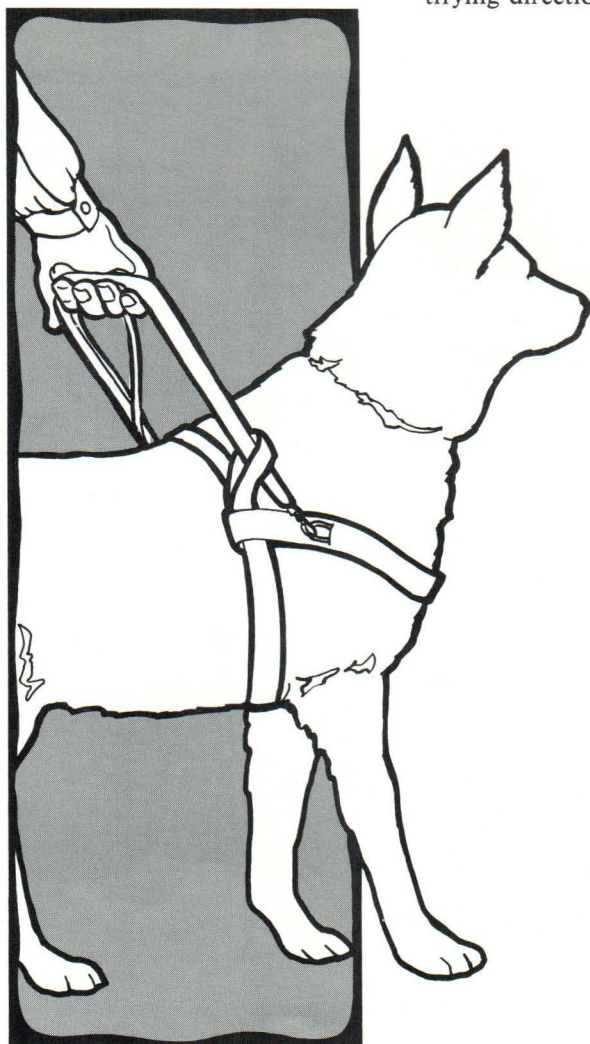


severely disabled. These statistics emphasize the need to intensify Federal affirmative action and independent living efforts.

Federal Interagency Committee Goals

In planning the government-wide observance of IYDP, the Federal Secretariat and the Federal Interagency Committee have established four goals for the Year:

Federal IYDP Plans: This goal involves analyzing and summarizing Federal agency IYDP plans and identifying directions for future action.



Federal Government Awareness of IYDP: This goal supplements and complements Federal agency and departmental planning by providing agencies with information and technical assistance, stimulating the involvement of disabled consumers and government employees in agency policy processes, and by linking Federal activities with state, regional, and local programs.

Public Outreach: The public outreach goal is to inform the nation's citizens about the observance of IYDP and the long-term U.S. commitment to disabled individuals. The Federal Interagency Committee is conducting a multi-media campaign to stimulate support for the Year nationwide.

International Information Exchange: This goal's focus is on the dissemination of information to the American and international communities about exemplary programs, research findings, and technological innovations.

Many agencies have initiated projects and programs which are unique and innovative for the International Year. However, all IYDP projects are financed with existing resources. No new monies have been appropriated to fund any component of the IYDP development and implementation phases. The Federal Interagency Committee sees these activities as part of an ongoing effort to integrate disabled persons into the nation's communities. This report presents examples of the total Federal commitment to the needs of disabled persons, and highlights activities which can be shared with and replicated by the public and private sectors.

The remainder of this report summarizes activities in the areas of prevention and rehabilitation, demonstration projects and programs, research and program accessibility, and awareness. The description of each activity is followed by the name of the Federal agency in which it is taking place.

Prevention and Rehabilitation

The proposed activities in prevention and rehabilitation promote the prevention of disability and the rehabilitation of disabled persons. The Federal Government is actively initiating and promoting programs to eliminate the onset of accident, sickness, disease or disability, and to rehabilitate disabled individuals and support their integration into their communities. During the Year, the Government will initiate or continue the activities listed below.

- The number of volunteers who are disabled will be increased by at least five to ten percent in 1981. (ACTION)
- Long-term efforts in independent living and other programs involving disabled people will be initiated and supported with agency funds or in cooperation with other agencies. (ACTION)
- The National Electronic Injury Surveillance System (NEISS), a computer-based network of hospital emergency rooms, is a primary source of injury data. Data from NEISS and associated investigations are used to identify product-related hazards, to determine the role of various disabilities in injury patterns, and to help guide a broad range of activities. (Consumer Products Safety Commission)
- The National Institute of Handicapped Research has made approximately 150 research grants and contract awards to universities, rehabilitation engineering centers and special facilities for disabled people. Solutions are being sought to problems related to the prevention of disabilities and the rehabilitation of persons with handicapping conditions. The approximate cost is \$30 million. These projects include:
 - Programmatic research on employment preparation for disabled persons
 - Evaluation research including an assessment of disabled people's attainment of independent living goals in independent living centers in California
 - Development of a Braille communicator/telecommunicator for deaf-blind persons
 - Early intervention with at-risk and disabled infants
 - Use of technology to improve the capabilities of severely disabled people
 - Research in control and development of communication and other support systems for severely physically disabled people. (Department of Education)
- The Rehabilitation Services Administration, in conjunction with Projects with Industry, will meet with local and regional groups of business, industry, and rehabilitation programs. Planned programs include the improvement of employment and advancement opportunities for disabled persons, sensitivity training for able bodied persons, and increased opportunities to exchange international experts on disability. (Department of Education)
- A report to Congress will be issued on the employment of disabled individuals, including veterans, in the Federal Government. It will indicate which agencies are (and are not) in compliance with affirmative action mandates. (Equal Employment Opportunity Commission)
- The Office of Science and Technology will review the unlicensed use of low power transmitters for educational programs for hearing impaired persons. A teacher can use earphones and this system to boost auditory levels when speaking with hearing impaired pupils. A special permit for



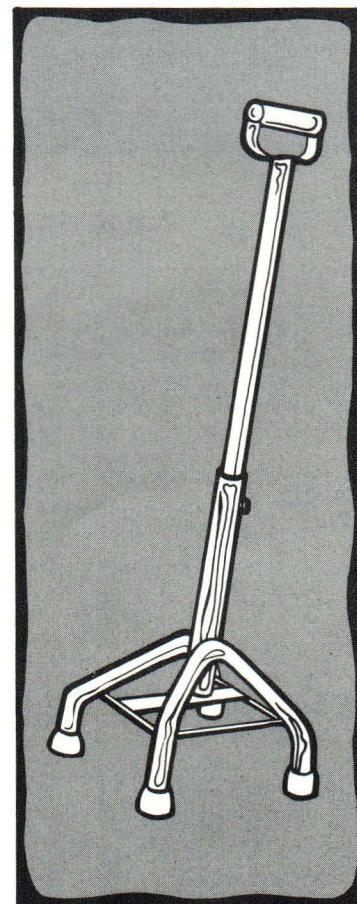
this system has been issued to the Buffalo Philharmonic Symphony for use by hearing impaired individuals who attend concerts. (Federal Communications Commission)

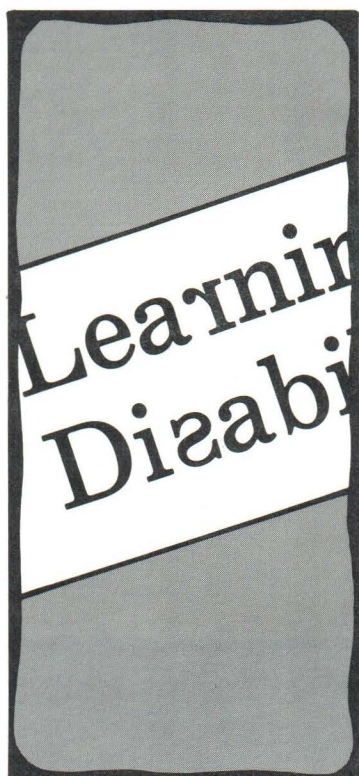
- The passage of the Fair Housing Amendments Act of 1980, which prohibits refusal to rent or sell on basis of handicap, will be promoted. (Department of Housing and Urban Development)
- The Sensory Assistance Center displays the latest technological devices which can assist disabled persons to perform job tasks. This Center also gives frequent demonstrations to visitors and serves as a training center. (Department of Justice)
- The Disabled Veterans Outreach Program maintains a staff of disabled veterans in State Employment Service/Job Service offices in more than 100 of the nation's largest cities. The offices locate jobless disabled veterans and inform them of the education, job training, and employment benefits for which they are eligible. The offices are expected to increase substantially the number of disabled veterans placed in training or jobs by the end of Fiscal 1982. (Department of Labor)
- The Health Services Administration will expand a two-year demonstration project which provides family planning services to disabled people. Services include sign language interpreters, transportation to clinics, and home services. (Department of Health and Human Services)
- The Center for Disease Control, in association with the World Health Organization, is sponsoring an expanded, world wide immunization program. The Center is providing personnel in Geneva, Asia, Africa, and South America to enable all the world's children to have access to immunizations by 1990. (Department of Health and Human Services)
- A sensory feedback prosthesis for high-leg amputees is being undertaken at Duke University in Durham, North Carolina. It is designed to accelerate the training of amputees who are using prostheses. (National Institutes of Health/Department of Health and Human Services)
- The Office of Human Development Services is establishing a policy review group which includes disabled consumers. (Department of Health and Human Services)
- The President's Committee on the Employment of the Handicapped is developing an interagency agreement to produce a "Careers in the Arts" publication. It will feature disabled people who are artists and art administrators, or who are working in art related fields. (National Endowment of the Arts)
- Public Law 96-523 will be implemented. The law authorizes the employment of personal assistants for disabled Federal employees who need special services to perform their official duties and related training and travel activities. (Office of Personnel Management)
- A special review procedure will assure that disabled applicants for Foreign Service appointments will receive full consideration. (Department of State)

Demonstration Projects and Programs

The Federal Government has initiated numerous projects, activities, and policies to assist disabled persons in their physical and psychological adjustment to society. This effort includes providing disabled persons with proper assistance, training, care, and guidance services to support their employment and promotion, and to ensure their full integration in society.

- The Hazard Identification Analysis Directorate will instruct agency field offices to collect specific information on certain product-related accidents involving disabled persons in 1981. (Consumer Products Safety Commission)
- A citizen participation program is encouraging disabled citizens' involvement in the governmental decision making process. Disabled consumers will receive information about the Federal agencies which reimburse consumers for participation in rule-making sessions, public hearings, and consumer education workshops and conferences, such as the National Low Income Consumer Conference. (Office of Consumer Affairs)
- A planned seminar, "Lessons from Public Law 480," will appraise the results of 20 years of cooperative rehabilitation and development projects between the United States and 14 other countries. (Department of Education)
- A tactile paging system is being considered to enable deaf and hearing impaired persons to be paged by feel (vibration) rather than sound. This system could be used for emergency communications. The transmission of digital messages on liquid crystal displays with standard messages is also being investigated. (Federal Communications Commission)
- The possibility of establishing a Personal Radio Service at 900 MHZ that could be used by disabled persons is being investigated. (Federal Communications Commission)
- Novice amateur radio examinations for disabled persons will continue to be given by volunteers. (Federal Communications Commission)
- The National Park Service will issue a directive calling for each National Park Unit to expand services for disabled visitors. (Department of the Interior)
- The Heritage Conservation and Recreation Service is assisting Seattle, Washington, to serve disabled persons by improving accessibility to 36 indoor and outdoor recreational facilities. Community centers, pools, theaters, parks, picnic areas, camping facilities, urban trails, and crafts centers will be made accessible to physically disabled people. The project, which will be completed by July 1981, could serve as a model for other cities. (Department of the Interior)
- The Federal Government is funding a model "Playground for all Children" in New York City. This accessible playground will serve disabled and able-bodied children and is expected to be a model for the rest of the city (Department of the Interior)
- State vocational rehabilitation facilities will offer open house tours to the public during 1981 to demonstrate services provided to vocational rehabilitation clients. (Department of Education)
- The Weatherization Assistance Program to improve the thermal efficiency of dwellings occupied by low income families, particularly those which include elderly and disabled persons, will be implemented. During 1981, approximately \$182 million in grants will be awarded to states and native tribal organizations. (Department of Energy)





- The vertical blanking interval (line 2) will be reserved for TV captioning. The NBC and ABC broadcasting networks are currently using this system on a voluntary basis. The Federal Communications Commission is also reviewing a CBS request to use the teletext system for captioning. (Federal Communications Commission)
- Authority to use FM subcarriers to read books to blind persons will be continued. This system is similar to MUZAK, except that it supplies verbal rather than musical communication. (Federal Communications Commission)
- The Broadcast Bureau is reviewing a petition from the Paralyzed Veterans of America for rules and policies to promote ownership of broadcasting stations by disabled people. (Federal Communications Commission)
- A rule is being written to obtain authority to create a codeless amateur radio service that does not require a person to send or receive Morse code. (Federal Communications Commission)
- Model demonstration programs will be developed to address the special and complex needs of institutionalized persons who are developmentally disabled. (Human Development Services/Department of Health and Human Services)
- The Food and Drug Administration will expand a model vocational program for developmentally disabled young adults at the National Center of Toxicological Research. This program provides vocational training and work experience for developmentally disabled young adults. (Public Health Services, Department of Health and Human Services)
- A competitive awards process will identify and allocate innovative project funds to exemplary community planning and development projects that are servicing disabled people. (Department of Housing and Urban Development)
- The effectiveness of a demonstration project which provides housing for chronically mentally ill persons will be evaluated. (Department of Housing and Urban Development)
- Under the targeted Job Tax Credit Program, employers can receive a tax credit for hiring disabled individuals who are referred by vocational rehabilitation programs. (Department of Labor)
- The Library of Congress has developed and will continue to disseminate a guidebook on Braille production for other countries which are interested in expanding services to visually-impaired persons. (Library of Congress)
- The "talking books" program for visually-impaired persons provides recorded books and magazines on cassette tapes or records through 160 libraries in nearly all states. (Library of Congress)
- The Office of Special Constituencies will support model projects to increase the art community's sensitivity and awareness to the needs of special populations. (National Endowment of the Arts)
- An international symposium on testing disabled persons for competitive placement will be held in November of 1981. (Office of Personnel Management)
- A program allows disabled and elderly persons to purchase stamps by mail. (Postal Service)
- "Postal Alert" is a voluntary program, aimed at helping disabled and elderly customers, in which delivery employees keep an eye on mail re-

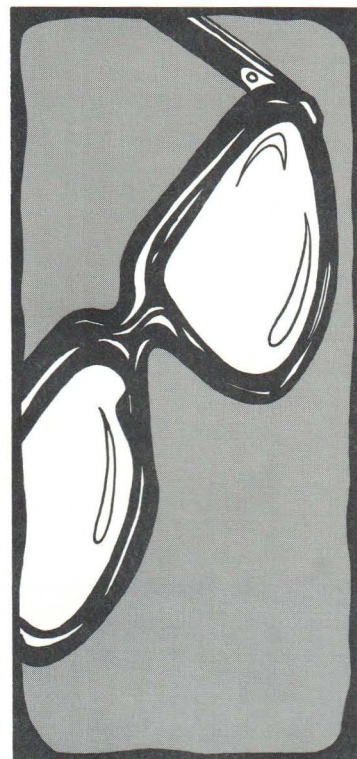
ceptacles marked with special stickers. If the mail is not picked up within a reasonable time period, the carrier notifies an official who checks on the customer. (Postal Service)

- The construction of a new ferryboat for Governors Island, New York, will include accommodations for physically disabled persons. (Department of Transportation)
- The Federal Aviation Administration will propose a rule to enable passengers with travel canes to keep them at their seats on airplanes. (Department of Transportation)
- The National Library Services for the Blind and Physically Handicapped has helped plan a "Symposium on Educating Librarians and Information Scientists." A special session will be held with a panel of international authorities on services for visually impaired and disabled persons. (Library of Congress)

Research and Program Accessibility

The Federal Government is supporting research and implementation projects which help disabled persons to participate in the daily life of their communities.

- A planning report, "Measurement Standards for the Handicapped," will be published by the National Bureau of Standards. It discusses IYDP opportunities, such as plans to serve as a reference laboratory for the resolution of critical problems related to measurement, methods, standards, data, and technological development in the areas of building performance standards, fire and building safety standards, materials performance characteristics, product safety and performance, computer-aided control, and communication. (Department of Commerce)
- During 1981, the Federal Communications Commission will actively study and seek public comment on the following:
 - Comparability of the amplified telephone with hearing aids
 - Rate structures for the use of teletypewriters for the deaf (TTY's)
 - Cost and availability of communications equipment
 - Comparability of specialized computer terminals and teleprinters with standard communication systems. (Federal Communications Commission)
- IBM "talking typewriters" will be purchased for visually disabled typists to increase their ability to handle job requirements. (Department of Justice)

- The National Institutes of Health, in conjunction with the University of Washington, is improving dental care for children with cerebral palsy by developing a head stabilizer. (Department of Health and Human Services)
 - The U.S. Public Health Service Hospital at Carville, Louisiana, is developing a technology which detects vascular insufficiency in Hansen's disease (leprosy) victims. This research, which has application for other diseases in which vascular insufficiency results in debilitating conditions, is being used in the rehabilitation of Hansen's disease victims. (Department of Health and Human Services)
 - A joint research project with the National Institute of Handicapped Research will assess the functional requirements of individual jobs and the functional capabilities of disabled workers. This project will enable a selecting official to determine appropriate accommodations for specific disabilities and jobs. (Office of Personnel Management)
 - Funding is being sought to study ways to retain employees who become disabled on the job. Techniques will be demonstrated which prevent the loss of productive employees, contribute to agency work effectiveness, and make use of professional rehabilitation and occupational specialists and community based resources. (Office of Personnel Management)
 - A manual identifying safe pedestrian accommodations will be field tested. (Department of Transportation)
 - The International Labor Office sponsored a resolution concerning disabled persons which was unanimously adopted at the 1979 International Labor Conference. It stresses the collection of documentation on legislation, experience, and research on the vocational rehabilitation of disabled persons in member countries. (Department of Labor)
 - A manual entitled "Accessible Networks for the Elderly and Handicapped" will be field tested in one or more cities. (Department of Transportation)
 - The following studies and projects to improve services for persons with disabilities will be conducted:
 - Develop manuals for use by operators of transportation services for disabled and elderly persons
 - Study the frequency and severity of physical barriers in transportation
 - Improve the design of fare boxes
 - Explore ways to eliminate gaps between rapid rail car floors and passenger platforms
 - Develop a prototype lift for use in light rail vehicles
 - Develop personal flotation devices (life vests) for disabled persons. (Department of Transportation)
 - National organizations of architects will be encouraged to develop educational programs on barrier-free design for the architectural community. The National Council of Architectural Registration Boards will be asked to include more information and questions about barrier-free designs in the certification exam for architects. (Architectural and Transportation Barriers Compliance Board)
 - In-depth workshops will be conducted in 1981-82 in every state for local and state code officials and Federal agencies. The workshops will interpret accessibility guidelines and provide educational and technical materials. (Architectural and Transportation Barriers Compliance Board)

Awareness

The International Year provides an educational opportunity to increase our understanding and awareness of both the potential and the right of disabled persons to participate in and contribute to the economic, social, and political life of our communities.

- An interagency advisory committee on development and training is planning workshops, exhibits, and films on the training needs of disabled employees of the Federal Government. (Department of Agriculture)
- Four regional civil rights conferences will be held during 1981 which will provide training on Section 504 regulations. (Department of Agriculture)
- IYDP will be highlighted through existing public affairs mechanisms directed at state and local consumer protection offices, and consumer community organizations. (Office of Consumer Affairs)
- Information and education programs developed by the headquarters office have included the needs of disabled consumers in program planning. Field staff in various regions have reported the following activities:
 - Braille fact sheets
 - Poison control information in large type print for visually-impaired persons
 - Audio tapes on product safety for the library network serving people with visual impairments
 - Materials have been developed by the Los Angeles Fire Department for blind and visually-impaired persons
 - "A Guide to C.P.S.C. Factsheets for the Handicapped," which describes a barrier-free environment, has been developed in conjunction with voluntary organizations representing retarded citizens. (Consumer Products Safety Commission)
- Additional copies of "A Matter of Independence," a booklet describing the use of model homes to meet the special housing needs of disabled people, have been purchased. (Department of Housing and Urban Development)
- A three-minute video tape will be incorporated in a traveling exhibit on independent living and housing for disabled people. This exhibit is scheduled for display in 1981 at major conventions. (Department of Housing and Urban Development)
- An international bibliography will be developed on housing and community development programs for disabled people. (Department of Housing and Urban Development)
- The Braille Service Unit in the Social Security Administration will serve visually impaired persons who would prefer to receive letters and notices in Braille. (Social Security Administration/Department of Health and Human Services)
- The National Parks Service is developing a traveling display which includes an audio-visual program describing the increased accessibility of the National Park System. The exhibit will be on display at numerous meetings, conferences and exhibitions across the country. (Department of the Interior)
- A photographic exhibit is being developed entitled "Special People," a sensitive, yet realistic portrayal of developmentally disabled people. (Department of Justice)
- The development of an international directory of libraries serving the visually and physically disabled will be completed by 1981. (Library of Congress)
- A current publication, *Technologies for the Handicapped and the Aged*, provides examples of technology transferred from advanced aerospace research projects to resolve problems



faced by disabled and elderly persons. (National Aeronautics and Space Administration)

- A report on exemplary programs, services, and aid devices related to disability will be compiled by February of 1981. (National Aeronautics and Space Administration)
- A publication entitled *Guide for Administering Examinations to Handicapped Individuals for Employment Purposes* will be developed. (Office of Personnel Management)
- A special publication on the needs of severely disabled female employees will be developed in conjunction with the Federal Women's Program Office. (U.S. Office of Personnel Management)
- The Clearinghouse on the Handicapped is continuing to provide information on a wide range of topics and concerns. Its information base is especially strong in Federal legislation, funding, and programs for disabled people. (Department of Education)
- A commemorative postage stamp will be issued in observance of IYDP in July of 1981. The IYDP stamp poster will be displayed in the lobbies of United States Post Offices nationwide. (Postal Service)
- Revisions of hazardous materials regulations on the transport of wet cell batteries on passenger aircraft will be explored. A current exception to this rule permits their carriage when installed in a wheelchair. Unfortunately, these provisions are not well known. Therefore, a notice of proposed rulemaking was published in the Federal Register in December 1980. A final rule is expected in July, 1981. (Department of Transportation)
- Outreach plans will be submitted by each facility for involving veterans, civic, and other community organizations in activities for disabled persons. (Veterans Administration)
- The National Library Services for the Blind and Physically Handicapped has produced a Braille IYDP Calendar, which is available at no cost to eligible users of State Libraries for the Blind. (Library of Congress)
- The President's Committee on the Employment of the Handicapped sponsors several awards programs which honor persons and organizations who have given distinguished service to disabled persons. The awards include:
 - A Presidential Trophy is given to the "Handicapped American of the Year," a disabled person of national distinction and service to disabled persons.
 - Two Employer's Trophies are awarded each year to employers with outstanding records for training, employing, and promoting disabled persons.
 - The John E. Fogarty Public Personnel Award is given annually to a public servant with an outstanding record for hiring and promoting employees with disabilities.
 - A Distinguished Service Award is made each year to an individual or organization who has given extraordinary service to disabled people.
- A Physician's Trophy is awarded each year to a medical doctor of national distinction in the service of disabled people.
- National poster and writing contests on disability topics are held annually for teenagers and undergraduate college students. (President's Committee on the Employment of the Handicapped)

Preface

This is an update of the Executive Summary of Federal Involvement in IYDP, 1981. It describes the efforts of government agencies which have developed and implemented the International Year guidelines provided by the United Nations. Federal activities celebrating the International Year constitute the main body of the report. A list of Federal Interagency Committee members is provided at the end of the report.

In planning the government-wide observance of IYDP, the Federal Secretariat and the Federal Interagency Committee have established four goals for the Year:

Federal IYDP Plans: This goal involves analyzing, summarizing and updating federal agency IYDP plans and identifying directions for future action.

Federal Government Awareness of IYDP: This goal supplements and complements federal agency and departmental planning by providing agencies with information and technical assistance, stimulating the involvement of disabled consumers and government employees in agency policy processes, and by linking federal activities with state, regional, and local programs.

Public Outreach: The public outreach goal is to inform the nation's citizens about the observance of IYDP and the long-term U.S. commitment to disabled individuals. The Federal Interagency Committee is conducting a multi-media campaign to stimulate support for the Year nationwide.

International Information Exchange: This goal's focus is on the dissemination of information to the American and international communities about exemplary programs, research findings, and technological innovations. Many agencies have initiated projects and programs which are unique and innovative for the International Year. This report provides an update of the activities in the areas of prevention and rehabilitation, demonstration projects and programs, research and program accessibility, and awareness. The description of each activity is followed by

the name of the federal agency in which it is taking place. The activities described in this report can be shared with and replicated by both the public and private sectors.

Update

Prevention and Rehabilitation

The proposed activities in prevention and rehabilitation promote the prevention of disability and the rehabilitation of disabled persons. The federal government is actively initiating and promoting programs to eliminate the onset of accident, sickness, disease or disability, and to rehabilitate disabled individuals and support their integration into their communities.

- Disabled personnel will be assigned to a task force considering policy decisions for an out placement program. (CIVIL AERONAUTICS BOARD)
- In an effort to establish individualized career plans for disabled workers, in-depth interviews between supervisors and disabled employees will be emphasized. (DEPARTMENT OF DEFENSE)
- Assistance is being provided to a Prevention Education Exhibit currently being conducted in Georgia and Florida. The exhibit is dedicated to the prevention of mental retardation. (PRESIDENT'S COMMITTEE ON MENTAL RETARDATION)

Demonstration Projects and Programs

The federal government has initiated numerous projects, activities, and policies to assist disabled persons in their physical and psychological adjustment to society. This effort includes providing disabled persons with proper assistance, training, care, and guidance services to support their employment and promotion, and to ensure their full integration in society.

- The Office of Policy and Planning has funded grants to local organizations to provide training and technical assistance for disability related projects. (ACTION)
- The problems of disabled air travelers will receive particular attention. (CIVIL AERONAUTICS BOARD)
- A TTY Hotline telephone number for the deaf is being publicized. Regional offices and local organizations are encouraged to inform their constituents of its availability and importance. (CONSUMER PRODUCT SAFETY COMMISSION)
- The National Bureau of Standards is working on various projects relating to disability, such as measurement of material characteristics for bio-materials (ceramics, metal and polymers) used in prosthetic and/or orthotic surgical implants, development of local area computer networks and access methods for potential use in mobility-limited situations, and measurement of human motion for use in studying gait, sign language, and other gross motions. (DEPARTMENT OF COMMERCE)
- The Office of Special Education will sponsor an International Symposium on Physical Education and Sports to be held in late 1981 or early 1982. (DEPARTMENT OF EDUCATION)
- A videotape is being developed to demonstrate examples of "reasonable accommodations" for disabled individuals in the work setting. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)

- The Constitution Gardens IYDP Festival is scheduled for August 29, 1981. Activities will include the creative and performing arts, sports, and recreation. The key event will be a ten kilometer run for IYDP. The Gallaudet dancers and various musical groups will perform. (DEPARTMENT OF INTERIOR)
- The Coast Guard has developed an audio-visual presentation of recreational boating guidelines for physically disabled persons. It is designated for use as an education tool by boating related organizations. (DEPARTMENT OF TRANSPORTATION)
- A combined Notice of Proposed Rulemaking and Notice of Inquiry regarding the possible authorization of teletext service is being considered. The proposal will also consider Petitions for Rulemaking submitted by CBS, Inc. and the United Kingdom Industry Group that requested the FCC to adopt standards for teletext. (FEDERAL COMMUNICATIONS COMMISSION)
- The concerns and viewpoints of disabled consumers of communications services are being obtained through the development of audio tapes, liaison with disabled groups and organizations, and the provision of sign language interpreters at meetings. (FEDERAL COMMUNICATIONS COMMISSION)
- The recruitment and hiring of disabled persons has been stressed. (FEDERAL DEPOSIT INSURANCE CORPORATION)
- A program is being developed to include an affirmative action plan, training and awareness, public information and outreach activities. (FEDERAL RESERVE SYSTEM)

- A Fiscal Year '81 Affirmative Action Plan for Handicapped Individuals and Disabled Veterans has been developed. (INTERSTATE COMMERCE COMMISSION)
- Disabled persons are being recruited for domestic and Foreign Service positions and a Medical Review Committee has been established to review applicants who fail to meet medical standards. (INTERNATIONAL COMMUNICATIONS AGENCY)
- A contest to discover computer-related inventions entitled "Personal Computing to Aid the Handicapped" which is sponsored by the Johns Hopkins First National Search will receive special attention and publicity assistance from the Agency. (NATIONAL AERONAUTICS AND SPACE ADMINISTRATION)
- An interagency agreement with the Veterans Administration to set aside one-half of one percent of the construction cost, up to \$50,000, for art in new and renovated medical centers is continuing. (NATIONAL ENDOWMENT FOR THE ARTS)
- The Nuclear Regulatory Commission participated in the Conference of the President's Committee on Employment of the Handicapped in May, 1981. An exhibit was provided, job opportunities were discussed, and several inquiries on employment opportunities were received from qualified disabled individuals. (NUCLEAR REGULATORY COMMISSION)
- A nationwide music contest is being sponsored by the Veterans Administration in recognition of the talents of inpatients and outpatients. Medical centers will

conduct their own contests and videotapes will be sent to regional competitions. The eventual national winners will meet in Tuskegee, Alabama, where a stage show will be produced. (VETERANS ADMINISTRATION)

- The White House has announced two programs in California to provide jobs for the disabled, called "Project Partnership." These are cooperative projects between business, government and local disabled constituent groups. (WHITE HOUSE, OFFICE OF CONSUMER AFFAIRS)

Research and Program Accessibility

The federal government is supporting research and implementation projects which help disabled persons to participate in the daily life of their communities.

- A variety of equipment, information and simulations will be offered to help eliminate real and imagined barriers affecting disabled workers. (CENTRAL INTELLIGENCE AGENCY)
- Future affirmative action plans will be based on an agency-wide survey conducted in June of 1981. It is hoped that the survey will clarify the number and types of disabilities within the agency. (CENTRAL INTELLIGENCE AGENCY)
- The National Telecommunication and Information Service has contracted an outside organization to investigate the commercial viability of electronic mail service for hearing impaired individuals. This study builds on a Department of Education project on the design and operation of a trial electronic mail service for

hearing impaired persons. Such a system will facilitate communication with the deaf in emergency situations. (DEPARTMENT OF COMMERCE)

- A major effort is being undertaken to make buildings under control of the Department of Defense accessible to disabled persons. (DEPARTMENT OF DEFENSE)
- A monograph on the international perspective of the economics of disability has been published. (DEPARTMENT OF EDUCATION)
- Questionnaires will be distributed to disabled renters and homeowners to determine their housing needs. (DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT)
- Training in basic sign language has been provided to employees, managers, and supervisors. (DEPARTMENT OF JUSTICE)
- Admission standards for entrance into the Foreign Service have been amended so that persons with physical disabilities may be considered for possible appointment and overseas service. (DEPARTMENT OF STATE)
- It has been mandated that all embassies will be accessible to disabled populations. (DEPARTMENT OF STATE)
- Most states will ensure that a significant number of interstate highway rest areas are made accessible to disabled persons during 1981. The states have identified the areas in need of modification and have

completed plans and schedules to meet the accessibility guidelines. (DEPARTMENT OF TRANSPORTATION)

- A manual entitled "Accessibility Networks for the Elderly and Handicapped" is being field-tested. The testing will examine the manual's usefulness in providing information about accessibility and how to achieve it. (DEPARTMENT OF TRANSPORTATION)
- The Commission has published a report "Employment of Handicapped Individuals, Including Disabled Veterans." This report summarized affirmative action programs for disabled persons in the federal government and describes federal agency progress in creating an equitable environment for disabled applicants and employees, including disabled veterans. (EQUAL EMPLOYMENT OPPORTUNITY COMMISSION)
- A task force of disabled employees will be maintained to identify specific problems and barriers, define solutions, and set priorities within the agency. (GENERAL SERVICES ADMINISTRATION)
- The Public Building Service (PBS) has taken a lead role in developing a single "Uniform Federal Accessibility Standard" to reduce confusion existing in the standards field. PBS is also undertaking a voluntary retrofitting program to make older federal facilities accessible. (GENERAL SERVICES ADMINISTRATION)
- Physical accessibility in U.S. and overseas facilities is being reviewed. (INTERNATIONAL COMMUNICATIONS AGENCY)

- A Visitor's Information Center is being constructed that will be accessible and contain special programs for sensory impaired individuals. (NATIONAL AERONAUTICS AND SPACE ADMINISTRATION)

- Ames Research Center has developed a liquid cooling garment for astronauts which can be used by people with spinal cord injuries to regulate body temperature. The official testing is being conducted this summer at the Texas Institute for Rehabilitation. (NATIONAL AERONAUTICS AND SPACE ADMINISTRATION)

- A model project grant was awarded to the Mark Taper Theatre Forum in Los Angeles to develop programs which are accessible to hearing impaired people. This consciousness-raising process caused the Taper staff to be more receptive to a new play, Children of a Lesser God, which subsequently received three Tony awards. (NATIONAL ENDOWMENT FOR THE ARTS)

- Opera America is providing a consultant to opera companies to ensure that their productions are available to people with disabilities by providing audio cassettes to help prepare visually disabled individuals for performances, sign language interpreters, and increased space for wheelchair seating. (NATIONAL ENDOWMENT FOR THE ARTS)

- A museum advisory task force composed of museum professionals, including disabled persons, will study the problems of access for disabled visitors. (NATIONAL ENDOWMENT FOR THE ARTS)

- The Cooper-Hewitt Museum of New York City and the President's Committee on Employment of the Handicapped have developed a museum guide which emphasizes accessibility for disabled persons. (PRESIDENT'S COMMITTEE ON EMPLOYMENT OF THE HANDICAPPED)
- The National Academy of Sciences Building and the Joseph Henry Building are being made accessible to mobility and sensory impaired persons. (NATIONAL RESEARCH COUNCIL)
- A booklet entitled "Applicant EEO Data Systems in State and Local Government" has been published. It describes the collection and maintenance of data on handicapped applicants. (OFFICE OF PERSONNEL MANAGEMENT)
- Legislation authorizing the employment of readers for blind employees, interpreters for deaf employees, and personal assistants for otherwise disabled employees has been sponsored by this agency. (OFFICE OF PERSONNEL MANAGEMENT)
- A training session entitled "Breakthrough" was conducted for management officials in June, 1981. The session outlined management's affirmative action responsibilities regarding disabled persons. (SECURITIES AND EXCHANGE COMMISSION)
- The requirement that federal contractors accommodate and employ disabled persons by providing jobs and services will be studied and standards to measure compliance with this requirement will be developed. (U.S. COMMISSION ON CIVIL RIGHTS)

Awareness

The International Year provides an educational opportunity to increase our understanding and awareness of both the potential and the fight of disabled persons to participate in and contribute to the economic, social, and political life of our communities.

- A staff notice will be issued to all employees highlighting IYDP and asking employees to participate in IYDP programs and activities. (CIVIL AERONAUTICS BOARD)
- A conference entitled "The Supervisor and the Disabled Person" was planned and hosted in cooperation with the Office of Personnel Management. The Department also arranged for an all-day exhibit of special equipment available to disabled persons. (DEPARTMENT OF AGRICULTURE BOARD)
- A support statement on the employment and advancement of disabled persons will be issued. (DEPARTMENT OF DEFENSE)
- Six hundred program coordinators for disabled employees have been designated across the country. (DEPARTMENT OF DEFENSE)
- A public forum on "The Place of Disabled Persons in Our National Economy" was co-sponsored by the National Council on the Handicapped and the President's Committee on Employment of the Handicapped. Topics discussed were: researchable ideas that impinge on the

place of disabled people in the economy and ways for the federal government to participate with state and local governments and the private sector. (DEPARTMENT OF EDUCATION)

- A two-week seminar commemorating the 20th anniversary of the Special Foreign Currency program was jointly sponsored by the National Institute of Handicapped Research and the World Rehabilitation Fund. The seminar focused on the application of recently developed rehabilitation techniques and processes emerging from the cooperative efforts of institutions in the U.S. and 14 other nations. (DEPARTMENT OF EDUCATION)
- The Rehabilitation Services Administration will sponsor various exhibits and seminars to be held in federal office buildings. (DEPARTMENT OF EDUCATION)
- Many regional offices are involved in a multitude of activities. For example, Region V in Chicago has developed display units for the region's IYDP activities to be used at conferences, meetings, and seminars. This display is available to all participating federal agencies. (DEPARTMENT OF ENERGY)
- Regional offices have been instrumental in organizing "Barrier Awareness" days with extensive media coverage in various locales across the country. On these occasions, city officials, federal agency managers, and staff members assumed the role of disabled persons for a day. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)
- The Social Security Administration and Health Care Financing Administration co-sponsored a one day

management training awareness program, "Ability Counts," on June 16, 1981. Over 300 managers attended this program which featured an employee-supervisor panel, demonstrations of types of accommodations, and exhibits. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)

- Forums will be held for HUD-funded organizations to inform them about IYDP and to encourage their efforts in meeting the needs of disabled persons. (DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT)
- The Department was an exhibitor at the President's Committee on Employment of the Handicapped Annual Meeting, May 6-8, 1981. (DEPARTMENT OF JUSTICE)
- An IYDP spot announcement will be aired over Public Broadcasting Service stations during the Fall of 1981. (DEPARTMENT OF JUSTICE)
- Two weeks of awareness sessions have been planned for the Fall of 1981 to focus on attitudes, accommodations, and various employment schedules and procedures in the Federal Government. (DEPARTMENT OF LABOR)
- The State Department was a participant in "Operation Horseshoe" held on February 8. It involved 12,000 Canadian and American volunteers who formed a giant human horseshoe around Niagara Falls in a symbolization of world-wide commitment to IYDP. (DEPARTMENT OF STATE)
- "Hands Across the Border," an event similar in scope and magnitude to "Operation Horseshoe," is currently in the planning stages. Representatives of the U.S. and Mexico are in the process of planning the events for this international event to be held in October. (DEPARTMENT OF STATE)

- A notice will be distributed to all agency employees describing IYDP and related activities. (FEDERAL TRADE COMMISSION)
- An "Information Campaign" will be conducted during the year aimed at organizations and schools which serve disabled people. (FEDERAL TRADE COMMISSION)
- A job fair for prospective disabled employees during "National Employ the Handicapped Week" will be held in October. (FEDERAL TRADE COMMISSION)
- Awareness training for supervisors, appointment of disabled persons for summer employment, and continual efforts to restructure positions are part of the Federal Maritime Commission's plans. Commission representatives also will meet with other agencies to share ideas for the improvement of disabled employees' working conditions. (FEDERAL MARITIME COMMISSION)
- An International Art Show which displayed art exhibits by disabled people was held early this year to publicize IYDP. It was sponsored jointly by the General Services Administration and the Sister Kenny Institute. (GENERAL SERVICES ADMINISTRATION)
- A coordinating committee is being formed to integrate and increase the number of media products used worldwide concerning disabled persons, programs and events. (INTERNATIONAL COMMUNICATIONS AGENCY)

- An IYDP public service announcement released in December, 1980 has received \$5.6 million worth of public service air time from American television stations. (PRESIDENT'S COMMITTEE ON EMPLOYMENT OF THE HANDICAPPED)
- Two new IYDP public service announcements, as well as two still graphic slides, were released in April, 1981. (PRESIDENT'S COMMITTEE ON EMPLOYMENT OF THE HANDICAPPED)
- At the annual Equal Employment Opportunity Conference in February, the Presidential Proclamation on IYDP and informational material on hiring individuals with specific disabilities was made available to participants. In addition, a speaker briefed employees on hiring procedures and special devices available to accommodate disabling conditions. (NATIONAL CREDIT UNION ADMINISTRATION)
- An exchange of paintings done by physically and mentally disabled persons is being planned between France's Personnes-Images and the President's Committee on Mental Retardation. The paintings will be exhibited in both France and the U.S. (PRESIDENT'S COMMITTEE ON MENTAL RETARDATION)
- The Securities and Exchange Commission is pooling its IYDP efforts with the Department of Labor and the General Services Administration. Some of the activities planned include equipment demonstrations, the enlistment of speakers on the subject of disability,

and the presentation of films on the accomplishments and abilities of disabled persons. (SECURITIES AND EXCHANGE COMMISSION)

- A publication, "IYDP Ideas," featuring IYDP related news clippings from newspapers across the country continues to be published. (PRESIDENT'S COMMITTEE ON THE EMPLOYMENT OF THE HANDICAPPED)
- The First "National Veterans Wheelchair Games" will be held in Richmond, Virginia, September 18-20. Events will include billiards, track and field, slalom events, table tennis, swimming, and weight lifting. (VETERANS ADMINISTRATION)
- The President and Mrs. Reagan have supported and participated in various programs of benefit to disabled citizens, such as the Annual Easter Seal Campaign Kick-off, the March of Dimes Poster Children Reception, the Scholastic Achievement Award presentation to blind students, the National Muscular Dystrophy Association Fundraising Campaign Kick-off, and many other activities. (WHITE HOUSE, OFFICE OF CONSUMER AFFAIRS)
- The Office of Consumer Affairs is continuing to represent the President at federally sponsored activities and will focus on federal IYDP activities in its "Dear Consumer" publication. (WHITE HOUSE OFFICE OF CONSUMER AFFAIRS)

- The White House has endorsed, stimulated and supported efforts of the Federal Interagency Committee. (WHITE HOUSE, OFFICE OF CONSUMER AFFAIRS)
- A seminar entitled "Civil Rights Issues of Handicapped Americans: Public Policy Implications" was held and papers presented at the meeting on civil rights and job barriers were published. (U.S. COMMISSION ON CIVIL RIGHTS)
- The Clearinghouse on the Handicapped continues to provide information about IYDP activities on both the domestic and international levels. (DEPARTMENT OF EDUCATION)
- Joint activities are underway with the Consumer Affairs Task Force. Safety and pre-natal care exhibits are on display at shopping centers, libraries, etc. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)
- A brochure entitled "Disabled? Discriminated Against? Section 504 Can Protect Your Rights" is being printed for distribution to disabled beneficiaries of health and human services programs. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)
- The Public Health Service hosted an IYDP kickoff on June 5 with the theme "Arts and the Handicapped." They have also scheduled an Open Meeting and an Awareness Week in celebration of IYDP. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)

- The Food and Drug Administration will sponsor a "Handicapped Awareness Week" on September 21 -25, 1981 featuring informational and pictorial displays, a poster contest, exhibition of technological equipment to assist the disabled, and awareness presentations on barriers in the workplace. (DEPARTMENT OF HEALTH AND HUMAN SERVICES)
- Managers and supervisors at all levels will receive training which will foster an awareness of employment of disabled people. (INTERSTATE COMMERCE COMMISSION)
- Posters are being displayed in headquarters and all regional offices which project a positive image of disabled persons. (COMMODITY FUTURES TRADING COMMISSION)
- Periodicals such as "Mainstream," a guide for community action for disabled Americans, will be distributed to employees to heighten awareness. (COMMODITY FUTURES TRADING COMMISSION)
- A policy statement was issued to all employees stating the Secretary's support of the Department's plans and activities. (DEPARTMENT OF COMMERCE)
- The National Oceanic and Atmospheric Administration and the National Weather Service are holding a Handicapped Awareness Program for managers, supervisors and co-workers. (DEPARTMENT OF COMMERCE)

- On behalf of the Federal Interagency Committee, the State Department, in conjunction with the President's Committee on Employment of the Handicapped and the People to People Committee, sponsored the official U.S. IYDP "kickoff" in February. The event honored disabled athletes participating in "Around the World" in '81." (DEPARTMENT OF STATE)
- Speakers from several service organizations have been scheduled to speak about attitudinal barriers and reasonable accommodation issues. (DEPARTMENT OF THE TREASURY)
- Recruitment of disabled employees is being emphasized. All managers and supervisors will be familiarized with the objectives of IYDP, and the Agency will present a Handicapped Employee Award during 1981. (FEDERAL EMERGENCY MANAGEMENT AGENCY)
