Dear Mr. Minister:

I regret very much that I did not have an opportunity to meet with you during your recent official visit to the United States, which I understand was a highly successful and productive one from the standpoint of Romania-United States bilateral relations.

The United States highly values the independent posture Romania has maintained in the foreign policy field, and we are anxious to continue and build upon the mutually beneficial relationship in trade and other areas, which currently exists between our two countries. I am certain that your recent discussions with key Executive Branch officials, as well as with several of my Congressional colleagues who play a particularly influential role in U.S. trade legislation, were an important factor in furthering these important mutual objectives.

It is within this context that I would like to bring to your attention the enclosed communication from a former colleague, the Honorable Patrick J. Hillings of California, regarding the family of Mr. Napoleon Fodor, former Romanian Economic Counselor in New York. Mr. Fodor has been granted permission to reside permanently in the United States since September, 1982 and is most anxious to have his wife and son, Stefan, join him here at the earliest possible opportunity. Mrs. Fodor has filed the appropriate documents requesting exit visas on behalf of herself and her son, but to date, I am informed, no action has been taken on these requests by the Romanian authorities.

While I did not have the chance to discuss this matter with the appropriate State Department officials or with you personally during your recent visit, I would like to appeal to you at this time, on purely humanitarian grounds, to undertake a full review of the circumstances in this case and to assist in any way you can in bringing about a favorable resolution of this problem. I can assure you that a decision to grant the Fodor family permission to emigrate would be a most welcome gesture, indeed, and would serve in an important way to improve the atmosphere of our bilateral relationship. Thank you for your letter of June 20 regarding the family of Napolean Fodor who wishes to emigrate from Romania to the United States.

We are writing to indicate our very strong interest in the human rights situation in Romania. According to the recently issued Department of State Country Reports on Human Rights Practices and reports submitted to Congress by major human rights organizations, including Amnesty International, our growing concern over the status of human rights in your country is warranted.

Severe restrictions on freedom of speech, the denial of the right to peaceful association, and the limitations placed upon the freedom of religion in Romania cannot be overlooked by any person who values individual liberties. Nor can we feign blindness at the practice of torture, the thousands of arbitrary searches and detentions, and the denial of a fair public trial to many Romanian citizens. The psychological and physical intimidation being leveled at those seeking to emigrate is also of major concern to us, as are the serious procedural problems remaining in the emigration system.

The renewal of Most Favored Nations trade status for Romania is an issue which will be before Congress in the near future. An improvement in the areas addressed in this letter may insure a continuation in the existing trade agreement between the United States and Romania.

While we believe in continuing and improving diplomatic ties with Komania, we also believe in the principles established in the Helsinki Accords. In the spirit of cooperation and understanding, we request your assistance in elevating the current human rights standards in Romania. We make these requests in order to insure a harmonious relationship between our countries.

We would appreciate your informing the appropriate authorities in your government of our personal interest in these matters. Please notify us if we can do anything to assist you in this regard.

We are writing once again to indicate our very strong interest in Mrs. Georgeta Fodor and her son, Stefan. Previous letters of April 5, 1984 and January 20, 1984 have not been answered, but our grave concern for the Fodor family's welfare continues.

Both Mrs. Fodor and Stefan were denied applications for exit visas by the Romanian Government on March 15. This denial violates the family reunification provisions in the Helsinki Accords to which your country is a party. We, as Members of Congress, consider family reunification to be a fundamental right which all countries should recognize.

In the spirit of cooperation and understanding, we ask that the Fodors' request to emigrate be granted. We believe in continuing and improving diplomatic ties with Romania. The strengthening of diplomatic ties between the United States and Romania is best exemplified in the granting of Most Favored Nations trade status which is again scheduled for review in the near future. We also believe in the preservation of the principles established in the Helsinki Accords. Hopefully, both of our countries will be able to maintain a harmonious relationship -- one which adheres to the fundamental values we share.

We request your utmost consideration of the Fodor family. We are anxious to see the agony they have experienced come to an end. Please notify us if we can do anything to assist you in this regard.

TO THE CONGRESS OF THE UNIT ... STATES:

I hereby transmit the documents required by subsection 402(d)(5) of the Trade Act of 1974 for a further 12-month extension of the authority to waive subsection (a) and (b) of section 402 of the Act. These documents constitute my decision to continue in effect this waiver authority for a further 12 month period.

I include as part of these documents my determination that further extension of the waiver authority will substantially promote the objectives of section 402. I also include my determination that continuation of the waivers applicable to the Hungarian People's Republic, the People's Republic of China and the Socialist Republic of Romania will substantially promote the objectives of section 402. The attached documents also include my reasons for extension of the waiver authority; and for my determination that continuation of the waivers currently in effect for the Hungarian People's Republic, the People's Republic of China and the Socialist Republic of Romania will substantially promote the objectives of section 402.

RECOMMENDATION FOR EXTENSION OF WAIVER AUTHORITY

I recommend to the Congress that the waiver authority granted by subsection 402(c) of the Trade Act of 1974 (hereinafter "the Act") be further extended for twelve months. Pursuant to subsection 402(d)(5) of the Act, I have today determined that further extension of such authority will substantially promote the objectives of section 402, and that continuation of the waivers currently applicable to the Hungarian People's Republic and the People's Republic of China will also substantially promote the objectives of section 402 of the Act. With respect to the Socialist Republic of ay also determined that continuation of the provident of Romania, I have waiver currently applicable to that country will substantially ! promote the objectives of section 402 of the Act. This determination is based on assurances provided by the Socialist Republic of Romania that it will no longer require reimbursement to the State of education costs as a precondition to emigration, and that it will not create economic or procedural barriers to emigration. My determination is attached to this Recommendation and is incorporated herein.

The general waiver authority conferred by section 402(c) of the Act is an important means for the strengthening of mutually beneficial relations between the United States and certain countries of Eastern Europe and the People's Republic The waiver authority has permitted us to conclude of China. and maintain in force bilateral trade agreements with Romania, Hungary, and the People's Republic of China. These agreements continue to be fundamental elements in our political and economic relations with those countries, including our important productive exchanges on human rights and emigration matters. Moreover, continuation of the waiver authority might permit future expansion of our bilateral relations with other countries now subject to subsections 402(a) and (b) of the Act, should circumstances permit. I believe that these considerations clearly warrant this recommendation for renewal of the general waiver authority.

I also believe that continuing the current waivers applicable to Hungary, the People's Republic of China and Romania will substantially promote the objectives of section 402-of the Act.

<u>Hungary</u> - Hungary continues to take a positive and constructive approach to emigration matters. The Hungarian record of the past year, during which all outstanding problem cases were resolved, was excellent. The number of Hungarian citizens who apply to leave Hungary remains small and emigration.permission is granted apparently without undue difficulty. There are no sanctions imposed on those who seek to emigrate, nor do emigration procedures appear excessive.

People's Republic of China - China continued its open emigration policy throughout the past year. Chinese who wish to emigrate do so with little difficulty. In FY-1982, nearly 9,000 immigrant visas were issued by our Foreign Service posts in China This figure has increased every year since the

Romania Emigration from Romania to all countries has approximately doubled and emigration to the United States has increased sixfold since the granting of MFN to Romania in 1975. In 1982, about 2,500 persons emigrated from Romania to the United States, while about 20,000 emigrated worldwide. This Administration initiated discussions with the Government of Romania on the improvement of emigration procedures. The rate of Jewish emigration to Israel in the period September 1982 to March 1983 was nearly double that of the same period in 1981-82. I will continue to monitor closely Romania's performance in improving its emigration procedures and in the !

Implementation in February, 1983, of the education repayment decree of November 1, 1982, imposed a requirement that any Romanian citizen wishing to emigrate must repay in convertible currency the costs of education received beyond the compulsory level (10 years of schooling). This requirement conflicts with the letter and spirit of section 402. For that reason, on March 4, 1983 I announced my intention to terminate MFN status for Romania on June 30, 1983 if the tax was still in force by that date. Since that time, I have received assurances from the President of Romania that Romania will not require reimbursement to the State of education costs as a precondition to emigration, and that Romania will not create economic or procedural barriers to emigration. Based on these assurances and on the above-described emigration performance, I believe that continuation of the waiver applicable to Romania will substantially promote the objectives of the Act.

For the above reasons, I have determined that continuation of the wivers for Hungary, the People's Republic of China and the Socialist Republic of Romania will substantially promote the objectives of the Act.

Mr. Fodor's wife (Dr. Georgeta Fodor) and his son (Stefan) are presently residing in Romania. On February 24, 1982, they applied to emigrate to the United States. This application had been denied by the Romanian authorities.

I would appreciate your assistance and support in bringing about a favorable resolution in this case. As I'm sure you are aware, during the ten years Mr. Fodor has been in the United States, he has been very instrumental in bettering trade relations between our respective countries as well as commanding a great deal of respect among the many American business people with whom he dealt.

As a member and former Co-chairman of the Commission on Security and Cooperation in Europe, I have paid close attention to the human rights situation in Romania. A case of particular interest to me--and one that I believe you are acquainted with--is that of Napoleon Fodor, whose wife and son have been trying unsuccessfully to obtain permission to emigrate from Romania to the United States since February 1982.

I have raised the Fodor case with the Romanian Ambassador on two occasions, most recently in June. I recognize that this is a difficult case but, as I told Ambassador Malitza, I do not believe that Fodor's family should be penalized for any actions that he has I also pointed out that the Fodor case is a family reunificataken. tion case under the Helsinki Final Act and that for this and humanitarian reasons, Mrs. Fodor and her son should be allowed to emigrate.

I had hoped that the Romanian government would favorably reconsider the Fodor case after my meeting with the Ambassador. I understand, however, that Mrs. Fodor and her son have been told recently that they should not reapply for exit visas. In light of these circumstances, I would deeply appreciate it if you would make an appeal on behalf of the Fodor family to Ambassador Malitza at the earliest opportunity.

I have had many discussions with the Ambassador about the full range of our human rights concerns in Romania. I appreciate and am grateful for the progress that the Romanian government has made with respect to family reunification. At the same time, I recall that Romania has taken the position that no case is too difficult to re-I believe that favorable action on the Fodor case would solve. demonstrate the Romanian government's good faith effort in this regard and would contribute to further improvement in US-Romanian relations.

I take this opportunity to greet you on behalf of the United States International Youth Year Commission, and I look forward to the opportunity to visit you in the near future.

You have received this letter delivered by the hand of my colleague, Mr. Robert Dolan, Esq. As the former Executive Director of the United States International Youth Year Commission, and as a colleague on the Executive Committee of the United States Youth Council, Bob and I have worked closely together on a number of occasions. Your initial conversations with Bob, and Ron Robinson, at the occasion of the United Nations Advisory Committee meeting several months ago provided important exchanges that assisted our plans in developing our IYY activities.

In the spirit of the cooperation you have already shown, I ask you to use your powers to make a humanitarian gesture in the name of International Youth Year and our mutual desires of cooperation. Bob Dolan is seeking the release of Georgeta Fodor and her son, Stefan, so that he may take them to the United States to be reunited with their husband and father, Napoleon Fodor.

Your father, the President of Romania, gave his personal assurance to the President of the United States that there will be no economic or procedural barriers to the emigration of the Fodors. I ask you to use your powers as one of the most recognizable members of the international youth community to find the means to grant the application of emigration to the Fodors to return with Bob Dolan to the United States. Support the word of your father in the name of international cooperation. Your name will be well remembered for this positive action.

I hope to see you in New York during the United Nations General Assembly on Internation Youth Year.
