SUBJECT: Olympic Medal Winner Tour

Representatives of the Southland Corporation will be in Washington this Thursday, May 31 to do some detailed planning regarding the Olympic Medal Winner Tour following the Olympic Games. Subject to the decision about the President meeting these Medal Winners in August there would be some obvious pre-planning that must take place. Would it be possible for you and/or whoever else you think appropriate to meet with the Southland people for 20 minutes at any time you select during the day on Thursday?

Some of the questions to be addressed are as follows:

1. President Reagan's involvement either in California or Washington.
2. If the President is not going to meet the group at the White House, is it going to be possible for someone else to meet them?
3. What detailed plans must be developed and who would be involved?

With the current Olympic Game situation it appears that there will be between 300-400 athletes and their guests in this touring group. This will entail a lot of detailed planning involving security, appropriate programs and a luncheon which is currently scheduled to be held at the Capitol.

If you cannot meet with the group would you give me a call during the day on Wednesday to share anything I might say to them?

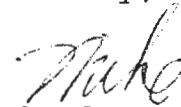

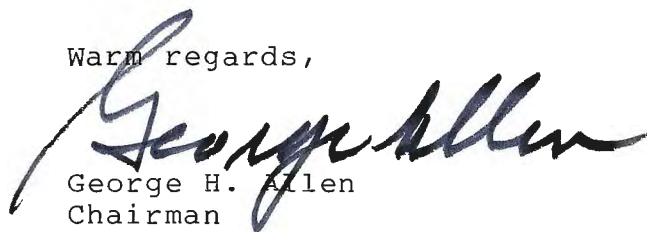

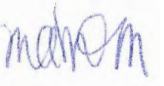

Dear Mike:

Everything has to come to an end and after serving six Presidents my situation is no exception. For some time I have felt that I must get back to Sacramento. My wife's health isn't the best and after nine years as a Special Advisor to three Presidents and 14 years as Executive Director to the last four Presidents I feel I have done as much as I can expect to accomplish under the bureaucratic constraints with which the Council has had to work.

I have an excellent opportunity in the private sector and will be able to work out of my Sacramento home. I have asked that my papers be processed for retirement and will resign as Executive Director effective May 11, 1984.

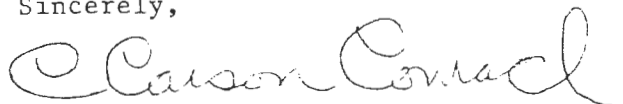
Nearly every day with the PCPFS has been satisfying but with the appointment of George Allen as Chairman in 1981 the excitement really began. As you know "Coach" is a believer, doer and has been totally committed to the Council's purposes and tasks. Earlier I sent you a summary report of major accomplishments and services of the Council during the current Administration which was prepared at Coach's request but just to ensure that you have an update he thought I should send you the enclosed.

The major reason for these achievements is because the Council has served under you in a semi-autonomous position under the direct supervision of the Council Chairman. Honestly, my biggest task has been to try and keep the PCPFS out of the Federal bureaucracy. I believe the Council would completely lose its effectiveness should it be a bureau submerged in the entanglements of the Department of Health and Human Services. I hope that the White House will continue to give strong Administration support because this is the only way such a Council can be effective.

I have enjoyed our associations and always left your presence with a renewed enthusiasm and inspiration. I am most impressed with the sensational job you are doing for your country. No weak kneed American can solve our nation's problems today.

In closing I wish to express my deep gratitude for your guidance, leadership and personal friendship. I have great admiration for President Ronald Reagan whom I was fortunate to know when I was Chief of California's State Department of Education for Physical and Health Education, Recreation and Athletics. I have great admiration and strong convictions about the importance of his reelection and will within my sphere of influence support his reelection.

SUBJECT: National Fitness Testing Week

Coach George Allen wrote Mike Deaver on December 6 regarding the President's participation in the National Fitness Testing Week. In this regard there's a matter which I wanted to bring to your attention and seek your counsel.

Each year the month of May is established as National Physical Fitness and Sports Month. In 1983 this was done by Presidential proclamation and by the action of Congress. Supporting this concept the National Fitness Foundation (NFF), a private, non-profit corporation for which George Allen serves as Chairman, has established National Physical Fitness Testing Week May 6-12, 1984 as reviewed in the aforementioned letter.

The issue is that Coach Allen has authorized "Living Well," a subsidiary of The Houstonian, Inc., to promote and conduct the test. Living Well is involved in the developing and marketing of health and fitness programs in the private sector. Each participant will pay a \$2 fee to take the test and the net proceeds from the monies collected will go to the NFF.

In the past we have followed the principle that governmental agencies are not permitted to engage in fund raising activities for charities no matter how worthy the project. The National Fitness Testing Week is a positive step towards creating a national awareness about the importance of physical fitness for American adults.

I am sure there are many ways that we can assist in helping the NFF to make this a success but in keeping our longstanding policy it would seem advisable not to use our logo or to serve in a cosponsoring capacity for the project.

I'd appreciate your views on this as a matter of propriety or perhaps it's a legal matter. At any rate I'd appreciate your counsel.

Subj: National Conference on Youth Fitness

Your attention is invited to the attached memorandum dated December 15, 1983, regarding the National Conference on Youth Fitness. In early January you suggested that it would be more appropriate to call this the National Conference rather than a White House Conference. The last and only National Conference on Youth Fitness was held in February 1961. We have made great progress in the National Program of Fitness for all Americans, but are back in trouble again with youth fitness. From the attached PCPFS Newsletter you will note that the Council officially has given youth fitness its top priority for the next two years. We need President Reagan to speak at the conference on the importance of physical fitness for children and youth and to give a charge for action to the more than 1,000 delegates. The best time would be at the opening general session at approximately 9:00 a.m. on Friday, June 8. The second best time would be the closing session at approximately 3:30 p.m., Saturday, June 9.

Attached as Enclosure 2 is a copy of the invitation to representative American leaders. The conference is underwritten by The Campbell Soup Company, which is one of our most active private sector sponsors.

Lastly, Enclosure 3 will describe the public hearings which are being held in six regions of our country. Considerable press is being generated through this means. The hearings will help provide a state-of-the-nation position for the conference and provide information which will assist in the determination of future policies and programs of the Council.

I will call you Wednesday upon my return to the office.

Dear Mike:

The conference to provide a national emphasis on youth fitness is scheduled for June 8-9, 1984 and will be held at the Washington Hilton Hotel. The basic program has been set up to reemphasize physical fitness needs of children and youth, establish the status of fitness in America's young population, and discuss roles and responsibilities for carrying out programs.

It is hoped that leadership personnel such as school and agency administrators, board members, and supervisors can be encouraged to participate. Participants from the following three youth serving segments in the United States will be encouraged i.e., (1) schools, (2) private non-school entities such as Scouts and Girls Clubs and (3) public non-school entities such as city recreation departments.

We need the President's help in providing appropriate status to this important topic and have the best chance of encouraging top leadership participation. I am requesting approval of these items right away so we can proceed with announcements and invitations:

1. Permission to have appropriate White House invitations go to selected leaders as identified above.
2. Have President Reagan speak at the conference on the importance of physical fitness for children and youth and give a charge for action to the delegates. This could be at the opening session at approximately 9:00 a.m. on Friday, June 8 or at the closing session at approximately 3:30 p.m. on Saturday, June 9.

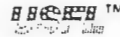

Dear Mr. Allen:

This letter will confirm the conversations you have had with David Waller of this office regarding the permissibility of private sector contributions to the President's Council on Physical Fitness and Sports ("PCPFS").

After consulting with the Office of Legal Counsel, U.S. Department of Justice, and the Office of General Counsel of the Department of Health and Human Services, we advised you that private sector contributions to PCPFS are permissible pursuant to the statutory gift receipt authority extended to the Public Health Service (42 U.S.C. § 219).

As we indicated, prior to acceptance of gifts, you should contact Mr. Jack Markowitz, Director, Office of Management, Public Health Service (202/443-3921) for acceptance approval of the specific gift. It is anticipated that procedures will be established between the PCPFS and the Public Health Service which will permit acceptance of unconditional monetary gifts, i.e., checks made out to "Public Health Service, for the benefit of the President's Council on Physical Fitness and Sports" without having to contact Mr. Markowitz in each instance. However, gifts which are conditioned in any manner, and all non-monetary gifts (e.g., personal and real property) should in each instance be cleared with Mr. Markowitz.

Do not hesitate to contact either me or David if you have any questions regarding the above or if any questions arise in connection with specific gifts.
