MEETING WITH CONGRESSIONAL MEMBERS OF THE DEFICIT REDUCTION GROUP

I. PURPOSE

To discuss the current status of the deficit reduction legislation with the House and Senate Members who agreed to the Rose Garden package.

II. BACKGROUND

The House and Senate have passed their deficit reduction packages and are trying to resolve their differences in conference. These discussions may reach an impasse resulting in no meaningful deficit reduction legislation this year.

Senate and House Republicans have hung tough and are continuing to support the Rose Garden agreement. However, they are very concerned that the appropriations process is continuing and that an agreement is necessary to maximize the defense dollars and to insure adequate funding for security assistance, foreign aid, State Department and USIA. There is also substantial concern about the economic ramifications if we fail to pass any deficit reduction legislation this year.

These Republican leaders are looking for guidance on how we want them to proceed. The attached summary outlines the current status of the plan and various options that need to be resolved.

TALKING POINTS

- I know from our discussions yesterday that we have a very difficult problem with the deficit reduction package.
- Thanks to your help, we have made great progress. By sticking together, we have shown that Republicans are serious about passing meaningful legislation this year.
- We can't let partisan politics prevent us from doing something about the deficit this year.
- I want Dave Stockman to bring us up to date and then let's open this up for discussion.

I. Rose Garden Downpayment Plan Summary

- o Consisted of three elements with three-year deficit savings (1985-87) as follows:
 - o Non-Defense: \$43 billion savings through entitlement reforms, Grace Commission savings and non-defense appropriations cap.
 - o Defense: Three-year budget authority reduction of \$57 billion. Estimated to reduce outlays and deficit by \$40 billion over same period.
 - o Tax Loophole Package: \$48 billion over three-years.
- o In combination with debt service savings (\$18 billion) resulted in \$150 billion deficit reduction over 1985-87.

II. Senate Action: Rose Garden Plan Approved Largely as Agreed To:

- o Defense Funding: Caps passed as per Rose Garden agreement (\$57 billion three-year budget authority cut). Starting funding level of \$299 billion in FY 1985.
- o Tax Loophole bill: \$45.5 billion over three-years -- slightly under agreed level.
- o Non-Defense Spending:
 - o Non-defense appropriation cap passed with adjustment for \$2 billion synfuels recission we asked for - with savings re-allocated to other non-defense appropriations.
 - o Entitlements/Grace Commission Savings: Amounted to \$29 billion of total non-defense outlay savings in Rose Garden package. Senate approved \$24.5 billion or 83%.

III. Current Legislative Situation: Conference with House; Big Differences on Domestic Spending and Defense; Guidance to Senate Leadership Needed

- o Tax loophole bills are only similar element: Substantive House/Senate agreement in \$45-48 billion range can be achieved that would be satisfactory to Treasury Department and meet our guidelines (no rate increases, no tampering with indexing).

o Entitlements/Grace Commission:

- o The \$29.4 billion Rose Garden savings target for this element consisted of two parts:
 - o \$9 billion in three-year savings for farm target price freeze, pay caps, retirement COLA delays and SBA reforms. 95% of these savings were achieved when you signed the farm bill and Reconciliation bill in April.
- o The remaining savings are now pending in conference and involve medicare, medicaid, Grace Commission recommendations and a number of smaller entitlement items. The situation stacks up as follows:

<u>Grace Commission and Entitlement Savings</u> <u>Now Pending in Conference (3-yrs)</u> (billions)			
<u>Program</u>	<u>Rose Garden</u>	<u>House</u>	<u>Senate</u>
Medicare	\$11.7	\$0.9	\$8.1
Grace Commission	3.1	2.2	3.2
Medicaid/Other Entitlements	5.4	1.1	4.5
Total	<u>\$20.2</u>	<u>\$4.2</u>	<u>\$15.8</u>

o Guidance Needed to Senate Leadership

- o Should Senate hold out for full \$15.8 billion savings. This could mean indefinite delay of overall downpayment package and highly contentious debate over medicare which accounts for two-thirds of the difference between House and Senate.
- o Should Senate explore a compromise on medicare and some smaller items. The maximum the House would likely agree to is about \$13 billion. In combination with the \$9 billion already enacted this would mean total entitlement/Grace Commission savings of about \$22 billion or about 75% of the Rose Garden target (\$29.4 billion).

IV. Defense and Non-Defense Caps -- General

- o House did not pass binding caps on defense and non-defense appropriations. Will likely refuse to consider in conference.
- o Only possibility of House agreement would involve further large defense compromise as indicated by following:

<u>Defense Budget Authority</u>	<u>3-Year Budget Authority Reduction</u>	<u>1985 Defense Level</u>
House	-\$130 b.	\$286 b.
Senate/Rose Garden	-57 b.	299 b.

- o Strategic Choices Are:
 - o Hold-out for Senate/Rose Garden defense levels even if no overall downpayment plan agreement can be reached.
 - o Implement defense and non-defense caps in Senate only and enforce with veto during regular appropriations process. This would allow other parts of downpayment package (tax loopholes and entitlements/Grace Commission savings) to be enacted separately.

V. Non-Defense Caps Specifically

- o It is likely that the Senate would adhere to a total 1985 budget authority level of \$139.8 billion -- which is consistent with the Rose Garden non-defense cap.
- o However, to ensure an adequate allocation of this total for security assistance, foreign aid, State Department and USIA -- the Senate will insist on taking most of the cut needed to stay under the cap out of housing programs.
- o Since housing budget authority takes 35 years to be spent -- the practical effect will be no outlay savings or deficit reduction in the next three years from non-defense appropriations.
- o This would jeopardize about \$14 billion of the \$43 billion in three-year domestic savings in the Rose Garden plan.

I. PURPOSE

To publicize a new national effort to ensure the safety and protection of our children and to announce the opening of the National Center for Missing and Exploited Children.

II. BACKGROUND

Each year hundreds of thousands of children disappear. While many return home safely, thousands are exposed to serious danger, exploitation and even death. The criminal and sexual exploitation of children is a growing epidemic confronting families, communities and the agencies of our criminal justice system. The National Center for Missing and Exploited Children has been established to address these difficult issues and to assist families, citizen groups, law enforcement agencies, and governmental institutions in a new national effort to ensure the safety and protection of our children.

Developed by the Department of Justice with a 2-year \$3.3 million grant, the Center will be located in Washington, D.C. The major objectives of the Center are: 1) assist parents, the justice system and other organizations in locating, identifying, and returning missing children; 2) promote prevention programs designed to deter exploitation of children; and 3) increase public awareness regarding the vulnerability of children to abduction and other criminals acts.
