I. PURPOSE

To afford Senator Goldwater an opportunity to discuss with you several issues of importance to the Senator.

II. BACKGROUND

In mid-April Senator Goldwater wrote a letter to you (copy attached) outlining concerns he has in several areas. In addition to the concerns regarding substantive issues outlined in his letter, Senator Goldwater mentioned in his letter to you (as well as his transmittal letter to me) serious concern that his views have not been brought to your attention. This meeting will allow you an opportunity to discuss with the Senator his views on these important issues and thereby indicate to Goldwater, a critical ally in the Senate, that his views are of importance to the Administration.

As Chairman of the Senate Select Committee on Intelligence, Senator Goldwater has been very involved in all of the legislative activity regarding Nicaragua.

Dear Mr. President:

I pray that this letter reaches you. I am not sure that all of mine do. I say this because you have some people, whom I honestly do not have all the faith in, as far as getting messages to you is concerned.

Almost all of the last 30 years of my life, I have spent in Washington. During that time, I have traveled extensively all over the world due to my various committee assignments and the world and its situation has always been uppermost in my mind.

At present, we are having more immigrants move into this country than at any time in our history. I am of a family of immigrants just as you are, who have made this country what it is today. Certainly, this is makes it easier for the world to get along.

In this regard, I would like to bring to your attention a specific matter. I would recommend that you give serious consideration to the recognition of Vietnam. If you want to know why, a personal chat between the two of us could take care of it.

I, also, believe that if we lose in Central America, it is the last place on Earth we can prove to the world that we are not paper tigers. If we lose Central America, to be honest with you, we can forget about defense, we can forget about everything except trying to live as a decent country without any power in the world.

I am only mentioning a few things because there is nothing I would rather do than to sit down and talk these things over with you. In addition, Mr. President, no one since Eisenhower has had command of the State Department and, if you don't get it pretty soon, that is another "kiss goodby" to America.

As I say, these are things that the experiences of almost half of a lifetime have taught me.

I am leaving soon for Taiwan and Korea and will probably say hello to you go through Hickam Air Force Base on your way to Red China.
