# PARTICIPATION IN RIVER DELL HIGH SCHOOL ANTI-DRUNK DRIVING PROGRAM

# I. PURPOSE

To highlight the serious National problem of drunk driving and to voice support for the grassroots movement against it.

# II. BACKGROUND

It is estimated that one-half of all highway fatalities are related to drunk driving. As a result, approximately 22,500 people were killed in 1983. In recent years, there has been a growing movement to put an end to drunk driving through stricter enforcement of traffic laws, strengthened penalties and efforts to increase the drinking age to 21, nation-wide. With 300,000 members, Mothers Against Drunk Drivers (MADD) is the largest group spearheading this effort.

Since 1981, nearly 300 pieces of legislation have been enacted by the various state legislatures to combat drunk driving. New Jersey is a leader through aggressive legislation that: raised the drinking age to 21, required a \$100 surcharge on all drunk driving fines to enable localities to increase enforcement efforts and placed an additional \$1,000 surcharge for offenders to retain their licenses. The latest statistics show the State has had a 30.8 percent decline in alcohol-related fatalities since 1981.

River Dell High School has developed a model alcohol awareness/traffic safety program. You will receive a demonstration on an alcohol reaction time simulator and participate in a shortened version of the awareness program. After this session, you will meet privately with a small group, made up of MADD members, students and others to discuss this problem in greater depth. Their principal concern will be your support for pending legislation that would force states to raise their drinking age. At the present time, the amendment is contained in legislation that we do not support. However, efforts are under way to find a suitable alternative vehicle. In addition, OMB has cleared a letter from Secretary Dole to Senator Baker underscoring our support for this.

# PROPOSED TALKING POINTS FOR MEETING WITH MADD MEMBERS AND OTHERS ON THE SUBJECT OF DRUNK DRIVING

- o When Mothers Against Drunk Drivers was formed four years ago by Candy Lightner, our Nation was being victimized by an epidemic of death from drunk drivers. Close to 25,000 people a year perished as a result.
- Groups such as MADD, SADD (Students Against Drunk Drivers), RID (Remove Intoxicated Drivers) and others serve as a perfect example of how a grassroots response to a problem can catalyze government action. Through this united effort, around 300 pieces of legislation have been enacted on the State level to fight drunk driving.
- o These efforts have shown significant results. Data from 30 states reporting show a 42 percent increase in drunk driving arrests and a 46 percent increase in convictions.
- o The fatality rate for 1983 was the lowest since 1950, with alcohol-related deaths dropping 12 percent.
- o Your activities have created a new consciousness toward this problem. We are seeing the beginning of the end of this terrible National tragedy. It goes to show that once Americans are united behind a common goal, there is no stopping us.
- o I want to particularly praise New Jersey for being in the forefront in the fight against drunk driving. Under the leadership of Governor Kean, your state has stated your message loud and clear: drunk driving must stop.
- o As I stated earlier, I believe that it is important that all states raise their drinking age to 21. While, as a former Governor, I am generally opposed to Federal intervention in State matters, on this question, however, the safety of our citizens is my first concern.
- You can be proud of your record, but you have just begun. I am here today because I want to join with you in this fight.

# 1984 PRESIDENTIAL ELECTION

June 5 presidential primary and delegate selection results\*:

Delegates selected 99 0 8

- The final 15 delegates will be named by the Democratic State Committee on June 16. Five are members of Congress, four of which have endorsed Mondale; James F. Maloney, the Democratic state chairman and a Hart supporter, and Newark Mayor Kenneth A. Gibson, a rules committee member and a Jackson supporter, will each receive one of the remaining spots.
- New Jersey primary overview:

Mondale: carried 18 of the state's 21 counties; had broad-based support - older voters (49-to-59 years, 60-plus years), Jewish voters, people who thought government experience was important, those earning \$40,000-plus, those with a post-graduate education, independents, and those worried about nuclear war.

Hart: carried two small counties, Hunterdon and Sussex, but the vote margin for both counties was only 448 votes total; basic support came from younger voters (18-to-29 years and 30-44 years).

Jackson: took Essex County (Newark), the state's most populous county, by over

10,000 votes; placed second in Union and Atlantic Counties and a strong third in Passaic, Camden and Hudson Counties; won roughly 85% of the black

vote.

• WCAU-TV/The Philadelphia Inquirer exit poll -- 63% of the respondents were

Democrats, 23% Republicans. Reagan 37% Reagan 36% Mondale 48% Hart 39% Undecided 24% Undecided 16%

# STATE POLITICAL SUMMARY

• The primary election for federal, state and local office was June 5.

<sup>\*</sup> delegates are elected independent of preferential primary vote.

## U.S. SENATE:

• In 1984, incumbent Democrat Bill Bradley will be seeking a second term. His Republican opponent is Montclair Mayor Mary Mochary. Mochary has the support of Maureen Reagan, Gov. Kean and state party officials. She supports President Reagan's economic and defense policies, but differs on such issues as abortion, tuition tax credits and the ERA.

#### GOVERNOR:

- In 1981, former Republican state legislator Thomas H. Kean defeated Democrat Congressman James J. Florio (and eleven others) by a 44.77%-44.70% margin -- less than 2,000 votes out of the 2.3 million cast.
- Gov. Kean's excellent/good approval rating according to June 5 exit polls was 80%. 76% of the Democrats and 86% of Republicans polled gave Gov. Kean positive marks.

U.S. HOUSE OF REPRESENTATIVES: 4 Republicans 9 Democrats 1 Vacancy

- Key 1984 Congressional races:
  - -- 4th C.D. (Central Trenton): Freshman Republican Chris Smith will face Democrat James Hedden, a lobbyist for AFSCME. Smith could be vulnerable due to the district's high Democrat registration, although redistricting strengthened his Republican base. However, Hedden is not considered a strong opponent
  - -- 9th C.D. (North Fort Lee, Hackensack): Freshman Democrat Robert G. Torricelli will face Republican printing executive Neal Romano. A recent Finklestein survey showed Torricelli as vulnerable with only 22% of those polled supporting his re-election and 53% undecided.
  - -- 11th C.D. (North Newark Suburbs): Eleven-term Democrat Joseph G. Minish will be challenged by Republican Assembly Minority Leader Dean Gallo. Redistricting diluted the Democratic strength of this distict by adding more of Republican Morris County.
  - -- 13th C.D. (South and Central): The Republican candidate campaigning to replace five-term Republican Edwin B. Forsythe, who died in late March, is state Sen. Jim Saxton. The Democratic candidate is Mt. Holly Mayor Jim Smith. Because of this district's strong Republican base, most observers do not feel Smith is a strong enough candidate to win.



# I. PURPOSE

To deliver a major address on the Administration's anticrime initiatives and successes.

## II. BACKGROUND

During the last two years of this Administration, crime in America has declined dramatically in all categories. This decline is directly attributable to the commitment by this Administration to fight crime on all fronts of the criminal justice system.

Your remarks review the accomplishments made toward Judicial reform, tougher sentencing procedures, the full-scale assault on drug trafficking, increased law enforcement budgets and personnel, the war against organized crime, citizens' watch crime prevention programs, and victims' assistance.

Also included in your remarks is the announcement of two new Administration initiatives: The establishment of a new National Center for the Analysis of Violent Crime, which will employ a nation-wide computer tracking system to identify and apprehend "serial killers;" and the introduction of Administration legislation to restrict the manufacture and sale of "Cop Killer" armor-piercing bullets.

Lois Herrington, of the Department of Justice, will have addressed the Sheriffs group in the morning on the issue of victims' assistance. The Sheriffs Association is a recipient of a Justice Department grant to promote victim witness assistance.

Approximately 1,200 of the 50,000 members of the National Sheriffs Association, will be attending your address.

## STATE POLITICAL BACKGROUND

• 1980 presidential results:

-- statewide: Reagan 48% Carter 39% Anderson 12% -- Hartford County: Reagan 41% Carter 45% Other 14%

1984 GOP Convention Delegates - 35

Republicans have:

-- won 5 of the last 8 presidential elections since 1952.

-- split representation in the U.S. Senate with the Democrats for most of the past 30 years.

-- held the governor's seat for only 4 years since 1949.

# 1984 PRESIDENTIAL ELECTION

March 27 Democrat presidential primary results:

- According to ABC News exit polling, two of every three Democrats who voted for President Reagan in 1980 supported Hart and half of those who voted for <u>Jimmy</u> Carter supported Hart.
- Jackson received approximately 75% of the black vote, carried Hartford and ran second to Hart in New Haven and Bridgeport.
- An early May survey by the University of connecticut's Institute for Social Inquiry of 500 adults showed: Reagan 56% Reagan 48% Mondale 37% Hart 41%
- President Reagan's excellent/good approval rating stood at 56% and his fair/poor rating at 42% in a late January Connecticut Poll.
- A new law went into effect on January 1 which eliminates the requirements for a presidential primary if only one candidate qualifies for the ballot. Therefore, no Republican primary was held this year.

## STATE POLITICAL SUMMARY

• The 1984 primary for federal, state, and local is office September 11. The filing deadline will be in June.

## U.S. SENATE:

• In 1982, GOP incumbent <u>Lowell Weicker</u> defeated Democrat Congressman <u>Toby Moffett</u> by a 51%-46% vote margin. Sen. Weicker is the first Republican in Connecticut to win re-election to a third term to the U.S. Senate since the 1920s.

• According to a May <u>Connecticut Poll</u>, Weicker rates better among Connecticut Democrats (59%) than Republicans (49%) and has an average excellent/good approval rating of 53%. Dodd scored slightly higher with a 57% overall positive rating.

#### GOVERNOR:

- Republican state Sen. Lewis Rome lost to Democrat incumbent William O'Neill by a 47%-53% margin in 1982.

- Key 1984 Congressional races:
  - -- lst C.D. (Central-Hartford): Freshman Democrat Barbara B. Kennelly will be challenged by either Combustion Engineering executive Herschel A. Klein, whom she defeated in 1982; stockbroker Doug Putnam; or Manchester Council minority leader Peter DiRosa. This is Connecticut's most heavily Democratic district and has not sent a Republican to Congress in 28 years.
  - -- 2nd C.D. (East-New London): Freshman Democrat <u>Sam Gejdenson</u> will be challenged by either former GOP state finance chairman <u>Nick Norton</u>; Professor Roberta Koontz; or publisher Richard Lightfoot.
  - -- 3rd C.D. (South-New Haven): Former U.S. Rep. <u>Larry DeNardis</u> has decided on a rematch with freshman Democrat <u>Bruce Morrison</u>. This race is considered the GOP's strongest opportunity race in Connecticut this year.
  - -- 5th C.D. (West-Waterbury, Danbury): Democrat incumbent William R. Ratchford will be challenged by either Rep. John Rowland, who is the Assistant Minority Leader in the state House; former police detective Fred "Moose" Miller, or state Rep. Alan Schlesinger.
  - -- 6th C.D. (Northwest-New Britain): Freshman Republican Nancy Johnson will be challenged by CIGNA Corp. vice president Arthur A. House. House has already received the endorsement of former U.S. Sen. Abraham Ribicoff.
