1. FOLLOWING RESPONSE FROM PRESIDENT REAGAN SHOULD BE DELIVERED TO PRESIDENT JUVENAL HABYARIMANA: HIS EXCELLENCY JUVENAL HABYARIMANA, PRESIDENT OF THE REPUBLIC OF RWANDA. DEAR PRESIDENT HABYARIMANA: THANK YOU VERY MUCH FOR YOUR THOUGHTFUL MESSAGES ON THE OCCASION OF MY ELECTION AND INAUGURATION AS PRESIDENT AND UPON THE RETURN TO FREEDOM OF THE AMERICAN CITIZENS WHO HAD BEEN HELD FOR MANY MONTHS IN VIOLATION OF INTERNATIONAL LAW. I AM PLEASED THAT ONE OF MY FIRST RESPONSIBILITIES AS PRESIDENT OF THE UNITED STATES WAS TO WELCOME THESE BRAVE MEN AND WOMEN BACK TO THEIR HOMELAND. ON BEHALF OF THE AMERICAN PEOPLE, I WISH TO EXPRESS MY APPRECIATION FOR YOUR KIND WORDS OF SUPPORT.

ALL NATIONS MUST WORK TOGETHER TO STRENGTHEN THE RULE OF LAW AND TO PRESERVE THE RIGHTS AND IMMUNITIES OF DIPLOMATIC PERSONNEL. DISREGARD OF THESE VITAL PRINCIPLES UNDERMINES THE VERY FOUNDATION OF INTERNATIONAL DISCOURSE AND ULTIMATELY THREATENS THE ABILITY OF EVERY NATION TO PURSUE NORMAL, PEACEFUL RELATIONS.

2. WE IN THE UNITED STATES ARE PLEASED BY RWANDA'S PROGRESS IN ITS QUEST FOR A SECURE AND PROSPEROUS FUTURE. I LOOK FORWARD TO THE CONTINUED FRIENDSHIP OF OUR TWO NATIONS AND EVEN GREATER COOPERATION FOR ECONOMIC AND SOCIAL PROGRESS IN THE FUTURE AND FOR ENHANCING THE CAUSE OF PEACE AND HUMAN DIGNITY THROUGHOUT THE WORLD.
