## FOSTER CARE ISSUES

- 1. The Foster Care system
  - A. Administrative structure varies among counties.
    - 1. Probation departments
    - 2. Welfare departments
    - 3. Private agencies
    - 4. Individual actions

We have not held hearing lately since the legislature has been in session. We have not concentrated on specific issues. It is time we did so now.

COMMENTS

Legislature has been concerned with Welfare Reform monetary aspects and caseload increase. Because of concern for these other areas have been ignored last two years due to force of time.

Questions must be asked - Is the state a good parent? Can it be a better one? State is parent in "loco parentis" to 33 thousand homeless in county custody and others in custody of county probation departments. These programs not reviewed lately. We need to catch up now.

How can we best transfer dependency from man to the state? These hearing may not show that the state does act as a parent well. We may need many months, not just two hearings. The issues may be raised in these first hearings but to develop answers to problems which have been ignored several years will take more time.

Maddy Bagley (cont'd)

County ratios differ for money spent on foster care homes compared with institutional placement. In Los Angeles County it is 10/1 (institutions/ foster homes) while Santa Clara County is 1/1. This is unfair treatment, people getting different care.

Also a disparity among counties in population and proportion of children in foster care. Marin population is 200 thousand and has 109 foster children compared with Mendocino's 50 thousand population and 171 foster children. I don't know which of these is the "bad" situation. Why is there the disparity?

We have had trouble finding foster parents to speak - Lancaster therefore we ask that there be no reprisals. Seemed to laugh

Bagley

Absolutely - I and Reagan guarantee it.

Chicco

Cited horror stories of unhappy foster children or unhappy natural parents. It is hard on foster parents.

She has acted as ombudsman for such problems for 10 years.

1. Criteria used to screen applicants are archaic, admission methods are no good.

2. Matching child and family is now a myth, natural parents should be considered, should take time initially, would save moving children later.

3. Training placement workers theory is a waste. Everyone's methods differ, each child must be understood separately.

Charges of abuse and molestation - no way to clear this now unless pay exorbitant attorney fees.

Evidentiary hearing held only when license to be withdrawn but no hearing available if worker just stops placing children in your home - right?
