SACRAMENTO--Governor Ronald Reagan today announced a statewide meeting this Spring to map an all-out campaign against juvenile delinquency, which he described as "one of the single most critical problems facing the people of the state of California."

The governor noted that more than 300,000 youths between the ages of 10 and 17 were arrested in California in 1966 and that the juvenile arrest rate is up almost 25 per cent since 1960.

"This trend must be reversed if we are going to prevent thousands of youths from embarking on criminal careers," he said.

A prime objective of the conference will be an action program enlisting the participation of thousands of Californians in a massive grass-roots effort to combat juvenile delinquency on the community level.

The conference, to be held in Sacramento, is tentatively scheduled for early April. It is expected to attract leaders of citizens' organizations, state and local law enforcement associations and youth serving agencies from all parts of the state. The leadership of county delinquency prevention commissions and juvenile justice commissions in this effort will be emphasized.

"An intensified delinquency prevention effort will obviously be of tremendous benefit to the youth of the state and to society in general," the governor said. "It is an effort that will be repaid many times over in the rehabilitation of human beings and in the money that crime costs society."

The conference will be coordinated by the California Delinquency Prevention Commission of the California Youth Authority. Mrs. A. Kenneth Spencer of San Gabriel is chairman of the commission.

The governor named Mrs. Robert T. Adams of Lafayette, a member of the Delinquency Prevention Commission, as chairman of a committee to plan the forthcoming conference.

Governor Ronald Reagan today outlined a plan to honor California high school seniors who achieve scholastic excellence in academic subjects.

In a letter to the state's 58 county school superintendents, the governor asked their support in initiating a Governor's Scholars Program designed "to recognize our bright, hard working high school students who attend school regularly and consistently bring home outstanding grades in academic subjects."

The plan calls for a governor's award to be presented at graduation for each student who received all A's, or no more than one B per year, during the final three years of high school in a planned academic curriculum.

The award, a certificate bearing the seal of the governor, would be designed by a high school student. It would be selected from many entries submitted by high school students in a statewide contest. The California Arts Commission would act as judge to select the outstanding design.

Governor Reagan said the program is intended to reward "excellence in student citizenship and academic achievement," both of which he feels "go hand in hand.

"I feel that all too often we in public life fail to provide as much recognition as we should for such accomplishments.

"In my opinion this program can give students another incentive to excel by providing high level recognition for academic achievement, thus combatting those factors which tend to contribute to student complacency and scholastic mediocrity.

"By emphasizing the importance of such achievement, we can help make more meaningful to our youngsters the necessity for good scholastic performance," he said.

The governor invited all 58 school administrators to send in their suggestions for the program.

Gordon P. Smith, State Director of Finance, announced today that California has paid off approximately \$61 million dollars indebtedness in the California Medi-Cal program for services given prior to June 30, 1967. This has been made possible by the net effect of over \$20 million of operating economies accomplished within various state departments by the administration during the period January 1, 1967 to June 30, 1967 coupled with a one-time savings of \$40 million dollars in the school allocation formula of 1966-67.

Smith said that, despite savings in the Medi-Cal program since June 30, 1967, total state costs will exceed total budgeted expenditures for the two year period ending June 30, 1968, by approximately \$30 million.

Smith stressed that the payment of the deficit does not end the need for legislative reforms in Medi-Cal, including action giving the administration more flexibility in administering the program, which this year is budgeted at \$305 million.

However, even without this flexibility, Smith said that Health and Welfare Secretary Spencer Williams has effected administrative changes that are expected to allow Medi-Cal to operate at a state funding level of \$274 million this year without any major cutbacks in services and none in recipient rolls.

Currently it is estimated that enough money will be available, including savings from this year, to budget Medi-Cal next year at the \$336 million level. However, early estimates from the State Office of Health Care Services indicate that, without further reforms, expenditures could run above \$400 million, close to 50 percent more than will be spent this year.

"I have warned continually that Medi-Cal without needed controls is growing at a rate that eventually will make it impossible to finance without annual tax increases or sacrificing other program_s" Smith said.

In a statement Emith said: "We are pleased that funds to pay

Medi-Cal's back bilis became available because of other savings. However, this does not change the need for a basic overhaul of the Medi-Cal program.

"Without this basic overhaul, the fact remains that Medi-Cal expenses are increasing at a rate much faster than the state's income and will require either tax increases or cuts in either services or recipient rolls.

"Because of this, we will continue to make economies wherever possible for the remainder of this year, so long as such economies do not affect those serviced by the program.

"In addition we will seek from the legislature the flexibility needed to administer the program properly.

"This administration remains dedicated to the ideal of adequate medical care for our poor and aged, but at a price our millions of wage earners and taxpayers can afford," Smith said.

Governor Ronald Reagan has named attorney John T. Rickard to the Santa Barbara County Superior Court bench.

The appointment pays \$25,000 annually and becomes effective April 1, 1968. The judicial post was created by the 1967 legislature.

Rickard, 54, is a 1939 graduate of the University of California's Boalt Hall law school. He served as a naval officer for five years during World War II in the Pacific. He subsequently obtained the rank of lieutenant commander in the Navy Reserve, from which he is now retired.

A Republican, Rickard has been engaged in private law practice in Santa Barbara since 1945. He is a former mayor of the city and served as Santa Barbara city attorney from 1951-53.

He is a past director of the League of California Cities and was a member of the Santa Barbara Harbor Commission from 1946-48. Since 1960 he has been a director of the Santa Barbara National Bank.

Rickard is a former director of both the Santa Barbara Chamber of Commerce and the city's community chest. For the past two years he has served on the Board of Fellows of Santa Clara University where he received his bachelor's degree in 1936.

He is the son of the late James B. Rickard who was Santa Barbara's postmaster during the Harding, Coolidge and Hoover administrations.

Governor Ronald Reagan today named seven persons to the ninemember New Car Dealers Policy and Appeals Board.

Of the two remaining members, one must be appointed by the Senate Rules Committee and the other by the Assembly Speaker.

The board, created by the 1967 legislature (SB-91), will hear appeals from new car dealers in the state with respect to actions taken by the California Department of Motor Vehicles. The board is also intended to provide a closer working relationship between dealers and the department, and to assist in the establishment of policies relating to the licensing of new car dealers.

The legislation requires that four board members be new car dealers. The remaining five must be "public members," one of whom has practiced law for 10 years prior to appointment. Members appointed initially will serve terms which expire as follows: one public member and one new car dealer member, January 15, 1969; two public members and one new car dealer member, January 15, 1970; two public members and two new car dealer members, January 15, 1971. Subsequent terms will last four years.

Appointed to terms expiring January 15, 1969, by the governor were:

--Robert D. Nesen, owner of the Robert D. Nesen Oldsmobile-Cadillac dealership, Oxnard. Nesen, 49, is a past president of the Motor Car Dealers' Association of southern California and currently serves as a director of the organization. He is also chairman of the association's legislative committee and insurance trust.

He is a Republican and resides at 85 Avocado Place, Camarillo. --Mrs. Audrey B. Jones, a Los Angeles attorney and hearing examiner for the city's police commission since 1959. A Republican, she operates her own law office. Mrs. Jones is a graduate of the Southwestern University law school.

She resides at 5011 Angeles Vista Boulevard, Los Angeles. Appointed to terms ending January 15, 1970 were:

--Gilbert D. Ashcom, 62, owner of the Gil Ashcom Rambler & Toyota dealership, Berkeley. A Republican, Ashcom is a former president of the Northern California Motor Car Dealers' Association and served three years as a director of the East Bay Motor Car Dealers'

The State Office of Economic Opportunity has recommended that Governor Ronald Reagan approve a request for refunding a \$1.4 million grant to the California Rural Legal Assistance Program, if the program undergoes certain modifications.

The modifications were outlined in a letter from the governor's executive secretary, William P. Clark, Jr., to Laurence P. Horan, regional director of the Office of Economic Opportunity.

Budgetary modifications would require that the level of supportive CRLA personnel be reduced to a ratio of 3.25 employees per staff attorney, and that the number of regional office staff attorneys remain constant.

Clark noted that CRLA is expanding beyond the scope of its original intent, and that the staffing is unrealistic in comparison with similar legal services in areas in which it operates. He cited several examples in Mercod county where, he said, three private law firms maintained an average of one attorney to every 1.3 supportive staff. In the Merced county district attorney's office, he said, each attorney has two supportive staff.

Here is the text of Clark's letter to Horan:

Dear Mr. Horan:

CRLA Legal Services, CG 7172 A/O

We have received information and action copies from your office regarding the request of the CRLA, Incorporated, for refunding.

The State Office of Economic Opportunity's technical assistance staff has completed an evaluation of the CRLA program, and a review of their grant request.

The State Office of Economic Opportunity has recommended that the governor approve the request for refunding, if the following modifications are accepted, in writing, by the CRLA, Inc., and the regional office of Economic Opportunity:

A. Budgetary Modification Recommendations:

 The number of regional office staff attorneys should remain constant. (20)

2. The supportive personnel level should be reduced to a ratio of 3.25 supportive personel per staff attorney as opposed to the requested ratio of 4.1 supportive personnel per attorney, and the following guidelines should be followed:

a.	Administrative personnel, 25 per attorney	(5)
b.	Research personnel, .5 per attorney	(10)
c.	Invest./cw personnel, 1 per attorney	(20)

3. Budget proposal should be reduced in operations in direct relation to personnel reductions.

4. A detailed survey of salaries of private and public legal offices in rural counties in which CRLA operates should be made, and the results of that survey should be used in determining salaries to be established for CRLA personnel.

5. All consultant and contract services expenditures included in the proposed budget should be deleted except for the following:

B. General Recommendations:

1. The Indian affairs portion of the CRLA program is generally research and specialized legal services which does not relate to the rural poor or farm worker. Accordingly, it is recommended that this portion of the program and grant be deleted and made the subject of a separately funded program.

2. In order to resolve jurisdictional differences and to cooperate with the bar association as provided for in their agreement with the State Bar Association, it is recommended that the CRLA shall request a resolution of authorization from the county bar association in each county in which they provide legal services.

The resolution should indicate the recognition of the local bar of its jurisdiction for providing legal services and the abdication of this responsibility. The resolution should further state that there are not any other available legal services programs and that they are willing to assign this responsibility to CRLA. In all instances where CRLA does not receive the said authorization, they shall terminate operation.

3. The CRLA shall agree to provide legitimate legal assistance to all eligible clients, and they shall establish offices and work hours convenient to the type of clientele being served. Further, they shall discontinue the practice of accepting only "selective" or "landmark" type cases and shall be available for legal assistance to any and all eligible clients. 4. The Ck_A shall adopt a reasonable standard of maximum earnings and net worth including therein a fair value of publicsupplied benefits to assist in the determination of clients' financial eligibility. Thereafter, they shall implement a rigid procedure of evaluation and verification of the financial condition of probable clients.

Further, they shall not provide legal assistance to any individual exceeding the established earnings or net worth financial schedule, until such time as there is a determination that the client is a legal service indigent--and that shall be ascertained by receiving in writing a refusal of referral from at least three private attorneys and all privately funded legal service programs normally available to provide this type of assistance.

5. The CRLA shall not represent any individual, groups of individuals, companies or corporations in any type of criminal case under any condition.

6. The CRLA shall not provide legal assistance in any civil case which is or could be of a fee generating nature, until such time as there is a determination that the client is a legal service indigent--and that shall be ascertained by receiving in writing a refusal of referral from at least three private attorneys and all privately funded legal service programs normally available to provide this type of assistance.

7. The CRLA shall not provide legal assistance or involve themselves in any way with union activities or members of a union who may be involved in a suit for which the basis thereof relates to union standards, practices, policies or programs.

8. The CRLA shall conform to all canons of ethics of the legal profession, and shall not involve themselves in unauthorized advertising, solicitation of suits, or the promulgation of nuisance type legal activities.

9. The CRLA shall not provide legal assistance in any law suit which could result in an action against any public agency or any agency totally or partially supported by public funds, until such time as there is a determination that the client is a legal service indigent--and that shall be ascertained by receiving in writing a refusal of referral from at least three private attorneys and all privately funded legal service programs normally available to provide this type of assistance in that area.

10. The A shall agree to assist p vate attorneys, the bar association, legal institutions, public agencies and interested citizens in the establishment of demonstration legal service programs involving the use of private attorneys to establish guidelines for the implementation of a statewide legal service program under the auspices of the bar association.

Further, they shall asist in the preparation of a chronological scheduling of the implementation of such a program and the establishment of a definite schedule for the phasing out of the use of full-time, government paid attorneys.

We recognize that certain items listed above have been partially satisfied by conditions established in the grant; but we feel they could be more forcibly stated, and have, therefore, included them in our comments.

Since we received your letter of approval (dated December 22, 1967) of the CRLA request for refunding on December 28, 1967, we would appreciate being advised of any action you intend to take regarding the State Office of Economic recommendations prior to January 20, 1968.

Upon receipt of your reply, we will advise the governor as to the proper disposition of this matter.

Governor Ronald Reagan today named a 36-person Delegation Organizing Committee to select a delegate slate pledged to his favoriteson candidacy in the June primary election.

Eighty-six delegates and 86 alternates will be selected. The governor named William French Smith, Los Angeles attorney, to head the organizing committee.

He charged Smith and the members of the committee with the task of selecting a broad-based delegation representing all segments of the party.

Smith said both the state's United States Senators, Thomas Kuchel and George Murphy, have approved the formation of the organizing committee. Both senators, however, have told the governor that they do not choose to be delegates, Murphy because of his duties as chairman of the Senate Campaign Committee and Kuchel because of his campaign for re-election.

Smith said partisan constitutional officers who are Republican also had approved formation of the committee.

Smith said the principal function of the organizing committee will be to recommend qualified persons to serve as delegates or alternates. He set January 22 as a deadline for receiving recommendations.

Smith said he will name an executive committee shortly to screen recommendations. The executive committee will then present its final selection to the governor for his approval.

He said each delegate and alternate will be asked to agree to remain committed to Reagan until he, Reagan, releases the delegation.

Selection of delegates must be done under a formula set by the state elections code which requires that from two to four delegates be selected from each congressional district.

Governor Ronald Reagan today signed a proclamation and issued the following statement regarding Industrial Safety Week, February 4-10:

"The rapid population growth in California has created many new business enterprises along with new job opportunities.

"Unfortunately, there are workers who suffer injuries in the day-to-day operations of our plants, construction sites, or mines, and even at offices, retail stores and farms.

"Currently, California's disabling injury rate is approximately 32 for each 1,000 employees in the state. There has been little improvement during the last ten years and, in fact, the injury rate in our large manufacturing industry has increased about 25 percent during this same period. That trend must be reversed.

"Technological advancement in the fields of manufacturing and processing has not only brought developments such as automation and nuclear energy but has also created new hazards in our industrial operations that require careful evaluation.

"I am issuing a proclamation designating by executive order the week of February 4-10, 1968, as Industrial Safety Week. I urge the California Department of Industrial Relations, through its division of Industrial Safety, management, labor, and all other appropriate segments of our state to join in a common effort--that of working together to improve safety performance for the benefit of everyone."

"This is a splendid example of how the diligent work of many officials concerned with California programs pays off.

"I want to commend every member of the California Congressional Delegation and both of our senators for cooperating with this administration in its long fight to have this money earmarked for the Century Freeway," the governor said.

"Gordon Luce, Secretary of Business and Transportation, and members of the State Highway Division - have since last January pressed for a reversal of the federal government's previous position of refusing to transfer the funds.

Governor Ronald Reagan said today his administration will seek modifications in the acreage limitation provisions of the federal reclamation law, as recommended by a special five-member task force appointed by the governor last April.

The task force study recommends that the 160 acre limitation be increased to 640 acres, and that an alternative to the limitation provisions be offered upon supplementary payment by owners of farms exceeding the limitation.

Governor Reagan said the modification approach was a practical answer to bringing the 60-year-old reclamation provision up to date with modern farming methods. He discussed the plan today with members of the California Congressional Delegation in Washington.

The task force study found that the acreage limitations on the delivery of water from federal reclamation projects do not benefit the economy, the farmer or the general public. But as a practical matter the task force concluded that outright repeal of these limitations is not likely to be achieved at an early date, and therefore recommended modifications in the existing law.

"The task force proposal recognizes the economic requirements of today's practices," Governor Reagan said. "It would modernize the land limitation provisions of federal reclamation law which have gone unchangsince established in 1902."

Based on studies of the State Department of Agriculture in collaboration with University of California experts, the task force found that farm sizes in California required for efficient operation range from 600 to more than 1000 acres. The task force therefore recommended updating the 160 limitation to 640 acres. It further recommended that the acreage figures be reappraised by the Secretary of the Interior at least every ten years to keep in step with future changes in agricultural technology and economics.

The task force also recommended that owners of farms exceeding the acreage limitation who desire to keep their farming operations intact be provided the alternative of making supplemental payments equivalent to an interest factor on the construction cost of the federal project, and receive water without restriction.

Governor Reagan urged all organizations interested in the welfare of California agriculture to join the movement for congressional action to modify the limitation provision as suggested by the task force.

The governor said that other western states have expressed interest in changing the archaic law. Support of those states will be sought in the drive to get congressional modification of the reclamation law.

Members of the task force which Governor Reagan appointed in April 1967 are Burnham Enersen, chairman, San Francisco attorney who is a director of the State Chamber of Commerce and chairman of its water committee: Breckinridge Thomas, Fresno attorney with expertise in irrigation laws; James Sorensen, Visalia engineer, a vice-president of the National Reclamation Association and consultant to several irrigation districts in the San Joaquin Valley; William Jennings, Jan Diego attorney, who represents several irrigation districts; and Richard Andrews, Fresno attorney and former minority counsel for the Senate Interior and Insular Affairs Committee.

Sacramento--The California Rural Legal Assistance program has substantially complied with modification requests from the governor's office and therefore will not be vetoed by the governor.

This was announced here this afternoon by **Azocutive** Secretary William P. Clark, Jr.

Clark said many of the problems between C.R.L.A. and the governor's office had been resolved in conferences held this week with O.E.O. officials in Washington, D.C. and the regional office in San Francisco.

"O.E.O. has exhibited a recognition of the deficiencies in the C.R.L.A. program and the problem areas which have arisen during its past year of operation," Clark said.

"On the basis of agreements meached for modification and careful monitoring of the program, it is felt that C.R.L.A. will now meet sufficient standards of professional conduct and management so that our objections to the program have been partially satisfied."

He said that under the agreements the administration's requirements of sound fiscal management and professional representation will be applied to all applications for legal assistance grants. He said the administration views C.R.L.A. and similar programs as necessary to provide for legal representation of the poor until such time as programs operated by bar associations and attorneys in private practice can meet such needs.

Clark indicated that the unresolved issues between O.E.O. and the governor's office will be the subject of continued discussion during the coming year. He also said that "the governor's office will carefully scrutinize the activities of C.R.L.A. and a further renewal of the grant at the end of this year will depend upon their compliance with the conditions agreed to by O.E.O. and the governor's office."

Clark added that the governor's office had received a telegram from the board of governors of the State Bar of California, with whom the governor's office has been working on this subject. expressing its appreciation to the governor for his cooperation with the state bar and the progress that has been made in regard to the C.R.L.A. grant.

Following is Clark's letter to the San Francisco office of O.E.O.: "We wish to advise you that pursuant to Section 209 (C) of the

Economic Opportunity Act of 1964, Governor Reaganhas reviewed the grant application of the California Rural Legal Assistance, Inc., as

well as the correspondence and negotiations between our respective offices. The governor has concluded that your acceptance and insertion of most of the conditions presented by this office on 9 January 1968 is substantial compliance with our requests and, accordingly, he shall not exercise his power of disapproval over the subject grant.

"However, we continue to be concerned by problems within the program that remain unresolved. Therefore, with the assistance of the bar association and your staff, we shall strive for more meaningful direction and control of public legal services in the hope that private attorneys and privately funded organizations may once again adequately provide legal services to the poor.

"During the ensuing year, we intend to closely review the activities of all legal services programs and shall provide you with all information that comes to our attention regarding possible deficiencies or abuses; we look forward to the cooperation of your office in taking appropriate actions in these matters."

Sacramento--Gov. Ronald Reagan today announced the creation of a six-man technical team to tackle the problem of parkway and scenic highway development on the west shore of Lake Tahoe.

The team is made up of three representatives each from the State Department of Public Works and the Resources Agency.

The action is an outgrowth of the continuing activities of the Joint Committee on Resources and Highways, made up of representatives of the same agencies.

The Joint Committee has met regularly since it was first established by Governor Reagan in mid-1967 to consider problems of conflict between the Division of Highways and the Resources Agency.

Governor Reagan said Samuel B. Nelson, Director of the Department of Public Works, and William Penn Mott, Jr., Director of the Department of Parks and Recreation, "are cooperating on this difficult question.

"By setting up this team of professional people we are assuring the citizens of California that the interests of all will be represented in environmental planning for these roads.

"We can be sure, by this approach, that the unique quality and beauty of the region will be of prominent concern in the planning process.

"At the same time, we will meet the need for an improved route. This type of cooperation is a milestone in relations between the Resources Agency and the Division of Highways," the governor said.

"This cooperative approach by state agencies will assist the California-Tahoe Regional Planning Agency in the important work it is doing in the area," he added.

Nelson and Mott said there has been considerable discussion regarding State Route 89 and the need to make it an all-year road. The most difficult problem is in the Emerald Bay region, where various

proposals have been presented.

The cooperative team approach will, the directors said, make it possible to solve the difficult problems which will confront the planner in the establishment of a suitable alignment and design for the road.

Sacramento--Governor Ronald Reagan today presented the state's highest valor decoration to two state employees, a forestry division crew foreman and a veteran prison administrator.

Receiving the State Medal of Valor with diamond were Joe G. Haggard, 42, a foreman for the Nevada-Yuba Ranger Unit, Nevada City, and Ruben E. Coyle, 42, a program administrator at the California Institution for Men, Chino.

The medal is presented to state employees for "extraordinary heroism" upon recommendation of the State Merit Award Board.

Governor Reagan praised the award recipients for their heroic acts during a brief presentation ceremony in his office.

"Your acts of courage are consistent with the highest traditions of public service. As governor, I extend to you the great appreciation of the citizens of this state", he said.

Haggard received the award for risking his life to aid a fellow fire fighter during a battle to control a brush and timber fire September 3, 1966, near Nevada City.

Coyle was honored for rescuing an injured motorist from a burning automobile near Santa Ana in June, 1967.

Haggard noticed a sudden change in the fire pattern and attempted to radio a warning to Jerry A. Miller of Grass Valley, a bulldozer operator. Miller was unaware of the shift in the fire front.

Haggard could not contact Miller. Fully aware of the danger, Haggard hurried along the fire line to warn his fellow worker of the advancing flames.

The two men were trapped by the blaze. They took cover under a fire-resistant blanket. The oxygen under the blanket was soon used up, and the two men were forced to seek refuge in a nearby irrigation ditch.

Both men suffered severe burns.

Coyle is credited with saving the life of an 18-year-old college student, Mark Miller of Santa Ana.

Miller's small foreign sedan was involved in a June 3 accident on the Santa Ana Freeway. Coyle saw the Miller car hurtle through the air, enveloped in flame. Coyle stopped his own vehicle and rushed to the burning auto.

Using a towel, coyle beat out burning grass so he could approach the Miller vehicle. He enlisted the aid of two unidentified bystanders to right the overturned automobile.

Coyle opened the door on the passenger side of the burning car. He tried to pull the victim free, but a seat belt held Miller in place.

Reaching across the injured Miller, Coyle managed to unfasten

the seat belt. Miller fell to the ground in the still-burning grass. Coyle helped Miller through the grass fire and used the towel to

put out flames on the victim's back.

Coyle suffered minor burns in the rescue. Miller received nearfatal burns. His car was destroyed.

Haggard has worked for the Division of Forestry since July, 1965. He and his wife, Doris, reside at 1923-59th Street, Sacramento. They have two sons.

At the time of the freeway accident, Coyle was assigned as a special agent in the Corrections Department's law enforcement liaison and investigation unit. He left the special agent post in July when he became a program administrator at the Chino Institution.

Except for service in the Air Force during the Korean War and three years when he was a deputy sheriff in San Bernardino county, Coyle has worked for the Department of Corrections since 1948.

He and his wife, Sally, live at 9618 Tudor Street, Montclair.

Governor Ronald Reagan announced today that his budget will for the second straight year include a substantial increase in funds for local mental health services.

The governor said he also would ask the legislature again to reimburse counties for all Short-Doyle programs on a 75 percent basis. Some early programs currently are matched by the state at 50 percent.

"Local mental health programs offer the most feasible and enlightened way to achieve the best results in the treatment of the mentally ill," Governor Reagan said.

"My budget will request that the Short-Doyle services be funded at a total of \$29.5 million, an increase of \$4.6 million over the prior year's appropriation. That, incidentally, was by far the largest in the history of the program," Governor Reagan said.

"I regard this as a sound investment in the human resources of our state," the governor said.

"I also will ask the legislature to eliminate the inequity created by existing law under which the earliest Short-Doyle programs are reimbursed at only 50 percent of local costs," Governor Reagan said. "Pioneering should not be penalized."

The Short-Doyle mental health health services were authorized in 1957.

More than 162,000 persons were served by the programs in the last fiscal year. There are now 44 state-supported local mental health programs serving approximately 95 percent of California's population.
