Governor Ronald Reagan today announced the reappointment of Vernon L. Sturgeon and William Symons, Jr., to six-year terms on the State Public Utilities Commission.

Governor Ronald Reagan today <u>nominated State</u> Court of Appeal Justice William P. Clark, Jr. of Shandon, San Luis Obispo County, to become Associate Justice of the California Supreme Court.

Governor Reagan lauded Clark as an outstanding jurist whose experience as both a trial judge and appellate court justice "will now enable him to render distinguished service to the judiciary and the people of California as a member of the Supreme Court."

Justice Clark will succeed Associate State Supreme Court Justice Raymond E. Peters who died last week. Governor Reagan's nomination of Clark has been submitted to the Commission on Judicial Appointments for confirmation.

A fourth generation Californian, Clark has served nearly four years on the bench, the last 18 months as a member of the Second Appellate District (Division 1) in Los Angeles. He has written 125 opinions and participated in another 250 cases as an Associate Justice of the Court of Appeal.

Justice Clark, 41, who lives on his Shandon cattle ranch with' his wife, Joan, and their five children, was named to the Court of Appeal in August, 1971.

First named to the Superior Court bench in San Luis Obispo County by the governor in 1969, Clark was reelected to the bench in 1970 by a vote margin of three to one. As a Superior Court judge, he often flew his small private plane from his ranch into eight nearby counties where he sat as a trial judge on cases assigned to him by the California Judicial Council.

Clark attended Stanford University and later worked his way through the Loyola University Law School at night as an insurance adjuster to help support his wife and family and to pay his school expenses. Later, as a Superior Court Judge, he attended the California Trial Judges College at the University of California at Berkeley.

Justice Clark interrupted his Oxnard law practice of ten years in 1967 to serve as cabinet secretary, and later as executive secretary, to Governor Reagan. He also was a member of the State Government Reorganization Task Force.

His father and grandfather were cattlemen and law enforcement officers in Ventura County. His grandfather, the late Robert E. Clark, served as sheriff of Ventura County and U.S. Marshall for Southern California. His father, William P. Clark, Sr. was undersheriff of Ventura County and Oxnard Chief of Police.

When Governor Reagan accepted his resignation as executive secretary in November 1968, he called Clark's performance "outstanding" and praised him as "one of the brightest and ablest young men I have ever had the pleasure of knowing."

In making today's nomination, Governor Reagan noted Justice Clark's "demonstrated commitment to the principle of judicial restraint--that courts should confine their duties to interpreting existing laws and not legislate new ones into effect."

The governor also pointed to Justice Clark's "balanced judgment, cool and deliberate approach to solving tough problems, and outstanding leadership characteristics, qualities I had the opportunity to observe first-hand over a period of many months.

"I believe his experience as a trial judge, and his energetic and admirable performance as an appellate court justice, will now enable him to render distinguished service to the judiciary and the people of California as a member of the Supreme Court," Governor Reagan said.

Justice Clark served in the U.S. Army as a member of the Counter-Intelligence Corps in Europe from 1954-1956. He is a member of the California Judges Conference, the American Bar Association, Stanford Associates, California Cattlemen's Association and the Rancheros Vistadores. He also is a member of the Board of Directors of the San Luis Obispo County A.I.D. His wife is the former Joan M. Brauner of Munich, Germany. They have three sons and two daughters.

The annual salary of an associate justice of the State Supreme Court is \$46,583.

GOVERNOR REAGAN'S 1973 STATE OF THE STATE MESSAGE

Governor Ronald Reagan called on the legislature today to "seek new horizons of greatness" for California through far-reaching and innovative reforms in the areas of crime, job creation, corrections, health, education, and by using the state's one-time budget surplus to reduce taxes.

In his annual State of the State Message to a joint session of the legislature, Governor Reagan outlined an ambitious 31-point program including major reorganizations to further streamline state government and provide improved services for the people of California at the least possible cost.

The governor noted that the budget he will propose for the coming year will provide the greatest single-year increase of state school assistance in history, along with "a substantial reduction in (homeowner) property taxes because of...increased exemptions (in SB 90)."

"Instead of a massive deficit requiring higher taxes or program uts, a situation we faced six years ago," the governor said, California has a one-time budget surplus this year "in the neighborhood of \$850 million, and that's a very nice neighborhood. While there are possible philosophical differences as how best to return this money to the people who paid it in the first place, I am sure there is no disagreement that it should be returned.

"I look forward to working with you to achieve this end," he told the legislators. "In addition to this one-time refund, I anticipate working with you on a program for permanent tax reduction," he added.

The governor called for a combination of tougher laws to combat crime along with some major innovations to provide more effective rehabilitation of casual juvenile offenders and research on the causes of violence.

"In November, the people of California gave us a mandate to restore capital punishment," the governor said. "We shall ask you to pass laws to carry out this mandate, including one to make the killing of a law officer mandatory first degree murder."

The governor also called for tighter parole and probation policies and for a system of justice to guarantee "that when criminals are convicted of crimes involving use of firearms, they will go to prison and stay there until they are no longer a menace to society." As part of the state's long-term streamlining of the correctional system, the governor said the administration would propose a major program of state-financed, locally-based juvenile rehabilitation facilities for first time and non-criminal juvenile wards. The state, he said, will continue to operate detention facilities for "hard-core juvenile criminals...the most vicious of the young criminals who terrorize our schools and urban areas. But the non-criminal juvenile wards and first time offenders not subject to long term confinement are better off isolated from the repeaters."

Part of this long-range program includes the phaseout of San Quentin Prison, construction of new and smaller maximum security prisons, and ultimately, a single Department of Correctional Services and a single parole authority.

In a major innovation, the governor proposed creation of a Center for the Study of Violent Behavior at the University of California at Los Angeles. "This center," he said, will be the first of its kind and would "explore all types of violent behavior, what causes it, how it may be detected, prevented, controlled, and treated.

"To rid society of the cancer of violence, we must expand our knowledge of the entire range of human conduct."

In another major program to achieve greater efficiency in government, the governor announced that the Department of Social Welfare would be reorganized into a Department of Benefit Payments to handle all the "banking" functions of the Health and Welfare Agency.

Here, in brief, are the 31 major points in Governor Reagan's State of the State message:

TAX REDUCTION-JOBS

--Announced an anticipated one-time budget surplus of about

\$850 million and:

(1) Called for tax refunds to "return this money to the people who paid it."

(2) Said he hopes to work with the legislature for permanent tax reductions as well.

(3) Noted that California's bonds rated Triple A for first time in 31 years; urged caution in issuing new bond obligations to preserve this excellent credit rating.

(4) Announced consolidation of the "maze" of governmental manpower and vocational programs into a single Department of Manpower within Health and Welfare Agency.

(5) Said the California Work Experience Program (CWEP) for ablebodied adult welfare recipients will be expanded to 35 designated counties in the months ahead.

(6) Announced creation of a new, decentralized California Job Creation Program incorporating activities of Cal Job program plus expanded loans and technical assistance to small business to help generate new job opportunities, especially in disadvantaged areas.

EDUCATION

--Noted that 1972 Tax Reform-School Finance legislation (SB 90) provided greatest ever single year increase in school funding; U.C. and State University-College support at record levels.

(7) Called for "total commitment to education that produces results."

(8) Reaffirmed need for tuition in State University and College Jystem.

(9) Called for early identification of students with potential for post-secondary education, possibly as early as 9th grade--for better counseling, more effective educational opportunity programs.

(10) Said teaching must have equal status with research in higher education.

HEALTH (A Healthier California)

(11) Proposed a "major long range expansion" of California's pioneering humanitarian program of community mental health treatment.

(12) Announced the administration will offer "new and far-reaching reforms" this year, to:

--Consolidate health facility licensing, hospital planning, and health cost review; eliminating overlapping and obsolete functions and over-building which contributes to higher hospital costs.

--Bring about better distribution of health care facilities to assure all citizens have access to "quality health care" at a price they can afford.

(13) Said he looked forward to working with legislature to develop rogram to "free middle income working citizens from the threat of a isastrous illness that could leave them bankrupt." (Catastrophic Health Insurance.)

(14) Said the reorganized Department of Health would be operational July 1, incorporating Departments of Public Health, Mental Hygiene, and Health Care Services into one administrative unit, including social services functions now handled by Department of Social Welfare.

MORE EFFICIENT GOVERNMENT/CONSUMER PROTECTION

(15) Proposed consolidation of all "banking functions" of Health and Welfare Agency into a Department of Benefit Payments. (This exclusively fiscal department would take over the fiscal operations of Social Welfare department. In addition to distributing welfare funds, it would include collection of the taxes and payment of benefits in unemployment, disability insurance programs, handling of Medi-Cal claims, payments and all other strictly fiscal functions in Health and Welfare Agency.)

(16) Urged continued efforts for economy in all levels of government and said this is the prime purpose of the administration's Local Government Reform Project, now underway.

(17) Called for a system of no fault insurance that best serves the interests of the people, and continued emphasis on consumer protecon "to assure that our citizens are protected against the unscrupulous new who profit off shoddy goods and services or by exploiting unsophisticated consumers."

(18) Announced that the single Department of Transportation (consolidating departments of Public Works, Highways and Aviation) becomes operational July 1 and is working on a statewide master transportation plan.

CLEANER ENVIRONMENT

#11

--Reviewed California's "toughest-in-the-nation" smog control program and other efforts to preserve and protect environment, assure clean water and air. To continue this effort:

(19) Announced that legislation would be offered to include the concept of requiring that automotive tune-ups guarantee efficiently operating emission control devices, effective initially in South Coast Air Basin (Los Angeles area). (Proposed by Task Force on Vehicle Maintenance Inspection and supported by Air Resources Board.)

(20) Said that "California still needs a balanced forest practices act" which the administration will again seek.

(21) Called for state to "work with Congress to close the Minarets corridor to protect the John Muir Trail from unnecessary highway development."

(22) Said the administration hopes to work closely with state and regional commissions (created by Proposition 20) to protect coastline; urged use of already completed coastal area plan.

(23) Announced a significant expansion of the California Ecology Corps which he said "has been especially effective in protecting the environment and providing useful work for young men seeking constructive employment."

A SAFER CALIFORNIA

--Declared that state's most important goal must be a safer California, so that people can enjoy cleaner environment and economic prosperity without fear of personal safety.

(24) Announced that state is implementing the recommendations of his Earthquake Safety Council, including additional funds for more seismic investigations.

(25) Urged action to make the historic State Capitol Building earthquake-safe "suitable for the uses it has served for a century."

CRIME/LAW ENFORCEMENT

(26) Announced laws will be proposed to carry out the voters' mandate to restore capital punishment as a deterrent to crime, including law making the killing of a law officer mandatory first degree murder.

(27) Declared that "our system of justice must guarantee that when criminals are convicted of crimes involving use of firearms, <u>they will</u> go to prison and stay there until they are no longer a menace to society. (Tighter probation, parole policies.)

(28) With age of adulthood reduced to 18, said "it also is time to consider changes in juvenile justice system," especially for the "most vicious of the young criminals who terrorize our schools and urban areas."

(29) Announced state will soon propose a major redirection of state's correctional system, including a program for breaking the "cycle of crime" by providing locally-based juvenile rehabilitation facilities for first time and non-criminal juvenile wards. The program will be patterned after a successful system of local mental health programs and will be over a long phaseout period.

(30) Along with the San Quentin phaseout and smaller maximum security facilities, the ultimate restructuring of the system will permit "creation of single Department of Correctional Services" and a single parole authority in the Health and Welfare Agency.

(31) To rid society of the "cancer of violence," Governor Reagan proposed the "creation of a Center for the Study of Violent Behavior at the University of California at Los Angeles, to be operated jointly with the Health and Welfare Agency. "This center, the first of its kind, will explore all types of violent behavior; what causes it; how it may be detected, prevented, controlled, and treated," he said.

The governor's State Operations Budget will be available to newsmen at 10:30 a.m. in the governor's office, Tuesday, January 16. <u>It is</u> <u>embargoed for Thursday p.m.'s, January 18.</u>

Mr. Orr will be available to newsmen for a State Operations Budget briefing at 11:30 a.m., Tuesday, January 16. <u>Information from this</u> <u>briefing also is embargoed for Thursday p.m.'s, January 18</u>.

Consistent with our policy of the last few years, we are asking that motion picture sound-on-film cameras and tape recorders <u>not</u> be used at these two budget briefings. However, those newsmen wishing to use silent and still cameras to film the briefings are welcome to do so.

#17 <u>HIGHLIGHTS</u> LOCAL ASSISTANCE BUDGET

The governor's Local Assistance Budget for 1973-74 increases state contributions to local government by 28.8 percent, from \$4,780,702,374 (1972-73) to \$6,157,801,816 (1973-74).

EDUCATION (K-14)

The proposed budget includes approximately \$2,446.8 million for financing public schools (K-14), including \$2,417.9 million from the General Fund, the highest amount in the state's history (a 30.7 percent increase).

During the current fiscal year, total expenditures for K-14 are estimated at about \$1,871.4 million.

The 1973-74 total includes \$561 million of new state financing for schools which was made possible by the recent enactment of Senate Bill 90. This includes \$215 million of revenue sharing.

Passage of SB-90 provided for an increase in foundation program levels from \$355 up to \$765 per elementary student and from \$488 up to \$950 per high school student. It also provides for new programs for educationally disadvantaged youths and early childhood education.

These additional state funds not only will result in \$327 million in new financing of schools, but also a local property tax reduction of \$234 million.

TAX RELIEF-SHARED REVENUES

The proposed 1973-74 budget will provide \$1,049 million in tax relief, including \$979 million in ongoing property tax relief.

This is an increase of \$600 million over the amount allocated during the current budget year. SB-90 accounted for \$511 million of this increase. Increases in assessed valuation account for the majority of the remaining \$19 million.

The homeowners property tax exemption will total \$647 million, an increase of \$404 million over 1972-73. The personal property tax relief program (business inventory exemption) will total \$208 million, or \$75 million more than the current year.

Property tax relief for senior citizens is included at \$62 million, an increase of \$2 million, and \$22 million is included to reimburse local government for the open space program, \$9 million more than the current budget year.

SB-90 provides for new relief as follows:

--The homeowners property tax exemption was increased by \$396 million as a result of raising the exemption from \$750 to \$1,750 assessed value.

--The business inventory exemption was increased by \$68 million as a result of raising the exemption from 30 percent to 45 percent of assessed value. The total increase in property tax relief resulting from this item will be \$75 million.

The amount of state funds available to reimburse local government for open space programs was augmented by \$7 million:

--A renter income tax credit and/or refund was provided at a total cost to the General Fund of \$110 million, with direct payments of \$40 million to be made to renters in lieu of property tax relief.

--A system of revenue controls for school districts will result in a \$234 million rollback of school district property taxes. This is in addition to the \$979 million in ongoing property tax relief.

Since 1967, state financed property tax relief has totaled over \$2.5 billion.

Shared revenues (money collected by the state and returned to local governments to finance various programs) will total \$737 million in 1973-74, an increase of \$36 million from the previous budget year.

HEALTH PROGRAMS

DEPARTMENT OF HEALTH

In 1973-74 it is estimated that \$2.5 billion will be expended from all sources for local assistance for health programs by the newly formed Department of Health. (\$896.5 million of this total is from the General Fund).

Programs for the mentally disordered will continue to be a shared responsibility between the state and Community Mental Health Programs. Since their inception, community programs have reduced patient populations in the state hospitals.

Concurrently, agreements were made with local programs to transfer amounts from state hospital funds to local programs for each patient-day not used in state hospitals. This transfer of funds consequently enables improvement in the local mental health programs.

The significant trend toward local programs will continue. The governor's proposed 1973-74 budget provides an increase of \$17.5 million in state funds for local mental health programs.

DEVE. MENTAL DISABILITIES PROGR .S

In 1972 the State Office of Developmental Disabilities, Mental Retardation, Cerebral Palsey, etc., was formed. This action broadened the scope and responsibility of the former Office of Mental Retardation Coordination in the all-inclusive recognition of developmental disabilities among Californians.

The office combines into a single operation the state hospital programs for mental retardation, protective living services (such as providing board and care homes for the mentally retarded) and regional center operations which will be located in the Department of Health beginning July, 1973.

The 1973-74 proposed local assistance budget includes \$144.2 million from the General Fund for Developmental Disabilities.

A new regional center for the mentally retarded is to be provided in south central Los Angeles (\$250,000). It will be the 15th such center established since 1965.

YOUTH AUTHORITY

The number of Youth Authority parolees and wards in the institutions is projected for a slight decrease in 1973-74. The Probation Subsidy Program will be increased by approximately \$2.6 million to a level of \$23.7 million in the budget year. This local assistance program, which emphasizes local supervision and treatment of offenders on probation, is one of the reasons for the decline in the commitment rates of offenders to the Department of Youth Authority and the Department of Corrections. DEPARTMENT OF SOCIAL WELFARE

This department is entering a period which will continue to reflect a number of major changes in its traditional role in state government. As a result of the administration's Health reorganizations, all programs and activities relating to the delivery of social services are being transferred to the Department of Health as of July 1, 1973.

During this past year, the department has continued the successful implementation of the "Governor's Welfare Reform Program" (March 1971). Since this plan was first implemented, there has been a decrease of nearly 250,000 persons on the welfare rolls of California.

HIGHER EDUCATION

University of California

Governor Reagan is proposing an overall general fund support budget including salary /increases for the University of California of \$429.6 million in 1973-74, an increase of \$44.8 million over the current (1972-73 level of support. This represents an 11.6 percent increase over the 1972-73 budget -compared to an average 6.5 percent yearly rate of increase during the last six years.

CALIFORNIA STATE UNIVERSITY AND COLLEGES

During the same six year period, the average rate of increase per year in total authorized general fund support for the California State University and Colleges system has been 9.8 percent.

The governor's proposed general fund support budget for 1973-74 provides an increase of 16.9 percent over the current spending level, up \$63.8 million from the present \$378.4 million to \$442.1 million as proposed for next year. These figures include proposed salary increases.

Financial Assistance to Students

The proposed budget reflects an increase in state financial assistance to students enrolled in California's public and private universities and colleges---up from \$44.6 million in the current year to \$51.5 million next year. Included in the \$51.5 million are funds for scholarships, educational opportunity programs, work/study assistance and student loans. The major portion of the state's student financial aid is through the scholarship and loan commission.

Since the governor took office six years ago, general fund support for the State Scholarship and Loan Commission has climbed substantially from \$5 million in 1966-67 to 38.6 million in the proposed 1973-74 budget. The proposed increase in commission programs and support next year over the current year (1972-73) totals \$7 million or approximately 25 percent. The commission provides assistance to needy students through scholarship awards based on academic achievement and grants for the socially and educationally delayed students based on subjective measures of potential as well as academic achievement. Recipients are entitled to attend public or independent universities and colleges in California.

State support for educational opportunity programs in California's public and private colleges and universities during 1973-74 is expected to increase by \$2.2 million or 20 percent above the current (1972-73) funding level of \$11.3 million. This includes a \$1,709,320 increase in the state-funded College Opportunity Grant (COG) program up from \$4.3 million this year to \$6.1 million in 1973-74.

(See Table C, Page A-58, Governor's Budget) Community Colleges

The governor's proposed 1973-74 general fund support budget for California's 96 community college campuses and its Board of Governors is up \$9.6 million over the current state support level---from \$209,748,000 this year (1972-73) to \$219,311,000 next year.

State support for the community colleges has gone up 204 percent since Governor Reagan assumed office.

STATE EMPLOYEE-FACULTY SALARY INCREASE

Last year the governor announced his intent to include in the 1973-74 budget the balances of the funds needed to remove salary inequities. Accordingly, the 1973-74 budget contains funds as recommended by the state personnel board and the other salary-setting authorities.

The proposed budget contains \$165,701,000 of General Fund monies and \$60,342,000 of Special Fund monies. Of the total amount proposed---\$226,043,000---the University of California is budgeted for \$30,690,000 and the state University and Colleges for \$34,260,000.

A huge \$160,493,000 is budgeted for salary increases for all other state employees. This represents an increase amounting to 12.9 percent of payroll. The remaining \$600,000 provides for judicial salary increases DEPARTMENT OF TRANSPORTATION

The 1972 legislature enacted Assembly Bill 69 (Chapter 1253, Statutes of 1972) which creates the Department of Transportation effective July 1, 1973. The new department succeeds, and is vested with, all the duties, powers, purposes, responsibilities, and jurisdiction vested in the Department of Aeronautics, the Department of Public Works and the Office of Transportation Planning and Research, which are abolished.

The department is to be concerned with the viability of all forms of transportation in California and the establishment of a comprehensive transportation planning process which involves all levels of government and the private sector in a cooperative process to develop coordinated ransportation plans.

This budget provides \$5,000,000 from the General Fund to implement this new department.

CALIFORNIA HIGHWAY PATROL

Approximately \$1,000,000 in federal funds have been added to the budget of the Highway Patrol to implement the recommendations of the California vehicle theft study. This study recommended that the department develop a program to coordinate and assist local law enforcement agencies in the investigation of interjurisdictional thefts, inspect revived salvage and certain non-resident vehicles prior to their registration in California, inspect certain business establishments for stolen vehicles and stolen parts, and establish a vehicle theft information system to provide information for otheragencies.

PARKS AND RECREATION

The number of visitor-days Californians and out-of-state visitors will spend in our state parks during 1973-74 will total more than 43 million.

The governor's new budget will provide \$2,630,000 in additional fund support for the operation of our growing state park system. The \$2.6 million provides for cost increases (\$1,366,000) minor capital outlay (\$256,000), and related administrative costs. Staffing of newly acquired parks and developed facilities will cost \$829,000. The largest single items in this category provide additional staffing and operating expenses at Seacliff State Beach (\$77,776), San Onofre State Beach (\$76,843), and the Santa Cruz Mountains area \$88,824). Eighteen other parks account for the remainder of the increased expenditures.

The 1973-74 capital outlay budget for the department proposes expenditures in excess of \$24.7 million. Over \$10,1 million is proposed from the Bagley Conservation Fund and approximately \$9.8 million from the Recreation and Fish and Wildlife Enhancement Fund. Some of the major areas proposed for development in 1973-74 include Bolsa Chica State Beach (\$2,867,000), Perris Reservoir (\$7,421,390), San Onofre State Beach (\$1,534,000), and Silverwood Lake State Recreation area (\$1,295,700) ENVIRONMENTAL PROTECTION

The secretaries for Resources and Business and Transportation have proposed a total expenditure of \$2.1 million from personalized motor vehicle license plate revenue for environmental protection and enhancement projects. For further information see page 761 of the supplement to the governor's 1973-74 budget.

SOLID WASTE MANAGEMENT

Chapter 342 passed by the legislature and signed by the governor in 1972 created the state Solid Waste Management Board with the objective of managing solid wastes in California so as to protect the public health, safety, preserve the environment, and to provide for maximum reutilization and conversion of solid wastes to useful purposes. \$315,000 is included in 1973-74 for the support of the Board.

HEALTH PROGRAMS

DEPARTMENT OF HEALTH

This budget reflects the consolidation of three major state departments---Public Health, Mental Hygiene, and Health Care Services--as well as certain related health and service programs in the departments of Social Welfare and Consumer Affairs into a single Department of Health by July 1, 1973. This consolidation will bring the major elements of all state health and services programs into one organization.

- 4 -

Consolidation of the various state health programs into one department will provide both greater effectiveness in delivery of health programs to the citizens of California and economy in staffing and operating the various programs. Consolidation of the major state health programs into the Department of Health and the subsequent review of all programs will result in savings in state funds through a departmentwide reduction of 600 positions during the 1973-74 fiscal year. In the subsequent year, it is estimated that an additional 400 positions can be eliminated after additional duplicate efforts are identified and departmental administration is further streamlined.

CORRECTIONS

The governor's proposed operations budget for the Department of Corrections in 1973-74 is \$128,708,931. In addition, \$2,004,160 is proposed for capital outlay.

The operations budget increased \$2,951,128 or 2.3 percent over 1972-73.

Funding increases in operations include a change in parole ratios for conventional parole supervision, plus increases in maintenance of plants, additions to vocational education and staffing to meet the requirements of the Morrissey v. Brewer decision. Morrissey v. Brewer requires a hearing for parolees prior to possible return to prison.

The capital outlay budget provides \$729,160 for security modification and equipment at the Chino Reception Guidance Center. A total of \$1,100,000 is being made available for working drawings for two 400-man maximum security institutions.

YOUTH AUTHORITY

The proposed 1973-74 General Fund budget for the Department of Youth Authority is \$54.5 million, a reduction of \$2.1 million below the 1972-73 level. A major result of the drop in commitment rates to the department is a decrease in the requirement for bed capacity in existing facilities. Continued decline in commitment rates will allow the department to close the Los Guilucos School by the end of the 1972-73 fiscal year.

HUMAN RESOURCES DEVELOPMENT

Human Resources Development will expend \$1.25 billion in 1973-74 with an increasing emphasis on placements and service to employers and employees. The WIN program is being redesigned to provide service for virtually all employable AFDC recipients and the Employables Program and Community Work Experience Program will provide employment service and training for welfare recipients.

REHABILITATION

Rehabilitation expenditures will increase \$3,295,381 in 1973-74. This increase is effected in the program area of disability determination and rehabilitation services to recipients and potential recipients of Social Security benefits. This program is totally federal funded. Services to welfare recipients will continue to expand in the current and budget years and services to the mentally ill and retarded will be shifted from the state institutions to the local mental health facilities without changing the extent of funding.

"I was shocked and saddened to learn of the death of former President Lyndon B. Johnson.

Sacramento---Governor Ronald Reagan today requested the President of the United States to declare the winter flood damaged areas of San Luis Obispo and Marin Counties and the City of South San Francisco as major disaster areas, opening the way for federal disaster relief.

Governor Reagan had on January 23 declared that a "State of Emergency" existed in Marin and San Luis Obispo Counties. In today's request to President Nixon, Governor Reagan added the City of South San Francisco in a second "State of Emergency" proclamation and requested that all three areas receive the federal aid available under the Federal Disaster Relief Act. The total damage---both public and private---from heavy rains, wind, flooding and runoff of mud and silt amounted to \$7.1 million in San Luis Obispo County, \$2.9 million in Marin County and \$2.2 million in the City of South San Francisco.

In his request Governor Reagan noted that all available state and local resources have been used in carrying out disaster operations in accordance with existing Mutual Aid agreements. Primary assistance was provided by the State Office of Emergency Services, State Department of Fish and Game, State Department of Public Health, and Division of Highways. Governor Reagan went on to say that state and local funds available for the purpose of restoration of the disaster area have been obligated or expended.

A Presidential declaration will provide over \$1.6 million in federal assistance to the stricken areas.
