Declared a moratorium on interest payments until fiscal year 1970-71 on state loans to the North Tahoe and Tahoe City Public Utility Districts and the Truckee Sanitary District for construction of sewage and storm drainage facilities to prevent and control water pollution.

Concerns California statutes about exemption of debtors' property from attachment, execution, and similar judicial process; reason for veto given.

Provided that the marshal in L.A. and San Diego Counties had sole responsibility to serve civil processes, because operation of sheriff's and marshal's departments is primarily a local concern.

Concerns emergency detention and treatment of inebriates; reasons for veto listed on #506.

(AB 564 - Brown)

Requires Department of Social Welfare to establish adoption services in the counties which do not have a county adoption agency; reason for veto given.

(AB 730 - Veneman)

Would have established separate retirement system for approximately 600 state employees who work for the legislature; reason for veto given.

Would allow boards of supervisors to establish and operate a ferry, etc.; governor already approved identical bill (Chapter 386, Statute of 1968). Approval of this bill would result in duplicate provisions being added to Streets and Highways Code.

Concerns advance payment of taxes and assessments by Department of Veterans Affairs for veterans holding farm or home loans; reason for veto given

RR vetoed bill which would have provided retirement benefits for out-of-state service for teachers who finish their teaching careers in California.

Omnibus education bill;

Reasons: AB-8 was "passed under the guise of property tax relief" because it "would, in fact, add to the already top-heavy tax burden borne by the people of California."

Vetoed by Acting Governor Hugh M. Burns; requires the exclusion of income in computing public assistance grants to the extent permitted by federal law; reasons for veto given.

PEACE OFFICER AS WITNESS  
SB 591 - Moscone VETOED

#375  
7-22-70

provides that in a hearing of a motion to suppress evidence, an investigating peace officer may be called by the defendant and examined as if under cross-examination. The peace officer may then be examined by the district attorney as if on redirect examination.

SB 945 - Lagomarsino

"As written, the bill might have provided some interference with the right of access to public fishing areas, a situation which Senator Lagomarsino definitely did not intend in his original drafting of the bill."

EMPLOYMENT OF MINORS  
(As Entertainers)  
AB 1028 - Brown) Vetoed

#402  
8-14-70

Permits employment of persons between ages of 18 and 21 as musicians, for entertainment purposes only, in premises selling and serving alcoholic beverages. The bill restricts the areas of such employment, and provides that no alcoholic beverages shall be sold, served, consumed, or taken into such area.

Includes licensed vocational nurses and psychiatric technicians within the definition of "professional employees" for purposes of the right to representation by professional employees organization under the public employer-employee relations law.



VENEREAL DISEASE INSTRUCTION  
AB 950 - Fong

The measure vetoed would remove from parents their right to consent to their children's participation in venereal disease instruction.

Would allow school boards to pay the cost of replacing property stolen from a school employee by robbery or theft while on duty.

RR vetoed SB 138 because it duplicates existing legislation regarding solid waste and cannot be managed effectively without the reorganization the administration currently is seeking.

RR announced that, to assure a balanced budget, he has vetoed more than \$302 million in spending proposals sent to him last month by the California legislature.
