Governor Ronald Reagan today announced the signing of his first bill passed by the 1971 legislative session.

The bill, SB 2, authored by Senator Gordon Cologne (R-Indio), decreases the requirement for maturity of desert-produced grapefruit from 6½ parts to 6 parts soluble solids to every part of acid in the juice. The bill permits the director of agriculture to establish a higher maturity standard when he finds that it would provide more acceptable grapefruit to the consumer. (Chapter 1)

SB 199 - Marks (Chapter 6) Authorizes the California State Education Agency for Surplus Property to waive, under specified conditions, charges otherwise required by law for delivery of certain surplus federal food in its possession. The bill also specifies that the charges for surplus food delivered directly by the federal government to a party for distribution shall be only for the actual cost of the agency of related document processing.

SB 96 - Moscone Specifies that in civil cases where the court has (Chapter 7) jurisdiction of the defendant by his general appearance, an action cannot be dismissed for failure to obtain judgement in three years, unless no answer has been filed.

following bills:

AB 1 - Badham (Chapter 4) Provides, under certain conditions, for the establishment of trustee areas and the election of a seven-member governing board following annexation of a unified school district to a community college district. The bill provides that, following annexation, voter disapproval of the establishment of trustee areas shall void the annexation. The bill is to be effective only for school district elections held during 1970-71 school year and is to have no force or effect after July 1, 1971.

SB 15 - Teale (Chapter 2)

SB 77 - Marler (Chapter 5)

SB 133 - Nejedly (Chapter 3) Continues in effect the requirement that the Department of Public Works remove snow from a specified portion of former U.S. Route 40 in the vicinity of Donner Lake.

Permits a combination of vehicles consisting of a motor truck and a logging dolly to exceed a total length of 60 feet, but not to exceed a total length of 65 feet.

Requires that the selling or giving away of any animal to any facility subject to the Federal Animal Welfare Act be conditioned upon compliance by such facility with the provisions of the federal act. Also exempts the giving or selling of cats to research institutions subject to the provisions of the Federal Animal Welfare Act from specified provisions relating to the spaying or neutering of cats.

Governor Ronald Reagan today signed legislation that will provide \$13 million in state emergency funds for repairs to public facilities damaged by the recent Southern California earthquake.

The emergency bill (AB-25) authored by Assemblywoman Pauline Davis (D-Portola), extends the same relief to public agencies with facilities suffering earthquake damage that is extended during floods and other natural disasters.

Under the bill, local agencies can file claims for repair and restoration of damaged facilities through June 30, 1971.

The bill (SB 178) was introduced to permit the district to meet an increased enrollment in the 9th through 12th grades which resulted from population growth.

The governor signed the bill at a brief ceremony in his office attended by Assembly Speaker Pro-Tem Carlos Bee (D-Hayward), co-author of the legislation.

AB 93 - Lanterman (Chapter 12)	Validates the organization, boundaries, acts, proceedings, and bonds of counties, cities, and specific districts, agencies, and entities. The bill is known as the First Validating Act of 1971.
AB 181 - Belotti (Chapter 13)	Specifies that certain property otherwise eligible for assessment as open-space lands shall be so assessed for the 1971-72 fiscal year if the instrument reflecting the fact that the property is enforceably restricted to open-space uses is signed and recorded on or before May 15, 1971.
AB 308 - Sieroty (Chapter 14)	Provides that industrial loan companies may make any loan or purchase or discount any other obligation of less than \$2,500 with maximum term up to 36 months and 15 days rather than acquire any loan or other obligation for such term only if amount is \$1,500 or more but less than \$2,500. It provides that the maximum maturity for loans of industrial loan companies in excess of \$10,000 is 84 months and 15 days.

AB 307 - Mc Alister (Chapter 15) Provides that where an interdistrict attendance agreement for adult classes requires one district to provide the instruction for all districts parties to the agreement, average daily attendance shall be credited to the district in which each adult student resides. The bill applies only to the Metropolitan Adult Program maintained by the San Jose Unified School District.

AB 413 - Belotti (Chapter 16) Authorizes the governing board of any school district to provide for a field trip to Canada, for pupils enrolled in grades 6 to 8, inclusive, and employees essential to the activities of such pupils. The bill prohibits the use of school district funds to finance such trips. The bill remains in effect until June 30, 1971.

AB 565 - Fong (Chapter 10) Allows the governing board of a school district or a county superintendent of schools, to participate in programs authorized by the "Demonstration Cities and Metropolitan Development Act of 1966."

Governor Ronald Reagan today vetoed the so-called "Southern Crossing" bill (AB-151, Crown) and sent the following veto message to the members of the legislature:

"I am returning without my signature Assembly Bill No. 151 entitled, 'An act to add Section 30661 to the Streets and Highways Code, relating to the southern crossing.'

"This bill prohibits construction of the southern crossing of San Francisco Bay prior to statutory authorization for such construction.

"During recent weeks, I have had the opportunity to discuss virtually every aspect of this important issue with individual citizens and civic leaders representing every major segment of the life of the communities which would be most directly affected by this legislation.

"What has impressed me most during the course of these discussions is the extremely wide disparity of view which has been expressed.

"By now, the arguments advocated on both sides of the issue are well known. They have been explored and discussed at length in the public press on numerous occasions and over a considerable period of time.

"The intensity of the arguments and the emotional atmosphere in which they have been debated point to how highly controversial the issue has become and, therefore, how critical and far-reaching any final decision will be. Because the divergence of opinion is so great and the matter so important, I am convinced that the citizens who live in the area must be given the opportunity to make the decision themselves---at the ballot box.

"The judgment of the people was sought directly at the polls in the creation of the Bay Area Rapid Transit (BART) system. Surely, their judgment can be no less vital in making a decision of this magnitude.

"Therefore, I feel I must veto this bill. However, to encourage the direct involvement of the people in any final decision on a Southern crossing I am today issuing an executive order prohibiting any further work on the development of the project, to be effective during the next six months, which will give the legislature sufficient time to work out a plan to bring the issue to a vote of the people in those counties which would be most directly affected.

"Therefore, I am returning the bill unsigned."

AB 19 - Chappie (Chapter 22)	Requires the Board of Supervisors of El Dorado County upon request of the El Dorado Hills County Water District, to levy a bond tax with respect to land only in the district or improvement district benefited by the purposes of the bonded debt.
AB 803 - Waxman (Chapter 23)	Permits an alternative method of computing the minimum school day for a high school when the student bodies of more than one high school are required to attend one high school. Due to earthquake damage, Los Angeles High School had to close its facilities and transfer all of its students to Fairfax High School on a half-day session basis, necessitating that the Fairfax High School student body meet only on a half-day session basis.

AB 82 - Dunlap (Chapter 19)	Allows assignment or subletting by the Upper Solano Association for Retarded Children of its lease of certain state lands within the Medical Facility at Vacaville to any public agency upon approval by the Director of General Services and the Department of Corrections.
AB 107 - MacDonald (Chapter 21)	Requires the board of supervisors of each county to designate a county officer or employee to have the responsibility for developing a coordinated countywide community drug abuse control plan, with various institutions and agencies contributing, and to submit the plan to the board of supervisors. Present law applies only to counties of over 40,000 population.
AB 242 - Gonsalves (Chapter 25)	Authorizes a health planning agency, if it declares that good cause has been shown, to extend until July 1, 1972, the date upon which applicants, who filed applications relating to voluntary area planning programs involving health facilities prior to January 1, 1970, and who received approval of such application prior to such date from the health planning association of the county wherein the applicant is located, are required to commence construction of their facilities.
AB 477 - LaCoste (Chapter 20)	Provides for uniform mileage payments to justice, municipal and superior court jurors in Stanislaus County.
SB 8 - Collier (Chapter 24)	Permits any election officer, rather than only the inspector and judge of election, to be paid for his services as such in a school district election.
SB 430 - Burgener (Chapter 18)	Extends the time for filing a map or plat of a newly created tax zone in a county service area, in order for local jurisdictions to impose taxes in accordance with such change for the 1971-72 fiscal year.

(Chapter 31)	Increases the sum available for school housing aid for exceptional children from an amount not to exceed $3\frac{1}{2}$ percent of the proceeds from the sale of state bonds for school building aid to $3\frac{1}{2}$ percent of the total amount of these bonds which have been or will be authorized for sale.
AB 43 - Chappie (Chapter 32)	Suspends until July 1, 1971, the application of vehicle licensing and certification laws to snowmobile dealers.
AB 44 - Chappie (Chapter 33)	Provides for a loan of up to \$25,000 from the School District Organization Revolving Fund to the Vallecito Union Elementary School District in order to enable the district to plan and provide for the changes resulting from a recent transfer of property to the district and an anticipated in- creased enrollment beginning in the 1971-72 fiscal year. The district will repay the loan plus interest in two equal installments.
AB 137 - Knox (Chapter 34)	Repeals the Government Code provision setting compensation of various county officers. The Constitution was amended by the voters in 1970 to provide that the salaries of county supervisors, district attormys and county auditors be set by each board of supervisors. Formerly, salaries for these officials had been set by the legislature.
AB 219 - MacGillivra (Chapter 35)	ay Transfers two parcels of surplus land in downtown Santa Barbara from the Department of General Services to the Department of Parks and Recreation.
AB 323 - Biddle (Chapter 38)	Amends provisions of various codes to conform to the recently enacted California Emergency Services Act.
AB 1384 - Russell (Chapter 39)	Appropriates \$4,700,000 for the homeowners' property tax exemption in augmentation of Item 292, Budget Act of 1970.
SB 48 - Grunsky (Chapter 37)	Provides that, if a lender finances the purchase of real property or lends money on the security of real property and recommends a particular insurance company or insurance agent to the borrower, the lender must clearly set forth in the recommendation both the name and the mailing address of the recommended insurance company or agent.
SB 136 - Stiern (Chapter 36)	Repeals obsolete provisions of law relating to taxation.
SB 186 - Burgener (Chapter 29)	Provides for the transfer of \$7,623,400 from sums appropriated in the Budget Act of 1970 for categorical aid programs, \$6,936,400 of which is to augment homemaker or attendant services and \$687,000 of which is to augment board and care rate allowances.

AB 120 - Murphy (Chapter 45)	Allows a person between the ages of 18 and 21 years who is registered to vote at federal elections to be appointed to the Republican State Central Committee or elected or appointed to a Republican county central committee.
(Chapter 46)	Defers for one year the repayment of state school building loan apportionments made for 1970-71 for a school district with respect to which the board of supervisors failed to levy a tax on the property in the district sufficient to meet the requirements of the State School Building Aid Law. In 1971-72 the State Controller will deduct as repayment the amount deferred plus a 6 percent penalty charge.
AB 182 - McAlister (Chapter 41)	Adds a grandchild of an employee or spouse of an employee to designated relatives, the death of whom entitles a school certificated or classified employee to a bereavement leave of absence.
AB 283 - Wood (Chapter 42)	Repeals the Fish and Game Code provisions requiring the Department of Fish and Game to report biennially to the Governor. The bill also eliminates provisions specifying size and bag limit for salt water eels in Fish and Game District 3.
AB 354 - Briggs (Chapter 47)	Amends the Western Interstate Nuclear Compact which California has ratified so as to allow each party state one rather than two members on the Western Interstate Nuclear Board. The bill also provides that California's member be appointed by the Governor.
V AB 391 - Pierson (Chapter 48)	Provides that where a county warrant is lost and only a portion of the original amount is still due, the county auditor shall, upon the filing of an affidavit, issue and deliver to the legal owner or custodian a substitute warrant for the amount still due.
AB 408 - Ketchum (Chapter 49)	Repeals the Government Code section which sets a fee of 25 cents for each page for examining the copy of any instrument or document presented for certification purposes concurrently with the document or instrument to be recorded.
AB 939 - Lewis (Chapter 50)	Exempts from prohibitions against discriminatory life or disability insurance practices any questions in applications for such insurance asking for the birthplace of an applicant, if such question is used only to identify the applicant and not to discriminate against him.
SB 84 - Grunsky (Chapter 43)	Provides that, with respect to allowances to the County School Service Fund for the education of handicapped adults, the Superintendent of Public Instruction shall establish a system of priorities which shall give the highest priority to those counties wherein school districts provide no programs or insufficient programs for educating handicapped adults.
SB 115 - Burgener (Chapter 40)	Provides that a bid for the lease or rental of portable buildings or temporary quarters to a school district may include an abstraction of that portion of the bid which may represent tax exempt reimburse- ment to the vendor, lessor, or his assignee.
SB 142 - Teale (Chapter 44)	Provides that when the Senate fails, rather than refuses, to confirm a Governor's appointee by specified session's end, such appointee does not remain in office, and the office becomes vacant. However, the bill provides that a person may be granted an interim appointment to the same office.

Governor Ronald Reagan today announced that he has vetoed AB-110, Campbell. In his veto letter, the governor said:

"I am returning without my signature Assembly Bill No. 110, entitled 'An act to amend Section 11251 of the Education Code, relating to public schools, and declaring the urgency thereof, to take effect immediately.'

"This measure defines 'immediate supervision' of high school pupils enrolled in work experience education programs to include employers. It limits the averate daily attendance for work experience pupils to one unit per pupil per day. The bill also deletes an obsolete provision from the education code.

"Under current statutes, only time spent under the supervision of a certificated instructor may be counted toward the ADA of high school students in work experience programs. Consequently, if a student is to be credited for any time spent on the job, a certificated instructor must be on the premises. This measure would permit high school districts with pupils participating in the work experience program to count time spent by the pupil on the job toward his daily ADA even though no certificated instructor is on the premises.

"While this bill might possibly permit more efficient use of certificated instructors' time or even reduce a school district's requirement for instructors, there is a very real possibility that state costs associated with this measure would be substantial. I do not believe that the potential fiscal impact of AB-110 was fully considered by the legislature since it was not heard by any fiscal committee.

"I recommend that the legislature consider establishing a pilot program in which established guidelines are used to evaluate the effectiveness and fiscal impact of the approach mandated by AB-110.

"Accordingly, I am returning the bill unsigned."

AB 330 - Z'berg

(Chapter 55)

AB 104 - Deddeh (Chapter 69) Authorizes the board of directors of a fire protection district to provide for the establishment of a petty cash fund, in an amount not to exceed \$500 rather than in an amount not to exceed \$50, to be used to pay small bills.

AB 106 - Hayes (Chapter 53) Requires, before final distribution of an estate, that the federal estate tax and state inheritance taxes be paid or that evidence of agreement for payment of such taxes between the taxing authority and the executor, administrator, or other persons liable for payment of such taxes be filed. The bill authorizes the Controller to make such agreements respecting inheritance taxes in cases of hardship.

AB 138 - Knox (Chapter 70) Provides that the requirement that the clerk of the court submit a copy of probation order and any subsequent changes in probationary status to the arresting or investigating law enforcement agency applies to a probationer who is under the care and supervision of a probation officer. The bill also provides for summary probation in infraction cases as well as misdemeanor cases.

AB 173 - Hayes (Chapter 61) Provides that the Member of the Assembly who is a member of the Consumer Advisory Council shall be appointed by the Speaker of the Assembly rather than the Assembly Rules Committee.

AB 246 - Townsend (Chapter 67) Exempts from the definition of retail food production and marketing establishments roadside stands whose retail sales solely consist of produce, or shell eggs. It requires the State Department of Public Health to adopt specified rules and regulations relating to such stands. The bill authorizes use of specified sawdust, or any other anti-slip agent authorized by the Department in certain areas, but prohibits use of such sawdust or any other antislip agent on floors in work areas constructed after effective date of the act. The bill also expressly permits use of carpets on floors in sales area or areas generally used by the public.

AB 288 - Dent Renumbers a Government Code Section relating to city (Chapter 54) incorporation. The bill makes no substantive changes in the law.

AB 299 - Johnson, R. Requires levee district board of directors to (Chapter 62) utilize the county assessment roll for the district as the basis for district taxation and that such taxes be collected at the same time as county taxes.

AB 311 - DentMakes various technical changes in provisions of<br/>(Chapter 63)(Chapter 63)State School Building Aid Law of 1952 and the State<br/>School Building Aid Bond Law of 1952.

AB 312 - Dent (Chapter 64) Validates certain final apportionments of state school building aid based on conditional apportionments made prior to the 61st day after final adjournment of the 1971 Regular Session.

> specifies that the cost of collection of a local tax levied under the Pleasure Riding Tax Law shall be paid from revenues collected by such levy and allows the use of funds for maintenance, as well as acquisition and construction, of riding trails.

Increases the fee for recording the first page of documents from \$1 to \$2 and the fee for each SB 46 - Stiern (Chapter 59) additional page recorded from 80 cents to \$1. The bill also increases the fee for filing papers from \$2 to \$3. SB 78 - Nejedly Makes provisions authorizing declaratory relief action by public agencies in case of attempted acquisition of agency-owned land for highway (Chapter 68) purposes also applicable to attempted acquisition for public utility route or structure purposes. Governor Ronald Reagan today signed legislation which will reduce real estate license fees mor than one half million dollars a year.

The bill, (AB 324) by Assemblyman Peter Schabarum (R-Covina), will allow the reduction in fees--the first in 40 years--because the Department of Real Estate has reduced the cost of operations.

"I am delighted that these savings can be passed on to licensees whose fees support this department, especially at a time of rising costs and pressures by some for increased taxes," the governor said.

Real Estate Commissioner Robert W. Karpe announced that public hearings will be held to determine the exact amount the fees can be reduced.

Karpe said he will continue to maintain economies in the administration of the Department of Real Estate without lessening service to the licensees and the public.

AB 277 - Ketchum (Chapter 82) Discharges the Director of Agriculture from accountability for the collection of sums up to \$5 instead of \$3 when it is impractical to collect such amounts, and increases from \$3 to \$5 the amount of a refund which may be retained by the Director unless a request for a refund is made.

AB 420 - Barnes (Chapter 76) Amends definition of "final compensation" for purposes of computing benefits under the Public Employees' Retirement Law to an average annual compensation earnable in last three consecutive years of employment or in three other consecutive years indicated by the member.

AB 553 - LaCoste (Chapter 77) Amends the salary schedule and salary ranges for the various attaches of the Modesto Municipal Court.

SB 33 - Burgener (Chapter 78) Prohibits the placement of a minor child in a special education class for the mentally retarded unless the results of a complete psychological examination substantiates the retarded intellectual development indicated by the individual test scores. It generally prohibits such placement if the child scores higher than two standard deviations below a specified norm but permits such placement in exceptional circumstances. The bill also prescribes procedures relating to obtaining the written consent of the parent or guardian for the admittance of a child into a special education program for mentally retarded minors.

SB 85 - Grunsky (Chapter 73) Provides that regularly employed coroners and deputy coroners are peace officers. The bill prohibits coroners and deputy coroners from carrying concealable weapons, unless authorized to do so by ordinance or resolution of the county board of supervisors.

SB 111 - Grunsky (Chapter 74) Provides that at an election of harbor district commissioners, held subsequent to the first election of commissioners, all candidates shall file nomination papers with the board of commissioners of the district not more than 99 nor less than 74 days, rather than not more than 85 nor less than 60 days, before the day of election.

SB 145 - Collier (Chapter 75) Permits a candidate for a local elective office to file a statement of qualifications with the clerk when his nomination papers are returned for filing if the office for which he is a candidate has no nominating election. The bill also provides that if a statement of qualifications is filed for an election for which nomination papers are not required, the statement shall be filed no later than the 59th day before such an election. It also increases the word limitation in the statement of qualifications from 150 to 200 words.

SB 167 - Marler (Chapter 31) Exempts from the licensing requirements of the Outdoor Advertising Act manufacturers or distributors of a product for sale who install or furnish for installation to a retailer of that product a sign which contains advertising pertaining to either or both the product and the name of the business or retailer.

SB 276 - Deukmejia (Chapter 79)	n Requires that physical performance tests, which school districts are required to administer to pupils, be given in any three grades designated by the Board of Education, rather than in grades 6 and 12.

Modification of this charter provision is presently being considered by the San Francisco Board of Supervisors. This is an issue that should be decided by the people of San Francisco.

Accordingly, I am returning the bill unsigned."

(Reduction: \$2,436) I have reduced this item to eliminate funds for a salary increase for the executive secretary. Item 62 For support of the Military Department. I reduce this item from \$4,152,938 to \$4,112,938. (Reduction: \$40,000) I have eliminated the augmentation for security fencing at Camp San Luis Obispo. Funds included in my budget already meet the highest priority security problems of the Department. Item 61 For support of California Commission on Interstate Cooperation. I reduce this item from \$115,530 to \$110,730. (Reduction: \$4,800) I am eliminating funds proposed for operating expense and travel. This item provides State reimbursement to local jurisdiction for the costs of lands, easements, and rights-of-way related to authorized flood control projects. The \$4,000,000 appropriation level is considered sufficient to meet the needs for projects currently authorized under State law. Local participation in flood control projects is essential before any added projects may be considered.

Item 279

For transfer by State Controller to the Teachers' Retirement Fund. I reduce this item from \$98,000,000 to \$20,000,000. (Reduction: \$78,000,000)

The State Teachers' Retirement Fund has sufficient resources available in contingency reserve funds, which when added to this appropriation are sufficient to maintain retirement benefits. These reserve funds are by law available for contingency purposes. We have determined that the contingency of adverse actuarial experience is a factor which must be recognized. The board of administration has authority to insure that benefit payments will be made in an orderly and timely manner.

This is an unusual year, one which requires that we face up to hard fiscal realities. The relationships we have developed jointly with state employee organizations have already resulted in improved employee benefits, including premium pay for overtime, night shift differential, an improved retirement plan, unemployment insurance coverage for state employees, added employee health benefits, and a "meet and confer" procedure which I established by executive order to permit employees and their spokesmen to confer directly with my representative.

For University salary increases. I eliminate this item. (Eliminated \$18,030,000)

In addition to the reasons I have cited in Item 80.1, salaries in the University remain in the top 5 percent of all universities in the country. At a time when the resources of these same universities, as well as those of this State, are strained, further salary increases cannot be granted.

> In addition to the reasons I have cited in Item 80.1, at a time when State resources are strained, no additional salary increase can be granted.

> I have reduced funds for the Duffy-Moscone Family Nutrition Education and Services Act of 1970 since increased Federal funding will enable the program to expand dramatically to meet child nutrition needs in the schools. Last year, the State received approximately \$33 million in federal funds. It is anticipated that in 1971-72 the State will receive approximately \$60 million for child nutrition programs in California schools.

#### Item 263.5 For support of the master teacher program, Department of Education. I eliminate this item. (Eliminated: \$150,000)

Legislation now before the legislature carries an appropriation for this same purpose.

For transfer by the State Controller from the General Fund Item 270.1 to the State School Fund. I eliminate this item. (Eliminated: \$100,000,000)

> I have eliminated this item inasmuch as there has been no clearly demonstrated need for additional funds nor any identification of the benefits which may be expected.

Item 273 For support of special elementary school reading instruction programs and Project SHARE pilot tutoring programs, Department of Education. I reduce this item from \$18,835,000 to \$18,360,000. (Reduction: \$475,000)

> I have reduced this item to the amount originally budgeted. Funding for the SHARE program can satisfactorily be accomplished within budgeted funds by means of special legislation now before the legislature.

Item 273.5 For Mathematics Improvement Program, Department of Education. I eliminate this item. (Eliminated: \$925,000)

> This program has not shown the results necessary to warrant continued funding.

For support of Children's Centers, Department of Education. I reduce this item from \$21,750,000 to \$19,750,000. Item 274 (Reduction: \$2,000,000)

> I find it possible to reduce this item inasmuch as additione. resources will become available for this program through the use of State and local in-kind matching funds.

Item 277 For assistance to public libraries, Division of Libraries, Department of Education. I reduce this item from \$1,800,000 to \$800,000. (Reduction: \$1,000,000)

> I have reduced the funds in this item in order to assure that funds are available for higher priority programs in public education.

Item 278.5 For support of summer vocational and technical education programs, Department of Education. I eliminate this item. (Eliminated: \$71,000)

> I have eliminated this item in the absence of positive results from previous expenditures for this program.

Item 284 For research in conversion of sea water, University of California. I reduce this item from \$334,900 to \$308,100. (Reduction: \$26,800)

> This level of budget finances the planned University program.

Item 285 For research in dermatology, University of California. I reduce this item from \$100,000 to \$92,000. (Reduction: \$8,000)

> This level of budget finances the planned University program.

Item 293 For support of State Scholarship and Loan Commission. I reduce this item from \$22,853,000 to \$20,000,000. (Reduction: \$2,853,000)

> This program has grown from 5.7 million dollars in 1967-68 to 20 million dollars for 1971-72. The number of awards in this same period has increased from 6,902 in 1967-68 to 21,509 in 1971-72. This represents a quadrupling of funding for the program over a four-year period.

Item 229 For transfer to the Health Care Deposit Fund to provide for Medical Assistance Program expenditures. I reduce this item from \$734,877,719 to \$597,097,750 and reduce the County Option Program limitation from \$65,000,000 to \$35,000,000. (Reduction: \$137,779,969)

> I am reducing this appropriation to reflect the most recent cost estimates for implementation of the Medi-Cal Reform Plan. I am also reducing the County Option Program limitation to the amount originally budgeted. This appropriation is consistent with the legislature's appropriation for welfare. It is within the power of the Administrative and Legislative branches to provide meaningful reform for this program.

Item 242 For support of Department of Mental Hygiene. I reduce this item from \$19,888,465 to \$16,360,075 and I am eliminating the restrictive language requiring me to continuously operate all state hospitals during 1971-72. (Reduction: \$3,528,390)

By reducing admissions to DeWitt and by accelerating the placement of patients into community facilities, the Department will be able to operate the hospital within the funds I have proposed. With the continuing decline in state hospital population, it is neither economical nor desirable from the patients viewpoint to continue operating all the hospitals. Item 305 For capital outlay, Department of Navigation and Ocean Development. I reduce this item of \$430,000 to \$230,000 by eliminating the construction of launching ramp at Crescent City. (Reduction: \$200,000)

> I am eliminating this project because it is not of sufficient priority in the building program of the Department of Navigation and Ocean Development.

AB 569 - McAlister Requires school districts to furnish every classified employee and his supervisor with twice yearly statements showing the employees' sick leave and vacation accrual. In addition, school districts must inform each classified employee who is paid on an hourly basis his rate of pay at least once a month.

# REASON FOR VETO: "I do not believe that school districts should be compelled to provide classified employees with their hourly rate of pay on a monthly basis when such information is now readily available to such employees. The bill mandates added cost to school districts, without a corresponding benefit to the employees concerned.

Accordingly, I am returning the bill unsigned."

AB 101 - Mobley (Chapter 259)	Makes the violation of provisions relating to weight limitations by vehicles upon highways, except in cases of weight violations where the amount of excess weight is less than 4,501 pounds, a mis- demeanor, rather than an infraction. The bill also reduces from \$55 to \$50, the fine for violation of weight limitations when the amount of excess weight is in the range of 4,251 - 4,500 pounds.
AB 236 - MacDonald and LaCoste (Chapter 260)	Requires notification of the Department of Motor Vehicles of actual mileage, as indicated by vehicle's odometer, of every motor vehicle under 6,001 pounds subject to registration under the Vehicle Code which is transferred or sold by its owner, transferred by sale, lease or otherwise, by a dealer, excluding sale or transfer by such a dealer to another dealer of new unregistered vehicle. The bill specifies that records of the department concerr ing mileage of motor vehicles shall be open to inspection by the public.
AB 369 - Gonsalves (Chapter 261)	Eliminates the present cigarette tax exemption for donations of samples of five or less cigarettes in a packet. It requires donors of cigarettes to collect applicable cigarette taxes from donees and makes the cigarette taxes that must be collected by distributors and donors of cigarettes a debt owed by them to the state.
AB 715 - Fenton (Chapter 262)	Requires issuance of reciprocity certificate authorizing practice as a physician and surgeon to individuals possessing specified qualifications who successfully complete a designated examination.
AB 784 - Fong (Chapter 263)	Provides a procedure whereby a local agency formation commission in a county other than the principal county in which a special district is located may exercise exclusive jurisdiction for any particular proposal over such district.
AB 1035 - Dunlap (Chapter 267)	Requires that classified school employees be furnished written information regarding class specification, salary data, assignment or work location, duty hours, and work week, at the time of initial employment and at each change in classification.
AB 1464 - Knox (Chapter 268)	Revises the provision regarding mailing of notice by a county surveyor of the filing of a proposal for change of district boundaries and requires notice to be given to a city, county, or district the boundaries of which contain any portion of the lands described in the proposal and to each person who has filed a written request for special notice.
AB 1570 - Johnson, I (Chapter 264)	H. Requires that coldpack cheese food be sold in prepackaged form labeled in accordance with specified provisions of the Agricultural Code, rather than requiring such food be sold in the original unopened package.
AB 2782 - Knox (Chapter 265)	Authorizes a board of supervisors to conduct and complete a district annexation, detachment or consolidation after local agency formation commission approval if the affected district fails to act after such approval.

have been signed:

AB 218 - Mobley (Chapter 278 With the Labor Commissioner a time certificate or surety bond, rather than a surety bond only, as a condition to obtaining a license as a farm labor contractor.

AB 767 - Knox (Chapter 279) Eliminates the requirement that the Board of Medical Examiners hold de novo hearings to act upon proposed decisions of its District Review committees under certain circumstances.

AB 909 - Hayes (Chapter 280) Includes "sex" within the Labor Code provisions relating to discrimination in any recruitment and apprenticeship program and specifies that discrimination on basis of "ancestry" is within those prohibitions. The bill also includes "sex" in provisions prohibiting discrimination in the employment of indentured apprentices on public works.

AB 1007 - Townsend Authorizes voluntary deductions from benefits (Chapter 281) payable under a retirement system established by the County Employees' Retirement Law of 1937 for payment of state and federal income tax.

AB 1031 - Bee Amends the County Employees Retirement Law of 1937 (Chapter 282) to provide that the lump sum death benefit after retirement, and the lump sum death benefit before retirement of persons with 10 years of service, shall be \$750, rather than \$400.

AB 1507 - Burke Authorizes designated persons to take the state (Chapter 283) examination for a physician and surgeon license.

SB 316 - Carpenter Requires the Department of Alcoholic Beverage Control (Chapter 269) to adopt rules and regulations relating to the notice required to be published by an applicant for an on-sale license. The bill deletes the specific time period within which such notice must be published.

SB 340 - Schrade Makes various changes in the number, salaries, and (Chapter 270) job titles of various officers, attaches, and employees of the municipal courts in San Diego County.

SB 389 - Stiern Excludes from the definitions of "sale" and (Chapter 284) "purchase" for purposes of the Sales and Use Tax Law the serving of food, meals or drinks, which are a part of the board and care of certain mentally retarded recipients of public assistance.

SB 466 - Bradley (Chapter 271) Authorizes a school district governing board to agree with a redevelopment agency for the constructio. of buildings to be used by the district in the project site. The bill also requires copies of notices regarding redevelopment plans and amendments to such plans to be mailed to the governing body of each of the taxing agencies which levies taxes upon any property in the project area designated in the proposed plan.

SB 491 - Moscone Requires the Department of General Services to (Chapter 272) distribute to the California Supreme Court 11 copies and as many additional copies as requested, not to exceed four copies, of the laws, resolutions and journals of the legislature.

	SB 632 - ( (Chapter	273)	Revises terms of office and powers of zone commissioners in the Riverside County Flood Control and Water Conservation District. It also authorizes supervising personnel, employees and equipment of either Riverside County or the district to be jointly used by the county and the district whenever such use is determined to be necessary by their respective boards of supervisors.

The bill provides for submission of the names of candidates for additional directorships at the time the measure proposing an increase in the number of directors is submitted to voters. AB 1186 - Badham Removes the requirement that the Department of (Chapter 290) Finance approve contracts for loans made by the Department of Navigation and Ocean Development to local governmental agencies for boating facilities. AB 1374 - Johnson, R. Changes the salaries and number of positions of (Chapter 291) personnel of the municipal courts in Santa Cruz County and the Chico Judicial District. AB 1497 - LaCoste Repeals the provisions in the Agriculture Code (Chapter 292) relating to sales, production, importation and labeling of egg products intended for human consumption. REASON FOR VETO: "AB 378 could require a premium payment to state employees in the event they are required to serve in response to an appeal from local government to meet a local emergency. The powers enabling me to act in emergency situations are necessary to assure the continued functioning of vital and necessary services when the public welfare is threatened for any reason. This authority should not be encumbered by consideration of the compensation to be paid state employees or by the possible stigma of state interference in a local public agency labor dispute.

"Accordingly, I am returning the bill unsigned."

have been signed:

AB 301 - LaCoste Permits a school district governing board to (Chapter 314) order the drawing of a new warrant to replace a school warrant which has become void.

Includes school districts within the terms "state department or agency" for purposes of the Insurance Code provision relating to placing of life or AB 460 - Knox (Chapter 315) disability insurance with a particular agent, broke or company.

AB 531 - Barnes Extends provision for allowance to survivors of a member who dies after attaining minimum retirement age to all local members of the Public (Chapter 316) Employees' Retirement System.

AB 568 - Keysor Provides that classified school employees laid off because of lack of work or lack of funds have the right to participate in promotional examination (Chapter 317) with a school district during the 39-month period after layoff. The bill also extends to classified employees of a school district not under a merit system, certain provisions relating to layoff and reemployment of classified employees of a schoo district which is under a merit system.

AB 582 - Dent Excepts from the provision granting rights to leave of absence, sick leave and bereavement leave to certificated employees employed by a county superintendent of schools and whose salary is paid from the county school service fund those persons who are civil service employees, merit system employees or were elected to office. The bill also makes applicable to such employees provisions concerning certain rights accorded probationary employees of school districts regarding termination of employment.

> Revises the Education Code provisions regarding the authority of the Superintendent of Public Instruction to grant yearly exemption from class size penalty provisions to a unified school district, to cover a pilot program of team instruction in mathematics, as well as reading, or both, to be conducted in elementary schools approved by the Superintendent of Public Instruction.

Makes technical amendments to the Public Employees' Retirement Law. The bill also modifies the definition of "industrial" as applied to law enforcement members.

Requires registered electrical and mechanical engineers to sign and seal plans, specifications, reports and documents prepared by them or under their direction.

Redefines the term "responsible charge of work" as used in the Professional Engineers Act to describe the nature of the services performed by a registered engineer. The term is presently defined as including "supervision" of engineering projects. The bill eliminates "supervision" and substitutes "direct engineering control."

AB 1920 - Stacey Prohibits persons from managing dispensing (Chapter 328) optician operations at more than one address. AB 1692 - Belotti Extends the time in which the certificate of completion of proceedings for detachment of (Chapter 327) territory from a community service district and from a fire protection district in an annexation by a city may be filed with the Secretary of State,

SB 65 - Carrell Chapter 299

Authorizes investigators employed by a district attorney or the Attorney General to possess tear gas and tear gas weapons.

- Carrell Adds parents who are licensed vocational nurses to the priority list for eligibility in determining the need of a child for childrens centers' services. The bill gives the same priority to licensed vocational nurses that is presently given to registered nurses.

SB 76 - Carpenter Provides for the appointment, compensation, employment Chapter 300 benefits, and administration of personnel of the Orange County Superior Court.

SB 88 - Cologne Chapter 301 Prohibits resort improvement districts from engaging in any activity or providing any service not already engaged in or provided, or budgeted for, as of July 1, 1970. Provides that whenever any activity or service of a district is terminated, it shall not be reactivated.

SB 246 - Bradley Chapter 302 Requires the reporting notes of official court reporters to be delivered to the county clerk when the reporter dies, retires, resigns, is dismissed, or upon any other absence for more than 30 days, and requires the reporting notes of pro tempore court reporters to be delivered to the county clerk upon termination of the reporter's appointment. The bill also permits destruction of court notes after five years instead of 10 years.

SB 335 - Short Chapter 303 Deletes the existing Revenue and Tax Code provisions for refund and cancellation of tax on late filed exemptions for college, cemetery, church, exhibition, orphanage and welfare exemptions. The bill reenacts such provisions as a comprehensive system and limits to \$250 the amount of tax any qualifying organization must pay.

SB 440 - Cologne Chapter 304 Amends the Desert Water Agency Law to permit the adoption of code laws by reference, increases the pay of directors from \$30 to \$50 per meeting, and permits the agency to retain exclusive control over water it makes available. The bill also permits water rates to be fixed at a rate that will repay advances made from the agency's general fund to an improvement district, and provides for termination of bond issuing authority whenever advances made from an improvement bond issue are repaid from other funds.

SB 486 - Bradley Chapter 305 Provides that the prohibition against the Savings and Loan Commissioner, his employees, and specified parties who participated in reorganization, merger, or rehabilitation of a savings and loan association from serving as officer or employee with the reconstituted association for two years after the reorganization, merger, or rehabilitation applies only to a reorganization, merger or rehabilitation in which the Commissioner takes possession of an association's assets or business.

SB 489 - Coombs Prohibits any local governmental body, or any agency thereof, from conditioning the issuance of any building or use permit or zone variance in a specified manner.

SB 558 - Lagomarsino Chapter 307

SB 641 - Coombs Chapter 308 Amends the Mojave Water Agency Act to require any person who intends to drill a water well or to divert surface water within the Mojave Water Agency to file a notice of intention with the agency at least 15 days prior to the commencement of construction. Persons failing to file the required notice will be subject to a civil penalty.

Increases the daily rate for court reporters pro tempore when they are on duty in the Santa Barbara Superior Court.

\_\_\_\_\_SB 663 - Bradley Requires reserve deposits or funds on credit life Chapter 329 Requires reserve deposits or funds on credit life insurance and credit disability insurance ceded to a nonadmitted reinsurer to be deposited in bank located in California in order to receive credit in accounting and financial statements on account of such ceded reinsurance.

SB 772 - Coombs Chapter 309 Authorizes the Crestline-Lake Arrowhead Water Agency to supply and deliver water to any property not subject to agency taxes, rather than to specified public agencies and property, at such special rates, terms, and conditions as the agency board may determine.

SB 840 - Cologne Chapter 310 Revises the procedures and conditions for issuance of callable bonds by reclamation districts, authorizes municipal water districts to disseminate information concerning rights, properties and activities of the district, increases permissable standby charges on a parcel of less than one acre from \$5 to \$10, authorizes municipal water districts to enage in the garbage collection and disposal business, and authorizes municipal water districts to issue bond anticipation notes where the bonds have been approved by the people.

SB 1134 - Moscone Provides for transfer of the Palace of Fine Arts Chapter 311 from the Department of Parks and Recreation to the City and County of San Francisco.

SB 1263 - Gregorio Allows the City of Millbrae to use lands previously Chapter 312 owned by the state for park and open spaces purposes rather than for street and highway purposes only.

SB 1636 - Kennick Authorizes general law cities which did not impose Chapter 313 a property tax for the 1970-71 fiscal year to pass an ordinance prior to July 15, 1971, rather than on or before March 1, 1971, which would provide for the levy and collection of the city's property tax by the county for the 1971-72 fiscal year.

Governor Reagan also announced the following bill has been vetoed:

- ---SB 150 Dymally This bill deletes the Elections Code requirement that all proceedings at the polls be conducted in English, and the prohibition against election officials speaking a language other than English.
  - REASON FOR VETO: The repeal of Section 14217 only adds uncertainty to the already confused state of California's election law. It merely would remove the current negative prohibition in the law requiring English to be the language used by election officials at polling places. By failing to create anything positive in its place to fill the void, it would create more uncertainty as to the duties and obligations of election officials.

Governor Ronald Reagan today announced the following bills have been signed: AB 1310 - Foran Exempts from certain reporting requirements of (Chapter 342) Retirement Systems Disclosure Law a retirement

system in which all contributions are paid to state or federal savings and loan associations doing business in this state. The bill also grants authority under specified conditions to domestic savings and loan associations to act as trustee of specified stock bonus, pension or profit-sharing plan and provide for the sale of checks, including travelers checks and money orders.

- AB 1704 MacGillivray Permits employers to pay executive, administrative (Chapter 343) and professional personnel once a month at the end of the month, or not later than seven days following the close of the pay period.
- AB 1746 Chappie Provides that no fee for the change of address of a (Chapter 344) real estate licensee shall be charged where there is no physical change in location of his office.
- AB 2242 Russell Requires an irrigation district collector upon an (Chapter 345) assessment becoming delinquent to collect, in addition to the assessments due and specified penalties and costs, the costs of publication of the list of delinquencies and notices.
- AB 3095 Monagan (Chapter 346) Provides that on or after June 30, 1971, no state officer or employee shall be deemed to have a break in service or to have terminated his employment, for any purpose, solely because of the failure to enact a Budget Bill for the 1971-72 fiscal year prior to the end of the preceding fiscal year. The bill also provides that any officer or employee who entered state service between June 30, 1971, and the effective date of the Budget Bill for the 1971-72 fiscal year shall be considered a state officer or employee from the time he entered state service until that date, notwithstanding the failure to enact a Budget Bill for the 1971-72 fiscal year prior to his entry into service.
- SB 90 Mills Provides that the Department of Public Works and (Chapter 332) the California Toll Bridge Authority shall consider the inclusion of bicycle and pedestrian access on all future toll bridges except the Southern Crossing.
- SB 248 Coombs Sets forth as an additional basis for setting aside (Chapter 333) a conviction that defendant has been discharged prior to termination or probation or a court has determined that such relief should be granted.
- SB 454 Kennick Extends the scope of the California Highway Patrol's safety regulations to include any combination of a two-axle truck and pole, pipe or logging dolly which exceeds 40 feet.
- SB 511 Carrell Authorizes the Department of Motor Vehicles to cancel (Chapter 335) driving school operators and driving instructor licenses issued in error or voluntarily surrendered and permits immediate reapplication at no fee.
- (SB 664 Bradley (Chapter 336) Amends, adds and repeals various sections of the Insurance Code, consolidating, without change in amount fees for variable annuity agents' applications and licenses into general fee provisions for production agencies. The bill also provides that specified provisions relative to inactivation and reactivation of underlying life agent's license shall apply to a variable annuity agent's license.
- SB 116 Deukmejian Makes state employees in the positions of "institution (Chapter 331) fire chief" or "institution fireman" safety members of the Public Employees' Retirement System.

SB 665 - Bradley Chapter 337	Exempts all insurers, rather than only life insurers, from the prohibition against admitted insurer's officers, directors, trustees, and any person having authority in management of insurer's funds, from certain insider financial dealings with the insurer if such officers, directors, or trustees do not own more than 5 percent of stock of any corporation with which the insurer is entering into transaction.
SB 667 - Bradley Chapter 338	Requires surplus line brokers to file on or before May 1, rather than March 1, a sworn statement of all business transacted during last preceding calendar year. The bill also requires that each surplus line broker, on or before May 1, rather than July 1 of each year, to pay the gross premiums tax on business done by him in the preceding calendar year.
SB 721 - Carpenter Chapter 339	Requires the Insurance Commissioner to mail, on or before March 15 of year of expiration of a permanent license of an insurance production agency, a renewal application for such license to the licensee or the employer in the case of a solicitor. The bill also deletes the requirement that the Insurance Commissione notify insurance production agencies of impending license expiration and eliminates the requirement to maintain a list of such production agencies so notified.
SB 1183 - Burgener Chapter 340	Eliminates provisions limiting authority of irrigation districts to provide for sewage disposal to districts meeting specified qualification as to size of district and purpose for which water is supplied by district.
SB 1233 - Bradley Chapter 341	Makes reciprocals subject to all of the provisions of the Insurance Code, except for listed exemptions.

Governor Reagan also announced the following bill has been vetoed:

SB 469 - Alquist Requires that the administration and maintenance portions of the annual State Highway Budget be subject to Department of Finance and legislative approval and that the remaining portions of the budget be subject to the approval of the California Highway Commission. It also removes the monetary limitations relating to the funds which may be spent for administration, maintenance and landscape maintenance.

**REASON VOR VETO:** "There appear to be several inherent defects in this legislation. It would leave the California Highway Commission responsible for preparing the capital outlay portion of the State Highway Budget without the authority to assure that such work is adequately supervised. The bill would also create serious timing problems in that the state highway capital outlay program must be undertaken six months prior to the time when the portion of the budget covered by this bill would be established. My action, however, is based primarily upon the belief that enactment of SB 469 and bills like it at this time would be premature. I recognize that the State Highway Budget procedure should be substantially overhauled. For more than a year now, a multidisciplinary task force has been engaged in an intensive review of the existing highway budget process. It appears that this group will be in a position to make recommendations for changes prior to January 1, 1972, at which time it is anticipated that substantive changes will be recommended to the legislature," the governor said.

-AB 271 - Z'berg Provides unemployment insurance benefits to permanent (Chapter 353) and probationary state civil service employees who are laid off after March 1, 1971 for reasons of economy, reorganization or reduced work load.

AB 579 - Cline Appropriates \$1 million from the Veterans Farm and (Chapter 362) Home Building Fund of 1943 to indemnify Cal-Vet purchasers for damages to their properties in excess of \$250 as a result of the earthquake of February 9, 1971, and its aftermath.

AB 924 - Knox (Chapter 354) Provides that when a county proposes to establish an agricultural preserve under the California Land Conservation Act of 1965, notice need only be given to those cities within the county within one mile of the preserve, rather than to any city within one mile of the preserve.

AB 1444 - Ketchum Increases the salaries of regular and pro tempore (Chapter 355) court reporters in Kern County.

AB 1589 - Schabarum Specifies that transportation services rendered as (Chapter 356) contract carriage and not as common carriage of passengers is not exempt from fuel taxes, rather than present reference to charter-party carriers of passengers. The bill is intended to clarify the definition of "charter party carriers of passengers" for the purposes of the fuel tax exemption.

AB 1592 - Biddle (Chapter 357) Provides that where the person who would consent to issuance of a student license to certain students and accept liability for civil damages is a nonresident, or the student is a foster child, then prescribed school officials may certify that the school has filed a specified certificate that an insurance policy or surety bond is in effect to cover such liability so that a student license may be issued.

AB 2125 - Hayden Provides that when required by local ordinance, a (Chapter 358) tentative subdivision map shall be submitted for approval as to flood and water drainage control, as well as area and lot design.

- AB 2281 - Monagan Makes several technical changes in the statutes (Chapter 359) relating to the sale of bonds by water conservation districts, including an increase in the maximum interest rate payable from 6 percent to 7 percent.

AB 2297 - Warren (Chapter 360) Makes temporary teaching certificates and permits issued by county boards of education valid for not more than one school year, rather than for not more than 120 days, and only until the credential or permit originally requested is either issued or denied by the State Board of Education. The bill's provision become inoperative on January 1, 1973, or at such earlier date as the Commission for Teacher Preparation and Licensing may determine.

SB 64 - Lagomarsino Revises the Fish and Game Code to provide regulations (Chapter 347) for oyster cultivation separate from regulations for shellfish culture which would be termed "mariculture." The bill also established procedures for the leasing of state water bottoms for cultivating marine life (mariculture). SB 620 - Gregorio (Chapter 348) Provides that a board of supervisors may establish by resolution and fund a municipal advisory council for any unincorporated area in the county, the council to advise the board on specified matters relating to the area.

SB 751 - Bradley (Chapter 352) Provides for a procedure by which the California Highway Commission may make minor modifications to the adopted location of a freeway within the boundaries of a local agency upon request of the local agency.

SB 883 - Dills (Chapter 349) Provides that employees of a bookstore maintained by a community college are classified employees of the school district and eligible for membership in the district retirement system. The bill also provides for entry without the examination into the classified service of a school district of persons who were employed in a community college bookstore maintained by a student body organization immediately preceding becoming an employee of a community college bookstore maintained by a school district.

SB 1036 - Whetmore Allows a general law city, upon voter approval, to (Chapter 350) impose a special charge on businesses and residences in an amount not to exceed \$3 annually for a period not to exceed 5 years. The revenues derived from any such charge are to be used for sidewalk installation on the city's select street system.

SB 1552 - Short Revises the compensation schedule of Sacramento (Chapter 351) Municipal Court attaches.

Governor Reagan has vetoed the following bill:

SB 235 - Alquist Increases the number of public members on the Coordinating Council for Higher Education from six to eight. The bill authorizes the governor to appoint four public members, the Senate Rules Committee to appoint two public members and the Speaker of the Assembly to appoint two public members.

REASON FOR VETO: "The Coordinating Council for Higher Education was reconstituted only last year through the enactment of AB 73. Furthermore, the composition and qualifications of the Council are an integral part of California's Master Plan for Higher Education. Two distinguished and capable bodies are now reviewing this plan: The Legislature's Joint Committee on the Master Plan, and a select committee appointed by the Coordinating Council. The recommend. tion of these bodies should be available and subject to analysis before further substantive changes are considered.

"Accordingly, I am returning the bill unsigned," the governor said.

Governor Ronald Reagan has signed what he calls "the most advanced legislation in the area of tenure ever considered in California.'

The legislation (AB 293) by Assemblyman John Stull (R-Encinitas) will help insure that "California elementary and secondary school children will be taught by competent and responsible instructors and at the same time provides increased job protection for qualified teachers," the governor said.

The new law establishes a hearing procedure through which dismissed instructors will be heard by a Commission on Professional Competence. It neither abolishes tenure nor changes basic regulations governing dismissal of teachers. Hearings will be conducted by an officer from the state Office of Administrative Procedure before the three-member commission.

The legislation also directs school districts to develop guidelines for evaluating the competence and performance of teachers and requires twice-a-year written evaluations on teachers which must be presented to them.

Under the law, if a teacher's performance is unsatisfactory his employer must confer with him, make recommendations for improvement and provide assistance in achieving standards of professional competence.

"Assemblyman Stull's bill answers demands from school boards, parents and from educators themselves and has gained support of the major teacher organization. It will make it possible to weed out incompetents from our educational system and, at the same time, protect and encourage dedicated educators," the governor said. "Those with the most to gain are our school children," he added.

Governor Ronald Reagan today signed AB 1195 authored by Assemblyman Vincent Thomas (D - San Pedro).

Upon signing the bill, the governor said, "I am aware there is controversy over AB 1195 which has just reached my desk. It seems to me this controversy should properly be resolved by the people of Los Angeles County and their county representatives. The Los Angeles Board of Supervisors voted 4 to 1 against requesting a veto of this measure and the chairman of the board, Warren Dorn, personally requested that I sign it as a matter properly coming within the jurisdiction of county government. Apparently both houses of the state legislature shared this view as indicated by their unanimous vote to permit county disposition of the problem.

"I am therefore signing this bill which gives permission to Los Angeles County to resolve this matter itself."

been signed:

- AB 289 Fenton (Chapter 375) Permits a buyer to cancel door-to-door sales contracts for consumer goods or services within three days of the contract date or until seller complies with a requirement that the buyer be advised of his rights to cancel the contract. The bill does not apply to sales where the goods are affixed to real property or to contracts covered by federal law. The seller is entitled to the return of the goods involved in the sale where the buyer cancels the contract. Emergency repair services are also excluded from the provisions of the act.
- AB 291 Ralph (Chapter 376) Requires a prime contractor on public work or improvement contracts to list persons who will specially fabricate a portion of the work or improvement, in an amount in excess of one-half of the one percent of the prime contractors total bid, off the jobsite, in addition to subcontractors currently required to be listed.
- AB 315 Townsend Provides that a recognizable dead human fetus of less (Chapter 377) than 20 weeks uterogestation, not disposed of by interment, shall be disposed of by incineration. It also provides that recognizable anatomical parts, human tissues or anatomical human remains, following conclusior of scientific use, shall be disposed of by interment or incineration. The bill makes it a misdemeanor to dispose of fetal remains in a public or private dump, refuse or disposal site.
- AB 497 Vasconcellos Provides that under specified conditions, an (Chapter 363) applicant for a driver's license participating in an approved methadone maintenance treatment program may be issued a driver's license and that such participation shall not be grounds for revoking or suspending his license.
- AB 1723 Cullen Allows a local election board to provide that at local (Chapter 364) elections, in precincts of fewer than 500 registered voters where ballots are to be counted by means of an electronic or electromechanical device of a punch card voting system, the precinct board may consist of one inspector and two judges.
- AB 1874 Hayden Provides that a recall petition for a city councilman (Chapter 365) elected by district need be signed by 25 percent of the voters of his district rather than 25 percent of the voters of the city. The bill conforms the Elections Code to existing Government Code provisions relating to eligibility to sign recall petitions.

AB 1877 - Hayden Suspends the right of a city council to determine (Chapter 366) contested elections of city officers during the period of time in which an elector who previously filed a written statement to contest the election was entitled to file that statement. The bill permits a city council to determine the contest upon the expiration of the suspension period if either no proceedings have been instituted as a result of an elector's filing of a statement of consent or such proceedings are terminated without a judgement being rendered by the court. The bill eliminates a conflict between provisions of the Government Code and the Elections Code. AB 2246 - Russell Revises the format requirements for sample ballots. (Chapter 367)

- SB 267 Nejedly Provides that the salary of a full-time certificated (Chapter 369) employee of a school district shall be pro rated over a 12-month period for the purposes of determining eligibility for aid to families with dependent children. The bill was introduced to prevent teachers from qualifying for welfare during the summer months.
- SB 551 Cologne Makes it unlawful for any person to compute at the time (Chapter 370) of sale of a commodity a value which is not a true extension of a price per unit which at that time is advertised, posted or quoted; to fail to deliver for test devices ordinarily tested at central locations under designated circumstances; or to alter by adding to tare weight of a vehicle under designated circumstances.
- SB 552 Cologne Revises the amounts of certain approved expenditures for (Chapter 371) recreation land acquisition, and certain approved joint cost allocations for recreation and fish and wildlife enhancement associated with state water projects, made by the Department of Water Resources.
- SB 652 Way (Chapter 372) Exempts milk and milk products processed in California for sale outside of the state from the labeling requirements of the Agricultural Code. The bill does not exempt such products from standards of composition and wholesomeness.
- SB 653 Way (Chapter 378) Defines county responsibility for making aid payments for a patient in a voluntary, nonprofit, or proprietary facility or other public or private institution, as the county from which such patient was admitted.

SB 750 - Burgener Authorizes a community college district to enter into (Chapter 373) an option to purchase, or lease with an option to purchase a proposed building site. The bill provides that the existence of such an agreement shall not affect the determination of the state's share of the cost of the project under the Community College Construction Act of 1967.

SB 1547 - Short Amends the Barber Law with respect to the length of (Chapter 374) the course in barber college, the curriculum therein and length of the apprenticeship periord.

AB 314 - Townsend (Chapter 382)	Requires that asbestos-containing materials used in air duct systems in buildings after the effective date of the bill be overcoated with a sealant adequate to preclude erosion of asbestos fibers.
AB 611 - Lanterman (Chapter 383)	Appropriates \$29,708 from the Motor Vehicle Transportation Tax Fund for transfer to the State School Fund for severance aid allowances to school districts during the 1970-71 fiscal year. This bill implements 1970 legislation which authorized severance aid allowances to school districts for property acquired for state highway purposes.
AB 707 - Cory (Chapter 384)	Allows the Superintendent of Public Instruction to designate a representative from the Department of Education to be on the Curriculum Commission and serve as its chairman.
AB 816 - Knox (Chapter 385)	Authorizes sanitary district boards to increase membership from five to seven within two years after a sanitary district consolidates with or annexes territory of a district with substantially identical powers.
AB 1100 - MacDonald (Chapter 386)	Authorizes the Ventura County Flood Control District to make ordinances relating to specified flood control, increases the limit above which bid contracts must be let for materials and supplies, and provides that the district may purchase equipment and other personal property as well as materials and supplies subject to this new limit.
AB 1697 - MacGillin (Chapter 381)	vray Repeals provisions regarding transportation of abalone meat out of the state. It eliminates provision prohibiting the taking of black abalone for canning or drying purposes. The bill also includes San Clemente Island within other specified islands where abalones may be taken for commercial purposes in less than 20 feet of water.
AB 1647 - Stacey (Chapter 380)	Expressly authorizes local authorities to delegate to the road commissioner or comparable officer in the county or municipality any or all powers granted local authorities in prescribed Vehicle Code provision relating to vehicle permits and agreements.
AB 1332 - Barnes (Chapter 379)	Provides that a local public agency must request quotation of contribution required for change in retirement benefits from the public Employees' Retirement System if requested to do so by a recognized employee organization of its employees and the employee organization pays agency cost for this quotation.
AB 1840 - Cory (Chapter 387)	Provides that the board of supervisors of one or more counties may loan up to \$50,000 to a transit district located wholly or partially within such county or counties for transit planning and development during the year following voter approval of the district's organization.
AB 1883 - Wood (Chapter 388)	Authorizes the Monterey County Flood Control and Water Conservation District to construct and operate recreational facilities and to license docks or other structures on its reservoirs or property.

AB 2115 - Cory (Chapter 389)

Provides for terms of the board of directors of the Orange County Transit District. It empowers the board to appoint its own clerk and grants specified per diem compensation to board members. The bill also provides that taxes levied to meet bonded indebtedness and interest of the district shall not be included in five-cent maximum levy per \$100 assessed valuation. The bill further provides that formation of the Orange County Transit District shall be effective for assessment and taxation purposes for the 1971-72 fiscal year if certain conditions are met.

AB 2290 - Burton Exempts the Legislative Counsel and his employees (Chapter 390) from the Government Code provision requiring approval of the governor and the director of Finance for travel outside the state.

Covernor Reagan has vetoed the following bill:

AB 440 - Cory Provides that vacancies on boards of supervisors may be filled by election if they occur more than one year prior to the next general election, rather than by appointment by the governor. The bill provides that the governor shall fill the vacancy if the board does not call an election within 60 days.

REASON FOR VETO: "The bill does not apply to any county where the charter provides for a different method of filling vacancies on the board of supervisors. AB 440 unnecessarily complicates the process for filling vacancies on boards of supervisors. There has been no showing that the present method of filling such vacancies has been other than acceptable to the counties of this state.

"Accordingly, I am returning the bill unsigned," the governor said.

AB 168 - Barnes Defines and standardizes retirement terms used in (Chapter 407) the Teachers' Retirement Law regarding credited and charged interest, return on the investment portfolio and tax-sheltered annuities and/or contributions.

AB 691 - Briggs (Chapter 409) Amends the Insurance Code to provide that, with reference to insurance required in connection with sales of real property or loans secured by real property, the lender's disapproval of the insurer selected by the purchaser or borrower must be based upon reasonable cause. The bill requires the Superintendent of Banks, the Savings and Loan Commissioner in conjunction with the Insurance Commissioner to jointly promulgate and issue regulations defining "reasonable cause".

AB 820 - Porter (Chapter 408)
Increases the per diem of members of the Reclamation Board from \$20 to \$25 for each day attending meetings of the board, not to exceed \$2,000 in any one year. The present per diem amount has not changed since the Board's formation in 1913.

AB 821 - Porter Requires compliance by all public agencies, (Chapter 410) including the State, with floodplain regulations established pursuant to the Cobey-Alquist Floodplain Management Act.

AB 983 - Arnett (Chapter 411) Eliminates the first-time violation limitation on the authority of the Insurance Commissioner to elect to impose an alternative monetary penalty assessable against insurance licensees for violations of the Insurance Code. The bill also increases the maximum penalty assessable under such penalty procedure.

-AB 1334 - Meade (Chapter 412) Directs that special bond elections under the Municipal Utility District Act held in even-numbered years shall be consolidated with the direct primary or general election, and that such elections held in odd-numbered years shall be held on first Tuesday after first Monday in November either separate from or consolidated with any other election.

AB 1929 - Powers Revises the district boundaries and the procedures (Chapter 413) for nomination and election of trustees of the American River Flood Control District.

AB 2317 - Barnes (Chapter 414) Authorizes the Board of Administration of the Public Employees' Retirement System to fix the period of and minimum payments for members electing to redeposit contributions and provides for the computation of interest on such redeposit on the basis of the annual interest rate in effect on the date of election.

-AB 2323 - Fenton (Chapter 415) Enacts the California Crime Insurance Act of 1971. The bill requires all insurance carriers writing crime insurance in multiperil insurance policies to participate in the Crime Insurance Pool established by the California FAIR Plan Association for equitable apportionment among such insurers of crime insurance for persons who, after diligent effort, are unable to procure such insurance from an admitted insurer or licensed surplus line broker.

SB 348 - N (Chapter 3	391)	Authorizes the Director of Agriculture by regulation, to revise the time deadlines for fertilizer registrants to file reports of sales with the Director of Agriculture. The bill also clarifies the law to provide that the last registrant of a fertilizer handled by more than one registrant is the person who pays the tonnage tax and files the report of the amount sold.
SB 431 - P (Chapter 3		Provides that the application form for assessment change at local equalization hearings must provide notice that the applicant must request written finding of fact or waive the right to such request. The bill also deletes the requirement that a record of all proceedings be made.
SB 476 - G (Chapter 3		Requires an applicant for adjudication of a claim' arising under the workmen's compensation laws to file a declaration that he is ready to proceed in order to obtain a hearing within 10 to 30 days after such filing.
SB 575 - S (Chapter 3		Authorizes the Director of Agriculture to adopt regulations pertaining to temperature requirements for market milk delivered to consumers.
SB 814 - C (Chapter 3		Repeals various obsolete provisions of the Barber Law relating to qualification for licenses.
SB 884 - D (Chapter 3		Permits the Public Utilities Commission to assess interest on fines it imposes on carriers, in lieu of suspension, revocation, alteration or amendment of any such carrier's operating right or certificate, when such fines become delinquent.
SB 941 - C (Chapter 3		Provides that the minimum school day for special class for pretuberculosis, tuberculosis, convalescent or other physically handicapped minors held in specified institutions shall be 180 minutes.
SB 964 - C (Chapter 3		Amends the Contractors License Law by providing for additional circumstances under which an application for an original license as a contractor or an application for a license in an additional classification or to replace a responsible managing operator or responsible managing employee becomes void.
SB 987 - D (Chapter 3		Revises the staffing and salaries of attaches of the Los Angeles Municipal Court.
SB 1027 - (Chapter 4		Authorizes state chartered credit unions to obtain insurance of members' share accounts pursuant to the Federal Credit Union Act.
SB 1067 - (Chapter 4		Provides that county boards of supervisors shall provide for and may contract for services for the proper care and upkeep of county buildings and grounds.
SB 1231 - (Chapter 4		Requires every insurer admitted in this state to transact life or disability insurance, or both, to maintain specified records of all life or disability insurance transacted.

SB 1476 - Rodda (Chapter 405) Permits municipal utility district to purchase or acquire insurance against loss or damage, including loss of electrical power generating capacity, in connection with the construction or operation of plants and facilities for generation of electrical power by nuclear energy.

SB 1556 - Alquist Provides that ordinances of a sanitary district may (Chapter 406) be enacted in the same manner as general regulations of the board. The bill also authorizes any sanitary district to correct any violation of district ordinances and to add costs of such correction to sewer service charges.

AB 678 - Townsend (Chapter 442)	Adds associations of contractors to the classes of persons who may seek an injunction against unlicensed persons continuously violating the Contractors' State License Law.
AB 685 - Hayes (Chapter 443)	Specifies that the State Personnel Board may adopt rules and regulations providing for methods separating intermittent employees from state service; revises provisions on reinstatements to reflect the repeal and addition of Article XXIV of the State Constitution and eliminates reporting to the State Personnel Board on probationary employees.
AB 710 - Deddeh (Chapter 444)	Requires equipment and structures for rapid transit of local public entities to be accessible to the handicapped. The bill excepts equipment and structures of an urban transit system until such equipment is available from two manufacturers.
AB 811 - Chappie (Chapter 445)	Revises provisions for firefighting tools and spark arrester requirements on engines.
AB 875 - Hayes (Chapter 446)	Incorporates all of the existing military leave and related provisions affecting State civil service employees into a single new Government Code chapter.
AB 1168 - Seeley (Chapter 447)	Requires that the State Lands Commission review and approve or disapprove an engineering survey to determine boundaries along a segment of the Colorado River. This survey will locate boundary lines betweer private and State lands as they relate to the present location of the river.
AB 1533 - Hayden (Chapter 448)	Provides that parking is permitted on either side of any one-way roadway under specified conditions, rather than requiring right-hand parking and only permitting left-hand parking on such roadways when authorized by local authorities.
AB 1534 - Hayden (Chapter 449)	AB 1534 authorizes cities and counties to use specified funds allocated to them from the Highway Users Tax Fund for highway-oriented transportation studies requested by a state or federal agency, as well as for acquisition of rights-of-way for and construction of routes on their select systems of county roads and city streets for maintenanace purposes thereon.
AB 1876 - Hayden (Chapter 450)	Makes laws affecting the Vehicle Code which are adopted at either a regular or special session of the

(Chapter 450) adopted at either a regular or special session of the legislature, operative on the 121st day after adjournment.

Provides for recodification of city or city and county charters. The bill makes provision for AB 2373 - McCarthy (Chapter 452) publication of the charter and . an election on the recodified charter.

AB 2395 - Hayden Permits the Board of Supervisors of the County of (Chapter 451) Santa Clara, without advertising for bids, to lease real property owned by the county to any nonprofit corporation or nonprofit association for a term not to exceed 55 years for the purpose of constructing, operating and maintaining buildings, structures and facilities for medical research and education and allied health care.

APPROVED WITH REDUCTION: "I am reducing the appropriation contained in Senate Bill No. 132 from \$10,896,024 to \$9,971,274 by deleting paragraph (1) (i) Residential care review by the Department of Health Care Services and (1) (ii) Review of nursing homes and intermediate care facilities.

"The appropriation contained in paragraph (1) has been deleted because it would jeopardize the operation of the medical social team function currently being conducted in the Department of Health Care Services.

"With the above reduction, I have approved Senate Bill 132," the governor stated.

SB 473 - RoddaCodifies the University of California Dormitory(Chapter 427)Revenue Bond Act of 1947. The bill makes no<br/>substantive changes in the law.

SB 524 - Stiern Prohibits the capture for sale, transport for sale (Chapter 428) or sale of wild rodents except muskrats and beavers. The bill is intended to prevent public exposure to plague infection.

SB 577 - Gregorio (Chapter 429) Provides that acceleration clauses relating to obligations secured by trust deeds or mortgages on specified residential property are invalid if not contained in both the trust deed or mortgage and the instrument evidencing the secured obligation. The bill applies to transactions entered into on or after July 1, 1972.

SB 589 - Carrell (Chapter 430) Commission to the State Resources Conservation Commission. The name of the Department of Conservation's Division of Soil Conservation is changed to the Division of Resource Conservation. The bill also changes the name of soil conservation districts to resource conservation districts.

SB 716 - Lagomarsino Permits two or more lessees to pool their acreage (Chapter 431) and pursue a cooperative plan for geothermal energy development. This bill will allow individuals or corporations to unitize their holdings and cooperate in the exploration for and development of geothermal resources.

SB 732 - Carrell (Chapter 432) Conforms the registration renewal deadline for miscellaneous types of vehicles to that for regular motor vehicles. The bill also authorizes the Department of Motor Vehicles to apportion taxes on interstate fleets of commercial vehicles on some basis other than miles traveled in California.

SB 733 - Schrade (Chapter 433) Requires the Department of Motor Vehicles to waive penalties due for late payment of renewal fees on repossessed vehicles when all other fees are paid within 30 days of the taking of possession by the repossessor of his agent.

SB 816 - Bradley (Chapter 434) Adds as securities which are eligible to secure deposits of moneys of local agencies those securities for which faith and credit of the United States are pledged for payment of principal and interest. The bill provides specific sanctions for noncompliance with law relating to deposits of moneys of local agencies rather than authorizing the Administrator of Local Agency Security to impose appropriate sanctions. It further authorizes the administrator to take legal action to prevent or stop violation of law relating to deposit of money of local agency. Authorizes specified safety members in San Diego County who failed to elect to pay contributions in order to receive safety membership credit for time prior to achieving such category of membership to now elect to pay such contributions.

(Chapter 436) (Chapter 436) (Chapter 436) Specifies that for purposes of the law relating to the California Insurance Guarantee Association, that the phrase "admitted to transact insurance in this state" refers to an insurer possessing a certificate of authority issued by the California Department of Insurance. The bill provides that a default judgement against an insolvent insurer or insured of an insolvent insurer shall not be binding on the Association. The bill also limits the amount of assessment in any one year by the Guarantee Association to 2 percent of premiums collected by an insurance company in that category of insurance against a member company.

SB 1124 - Lagomarsino Permits the continued employment of undersheriffs (Chapter 437) in Ventura County past the age of 70.

SB 1159 - Dymally Makes nonsubstantive amendments to several codes. (Chapter 438)

(Chapter 439) Provides that any person who does certain specified (Chapter 439) Provides that any person who does certain specified acts with respect to county highways without a permit from the road commissioner is liable for all expenses and damage caused thereby. The bill also authorizes road commissioners to immediately remove or by notice to require removal of specified encroachments.

SB 1336 - Wedworth (Chapter 440) Requires each county conducting a pilot program pursuant to the Wedworth-Townsend Paramedic Act to submit a report to the legislature and to the State Department of Public Health not later than 30 days from the first calendar day of the 1974 Regular Session evaluating paramedic programs conducted at county hospitals or hospitals under contract with the county.

SB 1417 - Walsh (Chapter 441) Reduces from 24 months to 23 months the period of service in the medical corps of the armed forces that gualifies designated persons to take the licensed vocational nurse examination.

#464 Authorizes a city board of education whose AB 1612 - Chacon members are elected in accordance with a city charter (Chapter 470) for terms of office commencing in December, to hold its annual organizational meeting between December 15 and January 14, inclusive, The bill requires the election of the president and vice president at such annual meeting. AB 1674 - Badham Excepts the costs of forest, range, and watershed fire protection within specified state responsibility (Chapter 471) areas for which the county is not reimbursed by the state from the law providing that a city or district providing its own fire protection service shall not be assessed for any portion of the costs of county fire protection services. The bill states that it is declaratory of existing law. AB 1751 - Cline Provides that a board of supervisors may establish (Chapter 458) a uniform procedure for the payment of rewards, payable from county funds, for ideas or suggestions made by members of the public which the board determines would reasonably result in financial savings to the county. Specifies the procedures to be followed for election of members of a separate community college governing AB 1871 - Deddeh (Chapter 472) board, rather than a common unified community college governing board, when elections are held in December pursuant to a city charter provision. AB 2420 - Stull Provides that proceedings for detachment of an area (Chapter 459) of a city from a municipal water district which were completed not later than February 8, 1971, shall be effective for assessment and taxation purposes for the 1971-72 fiscal year if the required statement and plat were filed on or before February 28, 1971. The bill also provides that reorganization of recreation and park districts shall be effective for assessment and taxation purposes in 1971 provided specified requirements are satisfied. SB 628 - Cologne Increases the additional license fee for public (Chapter 460) weighmaster for each additional location where service are rendered from \$5 to \$10. The bill also increases the fee paid by a public weighmaster, private weighmaster and public weighmaster at large for each deputy from \$2 to \$5. SB 720 - Carpenter Permits physically handicapped minors to be enrolled (Chapter 461) in work study or work experience programs for a total of two hours each day. This two-hour period, combined with two hours of attendance in a special or regular day class, would constitute one day of attendance for such minors. SB 767 - Cologne Provides that a county board of supervisors may (Chapter 462) provide that an area planning commission perform planning and zoning functions within a prescribed area of the county. SB 1000 - Petris Authorizes a reasonable and nondiscriminatory (Chapter 463) inspection fee established by city or county ordinanc to defray the cost of inspecting building construction work of another public agency in such city or county. The bill also authorizes such fee for cost of planchecking services. The bill does not authorize fee for a permit to do such work or assessment of a fee against the state or its agencies under specified circumstances. SB 1056 - Marks Defines "local agency" for purpose of the Revenue (Chapter 464) Bond Law of 1941 to include joint exercise of powers agency created to acquire, construct, or operate an enterprise for collection, treatment, or disposal of sewage, waste or storm-water. It provides for of sewage, waste or storm-water. It provides for approval of bonds by majority of all voters voting. The bill further provides if an emergency exists as result of determination that improvements must be

undertaken to comply with Porter-Cologne Act, certain election procedures are inapplicable, but undertaking the improvement shall be subject to referendum on the issuance of bonds by ordinance of the agency governing board. # # # # WAS
