Governor Ronald Reagan today announced the following bills

have been signed:

AB 699 - Beverly Permits a board of supervisors to enter into an (Chapter 479) agreement with a lessee or concessionnaire to amend leases and contracts relating to improved property to permit the improvement or alteration of the property under specified circumstances.

AB 1290 - Briggs Makes a technical amendment to the legislative (Chapter 480) standards for the establishment of minimum producer prices in the Milk Stabilization Act.

AB 1463 - Knox (Chapter 481) Provides that a portion of the assessments and bonds of an improvement district may be readjusted and refunded pursuant to a Special Assessment and Bond Refunding Law of 1939. The bill also provides a procedure by which the proceeds of the sale of surplus property on which certain improvements or repairs have been made pursuant to the Improvement Act of 1911 may be applied to aid the project.

AB 1781 - Knox (Chapter 482) Clarifies the authority of banks and trust companies to consolidate certificates for stock and other securities which they hold in fiduciary capacity, rather than keeping separate certificates for each fiduciary account.

AB 2072 - Porter (Chapter 483) Provides that a resolution of transfer of territory from one city to a contiguous city shall not be required in specified circumstances. The bill authorizes approval of such transfers without notice, hearing or election and provides that the provisions for such transfer shall become inoperative on January 1, 1974.

AB 2245 - Russell Provides that in assessing the cost of construction (Chapter 484) under the Improvement Act of 1911, an adjustment may be made for certain prescribed contributions made to the improvement by a past or present owner.

SB 253 - Grunsky (Chapter 485) Permits an injured employee to settle and release a claim against a third party tortfeasor without consent of the employer, subject to the employer's right to bring an action against the third party for compensation paid the employee rather than requiring the employer's consent to such settlement and release.

SB 756 - Harmer (Chapter 475) Excludes from the classified service of a school district which has adopted a merit system persons employed in positions established for employment of community representatives in advisory or consulting capacities. The bill also includes in the classified service, under specified conditions, employees with mental handicaps.

SB 924 - Gregorio Makes technical amendments to Education Code (Chapter 476) provisions relating to school district organization.

SB 1018 - Stiern (Chapter 477)

Reduces from 21 to 14 the number of days in which an animal is to be picked up by owner from veterinarian, kennel, pet grooming parlor, animal hospital or any other animal care facility after the day the animal was due to be picked up before the animal is deemed to be abandoned for specified purposes.

AB 98 - Roberti (Chapter 486)	Provides that whenever partial results of an election are made public after 10 p.m. of the day of the election, election officials shall issue a bulletin setting forth precincts not yet reported when approximately 50 percent of precincts have reported and again when 75 percent of precincts have reported. The bill requires a third such listing by election officials if the count is not completed by 6 a.m. of morning following election.
AB 922 - Knox (Chapter 487)	Provides that territory in an annexation proposal approved by a local agency formation commission shall be deemed a single area for purposes of determining the method of annexation proceedings under the Government Code chapter dealing with annexation of territory to a city.
AB 1005 - Wilson (Chapter 488)	Requires that specified year model vehicles sold and registered in California instead of first sold and registered in California meet exhaust emmission standards specified in the Health & Safety Code.
AB 1156 - Lanterman (Chapter 489)	Establishes a procedure under the Dental Practice Act for suspension of the licenses of persons who have become mentally ill.
AB 1601 - Townsend (Chapter 490)	Revises qualifications for admission to the cosmetology instructor's examination, specifying that candidates must have one year of practical experience within the past 3 years in all branches of cosmetology. The bill also deletes the requirement that applicant be not less than 21 years of age.
AB 1740 - Chappie (Chapter 491)	Authorizes and directs the Department of General Services to transfer the DeWitt State Hospital facility to Placer County on specified terms and conditions. The bill provides that if the county ceases to use the property for a public purpose, the property shall revert to the state.
AB 3091 - Badham (Chapter 492)	Establishes the Niguel and Irvine Coast Marine Life Refuges to protect marine life along the Orange County Coast.
SB 1091 - Holmdahl (Chapter 465)	Increases various time periods for the obtaining and filing of candidate's affidavit, and certifica- tion for the election of members of the board of directors of municipal utility districts.
SB 1514 - Moscone (Chapter 478)	Clarifies the procedure to be followed by public guardians when issuing warrants, and requires such warrants to be issued in the manner prescribed for the issuance of county warrants.

AB 290 - Keysor Chapter 500	Authorizes local agencies proceeding under the Improvement Act of 1911, with the owners consent, to do work on private property to eliminate disparities in level or size between the public improvement and the private property, rather than between the public improvement and driveways, housewalks and sewers.
AB 443 - Belotti Chapter 501	Provides, to the extent additional federal funds become available, for the establishment and maintenance by the State Department of Public Health of four additional regional centers for the mentally retarded.
AB 736 - Meade Chapter 502	Permits governing boards of school districts with average daily attendance of 20,000 or more, rather than 75,000 or more, to establish specified revolving cash funds for use by school principals and other administrative officers.
AB 1003 - Russell Chapter 503	Prohibits operation of a motor vehicle with an exhaust system modified in a manner which will amplif or increase the noise emitted by the motor above a prescribed limit.
AB 1276 - Bee Chapter 504	Provides that provisions of the County Employees Retirement Law of 1937 authorizing members who are entitled to receive a pension or allowance for service to receive refund of deposits if they were granted public service credit for such service, shall be limited to those members who would receive certain deferred retirement benefits. It also permits members under specified circumstances to receive all benefits granted as member entering a reciprocal retirement system.
AB 1669 - Badham Chapter 505	Amends the Collection Agency Act by authorizing a conservator, as an alternative to the present requirement of winding up and liquidating the collection agency for which he is the conservator, to permit the sale, transfer, or continuation of the agency.
AB 1689 - Mobley Chapter 506	Extends for two years the vehicle code provision, which authorizes combinations of vehicles consisting of two specified cotton trailers which exceed a total length of 60 feet.
AB 1789 - Knox Chapter 507	Amends the Municipal Utility District Act to permit the levying of taxes and the fixing of special rates and charges within an area which is annexed to a district.
AB 1907 - Foran Chapter 508	Provides that when the governing board or officer of specified public agencies permits public traffic upon driveways, paths, or grounds under their control then all provisions of Vehicle Code regarding traffic on highways shall apply to such traffic except for those conditions or regulations imposed or enacted by such board or officer.
AB 1926 - Thomas Chapter 509	Deletes provisions specifying that the Department of Motor Vehicles is divided into at least four divisior

AB 1977 Chapter	- Gonsalves 510	Exempts persons who install a spare tire on a vehicle as part of an emergency service rendered to a disabled vehicle upon a highway from provisions prohibiting installation of certain worn tires on a vehicle for use on a highway. The bill also provides that low- valued vehicles are vehicles appraised at a value not exceeding \$200, rather than \$100, for purposes of provisions re removal and disposition of abandoned vehicles.
AB 2081 Chapter	- Chappie 511	Provides that the annexation of territory to County Service Area No. 3, County of El Dorado, shall be effective for assessment and taxation purposes if specified filings are completed by March 1, 1971.
AB 2679 Chapter	- Crown 512	Permits municipal utility districts, upon a four- fifths vote of their boards of directors, to issue bonds or promissory notes to repair or replace public works damaged or destroyed by an earthquake or other disaster.
AB 2815 Chapter	- Karabian 513	Deletes the Fish and Game Code provision allowing the use of dogs to pursue bears during the course of breaking, training or practicing dogs. Dog training activities are permitted during the open season on bears.
AB 2840 Chapter	- Powers 514	Provides that orders or decisions of the Public Utilities Commission may be modified after notice to the parties rather than solely to the public utility affected.
AB 2888 Chapter		Liberalizes highway relocation assistance to conform with the Federal Uniform Relocations Assistance and Real Property Acquisition Policies Act of 1970.
AB 2940 Chapter	- Beverly 516	Amends the Public Weighmaster Law to specify that the term "weighmaster" includes "deputy weighmaster." The bill also authorizes gross and tare weights of vehicles carrying asphalt or paving materials to be certified either with the driver on or off the vehicle. This provision is now applicable to vehicle: carrying earth, stone, sand and gravel.
-AB 3077 Chapter		Provides that "low-income area" for purposes of the Small Business Assistance Program Law includes areas in which a job development corporation may be established. The bill further provides that "small business" for purposes of such law also includes any business dealing in alcoholic beverages.
AB 3090 Chapter	- Johnson, 518	R. Requires the State Board of Education to notify county superintendent of schools and county committee on school district organization of disapproval of plans and recommendations for dissolution of a unified school district, with a written statement of reasons therefor. The bill authorizes the county committee on school district organization to continue to have jurisdiction for 18 months to revise such disapproved plans and recommendations for resubmission to the State Board of Education.
-SB 477 Chapter	- Zenovich 493	Permits a disability retirant from the state teachers retirement system to be employed in a position requiring certification qualifications. The bill further provides that such a retirant will have his allowance reduced by fifty cents for each dollar earned.
SB 603 Chapter	- Gregorio 494	Provides that there is no incompatibility of office between being a member of a city council and the board of directors of the Estero Municipal Improvemen District.

have been signed:	
AB-559 - Gonsalves (Chapter 520)	Allocates approximately \$15.6 million from the Property Tax Relief Fund to 37 counties which were underpaid in reimbursement of loss due to the 30 percent business inventory exemption. The bill requires the State Board of Equalization to determine actual losses to local government caused by partial exemption of business inventories for the 1970-71 fiscal year and report any difference between actual loss and state reimbursement to the Controller for adjustment in the 1971-72 or 1972-73 fiscal year reimbursement.
AB 761 - Deddeh (Chapter 534)	Broadens the authority of the Department of Public Works, in conformance with federal law, with respect to the construction of fringe and transportation corridor parking facilities along the state highway system.
<u>AB</u> 1470 - Chacon (Chapter 535)	Provides that positions established by school districts in specified categories and restricted to persons in low-income groups or residency in specifically designated areas of the community, are to be classified as restricted. The bill further provides that persons holding such positions shall be classified employees and shall not be eligible for promotion into the regular classified service unti- they have complied with specified provisions.
AB 1561 - Davis (Chapter 536)	States specific statutory standards and requirements regarding the marketing of potatoes.
AB 1922 - Keysor (Chapter 537)	Prohibits on and after September 1, 1975, employment of noncredentialed persons to teach specified handicapped minors in a home, hospital, or licensed children's institution. The bill authorizes employment of substitute teachers under certain circumstances.
AB 2139 - Campbell (Chapter 538)	Authorizes the Department of Public Works to modify railroad alignment in vicinity of City of El Monte in order to eliminate railroad grade crossings and to facilitate construction and operation of the San Bernardino Freeway Busway Project. The bill makes such construction project eligible for allocation of specified state funds for grade separations, under specified conditions.
AB 2157 - Knox (Chapter 539)	Requires the governing body of a city or county to pay the amount of charges of the engineer or surveyor who sets the final monuments of a subdivision up to and including the amount of bond or cash deposit if the subdivider has not paid the amount. The bill also authorizes the governing body to direct the county surveyor or city engineer to set such monuments in the event that the civil engineer or land surveyor charged with the responsibility for setting monuments refuses to set such monuments.
AB 2827 - Maddy (Chapter 521)	Permits the governing board of a community college district to charge nonresidents enrolled during the 1971-72 fiscal year the same tuition fee set for nonresident students for the 1970-71 fiscal year.

SB 58 - Lagomarsino Requires the Resources Agency to contract for a (Chapter 522) study of oil leaks in the Santa Barbara Channel. The bill appropriates \$50,000 from the California Environmental Protection Program Fund for purposes of the act, but provides that prior appropriations from the fund have priority with respect to payment.

SB 188 - Dymally Changes specified references to the State Board of (Chapter 523) Education and the Department of Education in the Licensing of Certificated Personnel Law of 1968 to the Commission for Teacher Preparation and Licensing. The bill also states that the Teacher Preparation and Licensing Law of 1970 shall also be know and may also be cited as the "Ryan Act."

SB 498 - Short Authorizes the governing board of each community (Chapter 524) college district to offer a course of study leading to an associate in arts degree in bilingual, bicultural teacher assisting.

SB 560 - Lagomarsino Deletes oil and gas district boundary descriptions (Chapter 525) and authorizes the Director of Conservation to fix such boundaries.

SB 590 - Collier (Chapter 526) Eliminates provisions designating commercial fishing dependent upon Oregon and Washington States laws or regulations prohibiting commercial taking of silver salmon. The bill also eliminates provisions making it unlawful, with prescribed exceptions, to take salmon with any type of net or long line or to transport or possess any salmon taken by any type of net or long line in designated waters.

SB 618 - Cologne (Chapter 527) Permits a court to raise or lower the size of bonds which are required of the executor or administrator in those limited instances where the bond is not required in the will and where the representative is the sole heir or beneficiary of the estate and a reduction in the otherwise required bond is requested. Under the terms of the bill, the court will review the situation and, if good cause appears, may enlarge or reduce the bond for the best interests of the estate, the creditors, and other interested parties.

SB 621 - Carrell (Chapter 528) Provides that \$40,000 appropriated from California Environmental Protection Program Fund to the Department of Aeronautics shall be for expenditure during 1970-71 and 1971-72 fiscal years, rather than without regard to fiscal years. The bill states that amounts for subsequent years shall be as determined in the Budget Act.

SB 627 - Grunsky (Chapter 529) Provides for an attachment bond or deposit to include, in addition to the amount of the plaintiff's demand, an amount for those costs actually incurred to the time of the giving of the undertaking or the deposit of money with the sheriff, constable, or marshal, a sum of money not to exceed 25 percent of the amount of plaintiff's demand, and in no event to be more than \$1,000.

SB 672 - Carrell Modifies the method by which food vending vehicles (Chapter 495) are to be identified.

SB 719 - Bradley Broadens the reporting requirements of the Santa (Chapter 530) Clara County Flood Control and Water Conservation District to require the district to annually prepare a complete report on the district's activities in protecting and augmenting the district's water supplies.

SB 793 - Lagomarsind (Chapter 531)	<ul> <li>Increases the maximum permissible interest rate on bonds of the Ventura County Flood Control District from 6 percent to 7 percent. The bill also reduces the present requirement in the Ventura County Flood Control Act for a unanimous vote of the Board of Supervisors to adopt a resolution calling a bond election to a four-fifths majority of the board.</li> </ul>
SB 1144 - Moscone (Chapter 496)	Changes the compensation of court reporters in various counties.
SB_1160 - Rodda (Chapter 497)	Authorizes river port districts to issue short-term promissory notes up to \$500,000 to meet short-term cash flow problems.
SB 1182 - Burgener (Chapter 498)	Makes technical changes relating to accounting and budgeting practices in county educational units.
-SB 1192 - Deukmejiar (Chapter 532)	Allows a juvenile court traffic hearing officer to hear and dispose of cases involving a person under the age of 18 who is charged with driving a motor vehicle on the property of another without the permission of the property owner. It would also permit such cases to be heard on the basis of the citation issued, rather than by petition.
SB 1297 - Rodda (Chapter 533)	Amends the Public Utilities Code to allow municipal utility districts to enter into contracts for materials and supplies under situations of emergency without observing the requirements of public bidding.
SB 1507 - Moscone (Chapter 519)	Makes technical amendments to the Education Code.
SB 1616 - Beilenson (Chapter 499)	Requires the Department of Aeronautics to give notice of public hearing in connection with issuance of airport permit or approval of airport site to any affected or interested person making written request for such notice.

SB 697 - Rođđa	Revises the procedure relating to the dismissal of tenured teachers.

REASON FOR VETO: "Senator Rodda, the author of SB 697, has requested that I veto his measure because it is identical to AB 293, which I approved on July 20.

"Accordingly, I am returning the bill unsigned," the governor said.

AB 94 - Lanterman Chapter 564	Validates organization, boundaries, acts, proceedings and bonds of counties, cities and specified districts agencies and entities. The Second Validating Act of 1971.
AB 341 - Russell Chapter 565	Requires law enforcement agencies to notify private school authorities when a teacher of such school is arrested for certain narcotic offenses.
AB 342 - Quimby Chapter 566	Requires persons registering as legislative advocates to submit in addition to existing requirements, a recent black-and-white photograph.
AB 633 - Foran Chapter 567	Establishes four-year staggered terms for the seven members of the California State Transportation Board.
AB 692 - Briggs Chapter 568	Provides, with specified exceptions, that when a financed insurance policy is cancelled or the insured stops payments to the lender, the insurer shall calculate the return premium on a pro rata basis.
AB 978 - Brown Chapter 569	Specifies that where disability payments under workmen's compensation are made by negotiable instrument, the instrument must be immediately negotiable.
AB 1120 - Briggs Chapter 570	Requires the parallel extension of dependent coverage under a group disability insurance plan, a hospital service contract, or a health care service plan which now may provide for an extension of coverage to just the employee for a limited period of time following termination of his employment.
AB 1125 - Dent Chapter 571	Authorizes the governing board of any school district to establish a fund for losses to school district property to cover the deductible amount under insurany policies or losses due to noninsured perils.
AB 1142 - Brathwait Chapter 572	e Increases the jurisdiction of the small claims cour from \$300 to \$500.
AB 1155 - Lanterman Chapter 573	Authorizes governing boards of school districts to temporarily transfer funds in special or restricted funds or accounts to the district general fund, under specified conditions, for payment of district general fund obligations.
AB 1271 - Dent Chapter 574	Authorizes the governing board of any school district with an average daily attendance in excess of 50,000 to delegate to the district superintendent authority to exercise certain powers of the board relating to payment of travel expenses of district employees when performing services for the district.
AB,1305 - Karabian Chapter 575	Specifically authorizes investment by banks in bonds and other evidences of indebtedness of the State of Israel or certain public corporations thereof under specified conditions.
AB 2527 - Porter Chapter 576	Revises salaries and makes changes in positions of employees of the Los Angeles County municipal courts.
SB 512 - Marks Chapter 556	Provides that that portion of a county ordinance which changes supervisorial salaries becomes effective 60 days after its adoption.

	SB 1242 - Harmer Chapter 561	Revises the procedures for the election of, and qualifications for, the board of directors of the Castaic Lake Water Agency.
	SB 1411 - Nejedly Chapter 562	Includes district attorney inspectors and investigator within specified disputable presumptions under workmen's compensation law with regard to hernia, heart trouble, pneumonia, and tuberculosis.
	SB 1519 - Grunsky Chapter 563	Removes the limitation of \$1,000 per occurrence on the deductible coverage which may be included in a school fire insurance policy obtained by school districts with less than 50,000 average daily attendance.

AB 178 - MacDonald Provides for a pilot project to be selected by the (Chapter 540) Office of the Community College Chancellor, for a community college district in California to contract for data processing and related management services for a period of not to exceed five years. The legislative analyst is required to submit a report on the project at the beginning of the 1973 Session of the Legislature.

AB 882 - Chacon (Chapter 595) Deletes the provision for deduction of a \$25 fee in calculation of the refund of unearned finance charge when the purchaser of an automobile pays off his loan ahead of time. It provides that where the finance charge amounts to less than \$25, the seller or assignees may, after computing the refund, retain an amount equal to \$25.

AB 949 - Campbell Medi-Cal Reform.

(Chapter 577)

AB 1006 - Deddeh (Chapter 541) Changes the name of the Advisory Commission on the Status of Women to the Commission on the Status of Women. It deletes the provision terminating the commission's existence on June 30, 1971. The bill also directs the commission to study women's educational and employment problems, needs, and opportunities, to act as an information center with respect to educational, employment, and other related needs of women.

AB 1133 - Fong (Chapter 542) Excepts community colleges from the requirement that a fire alarm signal to be sounded each calendar month in public, private, or parochial school buildings

AB 1202 - Schabarum Makes it a misdemeanor to violate specified (Chapter 543) provisions of the Pure Air Act of 1968, relating to motor vehicle pollution control devices.

AB 1352 - Fenton Revises loan and investment limitations of state-(Chapter 544) chartered savings and loan associations.

Specifies that a school district's continuing

AB 1449 - Keysor (Chapter 545)

AB 1451 - Chacon (Chapter 546) Makes applicable to any permanent or probationary employee of the California State Colleges, rather than to academic and nonacademic employees, the provisions relating to the grounds and procedures of dismissal, demotion, or suspension.

AB 1454 - Belotti (Chapter 547)

Prescribes a maximum width limit of 100 inches for a truckload composed solely of particle board, hardboard, gypsum board, similar types of wallboard, or any combination thereof, stacked side by side.

AB 1466 - Burke (Chapter 548) Authorizes school district governing boards to authorize student organizations composed entirely of pupils attending the schools of the district to maintain approved activities, including fund-raising activities, and to conduct fund-raising activities on school property during school hours, under specified conditions.

AB 1500 - Dent (Chapter 549) Provides that once the election date for members of a county board of education is established, no subsequent change in circumstances shall require a change in the election date.

AB 1569 - Johnson, (Chapter 550)	H. Authorizes and prescribes a procedure for a public agency upon authorization by a municipal water district within whose boundaries such public agency is wholly or partially situated, to utilize funds derived from the sale of water or other funds not appropriated to some other use to pay such district such amounts in avoidance of taxes as may be determined annually by the governing body of such public agency.
AB 1858 - Seeley (Chapter 551)	Includes appointed, as well as elected, members of the governing committee of the California FAIR Plan as members of the governing committee of the California Riot and Civil Disorders Insurance Association. The bill specifies that allocation of state-paid premium to the association shall be allocated to member insurers thereof on basis of premiums on, rather than gross direct premium writings of, reinsured lines in state during the preceding year.
AB 2022 - Monagan (Chapter 552)	Authorizes deductible amount on fire insurance of community college districts to exceed \$1,000.

Governor Ronald Reagan announced today he has intentionally allowed a bill--authorizing a vote on the issuance of \$294 million in state general obligation bonds for health science facilities at the University of California--to become law without his signature.

He said he decided last week not to sign the bill because he believes the \$294 million figure is excessive and that adequate medical training facilities to meet the University's needs can be constructed for substantially less money. "However," he said, "to veto the measure would be to deny the citizens of California the right to express themselves at the ballot box on the issue, even though I am convinced that the amount of money authorized under the bill to provide for essential health science facilities at the University is much greater than actually necessary."

Article 4, Section 10 (a) of the California Constitution provides that a bill presented to the governor that is not returned after 12 days becomes a statute. Yesterday was the twelfth day.

The governor stressed that he is in complete sympathy with the basic objectives of the measure. "I do not question the urgent need for increased facilities to train more doctors," he said. "On the other hand, I do not believe the sum authorized by the bill represents the lowest possible cost at which this need can be met."

He said there is ample time between now and next year's election on the issue for University officials to carefully reevaluate their needs, and to consider the substitution of less expensive--yet thoroughly adequate--facilities.

"If the cost figures can be trimmed and the amount of the bond issue substantially reduced, I will support it."

He said his administration will work with University officials in the months ahead "to see if we, together, can agree on a much lower amount."

The governor noted that Californians last year declined to approve a bond issue amounting to \$246 million for similar purposes.

Governor Reagan also announced he has vetoed the following bills: SB 202 - Moscone Permits one additional grand jury to be impaneled in San Francisco, to be selected at random from the lists of trial jurors. This grand jury would have

exclusive jurisdiction to return indictments.

"The Attorney General is undertaking an extensive study of the grand jury system in California. Consideration of legislative proposals like SB 202, which make substantive changes affecting grand juries, should be deferred pending the outcome of the Attorney General's study.

"Accordingly, I am returning the bill unsigned," the governor said.

SB 1228 - Behr Increases the maximum tax rate for certain school districts by the amount required to compensate for loss of revenue resulting from land assessment under the provisions of the California Land Conservation Act of 1965.

REASON FOR VETO: "I recognize that SB 1228 is narrowly drawn and is limited in its application to the 1971-72 school year. However, it permits the affected school districts to raise the maximum school tax rate without a vote of the people. I do not believe that the approach taken by this bill is the only meaningful solution to the problem facing the school districts in question. There is still time during the current legislative session to consider other alternatives.

AB 2609 - Dunlap (Chapter 737) Provides that noncompliance with Elections Code provisions relating to submission of charter amendments to Legislature shall not invalidate or cause refusal of acceptance for ratification of such charter amendments. The bill applies only to charter amendments submitted at the 1971 Regular Session of the Legislature.

AB 2616 - Mobley (Chapter 738) Deletes the requirement that public transportation works be designed to operate on fixed tracks, rails, belts or cables where constructed by a local governing body to provide transportation pursuant to the Improvement Act of 1911 or the Municipal Improvement Act of 1913. The bill authorizes operation, as well as construction of such public transportation works, and specifically authorizes terminal and intermediate stations, structures, or platforms, and other necessary auxiliary facilities.

Governor Ronald Reagan today announced the following bills

have been signed:

SB 269 - Stevens (Chapter 695)	Makes January 1, 1974, rather than January 1, 1972, the termination date for application of the provision relating to approval by the Director of Human Resources Development of amendments to voluntary plans for payment of unemployment compensation disability benefits to employees electing to be so covered.
SB 327 - Wedworth (Chapter 696)	Provides that in the case of state college construction, specified work, including work on state-owned buildings and property necessitated by specified emergencies, may be awarded by contract upon informal bids in addition to the use of day labor.

SB 349 - Lagomarsino Declares that a search warrant may be made (Chapter 697) returnable before the issuing magistrate or his court.

Requires that an application for rehearing by the SB 457 - Kennick (Chapter 698) juvenile court of a hearing conducted by a referee to contain a statement of reasons such rehearing is requested. The bill provides that upon the request of counsel for a minor the juvenile court may continue any hearing under the Juvenile Court Law beyond the time limit within which the hearing is otherwise required to be held. In any case in which a minor is represented by counsel and no objection is made to an order continuing any such hearing beyond such time limit, absence of such objection shall be deemed a consent to the continuance. The bill authorizes the court to continue any hearing on petition under the Juvenile Court Law, except where a minor is in custody, for not more than 10 days in addition to any other continuance authorized by such law, whenever the court is satisfied that an unavailable and necessary witness will be available within any such time.

SB 484 - Lagomarsino Requires service of civil process in actions against (Chapter 699) the Department of Motor Vehicles and subpoenas for departmental records be made upon the Director of Motor Vehicles or his appointed representatives at the Department's headquarters in Sacramento.

-SB 576 - Gregorio Allows person 18 through 20 to hold civil offices. (Chapter 700) The bill also provides that persons 18 through 20 shall have full rights and liabilities, both civil and criminal, with regard to their activities as candidates as well as when in office, should they be so elected.

**非504** SB 680 - Short Makes designated investigators of the Division of (Chapter 701) Labor Law Enforcement peace officers. SB 745 - Lagomarsino Provides that the conviction, as such term is used (Chapter 702) in the law relating to vacancy of a public office due to an officer's felony conviction, shall be deemed to have occurred at the time trial court judgement is entered. The bill provides that certain public officers may be removed for willful or corrupt misconduct in office occurring within 6 years immediately preceding the presentation of an accusation by the grand jury. SB 768 - Collier (Chapter 703) Provides that the court commissioner of the Riverside County Superior Court shall receive a salary equal to 75 percent of the salary of a superior court judge. SB 1078 - Burgener Provides, with respect to alternate methods of (Chapter 704) payment of salaries for full time noncredentialed school employees that such payment may be made twice a month, as well as once every two weeks or once every four weeks, and that such provisions shall apply to unified school districts with 100,000 or more average daily attendance, rather than to school districts in cities of over 1,900,000 population. Revises provisions on immunization against polio and measles (rubeola) to require only persons age 16 and under to be immunized against polio and only persor SB 1080 - Burgener (Chapter 705) age 16 and under to be immunized against measles (rubeola) before admission to a public or private school for the first time. SB 1087 - Song Makes nonsubstantive amendments to the adult probation (Chapter 706) law. SB 1156 - Dymally Provides that if the members of the governing body (Chapter 707) of a chartered city are elected by district, such districts shall be of equal population according to the latest federal census. SB 1466 - Stevens Makes fraud or deceit in the purchase or sale of (Chapter 708) vehicles, parts, or accessories grounds to take administrative action against the license of a vehicle dealer, manufacturer or transporter. SB 1583 - Gregorio Provides that it is unlawful to notify any person (Chapter 709) by any means, as a part of an advertising plan or scheme, that he has won a prize and that as a condition of receiving such prize he must purchase or rent any goods or services, rather than any other item. SB 1622 - Marks Authorizes the use of personal checks to pay (Chapter 710) obligations owed to public agencies on specified terms and conditions. The bill authorizes public agencies, if a personal check offered in payment is not paid on demand, to prescribe a reasonable charge for such check and an alternative method of payment for such payment and for future payments. Governor Reagan has vetoed the following bills:

SB 784 - Marks Appropriates \$290,000 for the Frederick Burk Laboratory School.

REASON FOR VETO: "The question of state funding for the Frederic Burk School received careful consideration in my review of the 1971 Budget Act. At that time I deleted State funding and no facts have been produced which justify a change in that position.

"Accordingly, I am returning the bill unsigned," the governor said.

#504 SB 1064 - Alquist Provides that academic and nonacademic employees of a state college must be allowed to inspect material, with specified exceptions, in the employees' personnel file which may serve as a basis for affecting the employee's employment status. The bill also provides that notice and an opportunity to review and comment must be given to employee when material of a derogatory nature, with specified exceptions, is to be placed in his personnel file.

REASON FOR VETO: "I am vetoing this bill at the request of the State College Trustees and the Chancellor. The Chancellor's Council of State College Presidents is presently studying the matter of content of personnel files for academic personnel, as well as the degree of access to such files. This matter is of extreme concern since the degree of confidentiality of the files has been found to directly affect the willingness to render objective and meaningful evaluations. It is expected that specific policy recommendations will be made by the Council to the Chancellor and to the Trustees.

> "Further legislative proposals in this subject area should be deferred pending evaluation of the Council's recommendations to the Chancellor.

"Accordingly, I am returning the bill unsigned," the governor said.

AB 162 - Cullen Requires each state agency to submit copies of budget requests submitted to the Department of Finance, to the Legislative Analyst.

**REASON FOR VETO:** "The present system has worked satisfactorily for some years. The Department of Finance maintains close cooperation with the Legislative Analyst during the budget preparation period. Whenever possible, preliminary information concerning budget requests is given to the Analyst to facilitate preparation of his annual budget analysis. However, a governor's final budget must always reflect considerations of the entire state, not just a single department. The original budget requests from each department, unweighed by the needs of the entire state, would not materially assist the legislature in considering the total state budget. The lengthy budget hearing process conducted by the fiscal committees appears adequate to develop full and complete information concerning the state budget.

"Accordingly, I am returning the bill unsigned," the governor said.

AB 675 - Chappie (Chapter 678)	Permits a county committee on school district organization or a county board of education in counties with a population of less than 25,000, except with respect to a community college district, to amend the provision relating to whether or not trustees are to be elected by the voters of the entire district or only by the voters of the trustee area in which they reside.
AB 872 - Sieroty (Chapter 679)	Provides that anyone who has not reached the age of 30, rather than 24, shall be eligible for a state competitive scholarship.
AB 998 - Wakefield (Chapter 680)	Authorizes rather than mandates the State College Trustees to waive the tuition fees of certain foreign students. The bill also authorizes the Trustees to defer, under specified conditions, collection of tuition charged to nonresident foreign students.
AB 1071 - Z'berg (Chapter 681)	Makes changes relating to the investments of insurance company funds.
AB 1150 - McAliste (Chapter 682)	r Delineates the conditions under which an advertising claim or representation pertaining to more than one article of merchandise or type of service within same class of merchandise or service is deceptive.
AB 1351 - Fenton (Chapter 683)	Provides that the Insurance Commissioner shall have authority to determine whether premiums for credit insurance are reasonable with respect to benefits provided and approve or disapprove rates based on that determination. Previously such credit insurance rates had to be approved if they produced a 50 percent loss ratio.
AB 1468 - Burke (Chapter 684)	Allows a school district governing board to set the date when an in-year salary increase for certificated employees is to be effective.
AB 1545 - Barnes (Chapter 685)	Provides that authorization for limited employment of a person retired under a county retirement system established by the County Employees' Retirement Law of 1937 is prohibited if a person has attained mandatory retirement age for the employment from which he retired. The bill does not apply to Los Angeles County.
AB 1614 - Pierson (Chapter 686)	Provides that an unlicensed person employed by, rather than in, a licensed clinical laboratory may perform venipuncture or skin puncture under designated circumstances.
AB 1676 - Badham (Chapter 687)	Permits elected or appointed public officers to be appointed and serve as members of airport land use commissions during their terms of office.
AB 2008 - Barnes (Chapter 688)	Increases from \$500 to \$750 the lump sum death benefit for a retired member of a county employees' retirement system which is financed from surplus earnings.
AB 2156 - Knox (Chapter 689)	Provides that an insurance policy upon a motor vehicle may be included in the security agreement permitted by the Rees-Levering Act.
AB 2322 - Beverly (Chapter 690)	Provides that a reasonable escrow fee incurred with respect to real property secured loans made by an industrial loan company shall not be included in determining the maximum charges which such a company may make.

AB 2369 - LaCoste (Chapter 691)

AB 2828 - Maddy (Chapter 692)

AB 2938 - Badham (Chapter 693) Revises the method by which the salary owed to the estate of a deceased teacher is computed. The bill becomes operative on July 1, 1972.

Revises the notice on the sample ballot envelope of

the right to vote by absent voter's ballot.

Provides that, notwithstanding certain provisions of law relating to the granting of variances, certain variances may be extended under certain circumstances for up to five years. The bill provides that its provisions shall remain in effect until January 1, 1972.

SB 63 - Harmer (Chapter 694) Prohibits solicitation of employment from any injured person or from any other person to obtain authorization on behalf of the injured person to act as an investigator in investigating matters resulting in injury or death to such person or damage to his property. It exempts solicitation of employment from the injured person's attorney and exempts solicitation by business agents or attorneys employed by labor unions. The bill makes the prohibited solicitation a misdemeanor when engaged in by any person and a ground for disciplinary action under the Private Investigator and Adjuster Act. The bill also makes it a misdemeanor to knowingly and directly solicit any injured person or any person acting in his behalf for the sale or use of photographs relating to the accident which resulted in the injury or death of such injured person.

SB 225 - Behr (Chapter 668) Broadens the coverage of the civil penalty provisions (of up to \$6,000 a day) of the Porter-Cologne Water Quality Control Act, which now apply only to persons who violate cease and desist orders, to include persons who intentionally or negligently discharge waste in violation of waste discharge requirements, and create conditions of pollution or nuisance; and persons who cause or permit oil or any residuary product of petroleum to be deposited in waters of the state, except in accordance with waste discharge requirements.

> Increases from \$1,000 to \$2,500 the amount of the bond or in lieu cash deposit required for issuance, reinstatement, reactivation, or renewal of a contractor's license. The bill adds a provision that whoever denies a bond solely on the grounds of race, religious creed, color, national origin, ancestry, or sex is liable to the applicant or licensee for his actual damages plus \$250 on each offense.

Includes within the definition of "secondhand dealer" for purposes of certain provisions requiring specified reports concerning identifiable property, a person who owns or operates an auction or other organized event consisting of two or more sellers and where a fee is charged either to sellers or prospective buyers, except for persons acting as such dealers exclusively for charitable purposes, and persons who own the land, who know nothing of the details of the transactions handled. Existing law requires that dealers in identifiable second hand personal property report the acquisition of any such property to the local police. AB 1070 - Monagan (Chapter 808)

AB 1110 - Quimby (Chapter 809) Requires that official court reporters in San Bernardino County devote full time to the performance of their duties during times when courts are open for transaction of judicial business.

Substitutes "mandatory retirement age" for age of 70 years, with respect to provision providing for termination of employment of state college employees.

AB 1127 - Hayes (Chapter 810) Requires that each area vocational committee, as established by the Vocational and Technical Training Act of 1969, arrange for meetings with county superintendents of schools and superintendents of secondary and community college districts in the area to communicate their progress in vocational education planning in the area. Minutes of such meetings are to be submitted to the Superintendent of Public Instruction and the Chancellor of the Californi Community Colleges.

AB 1184 - Beverly (Chapter 811) Exempts from various provisions of the Personal property Brokers Law any commercial loan made to a person engaged in the business of selling goods for the sole purpose of financing the purchase of goods for resale.

AB 1502 - Beverly (Chapter 813) Specifies that failure of a lender to comply with certain requirements of law in connection with certain real property secured loan transactions, does not excuse or defer borrower's performance of his obligations other than an obligation to pay a late payment charge, nor does such failure impair or defer right of the lender to enforce any other obligations, including cests and expenses incurred in any lawfully authorized enforcement.

AB 1586 - Schabarum Deletes the requirement that courts report to the (Chapter 814) Department of Motor Vehicles convictions for violations relating to the registration and transfer of vessels.

AB 1599 - Duffy Permits the location of local in-patient and out-(Chapter 815) patient mental health facilities in any area zoned for hospitals.

AB 1734 - Moorhead Allows a contract under the Improvement Act of 1911 (Chapter 816) to contain provisions to determine a fair and equitable price for charges in work thereunder subject to prescribed limitations. The bill includes arbitration and cost plus fixed fee as methods of price determination.

AB 1988 - Mobley (Chapter 817) Permits an irrigation district board to exempt an annexed parcel of land which is not capable of being served water at the time of inclusion from the imposition of district assessments, in whole or in part, until such time as a water supply is available for such land.

AB 2001 - Priolo Establishes separate procedure regarding transfer (Chapter 818) of territory from one community college district in Los Angeles County to another such community college district.

have been signed:

AB 167 - Barnes (Chapter 855) Provides that the amount deducted from the refundable balance after termination of service under the State Teachers' Retirement System shall be appropriated to the State Teachers' Retirement System and credited to the system's General Fund support appropriation as a reimbursement for the fiscal year during which such amounts are deducted.

\_AB 260 - Priolo (Chapter 856) Requires the court to interview all persons listed as suitable to serve as grand jurors to ascertain whether they possess statutory qualifications for grand jurors. The bill further provides that in order for the name of an eligible person to be listed he must sign a statement declaring availability for service for number of hours usually required of member of grand jury in the county.

- AB 358 - Bagley (Chapter 857) Exempts any school district territory from the requirement that a school district unification election be held on the date of each presidential primary election in which after June 1, 1964, and prior to July 1, 1971, two unification elections were conducted within a 12-month period, both of which elections were defeated, or a unification election was held during the preceding calendar year. The bill also requires the Department of Education to study the progress and status of prescribed school district reorganization and to report thereon to the legislature in 1973.

AB 450 - Warren (Chapter 858) Provides that the University of California, the California State Colleges and the community colleges adopt the procedures necessary to inform their students of the rules and regulations of conduct and the penalties imposed for violations. This bill also deletes the requirement that each student be provided with a copy of such rules and regulations at the time of registration and that revisions be distributed.

AB 837 - Ryan (Chapter 859) Amends various sections of the Certified Master Teacher Law, including a revision of the description of the two school districts which may participate in the three-year master teacher selection pilot program, a revision in dates for applications for and appointments as master teachers, and changes in the schedule for implementing the program. The bill provides that a school district may not participate in the program until an election has been held for all certificated employees of the district and 60 percent of those voting indicate support of the program.

AB 898 - Brathwaite Revises the procedure required to be followed by the (Chapter 860) county clerk in making up the grand jury box and selecting persons therefrom to serve on the grand jury. The bill also changes the authorized maximum number of members of the Los Angeles County grand jury from 34 to 40.

AB 917 - Duffy (Chapter 861) Prohibits administration of certain drugs to horses before or during a public horse show, competition, or organized sale. It requires every exhibitor to allow a specimen to be taken from any of his horses upon request. It prohibits public exhibition or sale of a horse known to be drugged. The bill charges the Department of Agriculture with the responsibility for administering the program through a fee for entering or exhibiting a horse in a public show.

AB 937 - Biddle Requires manufacturers of motor vehicles to warrant that pollution control devises are effective for (Chapter 862) five years or 50,000 miles. AB 940 - Hayes Provides that the oath required to be taken by (Chapter 863) administrators or executors of estates may be taken, and dated, on or after the time when the petiton for letters testamentary or letters of administration is filed and may be filed with the county clerk after the petition is granted. AB 1013 - Johnson, R. Changes the composition and procedure of appointment (Chapter 864) for the Committee on County Tax Collecting Procedures. AB 1015 - Johnson, R. Specifies that where a public agency acquires (Chapter 865) property after the lien date by condemnation and seeks a refund of property tax on such property, it would be required as a prerequisite to such refund that the public agency reimburse the condemnee in the eminent domain action and submit proof of the reimbursement. AB 1509 - Keysor Excludes buildings utilized by adult schools or (Chapter 866) community colleges for off-campus, voluntary adult education courses from the definition of a "school building" for purposes of specified structural Present law permits the use standards provisions. of such buildings for non-credit courses. Provides that reconciliation of the parties, whether conditional or unconditional, shall be an ameliorating AB 2462 - Hayes (Chapter 867) factor to be considered by the court in considering any contempt of existing court order under the Family Law Act. Requires the Secretary of the Resources Agency to establish a task force to conduct a study of the SB 215 - Harmer (Chapter 827) state's effort to preserve and salvage the archaeological, paleontological, and historical resources of the state. The bill declares the intent of the legislature that there shall be a moratorium on the disturbance of native California Indian burial sites abandoned less than 200 years until the legislature acts upon the report required to be transmitted to the legislature by the secretary. Requires the State Allocation Board to review all SB 273 - Rodda (Chapter 828) applications for school building aid to insure that no apportionments will be made for construction of permanet facilities to meet temporary peak enrollments at any site or at any grade level. Provides that the county base commitment rate for SB 353 - Kennick (Chapter 829) purposes of state reimbursement for the Probation Subsidy Programs shall be limited to a range not less than 40 commitments nor more than 100 commitments per 100,000 population. To become operative July 1, 1972. SB 354 - Kennick Provides that if the amount received by a county (Chapter 830) from the state in reimbursement of its expenditures for special supervision programs under the State Aid to Probation Services Act in a fiscal year is less than maximum statutory amount allowable, the difference may be used by the State in the next two succeeding fiscal years rather than the next single succeeding fiscal year. SB 493 - Carpenter Specifies the annual fee for on-sale general bona fide public eating place intermittent dockside license to be \$360 per year. It also repeals two (Chapter 831) obsolete sections of the law dealing with the computation of the annual fee for off-sale general licenses and makes related changes.

SB 520 - Deukmejian Authorizes denial of an application to take the (Chapter 832) examination for licensure as a dentist, registration as a dental corporation, or licensure as a dental hygienist under designated circumstances.

SB 535 - Petris (Chapter 833) Requires the immunization against diptheria and tetanus of persons 18 years of age or under, and pertussis (whooping cough) of persons six years and under, prior to or within two weeks of first admission to school, a child care center, day nursery, or a nursery school.

SB 549 - Short (Chapter 834) Provides that development centers for physically handicapped and mentally retarded minors may conduct experimental programs for such minors who are between 18 months and three years of age. Such experimental programs are required to be approved in advance by the Superimendent of Public Instruction.

SB 557 - Marler (Chapter 835) Amends provisions of the Milk Stabilization Law relating to subdistributor prices. Present law provides that the price shall be the price established for the marketing area where the milk is ultimately sold rather than the price in the area of purchase. The bill changes the pricing point to the price in the area of purchase by the subdistributor except for sales outside of the milk pooling area.

SB 581 - Way (Chapter 836) Specifies that the county agricultural commissioner (chapter 836) shall be responsible for all local administration of the enforcement program in all cases where the provisions of the Agricultural Code place joint responsibility for the enforcement of laws and regulations on him and on the Director of Agriculture, except as otherwise specifically provided.

-SB 608 - Zenovich Amends the Physical Therapy Act to provide for the (Chapter 837) licensing of graduates of foreign physical therapy schools.

SB 609 - Zenovich (Chapter 838) Revises the Physical Therapy Act with respect to fees, terms of Examining Committee members, eligibility for appointment to the Committee, distribution of licensing and disciplinary powers between the Committee and the Board of Medical Examiners, licensing of physical therapists' assistants, administrative functions of the Committee, uniformity of examinations, reexamination, obsolete provisions, grounds for disciplinary action, and injunctive relief.

SB-648 - Lagomarsino Deletes the Government Code provisions specifying (Chapter 839) the salary of the Deputy Director of the Department of Justice.

<u>SB 655 - Rodda</u> (Chapter 840) Requires eligibility for state scholarships to be determined on the basis of results of a national or statewide test (or tests) which is to be determined by a panel of five psychologists or psychometrists appointed by the State Scholarship and Loan Commission, rather than generally on the basis of a competitive examination or the results of the College Entrance Examination Board Scholastic aptitude test.

- SB 670 - Song (Chapter 841) (Counting 1, and justice court judges can be represented in proceedings involving their judicial duties by the county's county counsel. The bill excepts (Countinal proceedings against judges, grand jury investigations of judges, proceedings before the Commission on Judicial Qualifications, and civil action or proceedings arising out of facts under which judge was convicted of criminal offense in a criminal proceeding.

SB 786 - Grunsky Repeals the provisions of the State School Building Aid Law which limit the authority of the State Allocation Board to allocate more than 3½ percent of the proceeds of State School Building Aid bonds for (Chapter 842) the construction and equipping of facilities for exceptional children. SB 918 - Grunsky Allows school districts to retain substitute teachers for the entire school year to fill positions for which no regular teacher is available. (Chapter 843) The bill also grants probationary status to a temporary teacher who has completed one full school year in that status and has been reemployed for the following school year in a position requiring certification qualifications. SB 921 - Way Authorizes the Director of Agriculture to order any animal carrying residues of pesticides, poisons, or other deleterious substances to be held on the premises where it is found or elsewhere until a (Chapter 844) determination that the animal may be safely released for human food purposes. SB 937 - Burgener Authorizes the State College Trustees, with the approval of the Department of General Services, to (Chapter 845) exchange a parcel of land near San Diego State College for another nearby parcel and expresses legislative intent that they lease the newly acquired parcel to the City of San Diego for use as a city park. SB 940 - Cusanovich Permits the Director of Motor Vehicles to refund (Chapter 846) cash deposits or assignment deposits after three years from the time a vehicle dealer goes out of business, providing there are no outstanding claims against the deposit or assignment. SB 1002 - Petris Authorizes the Superintendent of Public Instruction (Chapter 847) to use funds from the free textbook budget to ship obsolete textbooks to specific persons and groups, where the cost thereof will be lower than cost of storing or otherwise disposing of the books. SB 1063 - Alquist Modifies the filing requirements for certain tax (Chapter 848) exempt organizations. SB 1073 - Deukmejian Increases the time limits for a defendant to (Chapter 849) answer in forcible or unlawful detainer actions for possession of real property from three days to five days. The bill also provides for a five-day time limit for answer of a complaint or amendment of an answer under specified circumstances. SB 1076 - Burgener Authorizes the Superintendent of Public Instruction (Chapter 850) to approve an extension of 20 days for a substitute teacher to teach physically handicapped minors. SB 1278 - Coombs Changes the fee structure and license term for (Chapter 851) commercial driving schools and driving instructors. It requires instructor applicants to complete a special course of training in teaching driving and permits the Department of Motor Vehicles to take action against a license for teaching driving in an unsafe manner. SB 1317 - Grunsky Requires the Board of Governors of California (Chapter 852) Community Colleges to establish, for purpose of the Education Code provisions disgualifying school districts from State School Fund apportionments, standards to determine whether community colleges have maintained the regular day schools of the district for at least 175 days during the next preceding fiscal year.

SB 1406 - Lagomarsino Vests in the Department of Parks and Recreation (Chapter 853) exclusive jurisdiction with respect to property salvage and recovery operations in the state park system.

SB 1474 - Kennick Authorizes the lease of granted tidelands or (Chapter 854) submerged lands to the Regents or Trustees for educational purposes.

The governor also announced that he has vetoed the following

bills:

- AB 276 Stacey Includes licensed vocational nurses within the definition of "professional employees" for purpose of right to representation by a professional employees organization under the public employer-employee relations law.
- REASON FOR VETO: "When I vetoed a similar bill last year I expressed a concern that the creation of additional representation units could have an adverse effect on employee relations programs. I still have that concern. Approval of this bill would encourage other occupational groups to seek similar treatment and thus further fragment the number of representation units that government must bargain with.

"Accordingly, I am returning the bill unsigned," the governor said.

- SB 1596 Rodda Extends the existing permissive school override tax for child nutrition programs to include preschool children's programs.
- REASON FCR VETO: "I strongly support local decision making and local control of public education in California. The constant pressure for additional permissive school tax overrides or the extention of such overrides erodes local control by taking from the voters the right to participate in the determination of spending priorities. I am taking this action reluctantly; however, I feel there must be an end to the practice of bypassing the voter in matters affecting the financing of programs at the district level.

"Accordingly, I am returning the bill unsigned," the governor said.

Governor Ronald Reagan announced today that he has vetoed AB 950 (Fong).

In announcing the veto, the governor said:

"This measure would remove from parents their right to consent to their children's participation in venereal disease instructions.

"I am aware that venereal disease has reached epidemic proportions in many parts of this state. I agree with educators and public health officials that there is a pressing need for effective venereal disease education programs in our schools. Such education should continue and new programs should be developed. The issue of parental consent is no real barrier to the presentation of such instructional programs.

"Existing law already permits venereal disease instruction in the public schools with prior parental approval. Parents should be able to retain this prerogative with respect to venereal disease education courses."

AB 279 - MacDonald (Chapter 877)	Brings the definition of schoolbus in the Education Code into near-conformity with the definition of schoolbus in the Vehicle Code. The bill also clarifies the existing law with respect to passing a schoolbus.
AB 327 - Wood (Chapter 878)	Amends the Agricultural Code to broaden and strengthen the authority of the Director of Agricu to deal with the handling of pesticides and the disposal of pesticide containers.
AB 529 - Foran (Chapter 879)	Authorizes counties to permit their public defender to enter into mutual assistance agreements with public defenders of other counties permitting temporary assignment of deputies from one county to another in actions or proceedings in which the publ defender of the county to which the deputy has been assigned has properly refused to represent a party because of a conflict of interest.

AB 1033 - Moorhead Changes certain tax collection and regulation (Chapter 873) procedures of the Department of Human Resources Development . AB 1084 - Gonsalves Authorizes employees of the Department of Public (Chapter 874) Works to remove disabled vehicles which constitute an obstruction to freeway traffic. AB 1124 - Dent Revises membership of local admission committee (Chapter 887) for programs for mentally retarded minors. #553 AB 2624 - Cullen Deletes an archaic reference to a police chief's (Chapter 907) authority over chain gangs. The bill also authorizes requirement of labor on public works as a condition of probation of person confined in a city jail, by order of the city council, in the same manner as labor on public works may be required of persons in a county jail on order of board of supervisors. AB 2775 - Lanterman Amends the Lanterman Mental Retardation Act to (Chapter 908) create a State Developmental Disabilities Planning and Advisory Council. AB 2867 - Knox Establishes the Bay Area Sewage Services Agency (Chapter 909) comprising the territory of San Francisco, San

Mateo, Santa Clara, Alameda, Contra Costa, Solano Napa, Sonoma, and Marin Counties. The bill requires the Agency to develop and adopt a regional water quality management plan.

SB 914 - Grunsky (Chapter 968) Authorizes county superintendents of schools, with approval of county boards of education and the governing board of the school district, to provide programs for mentally gifted minors who reside in any school district, rather than who reside in any school district which has an a.d.a. of less than 901 in the schools of the district. The bill also provides for allowances for county superintendents of schools who maintain programs for mentally gifted minors, such allowances to be the same as for school districts which maintain such programs.

SB 1180 - Rodda (Chapter 869) Provides that after 30 days from the date that judgment is pronounced, any report of the probation officer may be inspected by court personnel, shall be made available only to persons authorized or required by law to inspect or receive copies of the report, and shall not be open to public inspection. Any other person may inspect or receive copies of the report by filing a petition with the court and the court, on its own motion, may make the report public, or disclose its contents at any time.

Governor Reagan has vetoed the following bill:

SB 855 - Song

Prohibits prosecution of felonies if not tried within 60 days after arraignment unless the prosecution can prove "good cause" for such delay.

PEASON FOR VETO: "It is highly doubtful whether this measure, presented as a court reform bill, will accomplish any reduction in court delay. There will probably be a good deal of litigation to determine what amounts to "good cause" when the prosecution seeks to refile a charge which was dismissed because the case did not proceed to trial within the 60 day period. More important, the bill misplaces the cause for trial court delay upon the prosecution. Almost all of the continuances granted in criminal cases are granted by the court at the request of the defendant or on the court's own motion because of insufficient courts in which to proceed.

"Accordingly, I am returning the bill unsigned," the governor said.

The bill also provides that such members be entitled to leaves of absence at full salary up to one year in lieu of temporary disability compensation benefits for disabling injuries. AB 499 - Quimby Includes within the class of peace officers whose (Chapter 919) dependents are eligible for specified scholarships, those peace officers who are totally disabled as a result of accident or injury caused by external violence or physical force incurred in performance of duty. AB 1038 - Quimby Extends the use of scholarship grants to (Chapter 920) survivors of police officers killed or permanently disabled as a result of accident incurred in performance of duty, to collegiate grade institutions located in California and accredited by the Western Association of Schools and Colleges. AB 1641 - Stacey Authorizes the Board of Medical Examiners, the Attorney General, and district attorneys to seek injunctive relief against violations of the law (Chapter 921) regulating dispensing opticians, and certain statutes relating to measurements for, and the fitting and furnishing of, prescription lenses. AB 1719 - Arnett Increases compensation of municipal court clerks (Chapter 922) and their deputies for the municipal courts of San Mateo County, AB 1771 - Miller Provides that not more than 6 percent of the proceeds (Chapter 923) of a school district override tax to finance school meals for needy pupils may be used for administrative and clerical costs of conducting such programs. AB 1790 - Knox Provides that specified public entities which own (Chapter 924) or operate a sanitation or sewer system may require the pretreatment of industrial waste otherwise detrimental to the treatment works, or prevent the entry of such waste into the collection system and treatment works, or may require payment of excess costs to the system for supplementary treatment plants, facilities, or operations needed as a result of allowing such waste into the collection system and treatment works. Amends the Land Conservation Act to eliminate the AB 1900 - Johnson, R. (Chapter 925) requirement of filing certain records, reports and maps with the Director of Agriculture and substitutes a provision to provide that once each year any county or city with an agricultural preserve file a map with the Director of Agriculture designating the area covered by agricultural preserves. AB 1965 - Greene, L. Permits admission to the first grade regardless of the pupil's age, of a pupil who has completed one (Chapter 926) year in the kindergarten of a private or public school, rather than only a public school. The bill also authorizes admission to the first grade, regardless of the pupil's age, of a pupil who has been lawfully admitted to a public or private school kindergarten, rather than only a public school kinder-garten, in California and who is determined to be ready for first grade work.

REASON FOR VETO:	"The Probation Subsidy Program is to be evaluated by a Department of Finance management audit in the next several months. Consideration of any adjust- ment in the level of state support for this worthwhil program should be deferred until the results of this study can be evaluated and the availability of additional funding is assured. At the present time no funds are available to pay the additional state cost mandated by AB 92. The Department of Finance estimates the added cost at \$3.6 million commencing in 1972-73.
	"Accordingly, I am returning the bill unsigned." the governor said.

**Provides that the Contractors' State License Board** may appoint the investigative or inspectional personnel necessary to enforce the Contractors License Law and that the Division of Investigation of the Department of Consumer Affairs shall have no authority to investigate violations of that law or perform inspections pursuant to it.

REASON FOR VETO: "Senate Bill 234 nullifies, as to the Contractors' State Licens<sup>e</sup> Board, the provision of Governor's Reorganization Plan No. 2 of 1970 which authorizes the Director of Consumer Affairs, when he determines it to be in the interests of efficiency, economy, and effective service to the public, and after consultation with and consideration of views of the agency concerned, to transfer the investigative or inspec\* tional personnel of any agency in the department to the department's Division of Investigation, subject to the statutory qualification that an agency may retain 10 percent of its investigative or inspectiona personnel, and in no event less than one person. "Accordingly, I am returning the bill unsigned,"' the governor said.

SB 1516 - Moscone Eliminates the requirement that the court first receive the consent of the district attorney before granting probation to persons convicted of specified serious crimes.

REASON FOR VETO:

"I am vetoing this bill at the request of the California Peace Officers' and District Attorney's associations. SB 1516 seeks to codify the holding of the California Supreme Court in <u>People v. Esteybar</u> I believe that the district attorney should retain the power to consent to the grant of probation to defendents convicted of serious crimes. This is a power which has traditionally and wisely been accorded the prosecution.

"Accordingly, I am returning the bill unsigned," the governor said.

Governor Ronald Reagan has vetoed the following bill:

SB 517 - Dymally Requires the governing board of Los Angeles Unified School District to provide for the establishment and operation of a school-community council for each school within the district.

REASON FOR VETO: "The need for meaningful parent participation in the educational processes of the Los Angeles School District is beyond question. However, I am vetoing this bill because it imposes on the Los Angeles School District a structure and procedures which are opposed by the Los Angeles Board of Education and by its Superintendent of Schools. It is not appropriate for the state to interfere in local school affairs against the will of those who immediately represent the citizens and at a time when the district is working out a decentralization plan, a major part of which is the operation of school-community advisory councils in each school. "Accordingly, I am returning the bill unsigned," the governor said.

Acting Governor Ed Reinecke has signed Senate Bill 504 which he described as "a landmark measure that will allow private property owners to open their lands to recreational use without facing the threat of losing title to the property."

The legislation by Senator Robert J. Lagomarsino (R-Ojai) prospectively reverses a California Supreme Court decision which held that if a property owner continued to allow the unchecked use of his land by the public for five years or more, it could constitute an implied dedication of the land to the public.

"This bill establishes a responsible balance between public and private property rights and should assure the continued use of access to beaches, streams and forests by the public," Reinecke said. # # # # #

Acting Governor Ed Reinecke today signed legislation (SB 168) that provides the issuance of \$160 million in bonds for community college construction, site acquisition and equipment and calls for a special bond issue election to be consolidated with the November, 1972 general election.

Pointing out that funds from the 1968 community college bond issue will be depleted by 1972, Reinecke said the measure provides matching state funds for communities which will allow them through a vote of the people to meet projected enrollment increases at community colleges.

"Our community colleges with 93 campuses and 800,000 students provide the people of California with the lowest cost, quality higher education in the nation and represent the largest single network of higher education in the free world," he said.

Acting Governor Ed Reinecke today signed into law a measure designed to protect the salmon and steelhead population in California's streams.

The measure (AB 2147) by Assemblywoman Pauline Davis (D-Portola) calls for the screening of water diversions on salmon and steelhead streams when they are determined by the Department of Fish and Game to be detrimental to fish life.

"In addition to protecting these game fish, this measure will require those who would divert these streams to pay for construction and maintenance costs of the diversion project. It also requires that the necessary protective measures must be approved by the Fish and Game Department before any water course is diverted," Reinecke said.

Acting Governor Ed Reinecke has signed a law which will strengthen California's air pollution controls on older model automobiles.

The measure (SB 622) by Senator Gordon Cologne (R-Indio) authorizes the State Air Resources Board to approve a device for controlling the emissions of hydrocarbons, carbon monoxide or oxides of nitrogens on 1955-65 model cars.

"This law, part of Governor Reagan's legislative program, provides us with another environmental protection weapon in our many-pronged attack against the causes of air pollution," Reinecke said.

"In addition to providing effective controls against one of the three emissions which contribute to smog, it reduces the expected useful life for a used car device from 50,000 to 30,000 miles and requires that the total cost for all devices approved for these cars cannot exceed \$65."

~	AB 35 - Cullen (Chapter 1053)	Provides that the Department of Public Works has authority to lease airspace over and under freeways for a period of up to 99 years.
	AB 121 - Greene, B. (Chapter 1054)	Permits tenant of a housing authority to serve as a commissioner of that authority if specified disclosumer made, and permits such a tenant to serve as a member of a community redevelopment agency.
	AB 414 - Johnson, H (Chapter 1055)	Provides that firemen employed by the state including University of California, but not including the Division of Forestry, shall be accorded workmen's compensation benefits for death or disability of a fireman occurring while firefighting, rescuing or preserving or protecting life or property anywhere in state when not acting under the immediate direction of employer.
_	AB 523 McAlister (Chapter 1056)	Provides that no justice court judge may share fees, commissions or expenses with any person who acts as an attorney in any justice court in the county in which the judge resides.
	AB 546 - Dent (Chapter 1057)	Requires each school district desiring an apportion- ment of funds, unless exempted by the State Allocation Board, to prepare a comprehensive master plan containing specified information. Provides for the issuance of a provisional license as a cosmetology instructor.

AB 1571 - Johnson, H. Eliminates the restrictions of purchase price or (Chapter 1072) consideration for transfer of off-sale or on-sale general licenses issued after June 1, 1961 after five years from the date of original issuance. It also eliminates the restrictions of purchase price or consideration for transfer of off-sale or on-sale licenses previously transferred intercounty after a period of five years from the date of intercounty transfer.

Revises provisions regarding vehicle pollution contro: devices by specifying that when a motor vehicle pollution control device is accredited by the State AB 1591 - Biddle (Chapter 1073) Air Resources Board, every motor vehicle in a class not exempted by the board shall be equipped with an accredited device, in accordance with schedule of installation established by the board. The bill requires the Air Resources Board, after consultation with the Departments of the California Highway Patrol and Motor Vehicles, to establish a schedule for installation of motor vehicle pollution control devices to be not less than one year, whenever the installation of such devices is required by the board.

AB 1904 - Warren (Chapter 1077) Provides that if at time of filing a verified petition to declare a child free from custody and control of parent by designated governmental agencies, the child is in the custody of such a petitioner, the petitioner may continue to have custody of the child pending the hearing on petition unless the court, in its discretion, makes such other orders regarding custody pending the hearing which it finds will best serve and protect the interests and welfare of the child.

AB 1919 - Stacey (Chapter 1078) Authorizes the Department of Water Resources to loan up to \$2,500,000 to specified agencies for construction of works utilizing water from the State Water Resources Development System.

AB 1986 - Mobley Provides that cash value of distilled spirits, for (Chapter 1079) purposes of property taxation, shall not include unpaid federal excise taxes where such distilled spirits are located in a controlled stock area.

AB 2091 - Meade (Chapter 1080) Provides for a person who is already imprisoned to be brought before a court for sentencing with respect to another criminal matter which is pending against him, within 90 days after he has given notice to the district attorney, unless he wants a continuance.

AB 2203 - Barnes (Chapter 1081) Creates an exception to the provision of the Public Employees' Retirement Law that a member's retirement may not be made effective earlier than the first of the month in which the member's application is receiv by the system. The exception would permit, for a limited period, an earlier effective date if the member chose to entrust the transmission of his application to his employer and the employer delayed unreasonably in such transmission.

AB 2135 - Campbell Makes certain Education Code provisions regarding (Chapter 1082) Makes certain Education Code provisions regarding districts applicable to annexation of parts of such districts, and provides that such parts be considered component districts for specified purposes. The bill also provides that the authorized amount of bond issues of the annexed district for purposes of paying share of cost of the annexing district's property, shall be reduced by the amount raised pursuant to a special tax for such purposes.

AB 2300 - Greene, B. Authorizes school districts to establish pilot (Chapter 1083) programs, upon approval by the Superintendent of Public Instruction, to provide for vocational training on Saturdays. The bill provides that such training may be part of, but is not limited to, a national defense program of the federal government or any agency thereof.

AB 2343 - Cullen (Chapter 1084) Requires the Department of General Services to provide local governmental agencies, upon request, updated lists of items available for purchase through the state cooperative purchasing program.

AB 2357 - Fong (Chapter 1085) Declares that one of the purposes of the State Aeronautics Act is to assure protection to persons residing in vicinity of airports against unreasonable noise levels. The bill further declares that the function of the airport land use commission is to achieve through zoning land use in vicinity of airports compatible with airports to the extent that such land is not already under an incompatible use, and to require new construction in such areas to conform to standards adopted from time to time by the Department of Aeronautics. #578 AB 2387 - Wakefield Changes the composition of the Board of Administratic (Chapter 1086) of the Public Employees' Retirement System, by deleting the Comptroller of the University of Californi on January 15, 1973 and substituting a member elected by noncertificated school employees.

AB 2468 - Burke (Chapter 1087) Authorizes school districts to authorize any person to perform pupil supervision services during meal periods.

AB 2802 - Stacey (Chapter 1088) Provides that, in any county, the board of supervisors may by ordinance fix a date or schedule of dates for the payment of salaries of judges and other officers, employees and attaches of the courts in the county.

AB 2818 - Foran (Chapter 1089) Makes nonsubstantive changes in substituting the name of the San Francisco Port Commission for its predecessor San Fransico Port Authority and in describing authority of policemen of the commission.

AB 3087 - Dunlap (Chapter 1090) Empowers Napa County to adopt rules and regulations with respect to specified forest practices matters which are stricter than those provided under the Forest Practice Act and those promulgated by the forest district forest practice committee.

SB 1511 - Moscone (Chapter 1029) Authorizes the Department of Public Health to establish a five year pilot project in not more than six counties in areas in high nutrition need, for women during pregnancy and infants under one year of age. The bill requires the department, if it establishes such a pilot program, to establish nutritional requirements, designate specific supplemental foods to meet those requirements, develop a system for delivery of food items and nutrition coupons, and seek federal and other funding regarding such project.

Acting Governor Ed Reinecke today signed legislation which will require county boards of supervisors to submit estimates on welfare expenditures and caseloads to the legislature.

The bill (AB 1598) by Assemblyman Gordon Duffy (R-Hanford) calls for estimates for present and forthcoming fiscal years of the average monthly caseloads and grants and the total appropriation and expenditure for certain categories of aid and medically needy to be submitted annually by May 15 to the Senate Finance Committee, Assembly Ways and Means Committee and the Joint Legislative Budget Committee.

"Although I recognize that at the outset this measure will require additional administrative effort by the counties and the state Department of Social Welfare, I believe that in the long run this information will be of considerable value in fiscal planning," he said.

Acting Governor Ed Reinecke today signed legislation that will allow the governor to appoint five additional members to the California Advisory Council on Vocational Education and Technical Training.

The measure (AB 576) by Assemblyman Bill Greene (D-Los Angeles) provides for the appointment of one representative of county offices of education, two representatives of occupations and two students who are enrolled in a vocational education program.

"I am particularly pleased that students will be given a voice in deciding policies in this very important educational field," Reinecke said in signing this bill.

Acting Governor Ed Reinecke today announced the veto of Assembly Bill 1335 which would authorize school boards to pay the cost of replacing property stolen from a school employee by robbery or theft while on duty.

"Present law permits school boards to compensate employees for personal property damaged or destroyed in the line of duty through no fault of the employee. I question the need to extend this authority to include personal property lost as a result of theft or robbery. Such compensation should be limited to personal property damaged or destroyed as a direct consequence of the employee's work activity. Furthermore, it would be impossible for a school district to accurately determine the value of personal property no longer in the possession of the employe

"Accordingly, I am returning Assembly Bill 1335 unsigned," the acting governor said.
