At 11:45 a.m. today you will present two Division of Highways employees with checks of \$10,680 (minus tax deductions) for developing a system that saved the state \$430,207 during the first year it was used. This, I am told is the greatest first year savings in the history of the California State Merit Awards Program.

They are Miss Ena E. Charlton, a Senior Clerk Typist who has been with the Highways Division for 16 years, and John W. Devinney, an Assistant Highway Engineer, who has been with the Highways Division for 25 years.
