THE STATE OF THE RESOURCES AGENCY*

Introductory Remarks

I am pleased to present this "State of the Agency" report on the Resources Agency, to discuss our accomplishments for the people of California during the past year, and our objectives for the year ahead.

The responsibilities of the Agency are diversified -they range from improvement of the quality of the air we breathe,
to predictive studies of earthquakes. While one department is
engaged in the design and construction of the California Water
Plan, another is preparing plans for underwater parks.

We proceed with the basic belief that the natural resources of California are for the benefit of <u>all</u> citizens.

Our major objectives are:

- Conservation, which is defined as the preservation, protection and enhancement of the quality of our natural environment;
- The balanced development of the natural resources of the State to meet the needs of an expanding population.

The contributions of the 12,000 employees working in the various units within the Agency are worthy of special commendation. They are hard working, loyal and effective state servants. Their dedication to the public is clearly demonstrated by their effectiveness in carrying out the various programs the Agency is responsible for.

Before we turn to reports of each department, I want to highlight some activities of the Agency that fit into Governor Reagan's Creative Society approach to government of and by as well as for the people.

In the area of minority employment, newly-created trainee positions will enable us to implement the Governor's Career Opportunities Development Program during 1969. We are proud that the Departments of Conservation and Water Resources have taken a leadership role in this field. These training positions will provide disadvantaged persons with an opportunity to qualify for regular civil service positions.

We will continue our efforts to insure efficiency and economy in all operations of the Agency without lowering the level of essential public services. To date, we have implemented 101 of the 166 recommendations of the Governor's Task Force on Efficiency and Cost Control -- I am proud to state that on a percentage basis this is the best record of implementation among the four Agencies. These implemented recommendations have resulted in \$9.9 million in potential annual savings and \$8.6 million in one-time savings. The savings were accomplished through development of improved purchasing and accounting procedures, efficient use of existing staff, reorganization of departments and bureaus, and the elimination of unproductive branch offices. Let me re-emphasize the fact that our economies have not reduced essential public services. Typical of savings accomplished through interagency coordination was the \$5 million saved through use of the Peripheral Canal as a borrow area for the development of the Interstate 5 freeway near Tracy.

A pilot program to develop an agency-wide automated records system for personnel and fiscal matters will provide for standardized procedures and will be studied by other agencies. If the program is found feasible, it will be adopted throughout State Government.

Establishment of an electronic data processing service center last year for all units within the Agency avoids the costs of developing separate computer centers within each department. The installation of remote access devices has helped to spread the advantages of computer use.

The Resources Agency has worked to encourage research by the private sector to identify potential sources of water. These sources would include desalinization, waste water reclamation, water conservation campaigns, underground water exploration, weather modification, and geothermal sources.

Major progress was made in the field of flood forecasting through improvements in computer techniques and by the
installation of a high-speed telemetry system to report rainfall
and river height data to the flood control center in Sacramento.
Data processing time for this vital data has been reduced from
over one hour to a matter of minutes.

We will continue support of several coastal and ocean area resource studies now being prepared. Attention must be given to recreation, scientific, education, and industrial uses of this great resource. During the next year, we expect to consider the creation of a better integrated organization for all ocean area programs.

Last year, we moved forcefully to preserve, develop and improve our environment. We are gratified with the progress made to date by the California Tahoe Regional Planning Agency in preserving the natural beauty of Lake Tahoe. We hope that legislation will soon be passed by Congress creating a bi-state Tahoe Regional Planning Agency. This important next step is a "must" if we are to move forward expeditiously in drawing up and enforcing an overall master plan that will protect the proper environmental development of the whole Tahoe Basin.

The 13-year controversy over allocation of water in the Lake Tahoe Basin and the Truckee, Walker and Carson River Basins has been successfully resolved. The interstate compact to ratify our water allocation agreement must now be approved by the California and Nevada Legislatures as well as by the Congress.

Our request to have the Middle Fork of the Feather River designated as part of the National Scenic River System was approved in 1968; it means this river will retain its natural wild state for public use and enjoyment.

Since the adoption of California's Protected Waterways Act in 1968, we have initiated a study which will identify our scenic waterways and determine methods of protecting them for future generations. As required by the Act, the final report will be presented to the 1972 session of the Legislature.

The Joint Resources-Highways Committee, established by Governor Reagan in 1967, initiated and was successful in helping the Legislature pass a bill to resolve the long-standing controversy over whether highways or parks have higher public priority. Legislation passed last year now provides for a procedure to head off controversies. When the highway interests and public park owners do not agree on proposed highway routings through a park, the park owner may seek relief in the courts. This permits a fair determination of which has the higher public priority, parks or highways.

The San Francisco Bay Conservation and Development Commission report has been presented to Governor Reagan and the Legislature. The Commission is scheduled to terminate 90 days

after the final adjournment of the 1969 Legislative Session. While the report is under study, it is important that the Commission's life be extended. This action is essential to insure no lapse in the State's efforts to protect San Francisco Bay.

Related to the San Francisco Bay problem are questions on the Sacramento-San Joaquin Delta area. In the next few weeks the State Water Resources Control Board will present a report to Governor Reagan and the members of the Legislature regarding the San Francisco Bay and Sacramento-San Joaquin Delta Water Quality Control Program. The Board will recommend a plan to coordinate regional water quality management with both the protection of fish and wildlife, while providing also for increased recreational use.

A major review of all federal laws, regulations and practices regarding public lands is being conducted by the Public Land Law Review Commission. Authorized by the Congress in 1964, the study will recommend action to coordinate and update federal public land policy. California has a major stake in the outcome of the study and will continue its active participation in the work of the Commission. I serve as the Governor's representative on this Commission.

Conservation is now part of the curriculum for California's elementary and high school students under the provisions of Senate Bill 1, adopted last year. Departments within the Resources Agency and the Department of Education have developed a <u>Guide to California's Natural Resources</u>, a manual to aid conservation education. All 15,000 copies of the Guide are in use, and it is being revised and updated before reprinting. In 1969, emphasis will be placed on introducing conservation education in colleges and universities as part of the teacher training program.

The Redwood National Park on California's North Coast became a reality in 1968, but problems remain to be solved before it is completed. Of major concern is the status of the three state redwood parks -- Jedediah Smith, Del Norte Coast and Prairie Creek -- located within the boundaries of the new national park. These State parks total nearly 28,000 acres, and contain the great majority of the best stands of redwoods within the 53,000 acre area. We are pledged to protect the equity of the state and the contributions by private individuals and various organizations in these park lands. More than \$14 million have been donated by the Save-the-Redwoods League, lumber companies

and other groups to purchase redwoods in these parks. Negotiations with the Federal Government will begin this year directed to the question of joint management, leasing or possible exchange for these state parks.

This year, the Environmental Quality Study Council will consider ways to protect, manage and improve the quality of our physical and biological surroundings. The Council will present its findings and recommendations to the Governor and the Legislature in 1971.

The joint state-federal study of the Salton Sea involves 18 state and federal agencies. We are optimistic that a sound plan to preserve this important recreation area will soon be developed.

As to financing, during 1969, we will study the feasibility of providing long-term funding for implementing environmental programs. This study will include, for example, consideration of the developing of recreation areas near population centers, assistance for local air and water pollution control programs, creating recreation facilities in conjunction with the State Water Project, and other environmental programs.

Following are brief statements of the progress of departments within the Resources Agency.

Department of Parks and Recreation (William P. Mott, Jr., Director)

For the first time a comprehensive State Park System Plan has been developed. This plan explores the role of the State Park System in meeting California's recreational and environmental needs. It will be reviewed and up-dated annually to keep pace with California's ever-changing needs. The Outdoor Recreation Resources Plan is also being prepared, which will provide guidelines for all public agencies in the development of recreation resources and to protect and enhance the quality of our outdoor environment.

High among the accomplishments for 1968 are the programs to bring urban dwellers and our minority groups into active contact with our parks and recreation programs.

These programs are being operated for both immediate and long-run results. Director Mott and other department officials have held several meetings with members of minority groups to explore their recreation needs, and to encourage their use of the Park System.

The Department has assisted both public and private groups which provide needed outdoor education and recreation for urban core children. Special illustrative and educational material has been prepared for minority groups, including a Spanish language guide to the parks.

For the long-term, the Department has commenced a study in conjunction with the League of California Cities and the County Supervisors Association to determine the needs of the people for urban recreation and open space. The study will be submitted to the Director for implementation when it is completed late this year.

Last year, the Department cooperated in the Governor's Interagency Council on Ocean Resources program which included a survey of the ocean shoreline, to provide basic data for long-range conservation of this resource. An Advisory Board on Underwater Parks and Reserves recommended two underwater park sites at La Jolla and Julia Pfeiffer Burns State Park near Big Sur, and tentatively identified a third off Salt Point in Sonoma County.

Involvement of private enterprise in State-operated facilities has been successful. In 1963, for example, \$500,000 was invested by private enterprise in cabins, shops and a restaurant in nine park system units with additional new capital investment expected in 1969 to exceed \$500,000.

About 14,500 acres of new lands valued at nearly \$15 million were added to the State Park System in 1968. The System now has over 800,000 acres in 182 parks, beaches, reserves and historical areas throughout the State. Also, the Department received over \$650,000 in gifts of land or cash to purchase land from private citizens and organizations.

Over 100 local citizens are members of advisory boards established by the Department. These boards provide an opportunity for local citizen participation and planning in our parks program.

Department of Water Resources (William R. Gianelli, Director)

Major progress was made during 1968. Construction on the California Water Project reached the highest level in history this year and the California Aqueduct reached the half-way point. Some 55,000 acres of San Joaquin Valley land were irrigated for the first time with water from the Project. Recreational development in conjunction with the Project is underway.

Legislation redirecting and appropriating additional funds for construction derived from tideland oil royalties were passed. This permitted the Department to move ahead with important parts of the Project which would have had to be deferred had these additional funds not been made available.

Contracts for all of the minimum Project water yield of 4,230,000 acre-feet annually were completed, and water deliveries to Napa County, through the first phase of the North Bay Aqueduct, were begun.

Agreement reached with the other western states resulted in congressional passage of the Colorado River Basin Project Act. This historic action restored harmony among the Colorado River states which has not existed for many decades. The legislation guarantees a minimum of 4.4 million acre-feet of water annually to California, but does not require construction of dams in the Grand Canyon, a proposal that was highly objectionable to conservationists.

Department of Conservation (James Stearns, Director)

Last year California experienced the highest incidence of forest fires on record, but the actual acreage burned was held below normal by more than 20 percent because of personnel added to our fire crews, including many young men from disadvantaged or hard-core unemployment areas. These young men obtained important work experience while helping to prevent a disastrous fire season.

In addition, the Department entered into a landmark contract with the Department of Rehabilitation to provide complete rehabilitation and vocational training services for seriously disabled employees to enable them to continue productive work within State Service whenever possible.

Forest Practice Rules for all four forest districts were amended during this year. These changes strengthen enforceability of the rules, meet current conditions, and provide greater protection to our forest resources.

During 1969, a Surface Mining Commission, which I have appointed, will report to me with suggestions for regulations that will be submitted to the Legislature with a view toward instituting regulations that will establish environmental standards and controls for surface mining.

An important step toward unification of all state land programs was taken when the Governor's Reorganization Plan No. 1 of 1968, assegned the State Lands Division and State Lands Commission to the Resources Agency. Important programs such as geothermal development, the San Francisco Bay Plan, land exchanges with federal landowning agencies, and the development of our coastal and ocean resource studies exemplify the areas in which State Lands and other units within the Resources Agency have a commonality of interests.

Department of Fish and Game (G. Raymond Arnett, Director)

The Department produced nearly 40 million fish in its hatcheries in 1968. Also, a new fish hatchery near Sacramento was opened. This hatchery will produce over 6-1/2 million trout annually. Annual production at the Fillmore Hatchery was doubled when the modernization project was completed.

Over 38,000 youths received instruction from qualified private citizens in the hunter safety program on how to handle and use firearms safely and an additional 650 sportsmen and others were certified as qualified hunter safety instructors during the year.

An additional 24 projects of the Wildlife Conservation Board were completed and opened to sportsmen of California in 1968.

Department of Harbors and Watercraft (Robert Walker, Director)

The Department made loans of over \$8 million to local governments during 1968 for the construction of boating facilities. Additional grants in the amount of \$432,000 were made for construction of launching ramps.

Several pamphlets of boating law and boating safety were prepared and distributed by the Department. Assistance was given to local boating law enforcement agencies and to private boating groups in the conduct of boating safety programs.

Air Resources Board (John Maga, Executive Officer)

In the effort to preserve and enhance the quality of the air we breathe, the Air Resources Board developed a significant program in 1968.

As a result of the actions of the Board during the year, waivers from the provisions of the National Emission Standards Act allowing California to set stricter standards to control exhaust emission have been obtained.

The Board has divided the State into 11 air basins and has undertaken the necessary study programs to adopt air quality standards for each basin. The creation of the air basins and the air standards for each is a necessary first step to a coordinated statewide attack on air pollution.

Funds for site acquisition and working drawings for a new State Air Resources Board Laboratory are included in the proposed budget.

Water Resources Control Board (Kerry Mulligan, Chairman)

A comprehensive review of the Water Quality Control Act is now underway and results of this study will be placed before the Legislature for action this year.

While the Tahoe Regional Planning Compact was being developed, the State and Regional Board, together with local government representatives, took the necessary action to help protect the crystal clear waters of Lake Tahoe. During 1968, the export of treated sewage effluent from the Tahoe Basin was begun. While this exportation affects sewage from the South Tahoe Basin only, I am pleased that loans have been authorized to construct the facilities for export from the north and west shores of the Lake.

Conclusion

My comments have been addressed to the highlights of our progress during the past year, and to describe a few of our goals and objectives for the coming year.

Our concerns are not limited to these subjects above; they include consideration of many other issues and activities affecting our environment which are too numerous to mention in this report.

To sum up, the central theme of our goals and policies in the Resources Agency: The Governor and this Agency are dedicated to the enhancement and preservation of the quality of our natural environment and the wise use of our natural resources. We are for preservation as well as production, esthetics as well as economics.

BIOGRAPHICAL SKETCH--WILLIAM R. GIANELLI

William R. Gianelli, a California water engineer for more than 20 years, became Director of the California State Department of Water Resources January 2, 1967.

For seven years prior to his appointment, he was a partner in an engineering consulting firm bearing his name in Sacramento, specializing in the field of water supply, water rights and related water problems.

From 1946 to 1960 he served the Department and its predecessor agency in various capacities. Joining the State Engineer's staff as a junior hydraulic engineer immediately after World War II, he later became principal engineer in charge of the Department's Southern California District when he left state service to enter private practice. During the late 1950's he served as engineering consultant to several legislative committees concerned with the area of origin-area of deficiency problem. He assisted in the formulation of the legislation to authorize the State Water Project.

Born in Stockton February 19, 1919, Gianelli received his B.S. degree in civil engineering from the University of California in 1941.

He is a veteran of World War II, having entered the Army Corps of Engineers as a second lieutenant. He was discharged as a major in 1945.

James G. Stearns, 46, Director, California Department of Conservation, was appointed to this position by Governor Ronald Reagan, February 14, 1967. The Department includes the Divisions of Forestry, Oil and Gas, Mines and Geology, Soil Conservation, their associated boards and commissions; and the State Lands Division.

From Tulelake, Modoc County, and active in civic affairs, Stearns served as County Supervisor of Modoc County from 1951 to 1967 and did not seek re-election to the position. In 1965, he served as president of the Supervisors Association of California following terms as president of the Northern California County Supervisors Association and the Western Regional District of the National Association of Counties.

On numerous occasions he represented these organizations on legislative matters in the State Legislature as well as in Congress.


