In response to your December 6 memo requesting that Karna Small be reimbursed for her expenses related to the 1984 Republican National Convention, I am afraid that I must decline this request.

On July 23, I advised Mike McManus that Karna could travel to the Convention, provided that she pay her own way. With the exception of five staff persons whose travel is always considered official (i.e. those performing "official government duties"), no White House or other government funds were used to pay for convention-related activities or expenses of White House staff members.

To compound this matter, the Counsel's Office advises me that the Reagan-Bush '84 primary campaign funds are the only funds from which Karna could have been reimbursed. My staff reports that in checking with the campaign, we are advised that these funds have long since been spent.

I understand your desire to assist Karna, but am afraid that nothing can be done at this late date.

SUBJECT: Cong. David Martin/Fort Drum Event

I returned a phone call to Congressman David Martin on behalf of Mr. Baker yesterday.

Congressman Martin has been actively involved in trying to get the Department of the Army to agree to move some of their Light Divisions to Fort Drum. The Congressman made it clear that (1) he is not trying to lobby Mr. Baker on this issue and (2) he is not asking Mr. Baker to expedite a decision or to influence this decision in any way. Mr. Baker concurred with the above by saying that he would not become involved in expediting this matter.

Congressman Martin was, however, suggesting a Presidential event, should the decision be made (through the normal channels) to move these Light Divisions to Fort Drum. Mr. Martin pointed out that New England has always been criticized for its lack of "military strength." He felt that the President, as "Commander in Chief," deserves full credit for this decision and that he could emphasize the "fair spreading of our defense dollars" in his announcement. Mr. Martin also suggested that this announcement include a mention of the U.S.S. Iowa which will soon be tied up at Staten Island.

Mr. Baker asked that we get this recommendation "into the system" for consideration at an appropriate date. Mr. Martin felt that a decision was "imminent," i.e. in the next 1-4 weeks.

Once a decision is made, I told Congressman Martin that someone would be in touch with him to "close the loop."
