DEAR MR. BAKER:

THE ATTACHED INFORMATION SHOULD BE OF VITAL INTEREST TO YOU, THE REAGAN ADMINISTRATION, THE CONGRESS, THE FEDERAL RESERVE SYSTEM, AND OUR NATION AS A WHOLE.

I WOULD ASK THAT YOU TAKE A MOMENT OF YOUR PRECIOUS TIME TO READ THE ATTACHED MANUSCRIPT. IT IS MOST IMPORTANT TO THE PEOPLE OF OUR COUNTRY AND THE WORLD. IF IT IS YOUR PLEASURE, I WOULD BE PLEASED TO DISCUSS THIS VERY IMPORTANT MATTER WITH YOU OR A COMMITTEE OF YOUR CHOICE.

I HAVE BEEN INVITED TO PRESENT ANOTHER PAPER, "CAUSE AND CURE OF WORLD INFLATION", AT THE INTERNATIONAL ATLANTIC ECONOMIC CONFERENCE, IN ROME, DURING THE WEEK OF MARCH 11 - 15, 1985. IN AN EFFORT FOR YOU TO HAVE A COMPLETE AND TIMELY UNDERSTANDING OF THIS INFORMATION, IT WOULD BE BENEFICIAL TO ARRANGE A MEETING PRIOR TO THIS PERIOD OF TIME.

WHEN YOU HAVE A COMPLETE UNDERSTANDING OF THE MATERIAL, I WOULD ASK THAT YOU, OR IN CONCERT WITH ME, PRESENT THIS PAPER TO PRESIDENT REAGAN.
