Summary of Meeting on Terrorism

- (S) On April 17, 1986 a meeting of the White House Operations Group was held. The primary purpose of the meeting was to provide last minute threat assessments concerning the Far East The secondary purpose was to assess the fall out from the US bombing of Tripoli.
- The DIA noted three months of reporting on threats to US personnel - the Defense Attache - stationed in the Philippines (NEACP will be at Clark AFB while the President is in Bali). DIA also commented on countless demonstrations and threats to US Embassies and/or US interests throughout the world over the last several days.

State remarked that the demonstrations appeared to be spontaneous rather than orchestrated.

The PCLS responded that

those in Libya did not understand that demonstrations occur everyday at the White House, so these demonstrations would mean nothing. The PCLS main concern was the status of the checks for the student aid. There was also reference to get black demonstrators involved. There was no reference to Farrahkan.

The Secret Service provided travel itinerary for all protectees. Of most concern was the travel of Former President Carter and his visit to Khartoum, Sudan for 2-3 July.

- None of the agencies had any information which indicated a threat to the President or First Lady in their travels to the Far East.
- (S) Preliminary plans for the Statue of Liberty event were discussed. The next meeting, which is scheduled for May 16 will address the threat posed to that event.
