DURING AND AFTER THE DINNER A SPECIAL PROJECT TO SPECIFICALLY SUPPORT THE PRESIDENT'S GOALS IN REGARD TO NICARAGUA WILL BE DISCUSSED AND UNDERTAKEN BY THE GROUP. THE PROJECT IS VERY URGENT.

WE SINCERELY HOPE YOU WILL SUPPORT THE PRESIDENT BY ATTENDING AND PARTICIPATING IN THIS CRUCIAL PROJECT WHICH IS SO CLOSE TO HIS HEART. PARTICIPATION IS SEVERLY LIMITED. ONLY 20-5 INDIVIDUALS CAN BE ACCUMMODATED. NO PUBLICITY IS ALLOWED. CONFIDENTIALITY IS IMPORTANT. THE URGENCY OF THE SITUATION REQUIRES ME TO CALL YOU FOR CONFIRMATION AND WHITE HOUSE SECURITY CLEARANCE INFORMATION IN THE NEXT 72 HOURS. YOUR DINNER AND ACCOMMODATIONS AT THE HAY-ADAMS HOTEL ON LAFAYETTE SQUARE IN WASHINGTON ARE COMPLIMENTARY ON THE NIGHT OF NOVEMBER 21, 1985. WITH VERY WARM REGARDS,
