REQUEST FOR DOCUMENTS

This is to follow up on our conversation of January 24, 1987. Following a number of such discussions, I wanted to bring some particular matters to your attention.

Our review must move to a conclusion much more quickly than the investigation being conducted by the Independent Counsel. Yet our review of documents may be delayed by the joint custody arrangements among the Office of the White House Counsel, National Security Council, the Independent Counsel (and the Federal Bureau of Investigation). As an example, we have requested and now badly need copies of PROFs notes and computerized calendars held in joint custody. These were requested from the NSC on January 14th (see letter enclosed).

To assist our review, we would appreciate the following:

- Access to and, if necessary, copies of full text A) PROF notes for North, Poindexter, McFarlane, Fortier, and Teicher that are retrievable from their personal files and back-up disks, and copies of all computerized calendars for Poindexter, McFarlane, and Fortier retained in the computer system;
- Legible copies of the 1985 McFarlane and 1986 Fortier desk calendars from the FBI as requested from Alan Raul;

- C) Access to records of meetings and visits with, and phone conversations by the President to relevant parties during 1985 and 1986 as detailed in the attached requests;
- D) Access to, and if necessary, copies of all documents retained by the President and his White House staff (except for the National Security Advisor who previously provided the relevant documents) that pertain to Iran and the Contra diversion and any government involvement in the private supply of the Contras. The attached list will hopefully guide your search toward the types of documents we are seeking.
- E) Access to the encryption devices and other electronic hardware from North's offices and residence that are in joint custody and held by the NSC. In addition, access to and copies of any documentation for the transfer of such devices to North and others from the National Security Agency.

Finally, the attached memo from internal Board staff memo details our understanding of the status of the completed and ongoing searches for documents by the NSC.
