
Dear Chairman Fascell:

Pursuant to the oral request we received last week from John J. Brady, Jr., Chief of Staff, House Committee on Foreign Affairs, enclosed is a copy of the October 5, 1981, memorandum of William French Smith, along with supporting materials. These materials were previously made available to your Committee for inspection in the offices of the House Permanent Select Committee on Intelligence; by this transmission we are making available to you another copy of these materials for your review.
