



James F. Sisk has written Rich Williamson, on behalf of himself and Thomas Lavin, Peter Dugan, and Patrick Conaghan, to request appointment of a Special Prosecutor to investigate allegations of Mob infiltration of the Military Ocean Terminal in Bayonne, New Jersey (MOTBY). A New York Daily News article of March 7 (copy attached), based on "leaked" F.B.I. affidavits, alleged that Sisk (Bayone Public Safety Director), Lavin (Bayonne Deputy Police Chief), Dugan (a detective), and Conaghan (a Bayonne attorney) were involved with the Mob's efforts to infiltrate MOTBY. Sisk requests a Special Prosecutor to investigate the allegation that he and his colleagues are corrupt, and to investigate the illegal leak of the affidavits. Williamson has referred the matter to you, and so advised Sisk.

It seems apparent that the Special Prosecutor provisions do not apply to this case. 28 U.S.C. § 591. No matter how obvious such a determination may be, however, I do not think our office should become involved in making it. Nor do I think we should become a conduit for Special Prosecutor requests. Accordingly, I recommend advising Sisk that by statute the determination to apply for the appointment of a Special Prosecutor is the responsibility of the Attorney General, and that Sisk should direct any inquiries or requests on that subject to the Department of Justice.

Dear Sir:

Predicated on the leak of a sealed F.B.I. affidavit, the New York News is this week running a series of articles on organized crime control of the Military Ocean Terminal in Bayonne (MOTBY), a federal installation. Included in this articles are a series of unsubstantiated allegations about the Bayonne Police Department and me personally. I have been advised by both the Federal Bureau of Investigation and the United States Attorney's office in Newark that this matter is being investigated.

Since this type of "yellow dog press" rivals what our fine Secretary of Labor, Raymond Donovan, has been through, I ask that I and my fellow officers, Deputy Chief Thomas Lavin and Detective Peter Dugan as well as attorney Patrick Conaghan be accorded the same effort at vindication as was provided the Secretary. The appointment of a special prosecutor to fully investigate the matter as to the illegal leak of a court sealed document and the scurrilous allegations in the document itself is demanded.

## Best cops money can buy

FBI agents who investigated New York mob operations in New Jersey concluded that the city of Bayonne has the best police force money can buy.

The six-year probe focused on criminal activities of the DiGilio Group, a Bayonne-based mini-mob headed by John (Mace) DiGilio, 50, rackets ruler of North Jersey and soldier in the Genovese crime family, which is second only to the Gambino mob in size, wealth and power.

Results of the investigation were described in a 165-page affidavit filed in federal court to support a request for search warrants authorizing FBI agents to seize evidence from mob members, their homes and offices.

In the affidavit, FBI agents reported: "The evidence developed during the electronic surveillance (of Di-Gilio and his crew) established that DiGilio is able to conduct his various criminal activities with a significantly diminished risk of detection because he and some of his associates have developed a corrupt relationship with certain police officials."

The Daily News obtained a copy of the affidavit. Much of the information in it was obtained from electronic surveillance of gang members and from several inside "sources," or informers, who were members of the DiGilio Group.

THE FBI papers said two of these sources "separately reported that Bayonne Public Safety Director James

Sisk received bribe payments from DiGilio."

The affidavit also mentioned Deputy Police Chief Thomas Lavin, commander of the Bayonne Police Department's Detective Bureau, and Detective Peter Dugan.

According to the affidavit: "The first electronic surveillance evidence in corroboration of the informants'

information was developed on 10-19-81 during a conversation" between Di-Gilio and two of his men. The affidavit said the mobsters "agreed that Sisk was obliged to tell them about any police activity in the area."

THE AFFIDAVIT also said a source inside the DiGilio Group had identified Bayonne lawyer Patrick Conaghan as "DiGilio's 'bagman,' who handled 'payoffs' between the DiGilio Group and public officials in Bayonne."

That informant, described in the affidavit as Source Nine, is a member of the DiGilio Group who had "provided information to a special agent of the FBI" for more than five years. The affidavit said his information had resulted in two arrests and the recovery of more than \$50,000 in stolen property.

In interviews with The News, the three Bayonne police officers and Conaghan denied the allegations and in-

sisted they had never been involved in bribe-taking or other wrong-doing.

The FBI papers state that the electronic surveillance on DiGilio suggested that the Bayonne police acted on behalf of the reputed mobster on several occasions.

For example, DiGilio complained to a close associate, Anthony Gallagher, that the New York bosses of the Genovese mob were trying to take over DiGilio's lucrative operations at the U.S. Army's Military Ocean Terminal in Bayonne (MOTBY). DiGilio told Gallagher that "it had been the DiGilio Group's power with the police and politicians which had made possible the entire MOTBY operation in Bayonne," the papers said. "Gallagher claimed credit, and his asserted influence with the police was borne out by the subsequent electronic surveillance of his residential telephone."

In another instance, the FBI planted an electronic listening device in Di-Gilio's office-apartment above the Bayonne union hall of International Longshoremen's Association Local 1587-88, which DiGilio controls. During a conversation in the apartment on Oct. 19, 1981, DiGilio told two of his men that he and Gallagher were being tailed by members of some law enforcement agency.

forcement agency.

"I THINK THEY work for Bayonne," he said. "That Sisk, he's just double-crossing us.... That ain't right. In fact, I want to talk to Mr. Conaghan about that and give him a message."

And again, a month later, the affidavit said, DiGilio phoned his "intimate friend," Marguerite Nichols, and told her he thought someone was following her. "She said she did not believe that she was under surveillance, but Di-Gilio was not satisfied and said that he intended to get to the bottom of the matter."

Two days later, the affidavit continued, Sisk called FBI Supervisory Special Agent Joseph Vidovich, in charge of the DiGilio probe, and "said that Bayonne police had been surveilling DiGilio and had found that he was visiting Nichols' residence each morning. Sisk asked whether the FBI knew of Nichols and was investigating her. Vidovich gave Sisk a negative response to both questions."

Four days later, "Vidovich telephoned Sisk and asked if the FBI could interview Nichols. Sisk discouraged the request and he promised to make Bayonne's reports available after they had completed their investigation.

"Approximately 10 minutes after the call to Sisk, Detective Peter Dugan drove up to the ILA office in an unmarked Bayonne police car," the FBI affidavit said. Dugan spent 18 minutes there, "during which time Di-Gilio was also inside the union office." (Unlike DiGilio's quarters upstairs, the union hall apparently was not bugged.)

In yet another instance on the same day, the affidavit states, DiGilio henchman Richard (Bocci) DeSciscio told his boss that he had been tailed and had been stopped by a cop while en route to the Staten Island home of reputed Genovese mobster John (Johnny Sausage) Barbato. DeSciscio asked DiGilio to "get the guy off my back."

"DiGilio then telephoned (downstairs to) the ILA office and told the secretary to set up a meeting with the person who had been in 'the room' with him earlier that morning. Dugan returned to the ILA office the next day. He also returned the following day while DiGilio was there," according to FBI surveillance described in the affidavit.

The FBI agent who wrote the affidavit said in it that he believes Dugan's first visit was "related to DiGilio's concern that Nichols was under surveillance by the FBI" and that the subsequent visits were "related to De-Sciscio's complaints about being followed."

Dugan told The News that he had been "in and out" of the ILA hall. He said his two sons had been working for a waterfront firm allegedly controlled by DiGilio and Gallagher. "My sons were being laid off," he said. "Therefore I had a reason to go there (to the union office)."

Dugan said he felt his sons were laid off "in retaliation" for his investigation of DiGilio's activities. "It was part of my job to get information," he said, adding: "I never had a dealing with DiGilio that benefited me or him."

At another point, the affidavit describes what happened to a cop who began surveillance of the DiGilio gang without authorization from superior officers.

The documents say that alleged gang member Joseph LoRe "told Di-Gilio that he had spoken to Dugan, about a particular officer who had been taking surveillance photographs of members of the DiGilio Group—including a picture of LoRe leaving the ILA local. LoRe said that 'Jimmy' (Sisk) was not able to give orders that such photographs were not to be taken, but that Dugan had given LoRe assurances that the officer would be brought under control."

This would be done, LoRe said, "first, because (the officer) was paying for the film himself on a salary of only \$13,000; second, because (Detective Chief) Lavin and everyone in the Police Department were giving the officer 'the cold shoulder,' and third, because 'Jimmy' had separated the officer from his trusted partner and had reassigned him to the East Side where his movements could be controlled by supervisors who were in collusion with Sisk."

Interviewed by The News in Sisk's office at the Bayonne Municipal Building, Sisk and Lavin both denied accepting bribes or doing favors for DiGilio. They said they had been investigating him and his associates since 1968.

Asked about the officer who reportedly was disciplined for taking photos of the DiGilio Group, Sisk said: "Two rookie cops were screwing up our investigation of DiGilio. They were out free-lancing. It was embarrassing to us."

"I provided tons of information on organized crime activities to the FBI," Sisk added.

"We brought DiGilio to the FBI's attention," Lavin said. "We were the first to investigate DiGilio. There's no way a relationship exists between him and us."

"I would say a relationship exists," Sisk said, "but I would say it's an adversary relationship. We have been investigating him. Our gambling arrests of his associates, for example, are unparalleled. We're proud of what we did to DiGilio."

"We have him under constant surveillance. Detective Dugan spotted him twice yesterday.

"DiGilio is as fearsome a fellow as you can find. He has the power of life and death, especially if you work on the docks. If you work on the waterfront, you better pay tribute."

Sisk, who heads both the police and fire departments, added: "You're not going to find a corrupt policeman or politician here."

Lawyer Conaghan, who represents ILA Local 1587-88, was asked about the FBI informants assertion that he was DiGilio's bagman.

"It's outrageous," he said. "I can't believe it.

"It's absolutely false. I never received a nickel from John DiGilio. I could swear on a stack of Bibles, take a lie-detector test."

Asked what his relationship was with DiGilio, Conaghan replied: "None really. He would come around the union hall. I was there (as the union lawyer) on a daily basis."

The FBI affidavit noted that Conaghan once was seen entering the ILA hall, carrying a briefcase. The affidavit said he left without the briefcase, returned the next day and picked up the briefcase. On both occasions, the affidavit said, DiGilio entered the hall a few minutes after Conaghan's arrival.

"I never gave him any briefcase,"
Conaghan told The News. "I may have
taken a briefcase (to the hall) with a
tape recorder in it. I'm not sure. I can
remember many times I had to give
documents, transcripts, tapes to Mr.
DiGilio (in connection with a trial in
which he was representing a co-defendant of DiGilio). I may have left my
briefcase there."

In that letter you reported on the progress of your campaign to retire the national debt, first described in your letter of January 3, and enclosed another signature card for the President to sign. You also enclosed a copy of your newspaper advertisement, and an article on the project which appeared in The Anchorage Times.

As I explained in my letter of March 4 -- which, of course, had not reached you when you wrote your January 13 letter -- gifts to retire the national debt need not be and appropriately should not be made through accounts in the President's name. As I explained in my letter of March 4 -- which, of course, had not reached you when you wrote your January 13 letter -- gifts to retire the national debt need not be and appropriately should not be made through accounts in the President's name. Accordingly, I am returning the latest signature card to you for appropriate disposition. I would also note that, in light of the advice contained in my March 4 letter, newspaper advertisements concerning the accounts may not use the President's name. Thank you for observing this limitation in any future advertisements.

You will recall that this account was opened by Dayton Child, to accept donations to retire the national debt. You have written Child and advised him the account should not be in the President's name; apparently we should similarly advise the bank. I have prepared a letter informing the bank that the account should not be in the President's name, and that it should contact the appropriate individual at Treasury — identified in the letter — to work out arrangements for disposition of the monies collected.

This is consistent with the recommendation of Ken Schmalzback, General Counsel of the Bureau of Financial Operation at Treasury. Schmalzback is Treasury's legal expert on private donations to retire the national debt. #### **DIRECTIONS FROM MOSCOW**

Directions from the Kremlin to Soviet diplomats throughout the world counsel these covert members of the KGB to use their influence on terrorist groups and Marxist leaders receiving aid and weaponry from the Soviet Union to "cool it" until after the American 1984 elections when the "American masses will rid themselves of the warmongering President Reagan."

#### THE BUILDUP CONTINUES

Cuba's Soviet masters are furious over the inability of Castro forces in Nicaragua to prevent the steady infiltration of American-supported, Honduras-based, anti-communist Nicaraguan guerrillas who, apparently, come and go as they please with little or no interference.

A high-ranking Russian, accompanied by two military engineering officers, recently landed in Managua for the purpose of 'showing the stupid Cubans how to do it.' #### THE TABLES ARE TURNED

Missile sites are being constructed along the southern border of Angola, threatening the South African defenders in South West Africa.
