Dear Mr. President:

I am required by the Pelly Amendment to the Fishermen's Protective Act of 1967 to certify to you my determination that nationals of a foreign country, directly or indirectly, are conducting fishing operations which diminish the effectiveness of an international fishery conservation program. By this letter, I am certifying that nationals of the Soviet Union are conducting whaling operations that diminish the effectiveness of the International Whaling Commission's (IWC) conservation program.

My decision is based on the fact that the IWC quota for Southern Hemisphere minke whales has been exceeded as a result of the harvest by the Soviet Union. I am certifying the Soviet Union for the taking of minke whales under both the Pelly Amendment and the Packwood-Magnuson Amendment to the Magnuson Fishery Conservation and Management Act of 1976.

Upon certification under the Packwood-Magnuson Amendment, the Secretary of State must, in consultation with the Secretary of Commerce, reduce fish allocations to the certified country by not less than 50 percent. This reduction applies to any unharvested allocations and to all allocations to be made within 365 days from the date of certification, until decertification is warranted.

The Pelly Amendment provides that upon receipt of this certification, you may direct the Secretary of Treasury to prohibit the importation of some or all fish products from the country involved into the United States. The Pelly Amendment also provides that within 60 days following the receipt of this certification, you must notify the Congress of any action you take regarding the certification, and you must inform the Congress of the reasons for any such action that falls short of prohibiting the importation of all fish products of the certified countries.

I have notified the Secretaries of State and Treasury, and the Chairmen of the Council on Environmental Quality and the Marine Mammal Commission, of this certification. The Department of Commerce is developing trade recommendations on fish import prohibitions and will make recommendations to you about further actions before the end of the 60-day period when the report to the Congress is due. I have recommended to the Secretary of State that the Government of the Soviet Union be advised of this certification. In addition, I will suggest to the Soviet Minister of Foreign Trade that we could discuss the certification of Soviet whaling at the meeting of the joint U.S.-U.S.S.R. Commercial Commission May 20-21 in Moscow, if he believes it would be useful.

Thank you for your letter to Counsel to the President Fred F. Fielding concerning a television advertisement developed by Art Pierson & Co. for Ace Hardware Corporation. Accompanying that letter was a script of the advertisement, which features Rich Little imitating Presidents Nixon, Carter, and Reagan. You inquired if we had any objection to the commercial.

The White House adheres to a policy of declining to approve any use of the President's name, likeness, photograph, signature, or voice in any manner that suggests or could be construed as endorsement of a commercial product or enterprise. In a certain sense, the proposed advertisement will feature the President's voice, but the appearance of Mr. Little during the advertisement should suffice to remove any suggestion that the President himself is endorsing the advertised products. Accordingly, this office has no objection to the planned imitation of the President's voice in the advertisement.

Thank you for raising this matter with us.

Dear Fred:

It was good seeing you, even for a few minutes last week. Forgive my troubling you with a minor matter when you have such a full plate of important problems.

Sidley & Austin represents Art Pierson & Co., the advertising agency for Ace Hardware Corporation. Our client has engaged the services of Rich Little, who from time to time renders his humorous imitations of famous persons in television commercials for various products, including Ace Hardware. As you probably are aware, Mr. Little recently appeared in the inaugural festivities and imitated President Reagan in the televised program.

As part of its on-going advertising campaign, our client has developed the enclosed script, entitled "Presidents" and has submitted it to ABC for routine clearance. This script includes one-line imitations of Presidents Nixon, Carter and Reagan. Thank you for your letter requesting permission to use recorded portions of an address the President delivered before the 1984 National Religious Broadcasters' Convention in advertising for <u>In God I Trust</u>, published by Tyndale House Publishers.

I must decline to grant the permission you requested. The White House adheres to a policy of declining to approve any use of the President's name, likeness, photograph, signature, or voice in any manner that suggests or could be construed as endorsement of a commercial product or enterprise. Use of a recording of portions of the President's speech in your advertising for In God I Trust would convey the impression that the President has endorsed the book, contrary to this policy. Accordingly, we must decline to authorize your use of the recording in promotion for the book.

Thank you for raising this matter with us. I trust you will understand the reasons for our response.

This letter is in regard to the murder of the Chinese American journalist Henry Liu. I urge you to secure the extradition and prosecution of those suspected in the October 15, 1984 murder.

On November 29, 1984 the F.B.I. and the Daly City Police Department identified and named four suspects in the murder of Mr. Liu: Chen Chili, Wu Tun, and Tung Kuei-sen, all of Taiwan, and David Yu, of San Gabriel, CA.

Local and federal law enforcement investigators have uncovered substantial evidence to conclude that (1) the murders of Henry Liu conspired successfully to deprive him of his First Amendment rights, and (2) foreign agents were the instigators and executioners of the murder of this Chinese American citizen.

On February 1, 1985 the Taiwan government announced that it will not be extraditing the suspects to the United States. The Taiwan Justice Minister stated that the suspects would be tried under Taiwan laws. In response, our government has voiced no concern and made no strong plea for the return of these suspects to stand trial for a murder of a U.S. citizen on U.S. soil by foreign agents.

Again, I urge you to take the necessary steps to ensure the return of these individuals suspected of carrying out the execution of Henry Liu. By your orders let the Departments of State and Justice secure this extradition and see that justice is fairly and finally served.

As you will note from the attached, the Paralyzed Veterans of America has been most active in the area of television public service announcements -- with special emphasis given to distributing spots for use in the Memorial Day and Veterans Day period.

For Memorial Day 1985, we would like White House permission to use portions of the President's remarks to our group as the basis for a 60-second public service announcement. This public service announcement is not designed, in any manner, as a fund raising device.

In terms of the supporting visual scenes, at the beginning of the spot, the President's voice is heard while viewers see footage from Vietnam depicting United States soldiers exiting helicopters. The footage, does not show combat in any way and is "generic" in nature.

PRESIDENT REAGAN'S PVA CONVENTION REMARKS

It's an honor and a pleasure to have this opportunity to speak to all of you attending the annual convention of the Paralyzed Veterans of America. I'm sorry I couldn't be with you in person but, believe me, I'm there with you in heart and spirit.

And, I'm pleased that one of my assistants here at the White House, Jack Svahn, is able to meet with you in New Orleans.

The greatest privilege of my office has been to lead those who wear America's uniform. And nothing means more to me as President than to live-up to the trust of our servicemen and women, past and present.

On Memorial Day our nation laid to rest an unknown of the Vietnam conflict—it was a day of healing and remembering, of caring and feeling. America joined hands and opened her heart in gratitude. Then several days later, on the wind—swept beaches of Normandy, Heads of State, veterans and citizens paid tribute to the heroes of D-Day. Speeches could never adequately portray their suffering, their sacrifice, their heroism...but we understood. You went to Omaha Beach, and Guada Canal, M.I.G. 





Article

Kathleen Bursley, an attorney for Harcourt Brace Jovanovich, Inc., has written to ask for a public domain copy of "Abortion and the Conscience of the Nation," by the President. Harcourt wants to include the article in a college rhetoric text as an example of argumentation. They approached Thomas Nelson, Inc., which published the article in book form, for permission. Thomas Nelson is demanding a fee of \$1,000, which Bursley considers exorbitant under the circumstances.

You will recall that this article first appeared in the Summer 1983 issue of <u>Human Life Review</u>, and was copyrighted at that time by the publisher of <u>Human Life Review</u>, The Human Life Foundation, Inc. The article was later published in book form by Thomas Nelson, pursuant to an arrangement whereby royalties benefit The Human Life Foundation. You approved the Nelson reprint and the royalties arrangement by letters dated November 7, 1983. The article has also been distributed by the White House in pamphlet form, bearing the Seal of the President, with no copyright notation.

As I read the law, no copyright protection is available for the article. There was no basis for the publishers of Human Life Review to copyright it when it first appeared. The article was clearly Government work, and not the private product of the President. It was drafted by OPD and Speechwriters, with editing by Peter Rusthoven of this office, and went through the White House clearance process. There is no copyright protection "for any work of the United States Government." 17 U.S.C. § 105. "Work of the United States Government" is defined to be "a work prepared by an officer or employee of the United States Government as part of that person's official duties." 17 U.S.C. § 101. The article clearly fits that definition from the perspective of those on the White House staff who prepared it. Since it expresses the President's view on a public policy issue, and was designed to shape the debate on that issue, the article should also be considered to have been prepared by the President in the course of his official duties.

The Presidential Records Act confirms this conclusion. The article certainly qualifies as a Presidential record, <u>see</u> 44 U.S.C. § 2201, and ownership, possession, and control of such records is retained by the United States, 44 U.S.C. § 2202.

My recommendation would be to send Harcourt one of the White House pamphlets of the article, advising that no permission is necessary to reprint it. I would alert The Human Life Foundation and Thomas Nelson before doing so, since they are apparently under the impression that they have some rights to the article. I have not called them yet, however, since the fact that the article was copyrighted by the Foundation, and the fact that this office has granted reprint permission (to Thomas Nelson) and denied reprint permission (to Charisma) suggest my view of the law may not have been previously operative in this area. Peter may have discussed these issues with you; perhaps there are some facts (not revealed in the file, which I have reviewed) of which I am unaware. Please advise.



Katherine Fanning, editor of the Christian Science Monitor, addressed the convention's awards banquet:

I'm going to talk about some of the way that I personally feel we might serve the public hetter and, while we're about it, improve our credibility with readers. . . .

I'm convinced that more compassion, restraint, and judgment are needed in our business at the right time and in the right way and that, if that [fine line between the public's right to know and the individual's right to privacy] is properly walked, this should in no way impair the fullest, most hard-hitting account of significant news.

Is tragedy our business? Is the way we dramatize people's sorrow — seldom balancing it with news of triumph — contributing to the sense of meaninglessness [in our society]? . . .

I'm not proposing that journalists become preachers, or even crusaders. But I am suggesting that we correct the tunnel vision that often misguides a journalist; try standing in somebody else's shoes;

and try some new perspectives.

The mandate for relentless pursuit of an important story, fearless exposure of wrongdoing, and absolute devotion to press freedom must always be our priority. But it news people do expand their vision, exercise more compassion, achieve a better balance, and more often report happy endings, the gulf between reader and media will narrow, trust [will] return, and, just possibly, we might have a better society.

Pettit: Who does what to whom?

Tom Pettit, executive vice president of NBC News, was the featured speaker at the convention luncheon on November 15, substituting for John Chancellor, who was ill:

Some people say that television dominates, takes over, shapes, and distorts any campaign, but especially a presidential campaign. That suggests that by some unknown force, candidates do stupid things, pose for stupid pictures, eliminate any substance, pretend to debate, and so on. . . .

One must distinguish between what candidates do to themselves and what we do to them. Let's look at some examples:

■ Was it wrong to inquire of Geraldine Ferraro's finances? No, it was proper.

Was it wrong for Mondale to say he would raise taxes? Politically, very wrong. But television did not force that upon him.

■ Was it wrong to have debates? I don't think so. It was not television that forced two men to be both cautious and dull.

What about Mondale's saying he had no good relationship with cameras and microphones? We did not sneak in the cameras and mikes. He was aware of their existence for a long time. Was he expecting inegaphones and sketches?

Now I would like to talk about exit polls — and their relationship to democracy, if any. I suspect that exit polling became controversial because losers need something to blame. And people too lazy to vote needed an excuse for not voting. . . .

This problem must be solved within the First Amendment. If Congress [attempts to] achieve its purpose by playing with the First Amendment, then we all lose. We all suffer — TV, radio, and print.

Freedom of the press is too vital to our democratic society. The free flow of information is equally necessary. Information is as precious as mother smilk. . . .

The First Amendment does not require that you be right. It only requires that you be free.

Adviser Hicks wins top SDX award

Attending SPJ/SDX national conventions have become a routine venture for CSUN journalism professor Maynard Hicks over the years, but last year's convention in Indianapolis, Indiana was extra special: Maynard received the Wells Memorial Key, the society's highest honor.

The award is presented to members who have served SPJ/SDX in especially meritoricus fashion during the previous year or years. The Wells Key is given in memory of Chester Wells, one of the Society's earliest members, who died in 1913 while serving as the second president


of Sigma Delta Chi.

Traditionally given to only one member of the Society each year, five Wells Keys were awarded last year bringing the total number of winners to seventy-five to commemorate the society's 75th anniversary.

Besides the awarding of the Keys at last year's convention, a plaque was dedicated at the Indiana Journalism Hall of Fame at DePauw University honoring the seventy-five members who have best served SPJ/SDX since the Wells Key was first awarded seventy years ago.

"It's an indescribeable honor, a lifechanger," said Hicks, a professor emeritus at Washington State University and a staple at CSTN for nine years, "I'm glad to be one if the 75 distinguished journalists to receive the honor."

Other 1954 Wells Key recipients were: Bert Bostrom, prifessor of journalism at Northern Arizona Eniversity in Flagstaff; Stanley T. McBriyer, founder of News Citizens Newspacers in Fort Worth, Texas: Jean Otto, editorial page editor of the Rocky Mountain News in Denver; and Ralph Otwell, of the Chicago Sun-Times.
