Thank you for inviting me to serve as a member of the reception committee for the fundraiser Dick Allen is hosting for you at the Mayflower Hotel on September 12. The impressive list of co-hosts in your letter ensures that the event will be a success.

I must, however, decline to serve on the reception committee. I trust you will understand that, in view of my present position, I simply would not feel comfortable becoming involved in a particular Congressional campaign to the extent of serving on a committee for a fundraiser. I am particularly concerned that if I were to serve on the committee, other candidates or prospective candidates would also want me to serve on their committees, and my inability to do so in every instance might be subject to misinterpretation. As near as I can tell from the attached, Evelyn Poulson, a former IRS employee, has filed a pro se Title VII action against her former employer. Somewhere along the line she was advised to name then-Secretary Regan as the proper defendant in her suit. Apparently she did so, although she thought the advice was a ruse to permit the real discriminators to go free, since she has no gripe with Mr. Regan himself. In any event, Poulson has now copied Regan on a letter to the Federal courthouse in Baltimore, complaining about the required change in named defendants and the refusal of the court to grant her request to compel interrogatories.

There is certainly no need for any reply from the White House on this. I would simply refer to Treasury for any action. If Regan were required to have been named because of his official position, he's off that particular hook now in any event. See Fed. Rules Civ. Proc. 25(d).

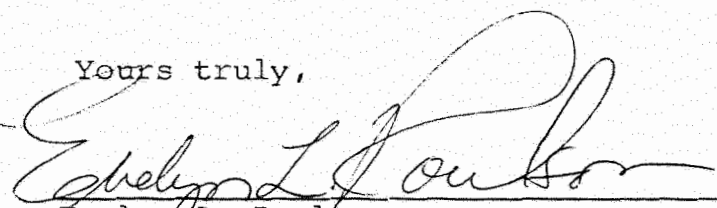
Dear Mr. Regan,

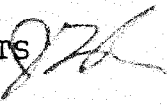

OMB has asked for our views by August 30 on a brief CIA draft report on a bill that would grant Defense, OPM, and CIA access to state and local criminal records for background investigation purposes. The draft report supports the bill, noting that state and local restrictions on access to such information hinders the security clearance process. I have no objection: records of past criminal violations should be fully available for reviews of prospective holders of security clearances. The "privacy" rationale for withholding access to such records is weak in any event but totally evaporates when the question of security clearances is involved.

Dear Mr. Chairman:

I am most pleased to be able to respond to your letter requesting comments on S. 1347, a bill to provide access by the Department of Defense, the Office of Personnel Management and the Central Intelligence Agency to state and local criminal history record information for national security purposes.

The Agency supports this legislation. Currently, state and local laws governing access to criminal history record information often hinder background investigations of persons seeking employment with the United States Government in positions requiring access to sensitive national security information. By removing those barriers, this legislation would enhance our ability to conduct the sort of thorough background investigation necessary to arrive at a reasonable judgment about an individual's trustworthiness. In these times when the United States faces renewed threats of espionage, we believe this legislation would be a valuable weapon against such threats. On behalf of the Agency, I therefore commend it to the Committee on Governmental Affairs for favorable consideration.

The Agency is not aware of any significant paperwork or regulatory burdens which might result from the passage of this legislation.

The Office of Management and Budget has advised that this report is consistent with the President's legislative program.

I am writing as a matter of inquiry regarding the disposition of the 'Tylenol Poisonings Incident' which occurred in Chicago in the autumn of 1982...

Although I had written a letter which I had intended to send for your attention shortly after the publicity surrounding the incident came to my attention, I changed my mind and decided not to mail it, thinking that I would probably be successful in obtaining sufficient information from other sources... Presently, however, with my efforts to obtain information from the Offices of the Cook County Medical Examiner more or less 'dead ended' by the exemption of materials pertaining to an ongoing investigation of law enforcement agencies from public accessibility through 'Freedom of Information', I've decided that perhaps I should redirect my inquiry to your office as originally intended...

It is my hope that you may be able to respond to my question of whether or not you, personally, had made an effort to alert the public to potentially hazardous conditions surrounding the product safety of capsuled acetamenophen analgesics, in your televised news conference of September 28th 1982, prior to the 'Tylenol Poisonings Incident'...

I hope, too, that you may be able to comprehend the gist of my concern in such a question by the simple and straightforward brevity of its presentation, without need for me to offer any further elaboration or elucidation of my own perspectives, at present...

I would like, however, to request your permission for my acquisition of a publishing right to such material as you may offer in reply... I hope to be submitting a literary work of the nature of a 'derivative compilation', to the Register of Copyrights, at some time in the near future; I would hope to have your concurrence with such a proposition for publication...

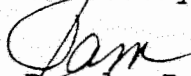

SUBJECT: Arata Expositions Lawsuit

You were copied on two August 16 letters from counsel for Taste of America, concerning the Arata Expositions claim. You will recall that Arata is owed money by Taste of America, and wrote the President on June 20, with an enclosed copy of a complaint against PIC and Taste of America. Bruce Soll responded to both Arata and Taste of America counsel, stressing that Taste of America was not a PIC event and any claim Arata may have against Taste of America should be directed to Taste of America and not PIC. Soll's letter to Taste of America also noted that PIC would consider counter-claims against Taste of America for any liability based on representations by Taste of America.

Taste of America has now responded to Soll, surprisingly agreeing with Soll's position on the Arata suit. The letter from counsel Kim Mann states Taste of America "has never represented itself as connected or affiliated with the Presidential Inaugural Committee." Mann also wrote Arata, stressing that Arata had no basis for proceeding against PIC. You were copied on both letters. I see no need for a response.

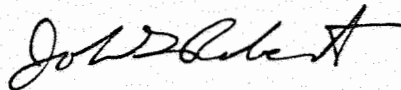

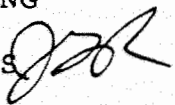

SUBJECT: Request to Develop Commemorative Paperweight

Herve LeGall, sales manager for J.G. Durand International, has written a confusing letter about Durand's plan to develop a commemorative paperweight. Apparently Durand, a glassware firm, is interested in producing products emblazoned with the Seal of the President or the President's name or likeness. I recommend a general reply alerting Durand to the restrictions on use of the Seal and our policy with respect to use of the President's name, likeness, signature, etc.

I am a bit concerned about the articulation of the latter policy, since there are countless items of dinnerware and glassware with the President's picture for sale in souvenir shops or vendors' carts. I would not assume that those items violate our policy, since I do not think most people who purchase a dinner plate with the President's picture on it suppose the President has endorsed the plate. In any event, I think we should state the policy as we always do and let Durand contend that there is no endorsement problem if they wish to pursue it further.

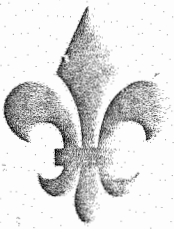
