SUBJECT: Request for the President and First Lady to be Honorary Chairmen of Crescent Gala Benefit, April 4-5, 1985, Dallas, TX

Fred Ryan has asked if you have any legal problems with the President and Mrs. Reagan serving as Honorary Chairmen of the Crescent Gala Benefit, to be held April 4-5, 1986, in Dallas. Proceeds of the Gala will benefit the Dallas Chapter of the Friends of the Kennedy Center. The Gala will celebrate the opening of The Crescent, a lavish hotel-shopping-restaurant-office complex. The Crescent is a development of the Caroline Hunt Trust Estate, and the request for the Reagans to serve as Honorary Chairmen came from Caroline Hunt Schoellkopf, a Kennedy Center Trustee. Ryan indicates that he is inclined to accept in light of the Reagans' personal friendship with Mrs. Schoellkopf.

I contacted Bill Becker, attorney for the Friends of the Kennedy Center, to clarify the legal status of the entities involved. The Friends is a committee of the Board of Trustees, the governing entity of the Center, which itself qualifies for 501(c)(3) status. The Dallas Chapter of the Friends is not a separate legal entity, but funds raised by the Dallas Chapter will be administered by the Board to cover expenses of Texas groups performing at the Kennedy Center. In short, a gift to the Dallas Chapter is a gift to the Friends is a gift to the Kennedy Center itself.

Since the Gala will benefit the Kennedy Center, the Reagans are free to lend their names to it if they so desire. I am a bit concerned by the fact that the Gala will also celebrate the opening of the Crescent -- a commercial venture in which Mrs. Schoellkopf has a direct financial interest -- and wonder if the Reagans will be lending their name to the Crescent as much as to the Kennedy Center. The attached memorandum for Ryan notes this concern.

You have asked if I have any legal objections to the President and Mrs. Reagan lending their names as Honorary Chairmen of the Crescent Gala to be held in Dallas, April 4-5, 1986. The Gala will celebrate the opening of The Crescent, a shopping-hotel-restaurant-office complex. Proceeds will benefit the Dallas Chapter of the Friends of the Kennedy Center.

Donations to the Dallas Chapter of the Friends of the Kennedy Center are, for legal purposes, contributions to the Kennedy Center. The Kennedy Center is of course a worthy activity, and the Reagans are legally free to lend their names to events to benefit the Kennedy Center.

I am concerned, however, by the mixture of commercial promotion and charitable benefit in this event. The Gala is, after all, described as a celebration of the opening of The Crescent, not simply a benefit for the Kennedy Center. If the Reagans do decide to participate in this event, care must be taken to ensure that they are listed as Honorary Chairmen only of particular events to benefit the Kennedy Center, not of all the festivities celebrating the opening of The Crescent.


Dear Mrs. Schoellkopf:


My dear Mr. Ryan:

You have asked for my views on a request that the President serve as honorary chairman of and/or attend a dinner at which Ross Perot will receive the Winston Churchill Award. The dinner will be a fundraiser for the Winston Churchill Foundation of the United States.

Established White House policy generally restricts acceptance of honorary chairmanships to those charitable organizations with which the President has been personally involved or with which the Presidency has been traditionally associated. This Foundation does not fall within either exception. It is, of course, not illegal for the President to agree to this request, and an exception to the established policy can be made if the President so desires.

COUNSEL TO THE PRESIDENT

SUBJECT: Scheduling Recommendation

You have asked for my views on a request that the President serve as honorary chairman of and/or attend a dinner at which Ross Perot will receive the Winston Churchill Award. The dinner will be a fundraiser for the Winston Churchill Foundation of the United States.

Established White House policy generally restricts acceptance of honorary chairmanships to those charitable organizations with which the President has been personally involved or with which the Presidency has been traditionally associated. Since this Foundation does not fall within either exception, the President should not agree to serve as honorary chairman. In addition, since the dinner is a fundraiser for a private organization, a message should not be sent, nor can I recommend that the President attend.





Dear Mr. Ryan:

We would like President Reagan to serve as honorary chairman of a dinner to be held in Dallas on February 18, 1986, during which the Winston Churchill Award will be presented to Ross Perot. In addition, we hope that the President will be able to attend the dinner and make some appropriate comments.

Ross Perot has been selected as the third recipient of the Winston Churchill Award. Prime Minister Margaret Thatcher and W. Averell Harriman are the only other two recipients of this award.

The dinner on February 18 will be attended by a minimum of 1000 and, more likely, [redacted] the most influential Texans, plus a group from New York. It is expected to raise [redacted] million (gross receipts) for the Winston Churchill Foundation of the United States to support scholarships for U.S. students to study and do research at Churchill College, Cambridge University. Since the inception of the scholarships, eight of the recipients have been Nobel Prize winners. Enclosed is a pamphlet describing the Winston Churchill Foundation of the United States.

His Royal Highness the Prince of Wales is scheduled to be in attendance, and will present the award to Mr. Perot. Texas Governor, Mark White, will be present, and has indicated intense interest in this evening's activities.

We are currently having discussions with both newspapers and other media to participate with features on Winston Churchill. Additionally, we are in discussion with the Dallas Museum of Art for a special showing of Churchill's work during the week of the presentation. Conversations are also being held with the president of Southern Methodist University for similar activities in their library. The Dallas


Symphony Orchestra will play music during and after dinner. The program will feature music that was popular during World War II.

Thank you for your letter of October 22 to the President, requesting that the President agree to serve as Honorary Chairman of the Campaign for Norman Rockwell. The purpose of the campaign, as detailed in your letter and accompanying materials, is to raise \$5 million to expand the Norman Rockwell Museum in Stockbridge.

White House policy generally restricts the acceptance of honorary chairmanships to those organizations with which the President has been personally associated, usually before assuming office, and to those with which the Office has traditionally been associated, such as the Red Cross or the Boy Scouts. In this case, however, the President has decided to make a rare exception to this policy, and will be happy to serve as Honorary Chairman of this laudable fund-raising campaign. I am confident that the campaign will be a great success, contributing to the preservation of not only Norman Rockwell's work but a bit of Norman Rockwell's America as well.

It will be necessary for this office to review any materials prepared by the Campaign for Norman Rockwell that use the President's name or designate him as Honorary Chairman.



of Benefit Premiere of "Eleni"

You have asked for our views on a request that Mrs. Reagan serve as patron of a benefit premiere of the film "Eleni." The premiere would benefit Children's Hospital and the Society for the Preservation of the Greek Heritage. The stated intent of having Mrs. Reagan lend her name to the premiere, however, is to give the film "a strong push" as it opens nationally, to overcome certain negative reviews.

As a strictly legal matter Mrs. Reagan may serve as honorary patron of a benefit for Children's Hospital and the Society for the Preservation of the Greek Heritage. White House policy, however, generally restricts such participation to benefits for charities with which the President or Mrs. Reagan are personally associated. Mrs. Reagan has been involved with Children's Hospital in the past, but neither she nor the President, so far as I am aware, have been involved with the Society for the Preservation of the Greek Heritage. A benefit for this society would clearly precipitate demands for equal treatment for societies representing other ethnic groups.

Quite apart from the foregoing, the participation of Mrs. Reagan would inevitably be perceived as an endorsement of the film. The film is a commercial enterprise, and the author of the letter requesting Mrs. Reagan's participation is quite explicit in wishing to use that participation to promote not Children's Hospital or the Society, but the film itself. For all these reasons, I must recommend against granting this request.

Thank you for raising this matter with us.

SUBJECT: Request from Nicholas Gage for Use of
Mrs. Reagan's Name as Honorary Patron
of Benefit Premiere of "Eleni"

You have asked for our views on a request that Mrs. Reagan serve as patron of a benefit premiere of the film "Eleni." The premiere would benefit Children's Hospital and the Society for the Preservation of the Greek Heritage. The stated intent of having Mrs. Reagan lend her name to the premiere, however, is to give the film "a strong push" as it opens nationally, to overcome certain negative reviews.

As a strictly legal matter Mrs. Reagan may serve as honorary patron of a benefit for Children's Hospital and the Society for the Preservation of the Greek Heritage. White House policy, however, generally restricts such participation to benefits for charities with which the President or Mrs. Reagan are personally associated. Mrs. Reagan has been involved with Children's Hospital in the past, but neither she nor the President, so far as I am aware, have been involved with the Society for the Preservation of the Greek Heritage. A benefit for this society would clearly precipitate demands for equal treatment for societies representing other ethnic groups.

Quite apart from the foregoing, the participation of Mrs. Reagan would inevitably be perceived as an endorsement of the film. The film is a commercial enterprise, and the author of the letter requesting Mrs. Reagan's participation is quite explicit in wishing to use that participation to promote not Children's Hospital or the Society, but the film itself. For all these reasons, I must recommend against granting this request.

Thank you for raising this matter with us.



Dear Mrs. Reagan,


It was a delight and a privilege to see you and President Reagan last Sunday night in the magical setting of the White House decked in its Christmas splendor. Joan and I were very grateful to be included among the glittering crowd attending the Kennedy Center Honors reception. I had visited the White House only once before, in 1963 when I was presented a writing award by President John F. Kennedy, but saw just the Oval Office at that time. Last weekend we were privileged to have Ambassador Roosevelt show us all the stately rooms and magnificent works of art, and I don't think anyone has had a better guide since Dante met Virgil. In one room we found Walter Annenburg sitting alone, staring pensively at a portrait of Benjamin Franklin that he gave to the White House at the prodding of Mrs. Kennedy a long time ago. "I lived with him for so long, I always come to pay a visit when I'm in the White House," he said.

That was just one of the special moments that filled a night we will never forget. The highlight of the evening, of course, was meeting you and the President again. We were deeply touched that you remembered us so graciously and asked how the film "Eleni" is doing. Although it's attracting good audiences in the four cities where it is now playing and has received good reviews from the leading television critics, it will open nationally at the end of January with the handicap of negative reviews from the leading New York newspaper and magazine critics. They criticized "Eleni" for the same reasons that they have attacked "White Nights" and other films that dramatize Communist abuses, saying that it evokes cold war hostility. "Communists haven't been depicted as such unredeemable curs in a mainstream movie since the '50s," was a typical comment, echoed in various forms in most of the New York print reviews.

That's why the film needs a strong push when it is released nationally, and we hope to provide it with a benefit premiere to be held in Washington at the end of January. There is nothing that would do more for the film than to hold the premiere under your patronage. If you would lend your name as honorary patron to this event, which will benefit the Children's Hearing and Speech Center of Children's Hospital and the Society for the Preservation of the Greek Heritage, both based in Washington, you would be doing a magnificent service not only to these good causes but also to the memory of my mother's sacrifice so that her children could be free. Some of the city's leading citizens will join the effort to make the premiere memorable, but the only guarantee of success is your personal support. If you can give it, you will have the lasting gratitude of myself and my family, as well as the many victims of totalitarian regimes who identify with Eleni's struggle.

I look forward to hearing from you and I wish you, President Reagan and all the members of your family a joyous holiday season filled with love.





You have asked this office for our views on a request from the Friends of the Superior Court of the District of Columbia that the First Lady serve as Honorary Chairman of its annual fundraising luncheon. The First Lady may legally accept this invitation. As you know, however, both the President and the First Lady generally decline requests to serve as Honorary Chairman of charitable endeavors, because of the volume of requests and the impossibility of distinguishing between the many worthy charities that submit requests. Exceptions to this policy are made for organizations with which the White House has been traditionally associated, such as the American Red Cross, or organizations with which the President or First Lady are personally and substantially involved.

The Friends would not appear to fit within either of these exceptions, so unless Mrs. Reagan is interested in becoming active in this organization, we recommend declining the invitation pursuant to the general policy discussed above. It would, however, not be inappropriate for the First Lady to send a brief message to the Friends, should she wish to do so. The organization appears to be an excellent example of public-spirited voluntarism.



It provides volunteer and intern services and rehabilitative assistance to wards, clients, and probationers whose involvement with the Court stems from child abuse, neglect, domestic discord, or youthful law violations — frequently resulting from parental drug and alcohol abuse.

The FRIENDS operates the Child Care Center for the Superior Court, providing free day care for the young children of witnesses, jury members, or parents whose presence is required by the involvement of their older children in Court proceedings. It arranges and funds supplemental assistance in this effort from the Foster Grandparents and Senior Aide programs.

Our organization also contributes support to the Court's Counsel for Child Abuse and Neglect, which appoints lawyers to represent both parents and children involved in such cases. The FRIENDS has further been called upon to serve as ombudsman to the Court as may be required.

THE FRIENDS

The FRIENDS of the Superior Court of the District of Columbia began as an independent organization called the FRIENDS of the Juvenile Court when Chief Judge Marvin Miller suggested to Mrs. Arthur Goldberg that such an organization could render needed services to the Juvenile Court. Under Mrs. Goldberg's leadership, the FRIENDS functioned wherever it was needed, whether it was to furnish, decorate and provide reading materials for the waiting room, or to provide a new pair of shoes to a child on probation or to a neglected or abused child.

With the Court Reorganization Act of 1970, the FRIENDS suddenly found itself with three branches in the Court to assist, as well as being the central contact for all volunteer organizations seeking to work within the Court system.

In 1974, therefore, the FRIENDS of the Juvenile Court reorganized, adopted a constitution, and became a non-profit organization under the Internal Revenue Service Code 501(3). It now operates as the FRIENDS of the Superior Court of the District of Columbia.

The FRIENDS Board of Directors meets monthly to determine program focus and the general management of the organization. Board members represent a wide spectrum of skills, interest and resources -- all dedicated to augmenting court services. The Board sponsors an annual fundraising drive in the fall and an annual benefit in the late spring in order to underwrite the FRIENDS programs. Such proceeds provide staff, play and educational equipment, and supplies for the Child Care Center; insurance coverage for volunteers and interns assigned to the Social Services Division of the Court and to the Counsel for Child Abuse and Neglect Branch. (The Child Care Center caters to children two to twelve years old whose parents are required to be in court on court business such as jury duty, witnesses, or parents whose older children are having problems involving law violations.)

The Anne T. Lipfert Memorial Fund is also administered by the FRIENDS. This Fund provides up to \$50.00 for urgent needs of children when requested by a social worker or a lawyer for the child. The fund has provided shoes, school class trips when an individual child would be left behind, winter clothing, and much more.


