Fred Ryan, at Michael Deaver's behest, has asked for your views on a proposed photo with the President, actor William Devane, and the President of Westinghouse. The Patriots of Fort McHenry

I spoke last night with Donald Barbary, Chairman of the Patriots of Fort McHenry Executive Committee, and Brent Kansler, the consultant who is doing the public relations for the group.

The concept for the Patriots was developed by Walter Hyle, Adjutant of the Maryland Disabled American Veterans, three years ago. They incorporated three years ago and have their IRS non-profit status. They have an official agreement with the Department of the Interior designating The Patriots as a fundraising/development organization.

Their goal is to raise \$27 million in the next three years. Of that, \$15 million is explained in the attached background sheet; \$2 million will go towards the establishment of an endowment fund for future operating expenses (i.e. uniforms for a standing guard unit, etc.), and the remaining \$10 million will be designated for the restoration of the Fort's tavern, barracks and stable that were torn down during WWI. These projects will not only restore the Fort to its original structure, but will make it a "viable, living fort."

The Patriots Board of Directors has 16 active businessmen from the Baltimore area, whose mission is to raise the needed restoration funds. The Executive Committee is composed of Don Barbary, the chairman, Ed Hunton, and the Reverend Dr. Winthrop Brainard of the Christ Church. The board contains no publically-affiliated partisans and no elected officials. No Board member may profit from his/her association with The Patriots. There are no paid employees.

The group has raised \$50,000 to date, mostly from the proceeds of their "Patriot of the Year" dinner at which Baltimore Mayor Donald Schaefer was the guest of honor. Schaefer apparently has been a great booster of Fort McHenry and had provided workers and city resources to aid in its restoration and maintenance.

About 1000 people attended the dinner. General Devereux, the hero of Wake Island, was there as well as a representative from the British Embassy, and the great, great grandson of Francis Scott Key.

The Patriots have started to approach corporate sponsors as well, and are looking to sports figures to take the lead. Brooks Robinson and Johnny Unitas have already signed on. Edward Bennett Williams will help after the baseball season ends and his health improves.

The group plans to hold another major fundraiser in Washington on April 15, 1986. In the meantime, they are beginning a direct mail fundraising operation.

Barbary and Kansler just returned from meeting with the Statue of Liberty organizers yesterday. They plan to pattern their campaign after the one in New York.

They told me there was an article in the Baltimore Sun yesterday about the President's visit in which the Superintendent of the Fort expressed her desire to have the President publically support the Patriots. I am getting a copy now.

They would like to receive copies of pictures of the President at the Fort to use in their fundraising efforts.

Dear Mr. Jung:

Thank you for your letter of June 4, concerning your plans to use a photograph of the President in advertising brochures for one of your products.

The White House adheres strictly to a policy of not approving any use of the President's name, signature, likeness, or photograph in any manner that suggests or could be construed as endorsement of a commercial product or enterprise. Your use of the picture of the President in your advertising brochures would contravene this policy, even in the absence of any explicit claim that the President endorses your product. Accordingly, we must object to your plans to use the picture of the President. The picture may not be used in any manner in connection with your promotional activities.

Thank you for raising this matter with us. I trust you will appreciate the reasons for our response.

Photograph

The Gift Unit has asked for our advice on handling a check for \$100 payable to the Reagan Library from the Ansel Adams Publishing Rights Trust. The check was enclosed with a letter from the editor of the forthcoming posthumous autobiography of Adams, thanking Carol Greenawalt of the Photo Office for permission to reprint a photograph of Adams with the President. The editor, Mary Alinder, described the donation as "the agreed upon reproduction fee."

I contacted both Carol Greenawalt and Michael Evans, the only people at the White House with whom Alinder talked. Neither requested any reproduction fee, and neither suggested a donation to the Reagan Library. Evans told Alinder she needed permission from the Photo Office, and Greenawalt granted that permission. Both advised Alinder that there was no charge for reprinting the photograph in the book. The donation seems to have been Alinder's own idea.

I recommend returning the check to Alinder, advising her once again that no fee is necessary (and that none was "agreed upon"). A draft is attached.

Dear Mr. Smith:

Your letter of July 22 to Barry Fernald of the White House Photo Office has been referred to me for consideration and response. In that letter you requested a copy of the photograph of the President in a Lumex recliner, which appeared on a news telecast on July 18. You indicated that the photograph would be used at Lumex offices and in the Lumex dealer salesperson newsletter.

I must decline your request for the photograph, and decline to grant approval to use the photograph in the contemplated manner. The White House adheres strictly to a policy of declining to approve any use of the President's name, likeness, photograph, signature, or title in any manner that suggests or could be construed as endorsement of a commercial product or enterprise. Although you do not plan to use the photograph in direct advertising, your contemplated use nonetheless would contravene this policy, and accordingly cannot be approved.

Thank you for your inquiry. I trust you will appreciate the reasons for our response.

The Connecticut Division of the American Cancer Society has asked permission to use a picture of the President in a fundraising brochure on colorectal cancer. As you noted on the tracking sheet, we are likely to receive numerous similar requests. (I have already seen several advertisements, for products ranging from home colorectal cancer detection kits to prunes (a high fiber food) mentioning the President's cancer.) You may want to raise the question directly with the President, but I assume we will adhere to our usual policy of generally declining to participate in particular fundraising campaigns. Requests from Charitable Organizations Concerned with Cancer for Fundraising

Endorsements

I. ACTION FORCING EVENT

We have received several requests from reputable charitable organizations involved in cancer treatment and research, asking that you permit your name to be used in their promotional or fundraising campaigns.

II. DISCUSSION

As you know, our usual policy is to decline such requests from charitable organizations. We explain that the White House receives countless requests for such endorsements, cannot possibly grant them all, and out of fairness to all has been compelled to adopt a policy of generally declining such requests. Rare exceptions are made only after consultation with you and Mrs. Reagan, and typically only for particular causes in which you or Mrs. Reagan have been personally involved, such as Foster Grandparents, various drug abuse prevention programs, and the Motion Picture Country House and Hospital.

A decision needs to be made whether to adhere to the general policy of declining to provide fundraising endorsement for particular charities in the case of cancer-related charities, or to make an exception. I recommend that an exception not be made for cancer-related charities. Your successful operation and recuperation have already done much to promote awareness in this area. Charitable fundraising is as intensely competitive as any business, and I think those working on other diseases might legitimately object to Presidential endorsement of donations to fight only cancer. You often endorse charitable contributions and voluntarism in general, but the choice of what particular cause to support should be an individual's own, and I do not think the President's name should be invoked to sway that decision.

III. RECOMMENDATION

That you adhere to our usual policy and not endorse particular fundraising or promotional campaigns for cancer-related charities.

Dear Mr. Norbeck:

Thank you for your recent letter to the President, requesting permission to use a picture of the President in connection with a fundraising campaign. As you might imagine, the President receives countless requests to lend his name to fundraising activities for laudable charities. We cannot grant all such requests, and there is no fair way to discriminate among the many worthy requests that are received.

Accordingly, we have been compelled to adopt a policy of generally declining requests that the President participate in particular fundraising projects.

I trust you will understand the reasons we must adhere to this policy, and that our inability to grant your request is in no sense an adverse reflection on your organization or the important work with which it is involved.

Dear Mr. Schecter:

This is in response to your letter of August 12 to Barry Fernald of the White House Photo Office. In that letter you requested a color photograph of the Seal of the President, for use in a motion picture documentary on the signing by President Carter of the Taiwan Relations Act of 1979.

The permitted uses of the Seal are limited by law. Section 713 of Title 18 of the United States Code prohibits any use of the Seal except in accordance with regulations promulgated by the President. Those regulations are embodied in Executive Order 11649, as amended. I have enclosed for your information copies of the pertinent statute and regulations.

You will notice that the Seal may be used "in moving pictures...of bona fide news content." The enclosed copy of the Seal is provided for your use only in a "moving picture...of bona fide news content," and for no other purpose. The Seal may not be used in any fashion that suggests or could be construed as official endorsement of your documentary.
