Counsel's Office has reviewed the request from Dallas Market Center Co. for a Presidential proclamation or other message to mark the opening of INFOMART, a permanent marketplace for producers of information processing products, in Dallas. As you are aware, established White House policy precludes the issuance of proclamations that are not requested by joint resolution of Congress or traditionally issued (e.g., Thanksgiving). In fact, any sort of Presidential message would be inappropriate in this case, because of the commercial nature of the event. The White House does not approve messages from the President that are or could be construed as an endorsement of a commercial product, enterprise, or event. Adherence to this policy is necessary to avoid unseemly commercialization of the office.

SUBJECT: Proposed Proclamation Implementing Duty Reductions

on High Technology Products

Attached for your signature is a proposed Presidential Proclamation to implement a trade agreement entered into on February 11, 1985 with Japan to reduce to zero both U.S. and Japanese tariffs on semiconductors. The action has strong Congressional and industry support.

The authority for this reduction was provided by section 308 of the Trade and Tariff Act of 1984. The proposed Proclamation also delegates the authority to implement duty reductions on two additional items covered by the legislation. One is subject to the February 11 trade agreement, and will take effect when a typographical error in the statute is corrected by Congress. The other will be implemented if agreement is reached on certain computer parts. This authority will facilitate the implementation of further negotiations on high-technology trade negotiations.

In addition, the proposed Proclamation makes technical corrections to the Tariff Schedules to eliminate numbering conflicts caused by recent trade legislation.

The semiconductor agreement implements a commitment to reduce semiconductor tariffs which was endorsed by the Cabinet on November 11, 1983; it has the support of the Trade Policy Committee agencies. The draft Proclamation has been cleared by the Justice Department as to form and legality.

The agreement and this Proclamation provide for implementation of the tariff reductions effective March 1, 1985.

MEMORANDUM

Re: Proposed Proclamation entitled "Duty Reductions on High Technology Products"

The attached proposed Proclamation was submitted by the United States Trade Representative (USTR) and has been forwarded for the consideration of this Department as to form and legality.

The proposed Proclamation will achieve two objectives. First, it will implement a trade agreement entered into on February 11, 1985 between the United States and Japan. agreement was authorized by sections 305 and 308 of the International Trade and Investment Act, Pub. L. No. 98-573, §§ 301-308, 98 Stat. 2948, 3000 (1984). Section 305, to be codified as 19 U.S.C. § 2114A, added new negotiating objectives to the Trade Act of 1974, such as negotiation of agreements that eliminate restrictions on trade in high technology products. Section 308, to be codified as 19 U.S.C. § 2138, specifically authorized the President to enter into bilateral agreements eliminating the duty on seven identified high technology products, including transistors and parts of semiconductors. The agreement with Japan provides that the United States will eliminate duties on all seven products. The proposed Proclamation will remove the duties on five of the products on March 1, 1985. The Proclamation delegates to the USTR the authority to eliminate duties on the other products. The USTR is directed to eliminate the duty on transistors after a typographical error in § 308 has been corrected by Congress. 1/

^{1/} Section 308 refers to "item 587.70" rather than "687.70."

The proposed Proclamation will also amend Proc. No. 5291, 50 Fed. Reg. 223 (1985), to reflect numbering changes made in the Tariff Schedules of the United States by various provisions of the Trade and Tariff Act of 1984, Pub. L. No. 98-573, 98 Stat. 2948 (1984).

As with other trade proclamations, we are relying on the Office of the United States Trade Representative for the accuracy of the technical parts of this Proclamation.

The proposed Proclamation is acceptable as to form and legality.

SUBJECT: Proposed Proclamation Implementing Duty Reductions

on High Technology Products and Technical Corrections

on Certain Articles in Trade in Civil Aircraft

Attached for your review and processing is a proposed Presidential Proclamation implementing a trade agreement entered into today, between the United States Government and the Government of Japan, to reduce to zero both U.S. and Japanese tariff duties on semiconductors. The attached Proclamation reduces to zero the applied tariff duties on certain articles enumerated in section 128 of the Trade Act of 1974 (19 U.S.C. 2138; "section 128") which are covered by the U.S.-Japanese agreement. The proposed Proclamation also delegates to the U.S. Trade Representative (USTR) the authority to implement duty reductions for the remaining articles set forth in section 128. Finally, the proposed Proclamation makes technical corrections redesignating certain items in the Tariff Schedules to eliminate numbering conflicts caused by recent trade legislation.

Paragraph 1, preceding the operative portion of the Proclamation, recites generally the provisions of law providing negotiating objectives for high technology trade, authority to enter into trade agreements in this area, and Presidential authority to proclaim changes in tariff duties; and the agreement entered into today with Japan. Paragraphs 1 and 2 determine that reduction to zero of existing column 1 duties for the items listed in section 128 is appropriate, that the agreement should be implemented, and that certain of these items should be afforded duty-free treatment effective March 1, 1985. Paragraph 2 authorizes the USTR to modify the TSUS to make duty-free treatment effective for the remainder of the items listed in section 128.

Paragraph 3 makes the determination that technical corrections to the TSUS are necessary to correct changes to the Tariff Schedules made by Proclamation 5291 of December 28, 1984 (50 F.R. 223), to eliminate numbering conflicts caused by redesignation of certain items in the Trade and Tariff Act of 1984 (Pub. L. 98-573; 98 Stat. 2948).

Paragraph (1) of the operative portion of the draft Proclamation modifies certain tariff items that were listed in section 128 and included in the scope of the U.S.-Japanese agreement, by reducing the tariff duties for these items to zero effective March 1, 1985.

Paragraph (2) provides that for another item which was listed in section 128, duty-free treatment will be effective after enactment of legislation correcting a technical error in the enrollment of Pub. L. 98-573. Paragraph (3) authorizes the USTR to implement duty reductions on the remaining items in section 128.

Paragraph (4) makes the above-mentioned technical corrections in the Annex to Proclamation 5291, effective December 28, 1984.

Because the implementation date for the agreement is March 1, 1985, your early attention is requested.

DUTY REDUCTIONS ON HIGH TECHNOLOGY PRODUCTS

BY THE PRESIDENT OF THE UNITED STATES OF AMERICA

A PROCLAMATION

- 1. Pursuant to section 308 of the Trade and Tariff Act of 1984 (Pub.L. 98-573; 98 Stat. 2948, 3013) and section 128 of the Trade Act of 1974 (19 U.S.C. 2138), I have, through my duly empowered representative, entered into an agreement with Japan to achieve the negotiating objectives under section 104A(c) of the Trade Act of 1974 (19 U.S.C. 2114A). In order to obtain those objectives, in particular the maximum openness with respect to international trade and investment in high technology products, I have determined that the reduction to zero of existing column 1 duties provided for in the items of the Tariff Schedules of the United States (TSUS) (19 U.S.C. 1202) listed in section 128 is appropriate.
- 2. Accordingly, I have determined that the agreement should be implemented and duty-free treatment should be afforded to certain articles enumerated in section 128, effective on or after March 1, 1985. Furthermore, I authorize the United States Trade Representative (USTR), or his designee, on behalf of the United States of America, to modify the TSUS in order to make duty-free treatment effective for the remaining articles set forth in section 128.

3. Pursuant to section 604 of the Trade Act of 1974 (19 U.S.C. 2483), I have determined that technical corrections are necessary in order to implement modifications to the TSUS made by Proclamation 5291 of December 28, 1984 (50 F.R. 223), modifying duties on certain articles used in civil aircraft and on globes. Certain new items in the TSUS created in the Annex to that Proclamation must be redesignated to eliminate numbering conflicts resulting from the redesignation of other provisions by the Trade and Tariff Act of 1984.

NOW, THEREFORE, I RONALD REAGAN, President of the United States of America, acting under the authority vested in me by the Constitution and the statutes of the United States, including but not limited to sections 128 and 604 of the Trade Act of 1974 and section 308 of the Trade and Tariff Act of 1984, do proclaim that:

- (1) Items 687.72, 687.74, 687.77, 687.81, and 687.85 in part 5 of schedule 6 of the TSUS are modified by striking out, from the column entitled "Rates of Duty 1" for each item, the duty rate "4.2% ad val." and inserting in such column for each item the duty rate "Free". These modifications shall be effective with respect to articles entered, or withdrawn from warehouse for consumption, on or after March 1, 1985.
- (2) Item 687.70 in part 5 of schedule 6 of the TSUS is modified by striking out, from the column

entitled "Rates of Duty 1" for such item, the duty rate "4.2% ad val." and inserting in such column for such item the duty rate "Free". This modification shall be effective with respect to articles entered, or withdrawn from warehouse for consumption, on or after a date determined by the USTR and published in the Federal Register which is after the effective date of legislation making technical corrections in section 128 of the Trade and Tariff Act of 1984.

- (3) The USTR is hereby authorized to make any other modifications of the TSUS in order to make duty-free treatment effective for the remaining articles covered by section 128.
 - (4) The Annex to Proclamation 5291 is modified--
 - (a) by striking out, in the modification numbered 16, the item numbers "708.09" and "708.10" and inserting in lieu thereof "708.10" and "708.12", respectively; and
 - (b) by striking out, in the modification numbered 17, the item numbers "708.29" and "708.30" and inserting in lieu thereof "708.30" and "708.32", respectively.

These modifications are effective on or after December 28, 1984.
