AMERICANS HOLDING LIBYAN ASSETS TOLD TO REPORT THEM

WASHINGTON (AP) — THE TREASURY DEPARTMENT ON THURSDAY ISSUED REGULATIONS REQUIRING AMERICAN BANKS AND OTHERS HOLDING LIBYAN ASSETS AND THOSE WITH CLAIMS AGAINST LIBYA TO FILE REPORTS WITH THE GOVERNMENT BY NOV. 20.

THE DEPARTMENT SAID THE REPORTS WERE NEEDED TO MONITOR COMPLIANCE WITH PRESIDENT REAGAN'S ORDER IN JANUARY 1986 FREEZING LIBYAN ASSETS IN THIS COUNTRY.

AT THAT TIME, THE PRESIDENT ORDERED ALL AMERICAN COMPANIES AND WORKERS OUT OF LIBYA, FROZE LIBYAN ASSETS IN THE UNITED STATES AND BANNED AMERICAN EXPORT SALES TO LIBYA BECAUSE OF THAT NATION'S ALLEGED SUPPORT OF TERRORISTS.

THE REPORTING REQUIREMENTS COVER U.S. BUSINESSES THAT ARE HOLDING BLOCKED LIBYAN ASSETS AND AMERICANS WHO HAVE CLAIMS AGAINST LIBYA. THE FORMS THAT MUST BE COMPLETED WILL BE PRINTED IN THE FEDERAL REGISTER THIS WEEK AND WILL ALSO BE AVAILABLE AFTER SEPT. 28 FROM THE 12 REGIONAL FEDERAL RESERVE BANKS, THE GOVERNMENT SAID.

THE TREASURY SAID FAILURE TO FILE COMPLETE INFORMATION ON THE REPORTS WOULD CONSTITUTE FAILURE TO COMPLY WITH THE LIBYAN SANCTIONS REGULATIONS.

1. ON OCTOBER 9 THE UN CIRCULATED A U.S. LETTER DATED OCTOBER 2 (A/42/623) RESPONDING TO LIBYAN GENERAL DEBATE STATEMENT (REFTEL). ANNEXED TO LETTER IS CHRONOLOGY OF LI YAN TERRORISM PROVIDED IN STATE REFTEL. USUN MAILED ANNEX TO OTHER UN MISSIONS JUST BEFORE OPENING OF 42ND UNGA.

2. TEXT OF U.S. LETTER, INCLUDING ANNEX FROM STATE REFTEL, FOLLOWS:

EXCELLENCY,

IN HIS STATEMENT IN THE GENERAL DEBATE ON SEPTEMBER 25, THE LI YA REPRESENTATIVE MADE A NUMBER OF UNFOUNDED AND HIGHLY OBJECTIONABLE ACCUSATIONS CONCERNING THE UNITED STATES, INCLUDING THE CHARGE THAT THE UNITED STATES IS GUILTY OF TERRORISM.

THESE BASELESS CHARGES ARE THE LATEST LIBYAN EFFORT TO STAND TRUTH ON ITS HEAD AND TO HIDE THE REALITY OF LIBYAN TERRORISM AND AGGRESSION.

IT IS LI YA WHICH HAS THOROUGHLY INTEGRATED TERRORISM INTO ITS FOREIGN POLICY. IT IS LIBYA WHICH IS FORCEFULLY OCCUPYING THE TERRITORY OF A NEIGHBORING AFRICAN COUNTRY AND IS INCREASING ITS MERCENARY FORCES. THE REALITY OF LI YAN TERRORISM CANNOT BE EXPLAINED AWAY OR GLOSSED OVER BY LIBYAN RHETORIC AS THE ENCLOSED CHRONOLOGY OF LI YAN TERRORISM MAKES CLEAR.

I REQUEST THAT THIS LETTER AND ANNEX BE CIRCULATED AS A DOCUMENT OF THE GENERAL ASSEMBLY UNDER ITEM 9.

LIBYAN TERRORISM, WHICH IS THOROUGHLY INTEGRATED INTO

LIBYA'S FOREIGN POLICY, CANNOT BE EXPLAINED AWAY OR GLOSSED OVER BY LI YAN RHETORIC. THE FACTS BELIE LIBYA'S PROTESTATIONS OF INNOCENCE, AND THE FACTS ARE COMPELLING.

IN 1980 THE LIBYAN GOVERNMENT EGAN A TERRORIST CAMPAIGN TO ASSASSINATE ANTI-QADHAFI EXILES. AMONG THE OFFICIAL LIBYAN PRONOUNCEMENTS ARE THE FOLLOWING:

-- IN FEBRUARY OF 1983, THE LIBYAN GENERAL PEOPLE'S CONGRESS WARNED ALL LI YANS IN EXILE TO RETURN HOME OR FACE THE "ANGER OF THE LIBYAN PEOPLE."
-- IN FEBRUARY OF 1984, THE LI YAN REVOLUTIONARY COMMITTEES ANNOUNCED THAT ALL LIBYAN EXILES MUST RETURN TO LIBYA OR FACE "THE DEATH PENALTY."
-- IN JUNE OF 1984, THE OFFICIAL LIBYAN NEWS AGENCY JANA ANNOUNCED "LIBYAN MASSES HAVE DECIDED TO FORM SUICIDE COMMANDOS TO CHASE TRAITORS AND STRAY DOGS WHEREVER THEY ARE AND LIQUIDATE THEM PHYSICALLY."
TERRORIST ATTACKS AGAINST LIBYAN DISSIDENTS IN EXILE IN EGYPT, FRANCE, GREECE, WEST GERMANY, CYPRUS, ITALY, AUSTRIA, GREAT BRITAIN, AND THE UNITED STATES SINCE
UNCLAS SECTION 02 OF 07 USUN NEW YORK 03246

SUBJECT: 42ND UNGA: U.S. LETTER ON LIBYAN TERRORISM 1980 HAVE RESULTED IN THE DEATHS OF OVER 20 LIBYAN STUDENTS, BUSINESSMEN, AND FORMER LIBYAN DIPLOMATS. THIS POLICY OF ATTACKS ON LIBYAN DISSIDENTS CONTINUES. IN MAY OF THIS YEAR TWO LI YAN NATIONALS ATTACKED AND WOUNDED THE FORMER LIBYAN AMBASSADOR TO AUSTRIA. CHASED BY POLICE, ONE ASSAILANT WAS CAPTURED IMMEDIATELY. THE OTHER TOOK REFUGE IN THE LIBYAN PEOPLE'S BUREAU IN VIENNA, FROM WHICH HE WAS RELEASED 48 HOURS LATER. BOTH ATTACKERS WERE REVEALED TO BE MEMBERS OF THE LIBYAN INTELLIGENCE SERVICE. IN JUNE LIBYAN NATIONALS KILLED A LIBYAN DISSIDENT ON THE STREETS OF ROME AND WERE ARRESTED IMMEDIATELY. COLONEL QADHAFI IS NOT ONLY VICIOUS IN OPPOSING LIBYAN DISSIDENTS, HE IS ONE OF THE ARCHITECTS OF MODERN STATE-SPONSORED TERRORISM. HIS VERY WORDS CONDEMN HIM. FOR EXAMPLE:

-- IN JUNE 1984, QADHAFI TOLD A LIBYAN AUDIENCE, "WE ARE CAPABLE OF EXPORTING TERRORISM TO THE HEART OF AMERICA."

-- IN MARCH 1985, HE INSTRUCTED HIS FOLLOWERS TO "DIE JUST TO SPITE AMERICA" AND CALLED FOR VIOLENT ACTION AGAINST THE U.S. HE ALSO URGED GUERRILLA GROUPS TO LAUNCH ORGANIZED "SUICIDE MISSIONS" TO TOPPLE MODERATE MIDDLE EASTERN GOVERNMENTS.

-- DURING A SPEECH IN SEPTEMBER 1985, QADHAFI SAID "WE HAVE THE RIGHT TO FIGHT AMERICA, AND WE HAVE THE RIGHT TO EXPORT TERRORISM TO THEM."

-- ON JANUARY 2, 1986, HE THREATENED AT A PRESS CONFERENCE TO "PURSUE U.S. CITIZENS IN THEIR COUNTRY AND STREETS" IF THE UNITED STATES TAKES ACTION IN RESPONSE TO LIBYA'S INVOLVEMENT IN THE TERRORIST ATTACKS AT THE ROME AND VIENNA AIRPORTS.

-- A WEEK LATER HE DECLARED THAT LIBYA WILL TRAIN, ARM, AND PROTECT ARAB GUERRILLAS FOR "SUICIDE AND TERRORIST MISSIONS."

-- ON MARCH 24, 1986 HE SAID, "THIS IS NOT THE TIME FOR
