1. CONFIDENTIAL -- ENTIRE TEXT.

2. ACCORDING TO REPORT IN SEPTEMBER 14 AL-SAFIR, HIZBALLAH MOURNERS ASSEMBLED THE PREVIOUS DAY AT A "HUSSEINIYA" (SHIITE PLACE OF PRAYER AND ASSEMBLY) IN BEIRUT'S SOUTHERN SUBURBS TO MARK ONE WEEK FROM THE DEATH OF AN HIZBALLAH ADHERENT, HUSSAYN ABDEL JALIL. THE CEREMONY WAS ATTENDED BY HIZBALLAH "SPIRITUAL GUIDE" SHAYKH MUHAMED HUSSAYN FADLALLAH, BUT MAJOR ADDRESS WAS DELIVERED BY ANOTHER PARTY OF GOD SPOKESMAN, HASSAN NASRALLAH. WE FOUND NASRALLAH'S REMARKS ON TERRORISM AND EXPLOSIONS AT US EMBASSY AND MARINES HEADQUARTERS NOTABLE, AND HERewith REPORT EXCERPTS.

3. QUOTE NASRALLAH:

WHOEVER STANDS UP TO TELL THE WEST THAT THERE IS A DISTINCTION BETWEEN THE (ISLAMIC) RESISTANCE AND TERRORISM (COMMENT: NASRALLAH IS REFERRING TO AMAL LEADER NABIH BIRRI, WHO INSISTED UPON THIS DISTINCTION AT A AUGUST 31 RALLY IN TYRE. END COMMENT), TO HIM WE SAY THAT THE RESISTANCE IN THIS COUNTRY IS TERRORISM. WE DO NOT NEED TO CONVINCE THE WEST OF ANYTHING ABOUT OUR RESISTANCE. TO THE WEST, FIGHTING ISRAEL MEANS TERRORISM. NO MATTER HOW HARD THE WEST TRIES TO FORCE US TO ACCEPT ISRAEL, WE WILL NEVER DO IT.

"AND INSIDE (LEBANON), WHAT IS TERRORISM? IF YOU KEEP SPIES TO FILL UP THE AREA WITH INTELLIGENCE AGENTS AND SEDITION, IF YOU ATTACK INNOCENTS, THAT'S TERRORISM, AND THAT'S WHAT AMERICA AND ISRAEL DO. BUT THE ISLAMIC PEOPLE DON'T ATTACK (JUST) ANYONE. WHO SAYS THAT THOSE WHO ARE KIDNAPPED ARE INNOCENT? WHY IS IT TERRORISM WHEN A CAR STORMS THE HEADQUARTERS OF THE MARINES? WHAT ARE THEY DOING IN OUR COUNTRY? AND WHEN YOU BLOW UP THE AMERICAN EMBASSY, WHO SAYS THAT IT IS CARRYING OUT DIPLOMATIC WORK? IT IS A NEST OF SPIES, AND WHEN IT WAS BLOWN UP, A MEETING WAS BEING HELD THERE OF ALL THE AMERICAN INTELLIGENCE OFFICIALS IN THE MIDDLE EAST. ALL OF THEIR JOURNALISTS ARE SPIES AND INTELLIGENCE AGENTS

UNTIL IT IS PROVED TO THE CONTRARY. THAT IS NOT

REPUTED TERRORIST PLEADS INNOCENT TO BOMBINGS@

LOS ANGELES (UPI) AN ACCUSED MEMBER OF A TERRORIST GROUP SEEKING AN ARMENIAN HOMELAND IN EASTERN TURKEY PLEADED INNOCENT MONDAY TO CHARGES THAT HE MASTERMINDED TWO BOMBINGS TO EXTORT MONEY FOR THE GROUP AND TO AVENGE THE ARREST OF FELLOW TERRORISTS.

VICKEN TCHARKHUTIAN, 34, WAS INDICTED IN 1983 ON CHARGES HE ENGINEERED THE BOMBINGS OF A SWISS BANK CORP. BRANCH AND A CARPETERIA CARPET STORE IN LOS ANGELES, AS WELL AS THE ATTEMPTED BOMBING OF THE SWISS CONSULATE IN LOS ANGELES.

HE PLEADED INNOCENT IN U.S. DISTRICT COURT TO CHARGES IN ALL THREE INCIDENTS, WHICH OCCURRED IN 1981 AND 1982.

U.S. MAGISTRATE VOLNEY BROWN SET TCHARKHUTIAN'S TRIAL FOR NOV. 10 BEFORE U.S. DISTRICT JUDGE DAVID KENYON.

IN ADDITION TO THE INDICTMENT, FEDERAL OFFICIALS HAVE FILED A SEPARATE CRIMINAL CHARGE AGAINST TCHARKHUTIAN ACCUSING HIM OF ENGINEERING THE ATTEMPTED BOMBING OF AN AIR CANADA WAREHOUSE IN LOS ANGELES IN MAY 1982.

TCHARKHUTIAN DID NOT ENTER A PLEA TO THAT CHARGE MONDAY. HE WAS TO APPEAR BEFORE A FEDERAL MAGISTRATE AGAIN SEPT. 28.

FEDERAL INVESTIGATORS BELIEVE TCHARKHUTIAN IS A MEMBER OF THE ARMENIAN SECRET ARMY FOR THE LIBERATION OF ARMENIA, A TERRORIST GROUP SEEKING AN INDEPENDENT ARMENIAN HOMELAND IN EASTERN TURKEY AND THE TURKISH ACKNOWLEDGMENT OF GUILT FOR THE 1915 MASSACRE OF ARMENIANS.

THE FBI LAST WEEK ARRESTED TCHARKHUTIAN AT LOS ANGELES INTERNATIONAL AIRPORT ON THE 1983 INDICTMENT, BUT HAVE REFUSED TO DISCLOSE DETAILS OF THE ARREST.

FEDERAL INVESTIGATORS BELIEVE THE BOMBING OF THE SWISS BANK AND THE ATTEMPTED BOMBINGS OF THE SWISS CONSULATE AND AIR CANADA WAREHOUSE WERE TO PROTEST THE ARRESTS IN CANADA AND SWITZERLAND OF OTHER ALLEGED ARMENIAN TERRORISTS.

THE 1983 INDICTMENT ALSO CHARGES TCHARKHUTIAN AND HIS FORMER ROOMMATE, WARTAN BOUZOGHLANIAN, WITH EXTORTION FOR ALLEGEDLY USING THREATS OF PHYSICAL HARM TO DEMAND \$150,000 FOR ASALA'S CAUSE FROM THE PRESIDENT OF CARPETERIA, A CARPET STORE CHAIN, IN JANUARY 1981. @BOUZOGHLANIAN WAS ACQUITTED OF THOSE CHARGES.

THREE ARMENIANS WHO WERE CONVICTED IN 1983 OF PUTTING A COTTAGE CHEESE CONTAINER FULL OF EXPLOSIVES ON THE DOORSTEP OF THE AIR CANADA WAREHOUSE IDENTIFIED TCHARKHUTIAN AS THE ONE WHO PLANNED THE BOMBING ATTEMPT. POLICE DISMANTLED THE BOMB BEFORE IT EXPLODED.

ONE OF THE THREE, HRATCH KOZIBIOUKIAN, SAID TCHARKHUTIAN FORCED HIM TO MIX THE EXPLOSIVES BY THREATENING TO KILL HIM AND HIS PREGNANT WIFE.

BOUZOGHLANIAN IDENTIFIED TCHARKHUTIAN AS THE SOURCE OF THE EXTORTION LETTER THAT BOUZOGHLANIAN WAS ACCUSED OF DELIVERING TO CARPETERIA'S PRESIDENT, DEMANDING MONEY FOR LIBERATING ''OUR ENSLAVED LAND AND (GIVING) OUR PEOPLE ITS NATIONAL HONOR AND HUMAN DIGNITY.''

A FEW DAYS BEFORE THE ATTEMPTED AIR CANADA BOMBING, TCHARKHUTIAN TOOK A LEAVE OF ABSENCE FROM HIS JOB AS A DESIGNER FOR FLUOR CORP. IN IRVINE AND LEFT THE COUNTRY. FRENCH OFFICIALS ARRESTED HIM BUT REFUSED TO COMPLY WITH A UNITED STATES EXTRADITION REQUEST AND FREED HIM.
