HIJACKING/DELTA FORCE? - After urging Cyprus not to provide the hijacked plane with fuel, Cyprus did it anyway. The U.S. was not happy. (CHARLES REDMAN: "We had repeatedly indicated that we believed the plane should be kept on Cyprus, and we regret the decision to allow it to leave.") The fact of the matter is the U.S. has almost nothing to say about how this hijacking is handled. It's not an American carrier and there are apparently no Americans on board. When the plane first arrived in Cyprus, American officials say the U.S. did offer both Cyprus and Kuwait technical assistance, with the possibility of help from the elite delta force. American conditions included: clearing the airport of press, maintaining complete security and secrecy for the delta force, and allowing the commandos to call the shots. The American offer was declined. Even if the offer had been accepted, analysts say the job would have been enormously difficult. The 747 aircraft is so big, so far off the ground, its doors so heavy, access through the baggage compartment so difficult, that any rescue attempt could have turned into a nightmare. Despite all that, U.S. sources say the delta force was and is prepared to move if called upon to do so. But, thus far, there has been no call. (John McWethy - State Department)
