''IT DOES LOOK LIKE TERRORIST BLACKMAIL WORKS IN BONN,'' DOLE, R-KAN., SAID ON THE SENATE FLOOR. HE REFERRED TO REPORTS THE WEST GERMAN GOVERNMENT MAY NOT EXTRADITE MOHAMMED HAMADEI, WHO WAS INDICTED IN THE UNITED STATES ON CHARGES CONNECTED WITH THE TWA HIJACKING TWO YEARS AGO AND WITH THE SUBSEQUENT MURDER OF NAVY DIVER ROBERT STETHAM.

''AS YOU PREPARE TO DEPART FOR THE VENICE SUMMIT, WE URGE THAT YOU PLACE HIGH ON YOUR AGENDA FOR TALKS WITH WEST GERMAN CHANCELLOR KOHL THE NEED FOR SPEEDY ACTION BY BONN TO EXTRADITE ... HAMADEI,'' DOLE AND SEN. ALFONSE D'AMATO, R-N.Y., WROTE REAGAN ON TUESDAY.

''NOW WE SEE REPORTS THAT THE BONN GOVERNMENT MAY ACTUALLY BE NEGOTIATING A DEAL WITH IRAN, UNDER WHICH HAMADEI WOULD NOT BE EXTRADITED; WOULD HAVE HIS WRISTS SLAPPED IN A SHAM TRIAL IN BONN; AND THEN WOULD BE SWAPPED FOR WEST GERMAN NATIONALS KIDNAPPED IN BEIRUT,'' THEY WROTE.

''NOW IS THE TIME FOR WEST GERMANY TO ACT TOUGH; TO DO WHAT IS RIGHT,'' DOLE AND D'AMATO SAID.
