Reagan ally in N.J. GOP bid

Bruinooge seeking post of party chairman

By Michele Fuetsch Staff Writer

Allendale Councilman Thomas H. Bruinooge, who has been called President Reagan's key patronage adviser in New Jersey, is soliciting support to become state -Republican chairman.

His emergence as a candidate for the GOP post ends months of speculation about what role he wanted to play in the administration.

Bruinooge said late Friday that he had been calling the 42 state committee members elected in last Tuesday's primary and that responses had been "very, very positive."

The committee members, who will select the chairman Tuesday, will almost certainly follow the wishes of GOP gubernatorial nominee Thomas H. Kean.

Kean said 30 persons had been suggested as succes- See REAGAN, Page A-32

sors to Chairman David Norcross, but he indicated no favorites. "I want to receive all the input I can," he said.

Campaign vice-chairman

Bruinooge, 37, who was vice-chairman of Reagan's New Jersey presidential campaign, said he had organized winning campaigns on national, state, and local levels.

"One of the most important things is that the state chairman has to have a good relationship with the national administration," said Bruinooge, "My credentials with the Reagan administration are excellent."

Since November's election, he has kept close contact with the White House and with Raymond L. Donovan, the Secaucus construction company owner whom Reagan named sceretary of labor.

"We had spoken with Tom Kean months ago about what we wanted in a state chairman," said Bruinooge, who was with Donovan at that meeting.

Bruinooge made no public endorsement in the primary, but said he was "personally supportive" of Essex

County millionaire Joseph "Bo" Sullivan, who finished third in the eight-way primary Sullivan helped raise money for the Reagan campaign last year.

A former Bergen County undersheriff who practices law in Rutherford, Bruinooge has been redirecting the Reagan campaign rank and file here into a grassroots lobbying force for the President's, budget.

He has also been forging ties with bluecollar ethnic voters, particularly in Hudson County. There Jersey City Councilman Gerald McCann, who last year headed a Democrats for Reagan effort, is trying to win the mayoralty against the Democratic machine led by his opponent, state Sen. Walter N. Sheil, and outgoing Mayor Thomas F. X. Smith.

After winning on Tuesday, Kean sent Mailgrams to GOP legislators and other party leaders, seeking suggestions for chairman.

Assemblyman W. Cary Edwards's name was among the many suggested, but Edwards, the only Bergen GOP legislator to support Kean, said Friday that he had told Kean he was not interested.

Others who were suggested include four of Kean's primary opponents - Paterson Mayor Lawrence "Pat" Kramer, State Sen. Barry Parker of Burlington County, Hamilton Township Mayor John Rafferty, and "Bo" Sullivan. One GOP insider said that Kramer and Parker were not being scriously considered.

Also suggested were the names of Gloucester County Chairman Eugene McCaffrey, a close friend of Kean's, and Joseph Gonzalez of West Windsor Township, executive director of the Assembly minority.

Two others recommended were Essex County Republican Chairman John Renna and Assemblyman Bill Gormley of Atlantic County, another Kean ally.

Tuesday night, Bruinooge traveled with Sullivan to Kean's hotel headquarters and met with the nominee in his hotel suite before Kean and Sullivan appeared together at Kean's victory party.

Bruinooge first caught Reagan's attention at the 1976 Republican convention. when he east the lone New Jersey delegate vote for Reagan against President Ford. Following the November election, there was speculation that Bruinooge was in line for a federal post, probably U.S. attorney, but he avoided talk of a federal post.


