**You** suggested vesterday that you would like to help I am a dangerous person to make such a suggestion Because I am delighted to exploit every such offer. Thus, as you see, not much grass has grown under my feet my feet before my first request.

The request is this: I have invited President Reagan both through formal channels and with a letter to Edwin Meese, to speak to a conference the Committee is calling in Washington on the weekend from Thursday evening, January 21st through Sunday morning, January 24th at whatever time and in whatever form would be most convenient for him. We are calling this conference because, like the Administration, we are profoundly anxious about the growth of European neutralism. we have a number of extremely influential Europeans on the Committee and since we have informal access to a number of politically important ones, we have decided to bring a group of them (about fifteen or so) to Washington to sit down with an equal number of their American counterparts and engage in a frank and serious discussion of what is to be done about the growing transatlantic rift.

We think this gathering could be a very important political occasion, both for us and for the Europeans. Naturally, it would be guaranteed to be an important political occasion if President Reagan were to consent to be present in some way. It is said that you are one of his most trusted friends and advisors; that is why I am appealing to you to put in a good word for us. I will not deny that I am keen for the President to appear because it will lend great strength and prestige to our efforts. On the other hand, I also believe genuinely that it would provide him with an unparalleled opportunity to explain to Western Europe what he - and all of us - wants, needs, and expects of it.

Any help you could give us in this matter would be more gratefully appreciated than you can know.
