I write to request a personal favor. I have been asked to chair the 1983 annual Lincoln Day dinner for the Bergen County Republican Organization, and I am in great need of your assistance in obtaining Senator Paul Laxalt as the dinner speaker.

Bergen County produced a 100,000 vote plurality for President Reagan in 1980, and has proven to be the county of the state. No statewide candidate is successful without a major plurality in Bergen, which is born out by Millicent Fenwick's recent loss. Within the last week, a new County Chairman has taken over; an extremely positive sign, since the party in the last year and one-half has been troubled by deep division. # On Kean's criticism of the President

DEAR EDITOR:

As a former chairman of the Bergen County Republican Organization and as a citizen, I am appalled and puzzled by the recent criticism leveled at President Reagan by Gov. Kean.

The Republican Governor says, according to news reports, that our President has lost touch with the major interest groups and, in fact, has alienated the women, the blacks, labor and a host of others. This is a blatant contradiction of fact since it was these very groups who helped elect the President.

The yardstick used by our Governor to measure this so-called disaffection with our President is the recent election results. I cannot agree with that conclusion nor do any expert observers I know of. In fact, the election results were classically on par with the numbers of any off-year election. For anyone to make "heavy weather" forecasts on Republican losses has simply not read history.

\* \* \*

Yes, unemployment is a terrible problem. But it's a problem that has been inherited due largely to years of Democratic administration bungling. And the President, I am confident, has that problem fixed as a high priority—just as he has strategized ways to deflate inflation and whittle down the 20 per cent interest rates with which the Carter administration decorated the White House doorstep.

No president can solve in 18 months the problems that took 20 years to generate. In my view, Gov. Kean would better spend his time and energies in New Jersey solving our problems than holding press conferences in Washington to wag his finger at the President — who is doing a difficult job in difficult times and doing it well.

DEAR EDITOR:

The recent assessments made by a number of national and state level Republican officials, including our own Gov. Kean, undoubtedly indicates the real course the Reagan Administration needs to adhere to.

By this I refer to the overdue urgent requirement for the Republican Administration to abort fatally antagonizing or alienating major voting groups: Farmers, small business people, union members, the elderly, women and (most often cited) minorities.

One of the comments made at the recent Governors Conference included: "We have very serious perception problems...and we're not going to change perceptions until we change policies at the national level." (Pollsters Robert Teeter, C. Lance Tarrance and John Deardourff, who designed the Republicans' 1982 "Stay the Course" campaign.)

Gov. Kean said: "A group that is alienated and does not have its desires articulated will go elsewhere, and there is clear evidence of that in this election. Obviously you can't succeed politically if major groups in the society feel they don't have a voice."

Illinois Gov. James R. Thompson said: "The 1982 election was a cry for help, and those in power have two short years to respond. Putting people back to work has to be our top priority. We have to reach out to blacks and Hispanics. They voted straight Democratic, against liberal Republicans, moderate Republicans and conservative Republicans. They were sending a message to someone that must be heeded."

Obviously the enactment of these concerns should be the immediate Republican agenda.

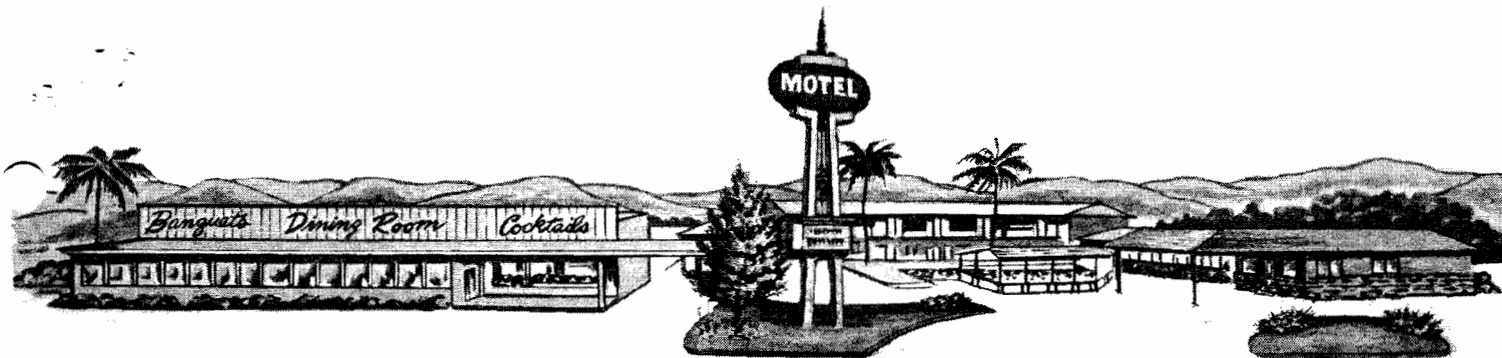

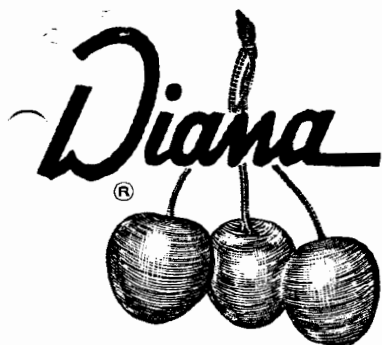


