
A copy is attached of the SEC's Fiscal 1982 Annual Report.

Dear Mike:

A year has passed since I wrote an expression of impassioned support for the President, enclosing it with a letter to you. I deeply appreciate the President's note to me for which I am indebted to you. May I be permitted an annual letter to the President?

In fact, I had to restrain my wife, Zoe Ann, from going to one of his recent fence-mending sessions nearby and pelting him with spitballs (in point of fact, other constituents did much the same thing, breaking up his meeting). Congressman Tony Cohelo is Zoe Ann's cousin but he's on the wrong side of the political tracks too.

Would you do me the favor of providing passes for Mark and his aunt?

He arrives June 15, leaves June 24. His aunt, Ms. Coralie Beane, lives at 3003 Van Ness St., N.W., Washington, D.C. 20008 (363-5774). Or you could send the passes to me and I will forward them to her.

Dear Mr. President:

The last thing I would want to do is add to your burdens, but I can recall seeing you scan through letters from ordinary citizens (for example, while riding with you in the limo), and I thought perhaps you might be interested in the perspective from the point of view of a man who first worked on your staff almost 20 years ago (1964 Goldwater campaign), later worked on your 1966 campaign press staff, then in the Governor's office before returning to the private sector.

My view is that your presidency comes at a unique point in history considering the number and magnitude of problems our country faces.

A malignant foreign power continues to press its aggressive aims while many Americans want to look the other way.

Priorities have become so distorted through a half-century of Welfarism that large constituencies, well-represented in Congress, think it is more important for government to try to give the needy everything they need than it is to protect our national sovereignty. They advocate siphoning money from our defense into the bottomless sinkhole of what is loosely called "welfare" (or even more loosely, "entitlements").

This mind-set has produced attitudes that work against our continued existence as a vital, productive, powerful nation.

In the name of equality, jobs and contracts are awarded on the basis of race. Crime goes unpunished (or under-punished) because society is held responsible for crime, not the criminals. Productivity is punished by withholding up to half of a producer's earnings. Our borders lack integrity because it would be beastly of us to insist upon respect for our national boundaries. Sex is widely treated as sport instead of a sanctified act of love between husband and wife.

Wonderland labor contracts such as the UAW's lead to losing battles with imports. Management makes blunders such as deciding that home video cassette recorders are impractical, resulting in Japan producing every blessed VCR sold today (millions of them). These events breed a sense of disenchantment, lost power and aimlessness which in turn leads to escapism on a scale never practiced before: The illegal drug business is estimated at \$90-billion a year, the nation's fastest-growing "business".

The financial lure of drug-pushing has sucked in such figures as a Baptist minister, a famous auto executive, a former state supreme court justice, the first violinist of the Metropolitan Opera orchestra, and many others of like stature.

Corruption has seeped into the bone marrow of American life.

And there you sit, Mr. President, presiding from the Oval Office over a nation wracked with self-doubts, fighting over who gets the mountains of money the government rips from producers, many stoning themselves blind, some despoiling our young women in pornography (from the "soft" Playboy type on down to the depths of hardcore), ripping our babies out of their wombs, piece by piece.

We are not the only people with these problems but these are our problems.

If anyone can deal with all this, Mr. President, you are the man.

If ever there was a time when we had the right man in the right place at the right time, it is now. Surely, the hand of Providence is at work here.

Already, you have turned around an economy that was headed pell-mell down a roller coaster ride into oblivion. I find breathtaking the progress you have made in quelling the fires of inflation, knocking down interest rates and pointing the nation's economy upward.

You have just the character traits needed to reunite a people riven by quarreling factions. You can restore a sense of purpose to American life, draw upon the best instincts in our people, turn us away from excessive self-indulgence. You can kindle a renewed sense of economic reality, rejuvenate national pride and rehabilitate a healthy patriotism. You have just the touch to do it.

That's why I hope you can find it in yourself to run again next year.

I will never forget the extremely long and very warm handshake we had just after you left the podium at the Biltmore Hotel victory celebration, Election night 1966, as you started down the stairs backstage. On a personal basis, I would say: Ron, retire to your beautiful ranch. Enjoy the outdoors life. Ride your horses. Enjoy being with Nancy. You have richly earned your leisure. Do as you wish.

But as an American, aware of the terrible problems with our national life, I am bound to plead: Mr. President, run again -- the nation needs you at the helm.
