Dear Mike,

Having worked with you as the only full-time volunteer on the hard fought, but unsuccessful "Prop. I" campaign in Sacramento, you are aware of my husband's and my allegiance to President and Mrs. Reagan.

In today's newspaper was a release about your heading up a group to help "court" women in preparation for the 1984 election.

Seeing this news release has prompted me to write you this letter.

Needless to say, I too am quite concerned about the President getting the "women's vote" in the 1984 election and would want to help in any way possible and could be an effective spokeswoman. Some of my national association "women's credits" include Daughters of the American Revolution of which I am a Regent and American Women in Radio and TV.

Over a year ago I wrote you about my husband Al and myself and of our interest in coming to Washington to be of service to President Reagan, since we had both served in his administration in California.

You turned my letter over to John Herrington, who at that time was in charge of personnel. We received a very prompt call from him.

At his request we went to Washington where he arranged for several interviews for both Al and myself.

However, John returned to DOD at the end of the week we were there. Following his departure everything he had originated for us came to a complete halt. Unfortunately, but through no fault of John's, it seemed we were passed into the hands of people with no decision making authority.

About a month ago, I saw in the Washington papers that John was coming back to White House personnel. (It needs his fine hand.) I wrote him and again expressed our interest in coming to Washington, but doubtless he has not been on the new job long enough to get back to me.

Al and I are still both interested in positions in the Reagan Administration and believe our diverse and varied business, government and political backgrounds and our loyalty to President Reagan can be of service to him in his Administration.

Unfortunately during the first year and a half of President Reagan's administration, Al and I were both "out of commission" as the result of a serious auto accident right after election day. I was on crutches for 10 months. Now all is back to normal, however, this is the reason we were not in touch with The White House immediately after election day per my conversation with Ed Meese when he and I talked at the Republican National Convention in Detroit.

Dear Mike:

I would like to concur with the recommendation in the enclosed letter that the President consider a trip to Michigan. I suggested that John Gnau might better contact you about this, but was told he had already contacted Ed Meese.

I know that there is normally not much percentage for the President to come to Michigan, but it might be helpful for the President to come through for a few hours on the weekend he announces for re-election. Stops could include the General Motors Lake Orion plant opening (there is an independent invitation), a Republican fundraiser, and possibly a visit to the (unemployed) working family he visited in the Detroit area in 1980. The Michigan Republican Party is much more favorable to the President now, but it needs money badly. A stop in Michigan, where the general election started, and where the economy is fast improving, would be a good symbol.

I am working for my part to help bring all parts of our Michigan party together behind the President in 1984. Jack Welborn has been very cooperative on this score and will work with Paul Laxalt on it. I will be seeing John Gnau at dinner tonight as part of our effort to unify and I will mention to him this letter to you.

This concern was among the reasons we have formed a group called Caucus of Republican Elected Women (CREW).


We have extended invitations to all Republican locally elected women as well as state local committee-women. While we are still in the formation stages, the response has been gratifying.

Thanks for writing to let me know about Graciela Beecher. She's obviously thoughtful and articulate.

I appreciate Dr. Beecher's offer to help the President achieve his goal of full and equal opportunity for women. As you know, the President has asked me to involve myself more deeply in issues of special concern to women. Indeed, he has asked all his appointees to do so. However, there is no formal chartered council or committee working on these issues.

I have already written Dr. Beecher to explain this and to thank her for her generous offer. But I want to thank you once again for calling my attention to Dr. Beecher.
