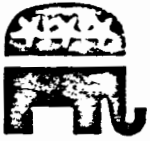
Assuming that you would run something like this past Judge Clark, I have not sent him a copy of this letter. Call me if I can be of help.

Después de la visita del Santo Padre a Nicaragua me escribe una sobrina religiosa que trabaja en una pequeña población de ese país y me dice que ha comenzado una represión contra la Iglesia Católica de parte del gobierno Sandinista.

Gracias a Dios que el General Torrijos se dio cuenta de su fracaso y volvió a entregar las tierras a sus dueños y a eliminar los líderes marxistas.

Yo viví toda esa tragedia y menos mal pudimos protestar de los abusos y defender los derechos de los indios y campesinos pobres. Hoy esa experiencia de lo que es el marxismo ha servido mucho en Panamá, pues es la gente pobre apegada a su tierra y a una vida libre e independiente la que más rechaza la esclavitud de la dictadura marxista.

Cuál será, pues, el futuro de la Iglesia en Nicaragua? Lo mismo que en Cuba y bajo los regímenes comunistas: formar parte de la Iglesia del silencio.

## WHERE IS NICARAGUA GOING ?

After the visit of the Holy Father to Nicaragua, I received a letter from my niece, who is a nun working in a small town in Nicaragua. She told me that the Sandinista Government has started a repression against the Catholic Church.

"I am writing to you," she said, "because someone is going to take my letter to Costa Rica and from there it will be mailed to you, but please don't write back directly to me because your letter will never reach my hands and it will be very dangerous for me."

The Communist government in Nicaragua is using another tactic as well. It is trying to divide the Catholic Church through the popular churches and it is succeeding. We can see it here in the United States, where there are religious men and women who support the Sandinista revolution. They do this knowing that it is a Communist regime, or they do it simply without being aware.

In my native Panama, I also at one time was one of those priests and bishops who believed that we could solve the problems of the poor by making an alliance with the Communists. Then for four years I lived in a region that the late General Torrijos had put in the hands of leaders who were indoctrinated in Communist countries. They had all the power and took possession of the lands of the rich, the farmers and the Indians. They organized common working places where they paid a salary to the working people.

This was the greatest downfall that one can imagine. The poor got poorer; the products were scanty and prices were doubled in order to meet the expenses of cultivation. Many millions of dollars were lost in one year. The Marxist leaders lived with the best and abused the farmers and Indians. Thank God that General Torrijos was aware of this downfall and gave the lands back to their owners and removed the Marxist leaders.

I lived through this tragedy and I am glad that we were able to protest the abuses and to defend the rights of the poor Indians and farmers. Today, the experience of Marxism has been useful in Panama. The poor people who are devoted to their land and to an independent and free life are the ones who strongly refuse the slavery of a Marxist dictatorship.

What, then, will be the future of the Church in Nicaragua? As in Cuba and under other Communist regimes, it will be part of the silent Church.

Mike Deaver has forwarded a letter to you that he received from Kenneth L. Khachigian of San Clemente. Khachigian forwarded a letter he received from Thomas A. Fuentes, First Vice Chairman of the Republican Party of Orange County. The subject of both letters is Archbishop Clavel, who is said to have been Archbishop of Panama and President of the Roman Catholic Bishops of Central America prior to leaving Panama in 1970.

Archbishop Clavel reportedly traveled to Central America with the Holy Father; he is said to be strongly anti-communist and pro-Reagan. The suggestion is that he be invited to the White House so that he can brief the President on the critical importance of help for Central America.

I must admit that I have not heard of Archbishop Clavel. If his feelings are as strong as they are said to be (and I have no reason to doubt this), he should be more outspoken with the Catholic Bishops' Conference, where we could really use the help.

RECOMMENDATION:

I would recommend a letter to the Archbishop signed the the President. Speechwriters approve the text.

Issue

That you sign your letter to Archbishop Tomas Clavel.

Facts

Ken Khachigian and Tom Fuentes, First Vice Chairman of the Republican Party of Orange County, have both written about Archbishop Clavel.

Discussion

Archbishop Clavel, according to Ken and Tom, accompanied Pope John Paul II to Central America on his recent visit there. Clavel is said to be strongly anti-communist and very supportive of your efforts. The Archbishop wrote a story for the local Catholic newspaper in Orange County that described the problems of the church in Nicaragua. Archbishop Clavel, when he was in Panama, thought that to help the poor, an alliance with the Communists was possible. He describes his experience as "the greatest downfall one can imagine." "The poor got poorer. . . . The Marxist leaders lived with the best and abused the farmers and Indians."

Recommendation:

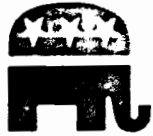

COUNSEL TO THE PRESIDENT

SUBJECT: Post-Employment Conflicts of Interest

This Office has previously advised you of the significance of the post-employment conflict of interest statutes and their potential effect on you as a "senior Government employee". We urge that at the time you may consider leaving government service, you again familiarize yourself with all the post-employment restrictions applicable by Federal law to all "senior Government employees".

Of particular significance to you is the one year prohibition, contained in 18 U.S.C. § 207(c), against any representational contact with a senior Government employee's former "department or agency". That provision states that any "senior" employee who

. . . knowingly acts as agent or attorney for, or otherwise represents, anyone other than the United States in any formal or informal appearance before, or, with the intent to influence, makes any oral or written communication on behalf of anyone other than the United States, to--

(1) the department or agency in which he served as an officer or employee, or any officer or employee thereof, and

(2) in connection with any judicial, rule-making, or other proceeding, application, request for a ruling or other determination, contract, claim, controversy, investigation, charge, accusation, arrest, or other particular matter, and

(3) which is pending before such department or agency or in which such department or agency has a direct and substantial interest--

shall be fined not more than \$10,000 or imprisoned for not more than two years, or both.

The Director of the Office of Government Ethics (OGE) has

recently determined that with respect to the prohibitions on representational contact with former departments or agencies "senior Government employees", the Executive Office of the President is divided into nine separate and distinct agencies. A list of those agencies is attached.

Accordingly, the one year ban on representational contacts with former departments or agencies of 18 U.S.C. § 207(c) does not apply to such contacts with the Executive Office of the President as a whole, but applies only to those separate and distinct agencies within the Executive Office of the President. This means that if you are an employee of the White House Office or the Office of Policy Development paid at the rate of GS-16 or above, you may not, upon leaving government service, have any representational contact with the White House Office or Office of Policy Development; however, you may have "representational contact" with the other "agencies" within the Executive Office of the President, e.g., the Office of Management and Budget or the Office of the Vice President.





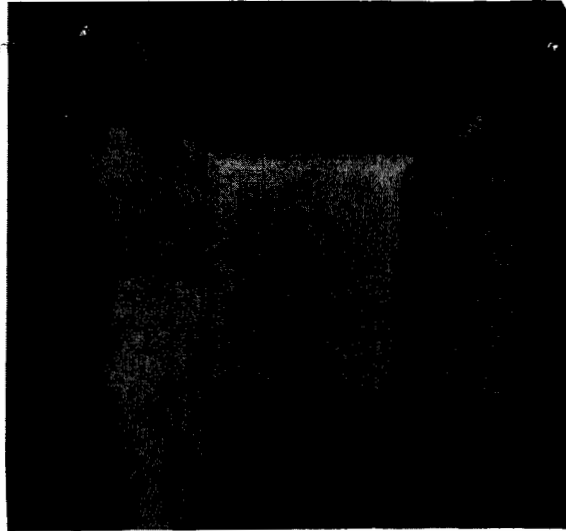
