

Mr. Holmes Tuttle said that he spoke with you last weekend concerning ka very special dinner in honor of Mrs. Margaret Martin (George C.) Brock at which time the President could also attend:

I also mentioned this to Judge Clark on the occasion when Margaret and I co-hosted a dinner here in Los Angeles honoring Bill and, therefore, will take the privilege of sending him a copy of this letter.

Margaret Brock would have few, if any, peers in her support of the Republican Party or as a community leader, especially in Southern California. I have attached to this letter just a brief background on Margaret, much of which you know as well as does the President. President Reagan, of course, is very familiar with Margaret's value to the Republican Party, to many candidates, as well as to other numerous charitable and educational institutions.

I have worked closely with Margaret on political and charitable events for several years, and on many occasions people have asked that she be the honored guest at a dinner to raise funds for some worthy event. Margaret confided in me that she is reluctant or embarrassed to ask her friends to make contributions honoring her; but, Margaret, more than any other person I know, deserves to be honored by those of us whom she has encouraged to work and donate to political and charitable causes.

I, therefore, have planned a dinner whereby those who have shared with Margaret in her endeavors can honor her, but not be asked to donate money; and, yet at the same time, the affair would benefit an important educational institution in which she and the President hold a high regard?

Here is the plan:

1. HONOREE: MARGARET MARTIN BROCK

We will produce an interesting, professionally done, film presentation of Margaret's active life and the important achievements that she has and is accomplishing.

2. DATE

The dinner to be held in October or November on a date when President Reagan could hopefully be expected to attend, even if for a short part of the evening.

3. LOCATION

The dinner would be held in our home at 333 Bel Air Road, in Los Angeles about 500 feet from the East Gate to Bel Air. The house is surrounded by a high brick wall and we have a surveillance and security system.

4. BENEFITING PEPPERDINE UNIVERSITY/AMERICAN HUMANICS DEPARTMENT

I would make a contribution to Pepperdine University and its American Humanics Department in honor of Margaret which would net \$50,000 over and above the cost of the dinner party. Therefore, there would be no contributions expected of anyone and yet, Pepperdine University's American Humanics Department would receive at least \$50,000 over and above the expenses of the dinner from the Glen A. Holden Foundation.

5. GUEST LIST

Invitations would go to 400-500 people whom Margaret would identify as those people who over the years have shared with Margaret in support of the same political and charitable causes. I am sure the guests would include one of the most auspicious groups ever sitting at one dinner together and all of the same political and moral persuasion as our President.

Please call me as soon as you can give me any comments on this important project.

Dear Mr. Deaver:

It was a privilege to have been with you for the first meeting of the President's Advisory Council on Private Sector Initiatives. I was tremendously energized by the day and look forward to the challenge that lies before us.

Along those lines, I would like to share with you some preliminary information that has come to my attention--programs and ideas which strike me as germaine to our study.

First of all, on the home front, at Providence-St. Mel we have begun a summer enrichment program for gifted youngsters (grades 4-8) from the Chicago Housing Projects and low-income areas. Through a major challenge grant secured for this program we are able to offer 146 bright young people an educational challenge that would otherwise not have been possible for them. It is extremely rewarding to see, in this one instance, what private sector initiatives can accomplish.

Additionally, I have sent inquiries to several individuals and businesses with whom I am acquainted in the hope that ideas and responses will be generated. This input should be helpful as some initial "food for thought" for the Private Sector Council.

Finally, I am enclosing a copy of an article which W. Clement Stone shared with me last week. This article will be published in the September issue of SUCCESS Magazine, but Mr. Stone has graciously agreed to let me share it with you NOW. I found it both uplifting and challenging.

Mr. Deaver, I look forward to working with you on this important task. Of course, I welcome any comments or ideas you may have. And anytime you are in Chicago I hope that you will give me a call. You might be interested in seeing Providence-St. Mel with a view towards what private sector involvement has done here.

Dear Mr. President:

The recent action taken by the House of Representatives in deleting from H.R. 2969, the FY 84 Defense Authorization bill, certain production funds that had been requested by you for the initiation of a chemical weapons protective and retaliatory program emphasizes, in my view, the importance of undertaking an immediate review and declassification of all appropriate information held by our government that pertains to the activities of the Soviet Union with the research, development, testing, production, transfer and/or use of chemical, biological and toxin weapons.

It is apparent to me that the chemical weapons program that you wish to initiate and that I believe is vital to our national security will not be funded by Congress unless the American people have an opportunity to assess the data on Soviet activities.

An informed public would not only be a key factor in securing the necessary funds for chemical weapons production but would also be a significant asset during the current nuclear "freeze" debate and with your efforts to obtain true arms reduction agreements with the Soviets.

Just as you decided several months ago that a similar review and declassification process involving photographs and information relating to Soviet activities in the Caribbean would advance U.S. interests, so I believe that a similar process applied to Soviet chemical, biological and toxin activities would significantly enhance the chances of success for the efforts being made by you to secure the peace through a position of strength.

Please give this matter your immediate and personal attention. Your action on this proposal could well be crucial in achieving the goals that I know you and I share.
