

Dear Mike:

It has been a long time since we've had an opportunity to speak but I did want to take this opportunity to drop you a note to recommend a local Judge for an appointment which I understand will soon be opening for the Federal District Court of the Northern District of California.

Judge John Marlo was appointed to the bench of the Municipal Court in 1973 by the (then) Governor, Ronald Reagan. Since that time, he has compiled an outstanding judicial record. While he is still in the Municipal Court, he has been one of the leaders in the State Judiciary and the education of Judges. He is highly regarded here locally; he has been a lecturer for the California Center for Judicial Education and Research and for the Continuing Judicial Studies Programs.

Judge Marlo's background was as a practicing lawyer here in Santa Cruz and as a City Attorney for the City of Capitola. He published a textbook through McGraw-Hill in 1970, entitled "The Police Officer and Criminal Justice". This is a widely used textbook for police officers throughout the country. He has also published some articles on California Courts and California Judicial Education Journals.

Judge Marlo was a Military Officer with the Military Police in the United States Army Police Corps and a Captain in the Army Reserve in the Judge Advocate General's Corps. He worked his way through college and law school as a Police Officer in the City of San Jose. He graduated from San Jose State University in Police Science in 1956 and from Santa Clara University Law School in 1961.

Judge Marlo has lectured at the Judge's College in Berkeley and has been the recipient of a number of awards connected with his judicial and civic acknowledgements.


I have known Judge Marlo and his family for close to thirty years. He and his wife raised five lovely children and have enjoyed the deep respect of the whole community.

Assuming that an opening is available in the Federal District Court in the Northern District of California, I could heartily recommend John Marlo and I know that if the President makes such an appointment, he will be as pleased with that appointment as I am sure he is with the appointment he made when, in 1973, he appointed Judge Marlo to the Municipal Court bench.

I marked this "personal" but assume it has been screened three times before getting to you. I appreciate your screeners' good judgment in clearing it . . . if they did.


The tremendous problems both you and Ed deal with on an hourly basis probably do not leave much time for small talk so Ed may not have mentioned my interest in filling a vacancy that is soon to occur in the Ninth Circuit. In any event, I have written about it to Ed, Bill Smith, Pete Wilson, Paul Laxalt and Lowell Jensen.

Two things I did not mention (and that's my excuse for writing you) are: First, my elevation would, of course, create a vacancy in my spot giving the President another appointment; and second, I will be eligible for and plan to take senior status in about three and one-half years when I will be 65 and will have completed 15 years of service. I plan, of course, to continue to sit as a judge, as do most senior judges, and will probably carry close to a full caseload. However, taking of senior status creates a vacancy which would give the President yet another appointment to the Ninth Circuit. You can see from this, that I assume that he will run for reelection and know he will be reelected. I have not bothered him with this, but would appreciate any good word you could put in for me at the right place and time.

The President is doing a terrific job! and, of course, that's where the credit goes and belongs. But we all know how much he depends on you for advice and support and we think it's the greatest thing that's ever happened to our country.

Kay joins me in sending you and Carolyn our very best. Our family is thriving, we now have six grandchildren, and I still find my work to be exciting and challenging. We hope all is well with you.

Dear Mr. Deaver:

I am writing to express my deep concerns regarding the issue of acid rain. As you know, this is one of the most complex and divisive issues on the national policy agenda. I understand that the Cabinet Council has been giving careful consideration to this issue over the past few weeks. I hope you share my misgivings with respect to the scientific basis of the major proposals to reduce acidic deposition in the Northeast by reducing emissions of sulphur dioxide from coal-fired powerplants in the Midwest and Appalachia.

The scientific uncertainty on these issues raises questions about the effectiveness of any acid rain control proposal that requires multimillion ton reductions in sulphur dioxide. The economic costs to such regions as the Midwest and Appalachia are likely to be high, and the environmental benefits to the Northeast are at least uncertain.

There are hundreds of communities in the Midwestern and Appalachian states which depend upon coal mining. For example, in my state of West Virginia, coal mining is a crucial part of the economy. If an acid rain control proposal were implemented, such as the one reported by the Senate Environment Committee, much of the coal produced in the high-sulphur coal-producing counties in Northern West Virginia would be rendered unmarketable. Thousands of coal mining jobs would be lost as a result, and the economies of the coal mining communities in those counties would be devastated. According to a recent study by the Congressional Research Service, a number of other states, such as Indiana, Illinois, Pennsylvania, and Ohio, could experience similar, or even greater, economic devastation. Supporters of stringent acid rain control proposals have simply failed to take such economic and employment consequences into account.



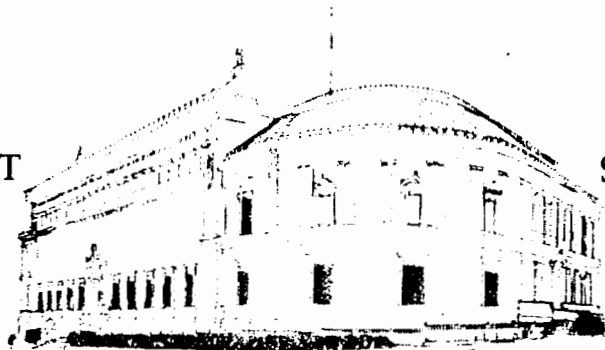


On behalf of the President, I want to thank you for inviting him to address the conference of the American Institute of Aeronautics and Astronautics on February 1-3, 1984.
