Dear Mr. McEntire:

Thank you for your recent letters furnishing information on the fencing of Government land by the United States Corps of Engineers at Lewisville Lake.

Fencing of public lands around Corps reservoirs is a difficult issue. It is my understanding that the Corps uses fencing as a resource management tool, not as a device to preclude public use of reservoir areas. In addition to marking boundaries, fences are used to control unauthorized vehicular access, trash dumping, and livestock trespass that is detrimental to public lands. On the other hand, fences also create problems such as those you cited.

Because of these problems, the Corps has been instructed to review the cost effectiveness of fencing compared with other means of resource management for all projects, including Lewisville Lake. I have been informed that the review will insure that future installation of fencing will occur only where there is an offsetting cost saving or where there is an obvious necessity, such as the safety of project employees or visitors.

I hope this letter has been helpful in explaining the Federal government's position.

Dear Mr. Deaver:

Last night I was introduced by telephone to Mrs. Deaver by our mutual friend, Janet Snider. Pursuant to our phone conversation, enclosed please find copies of:

- aerial map of Lake Lewisville;
- Dallas Morning News article of February 13th.;
- envelope with photographs of recently fenced Wynnwood Haven and of our area, Fiddler's Green, where fencing is planned to be done soon;
- resume of recent telephone conversation with Corps of Engineers;
- 1976-77 correspondence pertaining to this problem;
- 1981 correspondence in the same regard;
- letter to President Reagan of February 14th. with attachments.

This information outlines our problem. Following are related comments:

- The Federal Government owns all shoreland and 3/5 of all back-up land at Lewisville Lake. Balance of back-up land owned individually and mostly developed with residences.
- When lake level fluctuates lines of debris are left (logs, bottles, cans, etc.). This must be removed or mowing is impossible. Pick-up trucks are necessary to handle the amount of debris deposited.
- Much of Lake Lewisville is served only by community volunteer fire departments. An effective team cannot readily be sent out. Last week a neighbor had approximately 170 acres burned before the Frisco Fire Department could reach him. If we are prevented (by fencing) from keeping government shoreland cleaned and mowed weeds will be shoulder high in one growing season. In a dry season these burn like gunpowder. Our homes around the lake would be in danger.
- Unfortunately our history of dealing with the Corps of Engineers has been disappointing. The Corps makes assurances (especially when people are stirred up as they are now), then as we are "lulled" we find the Corps has a change of policy and old assurances are gone. Presently the Corps says we will be allowed to mow, but we anticipate that mowing permits may be hard to get at some point in the future. An example of change of direction: Please note (in light of the present fencing) the letter to me from Congressman Collins, dated February 22, 1977.
- I understand that some persons on committees funding the Corps have been convinced that government lake areas should not be mowed

In that event, I would strongly recommend Belden Bell for appointment as Ambassador to Fiji.

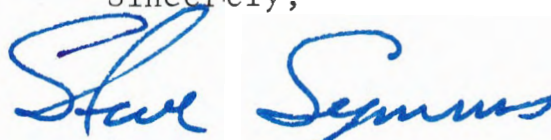

Dear Mike:

This is to follow up a previous letter, dated February 27th, inviting President Reagan to write an article on the Presidency for a special symposium issue on the Bicentennial of the Constitution for National Forum, the Phi Kappa Phi Journal.

Enclosed is an outline listing the titles and authors for this symposium issue, followed by a more detailed description which suggests basic ideas for each topic. The seventeen authors listed have all agreed to contribute, including Chief Justice Burger, who is writing the article on the Judiciary, and Speaker O'Neill, who is writing the article on the Congress.

National Forum has received sufficient foundation money to permit them to print at least an extra 50,000 copies. These will be distributed both to the leadership of major significant organizations to encourage them to initiate their own bicentennial projects and to organizations that are already undertaking bicentennial projects. This symposium issue may well be the most referenced work during the celebration of the Bicentennial of the Constitution over the coming six-year period.

We hope that President Reagan will feel it is useful to present his ideas on the historic and emerging role of the Presidency in this special issue.

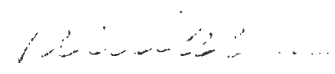

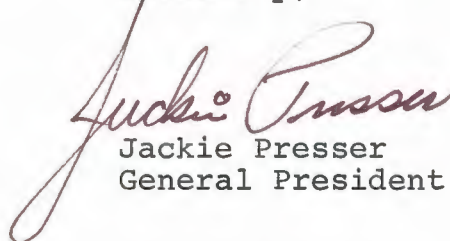
Dear Mike:

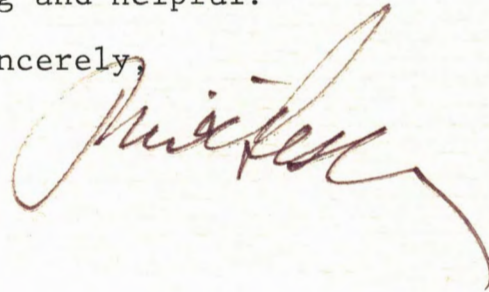

Getting institutions back in working order is the next logical step. It's time to fine-tune the machinery that has made our country a leader in the past but is threatening to break down under the burden of non-productivity.

Dr. Woodrow Sears suggests ways to avert that breakdown in his new book, Back In Working Order: How American Institutions Can Win The Productivity Battle.

He chronicles the demise of the work ethic and unravels the connection between a series of productivity-killing social programs and the economic embarrassment of the early '80s. He explains some of the invalid premises on which the philosophy and practice of management in North America have been based and shows why problems in the workplace can't be solved.

Most importantly, the California author outlines 20 action steps to provide a coherent framework and sharpened perspective for management both in the public and private sectors including:

- * Developing a constructive partnership between government and industry for strategic planning (rather than the more accepted legislated industrial policy that Dr. Sears believes will lead to further economic decline).
- * Providing tax-free status for all individual performance improvement awards.
- * Experimenting with job elimination systems.

His observations and recommendations may not be popular but they will stimulate fresh thinking on the word "productivity," and can help institutions get back on track.
