Dear Mrs. Whittlesey:

Please accept my personal thanks and those of my associates for your kind letter of July 20, which indeed clarified a situation which would have been far clearer to begin with, if a certain group would less presumptuously have presented itself as "Evangelical Protestant" rather than "American "Coalition for Traditional Values.

I also wish to assure you that my asking your office for the names of the people who attended that July 9 White House briefing -- and engaging even the services of some senators and congressmen in trying to obtain them -- was exclusively prompted by my sincere desire -- as a concerned citizen with contacts all over the country -- to help President Reagan gain "the Catholic vote" in the upcoming election.

That your office did not honor this request of mine is a decision which I fully respect and accept, as you undoubtedly must have good reasons for it. Bear with me, however, if I add the following remarks and explanation.

Brother Swaggart Visits President to Discuss New Bill on Voluntary Prayer in School

A personal invitation to visit the White House and review the wording of the new amendment on voluntary prayer in school with the President of the United States and several other religious leaders might have made some people nervous and/or excited. But for Evangelist Jimmy Swaggart, "responsibility" was the key word that described his feelings.

"I was tremendously impressed by President Reagan and his dedication to Godly principles," said Brother Swaggart. "I have always been amazed at the governmental process of the people, for the people, and by the people. It is a Godly concept — unique in the history of mankind. Under God, it is what has made this nation great. If we lose it, we will lose our greatness."

The issue of getting prayer back into the public school systems is one that has been a burden on the hearts and minds of Christians since the late sixties. It was in that era that atheist Madelyn Murray O'Hair used her own son to help abolish prayer in public schools.

has unleashed a storm of controversy nationwide with his continuing assault on "religious minorities."

Now, critics from coast to coast are demanding that his show be given the ax.

In recent months alone, Swaggert has:

- All but said that Jews were gassed, tortured and starved to death in Nazi concentration camps because they didn't believe in Jesus Christ.
- Charged that Mother Teresa's selfless work among the dirt-poor millions of Calcutta, India, "doesn't add one thing toward her salvation."
- Persistently criticized Roman Catholicism as if it's somehow "less Christian" than Protestantism.

"I'm a Christian and I'm put off by his radical, ridiculous remarks," declares Jerry Walsh, who, as general manager of WLVI-TV in Boston, cancelled Swaggert's show after hearing his commentary on the Holocallst

"Swaggert goes way too far," he alleges, "and we don't want to be a part of that."

Swaggert's show has also been cancelled by WANX in Atlanta, Georgia. Herman he preaches Ramsey, general manager of the station, says Swaggert's attacks on other creeds "got to the point where we were required to give those groups

equal time on the air.'

WAGA, the CBS affiliate in Atlanta, axed Swaggert's show for similar reasons and because the evangelist was soliciting contributions on the air in violation of station policy.

"A lot of viewers were finding his statements very offensive," explains station manager Mark Doyle.

Bishon Stanley Ott, of the

"There is general concern among my fellow bishops, and if the onslaught continues we plan to take more definitive steps.

Shirley Cook, a spokesman for Swaggert, told GLOBE that the evangelist was "not interested" in commenting on the charges against him.

Theodore Freedman, of the Jewish Anti-Defamation League, says Swaggert's statements stem from his "narrow" interpretation of the Bible.

"It's difficult if not impossible for someone with such a regimented view to change his opinion," he explains. "We merely hope that in the future he'll try to be a little more responsive to the feelings and beliefs of others.

"In the final analysis, it's unlikely that God is going to be interested in whether a person is Protestant, Catholic, Buddhist, Jew or Hindu," he adds, "but in that person's character and what he did with his life.

"If only Swaggert understood that we'd all be better

Ironically, her son has since become a born-again Christian and is working to "undo" his mother's actions.

"Endeavoring to get a bill of this nature before
Congress is extremely difficult," said Brother
Swaggart. "Anytime Congress strikes down
something the Supreme Court has already set
in motion as law, a tremendously complicated process develops. Consequently, unless the lobbying group
concerned is serious about their
project, it will never come to fruition.
However, we believe with the President's strong
support and the tremendous feelings among all
Christians, the possibility of this bill being made law
is very strong."

Literally all of the well-known ministers of the Gospel who attended the meeting at the White House were in agreement with the wording of the new prayer bill. However, irregardless of whether the bill is passed, Brother Swaggart believes that the problems within the public school systems are so intense they'll not go away.

"Basically the only real good this amendment will do, which is of course tremendously important," said Brother Swaggart, "is this: Our nation was founded on the principles of Godliness. Time magazine stated sometime ago that the Bible is really the constitution of the United States. I concur with that. 'In God We Trust' is still the greatest motto of this land. The children in our schools must know beyond a shadow of a doubt that the government of the United States of America is based on the Judeo-Christian concept. The simple act of a teacher leading in voluntary prayer will help reinforce this belief."

Dear David:

Last Friday I met with Jim Larocca, Commissioner of Transportation for the State of New York, and his staff to discuss the Westway project and the State of New York's plan to mitigate the impact of this project on the striped bass.

The draft Environmental Impact Statement of the Corps of Engineers to which the Regional Administrator of EPA was responding stated that the landfill for Westway would have a "significant adverse impact" on the striped bass population. Once this statement was made, EPA's Regional Administrator in New York had no choice but to object to the permit for that landfill. The pertinent EPA regulations, set out at 40 CFR 230.10(c), forbid any permit that would result in "significant degradation" of waters of the United States. The regulations specify, as primary factors in determining "significant degradation", "significantly adverse impacts" on fish, fish habitat, and ecosystem productivity.

EPA comments on the draft Environmental Impact Statement represent the Regional Administrator's best evaluation of the record presented to him at that time. However, the process provides for new information and further study and for reconsideration of these views.

I have instructed those dealing with this issue at my Agency to work with the Corps of Engineers, Fish and Wildlife Service and all other agencies to see if a mitigation plan can be devised that is acceptable to all concerned.

In closing, David, I certainly agree with you that thirteen years is too long a time to have such an important project subjected to uncertainty and a decision must be reached.

Dear Bill:

I am writing to convey my disappointment at the decision of EPA's regional administrator to again oppose the plans for the Westway park and highway complex. As you know, this ambitious and creative design to develop the lower west side of Manhattan has been snarled in bureaucracy and legal delays for more years than one would care to admit. It has been backed by the past three Presidents of the United States, the past four Governors of New York State and every Mayor of New York City It has bi-partisan support in the U. S. since John Lindsay. Congress. It has been endorsed by all three of New York's major daily newspapers, and has had enthusiastic business and labor support since it was first proposed. This project has great promise to do much more than just build a highway. creates some 80 acres of parkland in an area of town notoriously barren of parks at present, surely a laudable environmental goal. It provides new housing and commercial opportunities. Above all, it retrieves a magnificent river frontage which has not been accessible to New Yorkers for generations.

However, rosy as this picture may be, the project is not without its detractors. In particular, the active and personal opposition of lower level bureaucrats in the Federal agencies again makes this promise a hollow one for most of us in New York. Once again, this project is in danger of being derailed. As a result, it is also in danger of being used for political football. There are indications that Governor Cuomo plans to use Westway as an issue on which to attack President Reagan for failing to follow through on an earlier commitment to New York.

Moreover, I am convinced that the State of New York, after some earlier erratic performance, has in the past year and a

half provided a competent and highly professional administration of the project which has not been sufficiently recognized by the Federal agencies, including those of EPA. Accordingly, I feel it might be very useful for you to arrange a meeting directly between your office and that of the Commissioner of Transportation of New York, Mr. Jim Larocca, to review the State's plans to mitigate the impact of this project on the striped bass. I am sure you will find this plan quite impressive, as it proposes to dedicate some 200 acres of river bottom to this purpose. I will be interested to hear your reaction.

Again, I do appreciate your efforts to keep my office informed of on-going developments. I plan to be in Maine during most of August, but I have asked my assistant, Chris Kennan, to stay in touch with Ernie Minor of your staff, and to keep me posted on any new events.

Dear Mr. President:

Recently, a delegation from my union, the International Brotherhood of Teamsters, had an opportunity to visit the Republic of China on Taiwan at the invitation of the Chinese Federation of Labor. If I may, let me take this opportunity to share with you the impressions which my delegation brought back from Taiwan.

First of all, however, I should tell you that, while I recognize the need for pragmatism and flexibility in foreign policy, I have been disappointed and frustrated at the treatment of Taiwan by the last four Administrations. Nothing in my delegation's report lessens that disappointment and frustration.

The blessings of life, liberty and the pursuit of happiness, so absent from the Chinese Mainland, are alive and well in Taiwan. The island's economic miracle continues, political liberties have been broadened, the morale of the people is still very high and the emotional ties between the R.O.C. and the U.S., despite our shabby policies, remain strong.

Mr. President, I share these thoughts with you in order to urge you to rethink your Taiwan policy and to provide the people there with the arms necessary for their self-defense. I know that you are a long-standing friend of Taiwan and the things for which it stands. But I fear that your will may be weakened by some in the U.S. who would counsel expediency over loyalty and politics over principle.

For the sale of defensive arms to Taiwan is a matter of principle and loyalty. It is also a matter, I believe, of self-interest. The Teamster representatives, while they were in the Far East, also met with trade union leaders from South Korea, Japan and Singapore who all agreed that the gravest threat to freedom and prosperity in the region was an expansionist Communist China. They expressed concern over the drift of American policy and our seeming lack of will to support our friends in Asia.

The 1982 joint communique, which calls for a gradual reduction in arm sales to Taiwan, was a mistake and possibly violated the Taiwan Relations Act. The ambiguity of that communique does not relieve us of the moral responsibility to ensure that our loyal friends on Taiwan, who far from ever betraying our trust sent their sons to fight along side ours in South Vietnam, do not fall victim to Communist aggression.

Therefore, Mr. President, I respectfully request that you authorize the sale to Taiwan of the arms necessary to deter such aggression, including F-16 fighters and Harpoon anti-ship missiles. Such a sale would not only demonstrate America's will, but, just as important, America's loyalty to true friends and allies.

Thank you for your time and your consideration in this matter.

No reporters or network technicians were present, but the joke was heard and recorded at the White House press center in Santa Barbara, where journalists normally monitor the broadcasts.

The two networks that recorded the joke, CBS and Cable News Network, said they agreed that it was off the record under an agreement they had with the White House and did not air it Saturday. Two years ago, while similarly testing his voice, Reagan referred to leaders of Poland's government as "a bunch of bums." The off-the-record agreement was reached after that. In that incident, as in Saturday's, a government employee apparently left open the microphone inadvertently and the networks heard the president's words before the start of his broadcast.

Since news accounts of the joke were first reported Sunday evening, there has been a storm of criticism abroad and from critics in the United States

Aide: Dull Cabinet makes chief doze

LOS ANGELES, Calif. — (UPI) — A top White House official acknowledged Monday that President Reagan sometimes dozes off during Cabinet meetings but said it has "more to do with what's going on in the meeting than what time of day it is."

The comment was made in an interview by Michael Deaver with NBC's Chris Wallace in connection with a televised profiled on Reagan.

Wallace observed that "even when he's working, some officials have described a disengaged presider" who "just accepts staff recommendations" and sleeps during meetings between 1 p.m. and 3 p.m.

"Just as he did with the pope, Mr. Reagan sometimes dozes off in meetings," Wallace said. "Yes," Deaver replied. "These meetings are sometimes boring, and I doze off, too. I've seen him have difficulty staying awake, but he wasn't the only one in the room that does. I think it has more to do with

When asked about the interview Monday, Deaver asked a reporter: "Have you ever sat through one of those Cabinet meetings?"
