SUBJECT:

Helicopters

Lieutenant Colonel Paul S. Johnston, Commanding Officer of the Marine Corps unit furnishing our helicopter support, has forwarded a proposal (TAB A) to reinstate the VH-lN helicopters which were removed from the White House mission in 1977.

There is a definite need for the VH-lN in the mission to provide the flexibility and security now lacking. Colonel Johnston amply details these and cites instances of recent acknowledgment of that fact by the Carter Administration -- prior protestations notwithstanding.

I concur with this proposal and recommend that you approve. You should be aware, however, that there may be some press interest in this action because of the fanfare which accompanied the "cut back" four years ago (TAB B).





The lights for the cabin are controlled by a switch on the top of the right forward cabinet.



Evacuation

There is little likelihood we will encounter a situation requiring emergency preparation, however it is beneficial to become acquainted with the safety features on this aircraft. If emergency evacuation becomes necessary, please remain calm; follow instructions from the crew member. Exits are shown at left.

In the event both main doors become jammed, use emergency window exits. This may be accomplished by removing the plastic cover, turning the handle, and pushing outward on the window.

The cabin is equipped with life preservers which are located under each of the two-man seats. Also provided for your safety, an oxygen bottle, first aid kit, and fire extinguisher have been placed under the front two-man seat.



Around The Cabin

The helicopter provides seating for eight (8) passengers. The unique interior cabin design incorporates several conveniences that make the flight more comfortable and enjoyable. Design features include a quiet interior, special communication equipment, two (2) executive type seats, and refreshment bars. To add to passenger comfort, the cabin has draw curtains located at the front and on either side. The umbrella behind the curtain is for use during inclement weather. The sliding windows behind the forward two-man seat may be closed for additional cabin privacy.



The VH-1N is manufactured by Bell Helicopter Textron, and is derived from the 212 series.


This aircraft cruises at speeds up to 130 miles per hour, and can travel as far as 300 miles without refueling, depending on the number of passengers carried.

The two (2) main rotor blades make about 324 revolutions per minute. A nine (9) foot diameter Two Pratt Whitney T400 CP401 gas turbine turboshaft engines drive the 48 foot diameter main rotor. tail rotor provides directional control. The aircraft is 57 feet, 0.7 inches long, and 13 feet, 1.0 inches high; maximum gross weight is 10,500 pounds (4,763 kilograms).

The executive transport helicopters serving the needs of the United States are operated by Marine Helicopter Squadron One (HMX-1), headquartered at Quantico, Virginia, and the U. S. Army Executive Flight Detachment based at Fort or any other assistance desired, please do not hesitate to contact a member of the crew.






MOTRAC Radio Operation

- C. The upper half green shaded area indicates lighted portion of selector is on standby.



The radio is ready to transmit over the air on "CHARLIE" channel. The lighted portion on "SIERRA" indicates the channel is on standby.




"BRAVO"

THE WHITE HOUSE Helicopter

The President announced today that he intends to cut back on the White House helicopter fleet by 38% in order to save the taxpayers an estimated \$2 million per year. To achieve this savings, the President is eliminating five of the aircraft from the present White House fleet of thirteen. The aircraft are to be returned to the Defense Department inventory. The helicopters designated for transfer to DOD are all five of the six-passenger VH-li models that are assigned to the White House. The President will retain all eight of the larger VH-3s, the familiar aircraft seen landing and taking off from the south lawn.

The total cost of operations, maintenance and salaries for the five aircraft that are being returned to DOD is \$4,324,000 per year. This money now comes out of the DOD budget.

All of this money will obviously not be a savings because some maintenance and operations expenses will be incurred when these helicopters are re-deployed by DOD.

However, all aircraft on presidential duty undergo much more rigorous maintenance routines, usually in terms of more frequent replacement of parts, to guarantee a greater-than-normal margin of safety.

It would be impossible to compute exactly the savings to DOD by having the helicopters removed from White House service. However, the White House staff estimates a savings of 50% in the annual outlay of \$4,084,000 in operations and maintenance costs -- exclusive of salaries for the 20 people who work on the VH-lNs while in White House service.


Air Force One Lounge Area

Over the years the White House Military Office has coordinated the annual placement of Presidential wreaths at the burial sites/ memorials of former Presidents (and Benjamin Franklin) to commemorate the anniversary of their births. There are certain other memorials, shrines, and holidays for which Presidential wreaths are placed.

President Johnson formalized this wreath policy in August 1966 by establishing "The President's Approved Wreath List".

We have arrangements through the Department of Defense to have military representatives place the wreaths. For intown ceremonies, fresh flowers are used; for out-of-town sites, artificial wreaths are prepared and mailed by the White House Florist.

Attached for your information is "The President's Approved Wreath List". We will continue this policy unless otherwise instructed.

Duties

Reports of the Presidential Food Service Coordinator (White House Staff Mess). Coordinates valet and food service support for the President in the White House Oval Office, Cabinet Room and other spaces utilized by the President in the White House (other than food service in the residence), at Camp David and other trips away from the White House. Travels in advance of the President and/or provides other Presidential Support personnel to accomplish this function.

Responsible for the day to day supervision of Presidential valets in the residence and Presidential Office watch standers.

Personal

Eddie is 53 years of age, wife Andrelina and 3 children. He entered naval service in January 1946 and retired in June 1971 as a Master Chief Petty Officer. Entered Federal Civil Service in June 1971 as Assistant Presidential Food Service Coordinator.
