Dear Mike:

Further regarding our recent telephone conversation, on Wednesday, July 7, 1982, Vice President Bush will be speaking in San Francisco at a luncheon before the delegates to the 26th Biennial Clergy/Laity Congress of the Greek Orthodox Church.

The luncheon will be held at the St. Francis Hotel. The Congress extends over several days although Vice President Bush's appearance at the luncheon is the only participation which he will have in the events scheduled. The Congress attracts delegates of the Greek Orthodox faith from all over the United States and dioceses extending as far north as Canada and into South America.

The Vice President's visit happens to coincide with United States Postal Service Board of Governors meetings which will be held in San Francisco on Tuesday, July 6th and Wednesday, July 7th. On Wednesday, July 7th there is a public Board of Governors meeting after a closed session on the preceding day.

On Wednesday, the Board of Governors meetings last from 8:00 until 12:00 in the day and if it could be arranged for the Vice President to have a brief meeting with the Postmaster General and perhaps the Chairman and one or two other members of the board, this could be coincided with attendance of the Postmaster and selected board members at the St. Francis luncheon address of the Vice President.

I assume that the Vice President is arriving the very day of his address which would rule out Tuesday and since the Governors' meeting is in the morning of Wednesday, July 7, perhaps a brief meeting after the Vice President's address could be arranged on Wednesday.

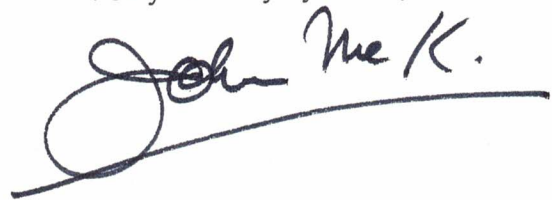
My impression is that the administration should take more credit for the postal surplus which is now in the neighborhood of \$600 million for this current fiscal year. It is a highly labor-intensive organization and the inflation rate having declined so rapidly has

caused certain cost of living increases that otherwise would have gone into effect to be unnecessary and this has affected expenses favorably. Basically, just giving the postal officials a bit of encouragement for an accomplishment would, if at all possible, seem to be worthwhile.

I leave it in your good hands as to whether or not this can be worked out. As things go forward I will keep you and Ed apprised of developments in the Postal Service of a fiscal nature. The postal staff people I speak to seem genuinely eager to operate the service as a business, but that requires board members who have a business orientation about which more later.

Dear Mrs. Mellon:

At the request of William F. Sittman, Special Assistant to the President, we are happy to respond to your letter of June 22, 1982 to the First Lady, Nancy Reagan regarding Antigua.

As you may know the Agency for International Development is playing an active role in the provision of development assistance in the Eastern Caribbean, including Antigua. The assistance is channeled through our field office, the Regional Development Office/Caribbean, located in Bridgetown, Barbados and in turn to Caribbean regional organizations which are involved in development activities. AID-financed regional projects are underway in health, nutrition, family planning, agriculture, education, and energy which respond to the basic human needs of the island populations. Several U.S. private voluntary organizations including Project Hope, the National Council for International Health, Meals for Millions and the International Eye Foundation receive AID funds enabling them to carry out projects in health and nutrition in the Eastern Caribbean.

Due to limited U.S. Government resources assigned by Congress to AID for international health programs priorities of course must be set for the health sector. A.I.D.'s strategy in health is to provide low cost basic services--focusing on preventive health care--for those most in need, in rural areas. To that end, A.I.D.'s funding has focused on manpower development, communicable disease control and nutrition. The construction of secondary and tertiary care centers, namely hospitals, falls outside of our mandate.

With particular reference to your concern about the quality of care provided in hospitals in the Eastern Caribbean, A.I.D. is funding a new project for maintenance of medical and laboratory equipment in the islands. This project is implemented by the U.S. National Institutes of Health. Also, within the U.S. private sector there is interest in providing support to Caribbean hospitals. If you desire specific information on the health projects funded by A.I.D. in the Caribbean we suggest that you contact our Regional Public Health Advisor Mark Laskin, c/o Agency for International Development, Box 302 Bridgetown, Barbados.

We hope that the information provided above may give you a better idea of how U.S. support in health is provided to the Eastern Caribbean.

It was a delight talking to you on the telephone today; you sounded as peppy and alert as ever !

As we discussed, I am enclosing a copy of my curriculum vitae which was written up over a year ago for some Brazilian concern.

Since Amy invaded the Rose Garden and State banquets, I have become an ardent Republican like my father. In fact, since late 1979 I have been very active as a member of the Executive Committee of Republicans Abroad (France) raising funds for the cause. I was particularly involved in selling a number of tables for the Inaugural Ball at the Conciergerie in Paris.

I am now helping the Chairman of our Committee and other members to get out the vote for Americans in France -- showing them how to register etc. During the past year I was a prime mover in assisting the Chairman to arrange breakfast, lunch, dinner and cocktail meetings with leading Republicans visiting France.

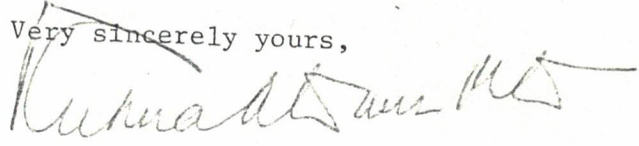
