I have been meaning to write this letter for weeks and I have been traveling constantly, it seems. I hope this attempt will succeed.

Dave Berkeley and I had lunch last week and He sent over his ideas for a "bottle" shop. His idea, of course, is to have more than just an off-sale liquor store. He would like it to be more of a mini-deli with cheeses, pate' and the like, much like Walkers was (before they went bankrupt). I think he has alot of good ideas and with proper management it could be very successful. He has of course, with your considerable help, achieved a degree of notoriety and this could be a great promotional tool, particularily with your continued support. He felt that it would be difficult to operate in competition with Corti Bros. in close proximity with them but not nearly as difficult on the fringe of their markets, but still in East Sacramento. We both agreed that location would be thekey to success for a venture like this and we both agreed to keep our eyes open for the "perfect" spot. Maybe you have some ideas, Think !!! I think that it could be a fun project and certainly a profitable one with all three of us involved. I also think it would be interesting if we each set down what we perceive our contribution to a venture like this to be. Let me know your thoughts.

This next subject is a little difficult to go over because it concerns the appointment that you recommend me for. It seems to have gotten lost or something. I will try to bring you up to date. A Sally Christian in the office of Presidential Appointments called me in October and asked me to send a resume' to her as you had recommended me for an appointment. It has been sometime since I had a resume' so I asked her if she wanted it directed in any particular area of my career and she said that the resume' was more a formality as your recommendation was really enough. Well, knowing how busy you usually are I deceided that when I was contacted with an appointment, I would then call and thank you. Well, the call never came and when you called that Sunday in December, I was really embaressed for not having let you know that I had been had contacted. Then, the next day, Sally Christian called again (after you brought it to her attention again, I am sure) and asked me if I would be willing to serve on a Commerce Dept. committee on Lumber & Plywood. I noticed that he had a new picture of the President (with QE II on mount) and commented on it and Fritz laughed and said "That's what I invited you up to see" I am jealous, Good ole Fritz, he is so funny and STILL very impressionable.

Carolyn sent us the picture of all of you Christmas Eve at the White House. It is realy terrific and you all look great. Fritz is getting a travel itch again and wants to go somewhere in April or May. He thinks Mexico City would be fun to take Libby and Griff to but I have a feeling our travel will be severly restricted this year. We did enough traveling last year to suffice for this year also.

I was just thinking about your trip west with the Queen and I called Shirley to see when it was. I know you told me late Feb. or early March but I coulden's remember exactly when. I really hope we will have a chance to see you when you are out, I know you said you would only be in Sacramento briefly but we would of course be delighted to come to San Francisco if there was something or somewhere we could see you.

I guess I have rambled on enough for now. I did want to tell you about my lunch with Dave (I suppose you know he is selling out his interest in Cafe Natoma.) and also about the appointment situitaion and of course to streamously advise you that we would like to see you out West inthe very near future. CHARTER

STATE DEPARTMENT - AMERICAN PRIVATE SECTOR OVERSEAS SECURITY ADVISORY COUNCIL

I. PURPOSE

The State Department - American Private Sector Overseas Security Advisory Council (OSAC) is established to promote coordination between American overseas business and private sector interests and State Department overseas security programs.

II. OBJECTIVES

The primary objectives of the OSAC Council shall be:

- (A) To establish continuing liaison between State
 Department worldwide security functions and American private
 sector overseas business and institutional interests,
 professional security agencies, and law enforcement agencies;
- (B) To establish continuing liason between the Council and professional security services and technology agencies and law enforcement agencies;
- (C) To provide for regular interchange of information between the private sector and the State Department concerning developments in protective security affecting overseas activities and developments in security technology and methods;
- (D) To recommend plans for operational coordination for protective security between State Department and American overseas private sector interests;
- (E) To recommend where appropriate the establishment of or changes in overseas protective security programs, such as the Department of State Threat Analysis Group (TAG) program; and
- (F) To recommend means of coordinating security planning and implementation of security programs which will be consistent with the national security interests of the United States.

III. AUTHORITY

The Council is established under authority of the Secretary of State pursuant to 22 U.S.C. 2656 and in accordance with the Federal Advisory Committee Act as amended. The activities of the Council are determined to be in the public interest and are directly related to overseas security functions of the Department of State.

IV. MEMBERSHIP

- (A) Membership on the Council shall include representatives of American private sector interests with overseas American facilities or personnel or a substantial interest in the field of industrial or protective security or security technology and design. The membership shall also be open to protective security and law enforcement organizations or associations, and state and municipal public agencies involved in security and law enforcement.
- (B) The Council shall generally be composed of not more than thirty members; additional members may be appointed from time to time reflecting specialized concerns of the Panel. The membership shall be balanced, in so far as possible, to represent:
 - (1) Major categories of American overseas business, institutional and other private sector interests, such as manufacturers, energy and minerals resource companies, shipping and transportation companies, agricultural export and equipment companies, and educational, research, religious and philanthropic institutions;
 - (2) Private American institutions or firms with a substantial interest in protective or industrial security, or security technology or design;
 - (3) State and municipal public agencies involved in security and law enforcement; and
 - (4) Security and law enforcement associations representing general or selected memberships composed of one or more of the above categories.
- (C) Members shall be appointed by the Assistant Secretary of State for Administration for periods not less than one (1) year from the following:

- (1) Any American private sector business, institution, association or public agency otherwise qualifying under this Charter, who has requested to be considered for appointment as a member of the Council of a Council subcommittee.
- (2) Private sector business or institutional members recommended by a protective security or law enforcement association upon recommendation by a United States diplomatic or consular post abroad, or upon recommendation by the Deputy Assistant Secretary of State for Security.
- (D) Federal agency participants shall be appointed by the Assistant Secretary and shall include representatives of the Department of State, and, as appropriate, representatives of (1) foreign affairs agencies, including the Agency for (1) foreign affairs agencies, including the Agency for International Development, the United States Information Agency, Foreign Commercial Service and the Foreign Agricultural Agency, Foreign Commercial Service and the Foreign Agricultural Service, (2) other agencies with overseas functions, and (3) law enforcement agencies.
- (E) The Council membership shall be reviewed by the Assistant Secretary annually to assure balanced representation.

V. REPRESENTATIVES OF MEMBERS

Council members and participating federal agencies shall each nominate not less than two representatives to the Council, and to any subcommittee of which they are a member, who should and to any subcommittee of which they are a member, who should be senior executives or persons with substantial operational, be senior executives or persons with substantial operational, or managerial experience in the fields of protective or industrial security, as well as overseas assignment or industrial security, as well as overseas assignment experience where relevant. Representatives shall be subject to experience where relevant. Representatives shall be subject to approval by the Deputy Assistant Secretary for Security, approval by the Deputy Assistant Secretary for Security, approval such security clearance qualifications as shall be deemed appropriate.

Members or agencies nominating representatives shall be presumed to have made a commitment to assure adequate time and resources in order for their representatives to participate fully in the work of the Council.

VI. ORGANIZATION

- (A) The Advisory Council:
 - (1) The Council Chairman shall be the Deputy Assistant Secretary of State for Security. In the absence of

the Chairman, the Assistant Secretary shall act in lieu thereof or shall appoint an alternate who shall be a federal official of a rank equivalent to that of the Chairman.

- (2) The Council shall have Vice-Chairmen, appointed by the Chairman from among the general members, representing major groups of American overseas private sector interests, and, in so far as appropriate, overseas geographic regions corresponding to the Department of State geographic Bureaus. The Chairman shall also appoint alternates for vice-chairmen as shall be necessary.
- (3) The Executive Secretary of the Council shall be appointed by the Chairman. The Office of Security shall provide support facilities and staff for the Council and for any subcommittee directly or, as appropriate, through its field offices at American posts abroad.
- (B) Specialized and Regional Subcommittees:
 - (1) The Council Chairman may from time to time approve the establishment of specialized or regional subcommittees from among the Council's members. Subcommittee Chairmen and Vice Chairmen shall be appointed by the Council Chairman.
 - (2) Specialized subcommittees may include a Security Technology and Design Subcommittee, which shall be composed of members and representatives with demonstrated specialization in fields of security technology, security design, construction, or delivery of security services.
 - (3) Regional subcommittees may include members with facilities and personnel in, or demonstrated interest in regional areas corresponding to geographic bureaus of the State Department.
 - (4) The Executive Secretary for each subcommittee shall be appointed by the Council Chairman.

VII. OPERATIONS

(A) The functions of the Council or subcommittees thereof will be solely advisory, and final determinations for actions to be taken by any agency of the federal government as a result

of any work or deliberations of the Council or any subcommittee will be made by appropriate Government officials.

- (1) Meetings of the Council shall be held at the call (B) of the Chairman, not less than twice annually, in Washington, D.C., unless an alternative location is approved by the Chairman. Subcommittees shall meet at the call of the respective Chairmen at least twice annually, at such locations as shall be approved by the Council Chairman. Regional subcommittee meetings, if held overseas, shall also be coordinated with the appropriate United States diplomatic post.
 - (2) All Council and subcommitte meetings shall be held in accordance with an agen a approved in advance by the Council Chairman, and sh ll be held in the presence of a federal official uly authorized to call to order and to adjourn any mee ing whenever considered to be in the public nterest. Subject to the foregoing, the actual atten ance at a meeting shall represent a quorum, and r commendations, plans and procedures shall be approve by consensus together with notation of alternative vi ws.

(3) Special invitees may attend meetings representing particular regional, operations, or technical expertise at the request of the appropriate chairmen, subject to prior approval of the Council Chairman and such security clearance qualifications as shall be required.

(1) The Council will report thi agh the Chairman to (C) the Assistant Secretary of Stat for Administration; regional and specialized subcon ittees will report to the Council through their respective Chairmen. The Council and all subcommittees v. 11 submit semi-annually, and at such othe appropriate, proposed plans and gendas for each succeeding semi-annual period.

VIII. RECORDS

- (A) The records of the Council will consist of all papers and documents pertinent to its establishment and activities, including its charter; agenda; minutes and documents related to its proceedings; communications related to its work and membership; and materials and reports considered or issued.
- (B) The Executive Secretary of the Council and each Subcommittee will prepare the minutes of each meeting, which shall as a minimum contain a record of the persons present including staff and agency employees; a description of the extent of public participation and the interests or affiliations they represented; a summary of matters discussed and conclusions reached, including rationale for recommendations made; and copies of reports received, issued or approved by the Council. The Chairman of each meeting shall certify the accuracy of the minutes.
- (C) The minutes for any portion of a meeting closed to the public shall include all that is required for an open meeting except those items relating to the presence of the public. Nothing in this Charter shall be construed as a waiver of security classification or the right of controlled distribution or exclusion from disclosure as otherwise authorized by law or regulation.

IX. PUBLIC ACCESS

(A) All meetings of the Council and each subcommittee will be open to the public, unless a determination has been made in accordance with applicable regulations that the meeting or a portion thereof should be closed to the public. Timely notice of each meeting, whether open or closed, shall be published in the Federal Register stating the time, place, and purpose of the meeting, whether the meeting is open or closed to the public, the reason for closing if a closed meeting, and the name, address, and telephone number of designated Government employees that members of the public may contact for further information. Except in emergency situations, such notice shall be published at least 15 days in advance of the meeting day. If shorter notice is given, the reason therefore will be stated in the notice.

X. RELATIONSHIP WITH OTHER BODIES

The Council will, as appropriate, maintain liaison with other federally sponsored organizations having related security interests, if requested to do so by the Assistant Secretary.

XI. FUNDING

- (A) All funding necessary for the organization and operation of the Council will be charged to the Salaries and Expenses Allotment of the Deputy Assistant Secretary for Security, or from such funds as shall otherwise be made available to that office for that purpose.
- (B) Representatives to the Council or to a subcommittee will serve at the expense of their respective organizations. Persons representing public agencies may, in accordance with applicable law and regulations, be allowed transportation and per diem if so authorized in advance by the Department of State.
- (C) The annual estimated operating cost to the Government of the Council and constituent subcommittees is \$250,000 and approximately 2 person years. It is estimated that the Council and each subcommittee established will hold not less than two meetings per fiscal year.

XII. TERMINATION

In accordance with the Federal Advisory Committee Act, as amended (Public Law 92-463), the Council will terminate two years from the date this Charter is filed unless it is formally determined to be in the public interest to continue for another two years.

NOW, THEREFORE, this Charter shall be considered filed as of the date copies have been provided to the Foreign Relations Committee of the Senate and the Foreign Affairs Committee of the House of Representatives, and to the Library of Congress.
