
Your credentials are impressive, however, there is nothing available on the White House staff at this time. There may be something later on.


Dear Mike:

Dear Mike:

About a month ago I submitted to Presidential Personnel a resume of Judge Perry J. Shertz for appointment to the present vacancy on the United States Third Circuit Court of Appeals. Perry is a member of the Pennsylvania Superior Court, our Intermediate Appellate Court. He has been a lifelong Republican and early supporter in the campaign, and a lifelong friend of my family.

Last month Perry and I met with Drew Lewis. Furthermore, Perry and I had made contacts with Senators, Heinz, Spector, Bradley, and Roth, as well as Al Angrisani, in Ray Donovan's absence.

Judge Shertz is not only eminently qualified, but his credentials are consistent with the philosophy of the administration. Particularly his position on abortion has been well known for many years.

The vacancy that exists was created by the elevation to senior status of Judge Max Roseen, a former law partner of Perry's and the only member of the Court from the Middle District of Pennsylvania.

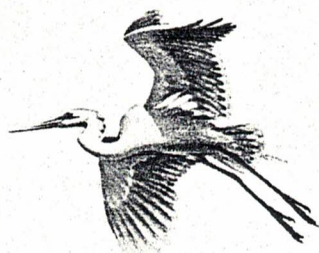



Dear Mr. Deaver:

We believe the following materials may be of interest to you regarding the confirmation hearings of Mr. Richard Perle as Assistant Secretary of Defense for International Security Policy. The material contains information concerning allegations that Stephen Bryen, presently a consultant for Mr. Perle at the Department of Defense, may have violated U.S. espionage laws by offering sensitive documents to Israeli government officials in the spring of 1978.

We believe this information is important. We do not question Mr. Perle's technical proficiency. Rather, we have sincere concerns about his judgement and motivation in appointing to a sensitive position a man about whom there are unanswered questions related to alleged violations of U.S. espionage laws.

We hope that by bringing this matter to your attention you will be able to satisfy your concerns that the Senate Armed Services Committee will not confirm to a sensitive position a man who has displayed staffing preferences which may pose a security risk to the United States; a situation which would certainly have profound negative effects on the ability of the United States government to determine and conduct foreign policy.

NAAA has had specific interests in Mr. Bryen's case because it was an NAAA employee who overheard Mr. Bryen's conversation in which he offered classified documents to representatives of a foreign government. The employee filed an affidavit with the F.B.I. and subjected himself to a polygraph test in this regard. Mr. Bryen, however, refused to take a polygraph test. Subsequently the F.B.I. conducted an extensive investigation of this matter and collected 600 pages of material which are

presently on file at the Criminal Division of the Justice Department (see enclosed U.S. Department of Justice response). However, the results of this investigation into the alleged espionage violations have never been made known to us. Our Freedom of Information request concerning this investigation is 63rd on the list of projects to be undertaken by the F.O.I. division of the Department of Justice. The Senate Armed Services Committee can obtain a copy of this file by requesting "the 600 page file of the F.B.I. investigation into allegations that Stephen Bryen may have violated U.S. espionage laws" from the U.S. Attorney General at the Department of Justice.
