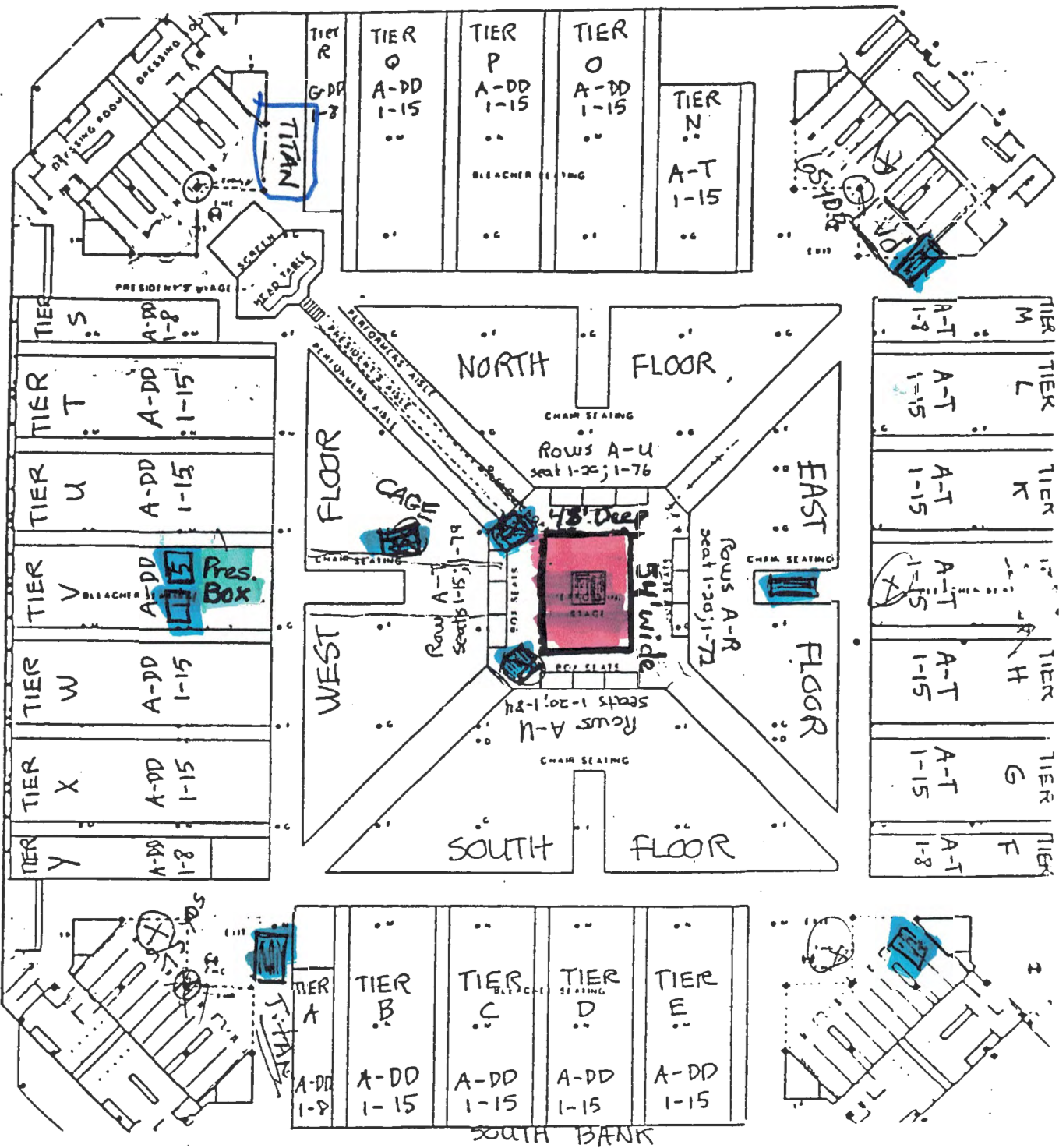

WASHINGTON (AP) — President Reagan's second inaugural celebration will run over four days, highlighted by eight black-tie balls, a national prayer service and a "greater emphasis—on youth and free events," the general chairman said Thursday.

"The inauguration, while by its nature a celebration, will be subdued by some standards in the past," said Michael V. Deaver, the deputy White House chief of staff and general chairman of the presidential inaugural committee.

"With greater emphasis on youth and free events, and less emphasis on black-tie events, we're going to make sure this is an exciting and all-encompassing inaugural — one that reaches more people than ever before," he said.

Inaugural festivities will kick off Friday, Jan. 18 with a free pageant and fireworks display on the Ellipse, and the first of two entertainment galas which are being organized by entertainer Frank Sinatra, who will also perform.

Reagan will be sworn in at a private ceremony at the White House on Sunday, Jan. 22. But the official outdoor inaugural ceremony at the capitol, the big presidential parade down Pennsylvania Avenue and the inaugural balls will take place Monday, Jan. 21.

The Constitution specifies Jan. 20 as the president's swearing-in day, but traditionally the public Inauguration Day has been postponed when Jan. 20 falls on a Sunday. That has only happened five times before, Deaver said.

The private swearing-in by Chief Justice Warren Burger will take place at the White House, following a non-denominational national prayer service at the National Cathedral.

"We're going to encourage churches and synagogues throughout the land to take some time off for this day," he said.

Deaver said the inaugural committee aims to raise at least \$8 million, primarily through the sale of tickets to the two gala events and eight inaugural balls, and advertising revenues from a inaugural television show of the galas to be aired Jan. 19 on ABC-TV.

In the 1981 inaugural, Reagan's committee spent \$15.5 million, more than four times the cost of former President Carter's inaugural. Ronald W. Walker, the committee's chairman, said he hoped the cost of the 1983 event will not exceed the 1981 figure.

The overall cost of the inauguration has not been calculated because the military, Congress and the District of Columbia government contribute some money for the parade and other events.

But Deaver said the committee will not use military personnel to serve as drivers for guests, a practice that has been criticized by Sen. William Proxmire, D-Mich. Military escorts may be given to some people, such as governors.

"I don't see anywhere near the use (of military drivers and escorts) as in the past, and this decision was made independently of Sen. Proxmire," he said.

Reagan, according to Deaver, particularly wanted the inauguration to pay attention to young people, who gave Reagan a large portion of their vote on election day.

As a result, there will be a \$25-a-person inaugural ball for youth, probably between the ages of 18 and 25, a concert for young Americans, and a forum at which invited youth will be able to meet leaders in the nation's capital.

Organizers expect between 50,000 and 60,000 people to pour into Washington for the inauguration.

Tickets and invitations to various events are being handled by state coordinators, and the allocation will be based in part on how big a margin the state gave Reagan in the election, Walker said.

He said, however, that he expected anyone paying \$125 would be able to attend one of the black-tie balls after the inauguration.

Reagan inaugural set Jan. 18-21<

WASHINGTON (UPI) — President Reagan's inauguration — the birth of a new American chief executive — will be held Jan. 21, 1981, capping a four-day extravaganza built on the theme "We The People ... An American Celebration."<

Reagan's inaugural chairmen said Thursday the public swearing-in will take place Jan. 21, not because the constitutionally mandated date of Jan. 20 conflicts with the Super Bowl, but because it falls on a Sunday.<

The president will be sworn in privately at the White House on the official day, and publicly on the steps of the Capitol the following morning. The last time inauguration day fell on Sunday was in 1921 when Dwight Eisenhower followed a similar procedure.<

Michael Deaver and Ronald Walker, the inauguration chairmen, released the schedule for the long weekend, which opens with fireworks Friday, Jan. 18, and ends with nine inaugural balls Jan. 21.<

Deaver said between 50,000 and 100,000 people will flock to Washington to attend the hundreds of inaugural events, most of which are free. Some events, such as the balls with a ticket price of \$100, and two entertainment galas with tickets ranging from \$50 to \$200, will cost pay for the inauguration, which has a price tag of about \$12 million.<

Scores of the president's old Hollywood friends will be featured at the major events, although the only one endorsed so far is Frank Sinatra, who will be chairman for the vice presidential gala Friday night and the presidential gala Saturday night.<

Both galas will be held before an audience of 15,000 people in the Washington Convention Center, and the Saturday night performance will be broadcast on ABC.<

Deaver said the inauguration will be heavy on patriotism with a special emphasis on youth.<

"We want participation to be as broad and wide as the president's victory," he told a news conference. "With greater emphasis on youth and free events, and less emphasis on black-tie events, we're going to make sure this is an exciting ... inaugural one that people of all ages and people than ever before."<

President Reagan's re-election with broad support from Americans of all backgrounds, and this inaugural honors to them, Deaver said.<

Events for young people 18 to 30 years old include a forum for 3,000 people featuring congressional and administration leaders, a concert in the District of Columbia Armory and a separate inaugural ball.<

Reagan's Sunday oath-taking will be "very private" with no press coverage, Deaver said. The White House will hold its own part of the ceremony. Chief Justice Warren Burger will swear in the president and Associate Justice Potter Stewart will administer the oath to Vice President George Bush.<

(11.20.46) at the Fulton Theatre, and more than one critic hailed her as "a young Tallulah Bankhead" (who had created the part of Regina in *Foxes*). "She came backstage to see me," says Neal, "and said, 'Dahling, you were as good as I was — and if I said you were half as good, it would have been a hell of a compliment!'"

Among the cast members were Jean Hagen and Mildred Dunnock. Hagen, who played a tramp named Laurette Sinee, had gone to Northwestern at the same time as Pat, and had become her roommate in New York. "It was just a coincidence that she was in the show." (The late Jean Hagen gained recognition in *Adam's Rib* and *The Asphalt Jungle* — and

was nominated for an Oscar as Lina Lammont in *Singin' in the Rain* — but her talent was largely wasted by Hollywood.) Dunnock played Neal's mother, Lavinia, and became a close friend. She appeared as herself in *The Patricia Neal Story*. Says Pat, "I adore Millie! She's a great woman."

The Tony (Antoinette Perry) Awards, Broadway's equivalent of the Oscars, were first presented in 1947, and Patricia Neal was selected Best Featured Actress. She laughs: "Isn't it good to be there at the beginning? The Awards then were compacts; I still have mine — with P.N. engraved on the outside."

Signed by Warner Brothers ("the best

offer"), Neal didn't journey west until year's end. "The play was not as great a success (182 performances) as everyone had hoped. I spent the summer at Ellitch Gardens in Denver, and among my roles was *Saint Joan*. In the fall, we went on tour with *Another Part of the Forest*." (The 1948 film version cast Ann Blyth in Neal's role.)

She had been gradually lightening her hair and, by the time she reached Hollywood, it was blonde. Warners gave her a big buildup, and, ironically, her debut was in the film version of the play in which she'd almost appeared, *John Loves Mary*. She and Ronald Reagan co-starred in the roles created on stage by Nina Foch and William Prince; and Neal has fond remembrances of "Pah-resident Reagan — my leading man." It was at the time his first marriage — to Jane Wyman — was ending "and he really did not want a divorce, but she wanted one. There was a great New Year's Eve party that we were at, and, just before midnight, he cried and cried." The reviews for the film — and its new female star — were not favorable. Bosley

King Vidor chose Neal to play Dominique Franchon in Ayn Rand's adaptation of her novel, *The Fountainhead*. "I was so flattered," she says. "It was my big break in movies." (However, the picture was not a success.) Cast opposite the 22-year-old actress was 47-year-old Gary Cooper. According to an interview that Vidor gave for Stuart M. Kaminsky's book, *Coop* (1980): "I remember the day we drove up to Fresno to do our location shooting...We met Pat Neal there that night. It was the first time they had met. They went for each other right away. After dinner we never saw the two of them again except when we were shooting." Neal also gave the author an interview, in which she discussed her three-year romance with the famed actor.

While making *The Fountainhead*, Neal and Eleanor Parker played themselves in a brief sequence for *It's A Great Feeling*, a Dennis Morgan-Jack Carson musical comedy which promoted new Warners star Doris Day and used several of the contract players in guest appearances.

Her second picture with Reagan, *The Hasty Heart*, was Neal's first good film. The John Patrick drama had been a success on Broadway with John Lund as Yank (which became Reagan's role), Anne Burr as Sister Margaret (the nurse played on screen by Neal), and Richard Basehart as the terminally ill Scot who learns to love life. (As Lachie, Richard Todd received a Best Actor Oscar nomination, but lost to Broderick Crawford in *All the King's Men*.) During production, she and Reagan "practically went steady. There was nothing romantic between us, but we had neighboring suites, and we'd have meals together. We had a good time. He didn't want anybody else, and I didn't either (because of Cooper). After that film,

Neal's last theatrical film was the 1981 *Ghost Story*, in which she played Fred Astaire's wife. "It was such a *tiny* part! I was trying to call the director to turn it down, but the line was busy. My daughter Ophelia asked what I was doing — and, when I told her, she insisted I *not* turn it down. I knew what she meant. My marriage was not good — and it hasn't been good for years. And I adore working! Fred Astaire was good, and it was great to see dear Melvyn Douglas (in his last role). So, even though the part was nothing, it got me out of the house — and I'm grateful to Ophelia."

On December 8, 1981, CBS-TV presented *The Patricia Neal Story*, starring Glenda Jackson as Pat and Dirk Bogarde as Roald Dahl. Written by Robert Anderson, it was directed by Anthony Page and Anthony Harvey. "I loved Glenda Jackson's performance," says Neal, "but I've never met her. We set up three dates for lunch — but had to break them all. I would really like to meet her."

Today — almost as if fulfilling her original ambition to deliver monologues — she tours the country with an autobiographical lecture, *An Unquiet Life*; she also does commercials for a popular pain pill — and "I'd like a good part in a film." She takes pride in her children: "Lucy is living in my apartment in London, going to cooking school, and working as a waitress. Ophelia does charity work in Haiti. Theo runs an antique store in Great Missenden. And Tessa is married (to James Kelly) and lives in England." Tessa, who appeared with Neal in *Happy Mother's Day, Love, George* (1973), has given up her acting ambitions. "She's not a devoted actress," says Pat, "like I used to be — and still am!"

Leaving the Plaza, the star leans heavily

on this writer's arm. "I had an awful accident, this morning. I've no peripheral vision out of my right eye — and I hit the door of the medicine cabinet. It was such a sudden blow that I fell into the bathtub and badly bruised my right thigh." (Actually, she had suffered a hairline fracture of her hip — and would enter a hospital 10 days later.) Suddenly, a celebrity-watcher steps in her way: "Oh, Miss O'Neal, you look much better in person! How do you feel?" Retaining her dry sense of humor, she replies, "*Cah-ripped!*"

While awaiting that "good part in a film," fans can see Patricia Neal on commercials and hear *that* voice; but wouldn't it be great if just once, during a pitch, she'd say:

"*Klaatu barada nikto!*"
