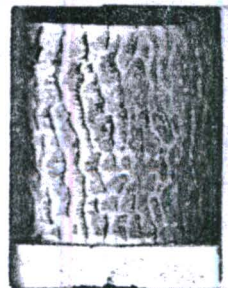
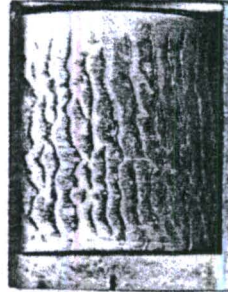
President and Mrs. Reagan are both very interested in doing something about drug abuse. The President appreciates your concerns.
