1 kilogram = 2.2045 lbs.

1 kilogram = 1000 grams

28.35 grams = 1 oz.

1 gram = 1000 milligrams (mg)

1 lb. = 0.4536 kilograms

50 grams = 1.764 oz.

Hope these are useful to you. On an average, 50 grams of pot will make from 75 to 120 joints. NIDA's standard Cannabis joints are approximately 0.998 grams. "Kiddie joints" are approximately 0.25 grams or 200 per 50 grams.



MEMORANDUM

TO: RIPS-Staff & School of Pharmacy

It was impossible for me to see each of you individually prior to departing. You have been very helpful to me; more than you will ever know. Without your support (and opposition) it would have been impossible for me to have moved on many controversial issues. You helped mold me, probably independent of a design, into a person with many views (smile Ron!) You also taught me to keep an appropriate number of rough edges. For your past help and advice, I shall be forever thankful.

Many rumors flow after, and sometimes before, any change. My move was not different. As a friend, do not be swayed by rumors. In fact, let me put some of those rumors to rest:

1. I plan to return to the University and pick up where I left: as Director of RIPS. The Chancellor and Dean Guess approved my leave of absence on a year-to-year basis for the remainder of the President's first term.
2. My research programs will continue. The people in charge are trained and understand the relevant protocol. I will resist in an appropriate way any dismantling of these programs.
3. I do not intend to drop my scientific credentials.
4. I do not intend to raise and educate my children in the D.C. area.
5. I will resist any and all attempts to isolate me from "Ole Miss" and the future development of RIPS.
