



Dear Mr. O'Donnell:

The meeting with you and Carolyn Bacon was most interesting. Your idea of a professionally-produced film to educate the young people of our society regarding the problems with drug abuse is a sound one which I support wholeheartedly.

We discussed the possibility of having certain literature sources shipped from Mississippi, abstracted by me or my office or the National Institute on Drug Abuse in order to provide information in support of your proposal. In checking with Ms. Beverly Urbanek of the Research Institute of Pharmaceutical Sciences, University of Mississippi, Beverly tells me that it will be a few days before she can have the material shipped to me. Subsequently, I spoke with Dr. Bill Pollin of NIDA, regarding the support his agency could provide. Dr. Potlin thinks it will be more than a six-month project. However, I think some of the work can be done in much less time. The papers on the reproductive system are numerous but a reasonable volume. The papers on the lungs are numerous but reasonable. The papers on the brain will present the greatest problem. Nevertheless, I intend to continue striving in this direction.

We are trying to formulate a comprehensive policy which will bring the resources of this country together in a unified front against drug abuse. These programs can only be successful with the support of individuals such as yourself.

Personally I thank you for the work you have done in the area of drug abuse, and look forward to the successful completion of your project. If this office ban be of any assistance, please call.
