



Dear Dr. Turner,

For the past two and half years, I have been actively involved in working in the area of drug abuse. We have been actively involved in the school system where we have had a pilot program in terms of educating both teachers and children as to the problems of marijuana, alcohol, and any of the psychoactive-type drugs.

As a result of this, we have had a very significant impact upon our community, a service area of about 35,000-45,000. The information we have received from many sources has been a major contribution to that success.


